These at-home bakers aren't loafing around

don't come with a temperature-controlled walk-in freezer, nor do they come with multiple stone deck ovens. Then again, most people don't dedicate three rooms in their house to storing smooth, sticky loaves of fermenting bread.

When Jesse Hellen-Lloyd started baking bread in 2015, he didn't expect his Bellflower home would become the headquarters of a burgeoning bread business: My Brother Baker.

"I love being in the middle of it. I don't notice it so much," Hellen-Lloyd said. "But every once in a while my landlord who lives in the front house will tell me how good it

On the morning of Wednesday, June 1, he was hard at work, folding a large tub of sticky white dough that would become the baker's popular country loaf-"a simple American country sour," he said. "It's not anything fancy but it's slow-fermented and super tasty, very utilitarian. It goes miles."

He was joined by head baker Michael Simenson and helper Jojo, who mixed, shaped and refrigerated breads in a coordinated dance as they squeezed through the tight corridors of the garage bakery.

In the late hours of the night, Hellen-Lloyd's wife Christina would haul the globular loaves of dough, tray by tray, into the three ovens to be baked. By early morning, she'd begin mixing dough for baguettes. It's a round-the-clock operation.

"Baking is 99% science and 1% black magic," said Simenson, who joined the team in July 2020. He's the lead on the bakery's pastries like flaky croissants and pan au chocolates that are sold at the Bixby Knolls Farmers Market every Thursday.

A former chef who lost all three of his kitchen jobs during the pandemic, he too was selling bread out of his house. When Hellen-Lloyd saw his focaccia on Instagram, he invited Simenson to help him with the business.

Catalytic converter thefts remain high, surpass 2020 levels, police data shows

Cases of catalytic converter theft began skyrocketing across the nation during the pandemic, and Long Beach is no exception.

Stolen catalytic converters are a hot commodity due to the precious metals they contain; people saw them off vehicles in order to sell them to recycling centers and muffler

From 2018 to 2019, 381 catalytic converters were stolen in Long Beach, according to data from the Long Beach Police Department. Then, as the pandemic arrived, there was a sudden explosion in these thefts.

In 2020, the year the pandemic arrived, the number of catalytic converter thefts was more than double the previous year's number, going up from 177 thefts to 565.

In 2021, the number continued to surge, reaching 854 catalytic converter thefts in a single year-a 383% increase

On March 22, Bixby Knolls resident Irene Brodie went shopping at the Ralph's on the corner of Cherry Avenue and Carson Street.

After about half an hour inside, a message was played over the store intercom asking the owner of a black Honda Accord to come to the front. Brodie originally assumed someone had backed into her parked car, but store staff informed her someone had just stolen her catalytic con-

"It was like literally less than one minute for them to go under and cut that catalytic converter out and leave [...] so even if I had seen or somebody had called the police they couldn't have gotten there in time," Brodie said.

Brodie's catalytic converter was stolen near a local hot spot for this type of crime. The 4100 block of Cherry Avenue, directly across the street from the Ralph's where Brodie was shopping, has seen six different catalytic converter thefts since 2017, according to data from LBPD.

"Here you are at noon time, it's not like I was somewhere at night or the car was parked in an alley or that it was just sitting there," Brodie said. "I mean, it was a busy parking lot with people coming and going and it was so brazen."

Signal Hill's Ten Mile Brewing will host grand opening of pizza kitchen this Saturday

Beer and pizza. Enough said.

Signal Hill's Ten Mile Brewing Company will host the grand opening of its pizza kitchen this Saturday, June 11. A menu boasting creative flavor combinations is the latest addition to the father and son's everchanging option of craft beers.

"This is something that we have been wanting to do for a long time," said brewer Jesse Sundstrom, who runs the brewery with his father Dan. "We actually were talking about wanting to do food when we very first opened the brewery."

The new menu will include Neopolitan-style pizzas with common flavors like cheese, pepperoni, margarita, and barbeque chicken, but will also include more unique flavorings crafted by Sundstrom.

The breakfast pizza uses Cajun cream sauce as a base and is topped with potatoes, bacon from Shady Grove Foods, a cracked egg and hot sauce

The Cajun pizza is topped with tasso—a heavily smoked, spiced pork shoulder traditional in Louisiana cuisine—as well as carrots, onion, zucchini and yellow squash with a heavy cream base.

"You get this really awesome flavor profile with that one," Sundstrom said. "A little bit spicy, that classic Cajun spice."

Today, the brewery will debut a new pizza complete with scallions, garlic, bacon and goat cheese which Sundstrom is "really, really excited about."

The pandemic played a key role in the Sundstroms' decision to add a kitchen to their brewery.

When the tasting room first opened in 2017, Ten Mile's permit allowed them to host food trucks in their parking lot in lieu of a kitchen. But food trucks can be "unreliable" and leave the brewery "hanging" if they don't show up, owner Dan Sundstrom told the *Signal Tribune* in 2020.

When local health officials let restaurants reopen with safety guidelines, breweries without com-

mercial kitchens were only allowed to sell alcohol to-go.

"That was kind of the thing that pushed us to actually make it happen," Jesse Sundstrom said. "So in the event, if something comes back around, and we do have to shut down again, we are still able to stay open, continue to serve food and serve the community."

The Signal Hill City Council approved Ten Mile's permits in December 2020. Since then, the Sundstroms have built out their commercial kitchen from scratch. The kitchen is located in the back of the brewery, replacing an office and storage area.

The brewery will continue to host a food truck on Fridays, with the intention of phasing out the trucks over time to focus on the pizza kitchen.

This Saturday's grand opening will coincide with Ten Mile's regular Sip & Shop event, where local vendors are invited to sell their wares in the brewery's parking lot.

On Saturday from noon to 2 p.m., Ten Mile will offer a special: any two beers and a pizza for \$30.

The Los Angeles County Registrar-Recorder is still counting votes—they last updated the tallies on June 8 at 2:07 a.m. —but here's how the primaries are shaping up so far:

Long Beach Mayor

Candidates Rex Richardson and Suzie Price are neck-and-neck for the Long Beach mayoral seat. Neither has netted the 50%+1 majority votes that would hand them the position without a runoff. The two are expected to head to a runoff election in November.

District 1

Incumbent Mary Zendejas is leading the way (49.98%) and may well secure her position as District 1 council member. To avoid a runoff election, she must maintain her already substantial lead against Mariela Salgado (28.04%) and net over 50% of the votes.

District 3

Kristina Duggan and Nima J. Novin are expected to head to a runoff election in November. Neither is currently close to netting over 50% of the votes, with Duggan at 22.89% and Novin at 19.20% of the votes. Greg Magnuson is closely behind Nima J. Novin with 18.78% of the votes.

District 5

Megan Kerr appears to be leading the way for a win in District 5, with 47.88% of the votes. Ian Patton is behind her at 32.7% of the votes.

District 7

Incumbent Roberto Uranga has easily secured his seat as the District 7 councilmember with 62.46% of the vote thus far. His competitor Carlos S. Ovalle is lagging behind at 25.38% of the votes.

District 9

Joni Ricks-Oddie and Ginny Gonzalez are battling it out for what may be decided in a runoff election. Ricks-Oddie has netted 44.37% of the vote thus far and Gonzalez has 26.83%.

City Attorney

Dawn McIntosh is leading the way with 56.48% of the votes. Her challenger Gerri Schipske has netted 43.52%.

City Auditor

Incumbent Laura L. Doud seems to have secured her position as city auditor with 61.77% of the votes. Daniel Miles is trailing behind with 38.23% of the votes.

City Prosecutor

Doug Haubert has netted 58.82% of the votes, a substantial lead over his challengers Nick Liddi III (22.45%) and George Moyer (18.74%).

United States Representative 42nd District

In a crowded field of challengers, Long Beach Mayor Robert Garcia is leading the way for a seat on the House of Representatives, with 44.66% of the votes. Republican challenger John Briscoe is behind him with 22.65% of the votes.

The majority of ballots counted by the Registrar-Recorder are mail-in ballots, which are counted first. Early ballots come next and then votes from polling stations.

The top two candidates in each election will move on to the general election unless they net 50%+1 of the votes, in which case their position is solidified and they will not be required to head to the general election.

Recreation Park Playground will hold grand reopening on June 14

Just in time for summer, the Recreation Park Playground will reopen on June 14 with new dinosaur-themed playground equip-

The playground will feature a new seating area near the facility, separate structures for age appropriate groups and ADA accessibility improvements.

The new playground was built with \$1.9 million of funds from Measure A, a voter-approved sales tax that helps fund "public infrastructure and public safety services," according to the city's website.

Accessibility features include a board of 15 different American Sign Language phrases for children to communicate with those who are not hearing. Some phrases include "monkey bars," "pretend," "slide" and "game."

"The inspiration behind the sign language board was a result of direct stakeholder feedback and discussions with the disability access community," said Project Manager Charlene Angsuco.

The playground includes a slightly smaller structure designed for children ages 2 to 5 years old, and a larger structure for older kids to play on, with monkey bars and a wall of rope to climb on.

Construction began on the playground in November 2021 and was originally expected to be complete by March 22, 2022. According to Angsuco, the delay was due to a backlog of playground equipment from the company GameTime, which didn't deliver the equipment until past March.

Now that the facility is nearly ready, the Long Beach Department of Parks, Recreation and Marine and Public Works will host a grand reopening for the public on Tuesday, June 14 at 1 p.m.

Recreation Park Playground is located at 4900 E. 7th Street.

Masking requirement is extended for indoor public transportation as COVID-19 cases rise

ong Beach has responded to a rising number of COVID-19 cases by extending the mask mandate on indoor pub-

The city has been requiring passengers to wear a mask on public indoor transit since the latest Safer-at-Home Health Order from Los Angeles county sent out on April

Residents must wear a mask when they are in:

- Commuter trains
- Buses
- Taxis and ride-shares
- Airport and bus terminals
- Train stations

- · Seaport or other indoor port terminals
- Any other indoor area that serves as a transportation hub

The department also stated in the order that it would reassess the mask mandate either every 30 days or when the seven-day rate reaches below 50 people per 100,000, whichever comes first.

From April 28 to June 3, the seven-day COVID-19 case rate in Long Beach more than doubled.

On April 28, the seven-day rate for positive COVID tests in Long Beach was 72.8 people per 100,000. As of June 3, that number has reached 230 people per 100,00, according to a statement released from the city.

The seven-day case rate is even higher in Los Angeles County, with 320.57 cases per 100,000 people,

according to the Centers for Disease Control and Prevention (CDC).

On May 21, Long Beach entered the yellow (medium) tier, the second of three tiers of the CDC's COVID-19 Community Levels.

The city released a statement saying, "The rise in cases has led to an increase of outbreaks across the city, including among our K-12 schools and nursing facilities, putting some of the most vulnerable residents at risk."

The city is also urging residents to take other common-sense measures as we see an increase in cases. These measures include: washing your hands more frequently, staying home when sick, testing for COVID after coming into contact with someone who tested positive and staying up to date on your vaccines and boosters.

'There's not really anything quite like this': Long Beach Municipal Band returns for summer season

series of symphonies and impressive vocals will mesh with the sounds of nature for six weeks this summer for one of the city's longest-running traditions. After performing a shortened, two-week season last year due to the pandemic, the Long Beach Municipal Band will return with gusto for its 113th season.

The Long Beach Municipal Band is made up of some of the top musicians in Southern California and led by conductor Kurt Curtis, who is entering his first full season conducting. They will be performing a mixture of studio band and guest vocalist concerts throughout six parks in Long Beach from June 28 through August 5, each week following a different theme.

As the longest-standing municipal band in the country, Curtis explains that one of the goals each year is to keep things exciting.

"There's favorites we've played over the years that people love to hear again, but it's always nice to sprinkle in some brand new things that they've never heard before," Curtis said.

Families have been flocking to Long Beach parks for over a century to enjoy the sounds of live music at parks and beaches. All venues are free, giving the community 24

chances to experience a highly renowned live studio band.

"I think what's the beauty of it all, is that it brings the community together," Curtis said. "Everybody brings their beach chairs and their blankets and their food spread. They have a wonderful outdoor evening in the parks and then to hear just an amazing ensemble play music ... There's not really anything quite like this in the whole country, not at this level."

Curtis also spoke to the "quality of musicianship" among the players on the municipal band. The musicians who plan on planting their chairs atop grassy fields are the same playing for the LA Philharmonic, the Disneyland band, various movie and television scores and teaching throughout Southern California universities.

It's not by chance that the band has stood the test of time-it survived The Great Depression from 1929 to 1939, and a pandemic that is ongoing-but through dedication from the City. Funds from the Long Beach city council created the first city band in 1889, formally known as the "Long Beach Marine Band."

The 30-piece ensemble performed in parks, restaurants and skating rinks throughout the year until 1905. Replacing the Marine Band was a city-approved municipal band under the direction of Nicola Donatelli, an Italian immi-

In 1909, the city passed an or-

dinance to create the Long Beach Municipal Band, which became one of the city's most esteemed attractions. Members of the community took to beaches and parks daily to hear their favorite scores performed.

was the most popular form of entertainment at the time. They would do just what we're doing here in the city of Long Beach, they'd go to the parks and hear outdoor concerts [...] And we're going to be doing that same thing. It's partly what I like about it, it's just such a great connection to history."

Themes are meant to intrigue crowds old and young, Curtis explained. Week two will feature sounds from iconic Broadway productions, "certain to bring back fond memories of music that has shaped our lives," according to a statement from the city. "Give My Regards To Broadway" will also include a debut performance from vocalist Crystal Lewis.

Week four, "Let's Dance" will get attendees on their feet, as the band will perform dance music "for all appetites" as well as fan-favorite jazz artist, Tony Galla.

Long Beach Architecture Week kicks off with tours, events, speakers

ong Beach Architecture Week (LBAW), a celebration of the city's built environment, kicked off on June 8.

Architectural tours covering iconic buildings and prominent architectural styles in Long Beach will continue until Sunday, June 12. This is the first time the volunteer-run nonprofit has celebrated the event in person since 2019.

"Art, architecture, design is all around us in our everyday lives, so much so that we overlook it," said Brian Trimble, an assistant professor of art at CSULB. "It's everything from the jewelry we wear to clothing we wear, to the chairs we sit on and the cars we drive, to the buildings that we work in and live in."

"Literally all of those things are designed by someone that has an education in art design or architecture," he continued. "For me, it's all related and has an incredible impact on how we live our lives."

Participants can pick and choose which areas of Long Beach architecture most interest them, whether it's an afternoon tea at the historic Victorian Bembridge House (\$60) or a look back into the '20s with a tour of the East Village (\$45).

Lovers of the '30s can hop on a double-decker bus for a tour of all things art deco and streamline modern (\$70) led by John Thomas, a local art deco expert and preservation consultant for the Queen Mary.

Most cities have a certain amount

of art deco and streamline modern buildings from the late '20s and early '30s, Trimble said, but Long Beach is unique in its abundance of the particular style.

The 1933 earthquake destroyed a number of structures, and federal funds from the New Deal era helped rebuild new art deco buildings across the city.

"There's just a plethora of that style of art deco in Long Beach," Trimble said.

The five-day celebration also includes a number of free events, such as self-guided tours of Downtown Long Beach, CSULB's recently-reopened Kleefeld Contemporary Art Museum, and tours of a dozen "bungalow mansions" designed by Miner R. Smith.

LBAW's mission is to foster an appreciation of architecture by looking at design through the lens of history, contemporary issues and preservation, according to their website.

"It's not just educational, but it's fun," Trimble said. "The people organizing it, the people that are doing the tours, our partners like the American Institute of Architects and Long Beach Heritage, they all love this city. They love what we're doing and we want to give something back to our community."

LBPD said in a statement that no one should ever approach someone they suspect is trying to steal a catalytic converter.

In January of this year, a Long Beach man was shot after confronting a group of men who were trying to steal his catalytic converter. According to LBPD, the suspects have still not been caught.

If it can be done safely, police recommend recording the license place number and vehicle descrip-

A bystander took a photo of the thief who stole Brodie's catalytic converter as well as the vehicle he was driving. But when police arrived, they told Brodie the perpetrator's vehicle or license plates were most likely stolen.

Brodie said she never heard back from the police after filing her police report.

Brodie had full coverage insurance, but it still took weeks for her car to be repaired. If she hadn't had full coverage insurance, she may have had to pay the \$6,300 to replace her catalytic converter out of her own pocket.


Joseph Boche, a director with the International Association of Auto Theft Investigators (IAATI), told NBC stolen converters can be sold for anywhere from \$50 to \$1,600.

"I'm just still so outraged over this," Brodie said. "And that it's so blatant that you can't even go to the grocery store at noon time on a Tuesday. And people saw it, I mean, people were coming and going and taking pictures and they still did it."

Brodie said it was fortunate that both she and her husband are re-

tired and were able to share his car as hers was waiting to be repaired, and wondered "What if we both had to work?'

To keep this from happening again, Brodie has invested in a protective plate for her catalytic converter. Her insurance wouldn't pay for this additional protection, but Brodie didn't want to risk it and paid \$470 for it herself. She's retired and on a fixed income from social security.

"I worked hard for everything I've got and you're just stealing it,'

—Irene Brodie, Long Beach resident who had her catalytic converter stolen Brodie said. "So honestly, I hope they catch the guy and I hope that there's some severe consequences."

According to the Long Beach Police Department, vehicle owners can take the following precautions to help prevent catalytic converter

- · Purchase an anti-theft cable locking device or catalytic converter shield, which are significantly less expensive than replacing a catalytic converter.
- · Etch a vehicle's catalytic converter with the VIN or license plate

number.

- · Park vehicles in a driveway or garage whenever possible.
- · Make arrangements for vehicles if they will be left unattended for an extended period of time.
- · Install motion sensor lighting around homes.
- · Become acquainted with neighbors and join or start a Community Watch Program.
- · Report suspicious persons or activity.
- · Victims can speak with their mechanic about potentially spot welding or collapsing the bolt threads at the time of replacement; this could prevent a second theft.

An analysis of data by insurance company State Farm shows a nationwide rise in catalytic converter theft; the crime increased 293% nationwide between July 1, 2020 and June 30, 2021, the first year of the pandemic.

Long Beach's State Senator Lena Gonzalez has introduced a bill that aims to crack down on catalytic converter theft by limiting who can buy and sell catalytic converters.

The bill would only allow detached catalytic converters to be sold by the owner of the vehicle the catalytic converter was removed from, automobile manufacturers, dealers, dismantlers, auto repair specialists, or any other business that generates, possesses, or sells used catalytic converters. Under the bill, a violation would be punishable by a fine between \$1,000 to \$5,000.

"Until they stop the person or people who are buying these, this is going to continue," Brodie said.

Local nonprofits prepare for Juneteenth celebration in North Long Beach

wo local organizations, The CRayProject and Urban Society Long Beach, have partnered to host a three-day celebration of Juneteenth that will include a professional networking event, motorcade, block party and brunch.

"I think it's very great that so many people are tapping into this, celebrating in ways that they see fit because it's very necessary and very needed in our culture and people need to know the history of it as well," said Chatiera Ray, founder of the CRayProject. "It's just as important as the Fourth of July."

Juneteenth commemorates when the last African Americans kept in chattel slavery in the United States were finally freed by Union soldiers.

Although the Emancipation Proclamation was enacted in 1863, African Americans were still enslaved in states that were under Confederate control. The last enslaved African Americans were held in Texas until Union troops, many of whom were Black, arrived on June 19, 1865 and informed them that they were now free.

The City of Long Beach recognized Juneteenth as an official day of celebration in June 2021.

This marks the third year that The CRayProject and Urban Society Long Beach have hosted a Juneteenth celebration for the Long Beach community.

"We appreciate all the support

that we've gotten over the past couple of years," said Wes Porter of Urban Society Long Beach. "We just want to continue to grow the event and grow awareness for the holiday of Juneteenth. It's very important in our community."

For this year's celebration, the two nonprofits partnered with the nonprofit organization Project Optimism to kick-off the threeday celebration with a networking event for professionals to connect with one another on Friday, June 16.

The networking event will be held at On The Rocks Bar & Grill, located at 5755 Pacific Coast Hwy., from 5 p.m. to 9 p.m.

On Saturday, a motorcade and block party will be held at the Uptown Commons in North Long Beach from 5 p.m. to 9 p.m.

The public is invited to decorate their vehicles and participate in the motorcade. Vehicles will start lining up at Martin Luther King Park at 4 p.m., before departing at 4:30 for the northside of Uptown Commons

The block party will feature between 10 to 12 vendors, performances, music and more.

"I was enamored, like, 'You built a bakery in your garage?" Simenson said. "It was so inspiring, how they handled it, how they built this bakery. I just really began to believe in it."

Hellen-Lloyd, a trained sound engineer, started baking bread when he was inspired by the extensive offerings of bakeries in San Francisco. At the time, he was working in the music industry, but he always had a knack for experimenting—previously in beer, pickles and cheese. He picked up some literature on the topic and started baking.

"There's a lot of concepts that interplay very tightly in this sort of dance, between time and temperature and development and fermentation," Hellen-Lloyd said. "Grasping that with natural fermentation, when I first started, it was a beast."

It took about a year and a half of baking before he made something he was proud of, Hellen-Lloyd said. Then, he started bringing extra loaves to his local watering hole, Heritage Sandwich Shop.

"The kitchen got ahold of one at one point, and I think the next time I walked in, two of the line cooks basically tackled me and were like, 'This is amazing. I love it, it's so good,' super flattering," he said.

Shortly after, he got in touch with the head chef, and earned his first official customer.

Now, instead of working to make louder beats, he works with flour and yeast.

It would take a year for Hey Brother Baker to get its second customer, Solid Coffee Roasters in Artesia. From there, the business grew organically. In Long Beach, his breads are scattered around the city: loaves at Commodity LB on Atlantic Avenue, Ethikli: Package Free Goods on E 4th Street and Heritage Sandwich Shop on 7th Street; baguettes and ciabatta at Oh La Vache on 4th Street; and sourdough and brioche at Berlin Bistro on 4th Street, not to mention their spread at the Bixby Knolls Farmer's Market.

"I've watched this happen now for the past decade. It's like a maker's renaissance. People like the idea that the stuff that they're consuming is made with care by somebody close by," Hellen-Lloyd said. "And it's not just pumped out of a machine at a factory. I think with bread, it's easy to tell the difference."

Though their bakery is currently crammed into Hellen-Lloyd's house, he's hoping to move the operation into a commercial kitchen space, but is waiting for the right time.

"If someone was going to be a fly on the wall at our bakery, they would be absolutely mind blown with what we're able to pull off," Simenson said. "It just makes me very excited, very proud of what we do."

City of Long Beach will offer free COVID-19 antiviral medication

The Long Beach Department of Health, in partnership with Health-Vana, the City's test result delivery partner, will provide free antiviral COVID-19 medication for those who test positive for the virus.

Whether receiving results from HealthVana, or a city-run location, residents can contact the Los Angeles County's Telehealth phone line at 1-833-540-0473 to order free medication.

The City is attempting to lower the rising number of COVID cases, as Long Beach entered the yellow (medium) tier of the CDC's Community Level on May 21.

On April 28, the seven-day rate for positive COVID tests in Long Beach was 72.8 people per 100,000. As of June 3, that number has more than doubled, reaching 230 people per 100,00, according to a statement released from the city.

If taken within five days of symptoms, either medication, Paxlovid or Molnupiravir, reduces the virus's ability to multiply and spread throughout the body. The prescription will be given over the phone line and should arrive at people's homes by the next day, according to a statement released from the city.

The Los Angeles County Telehealth phone line is open seven days a week from 8 a.m. to 8:30

New townhome development in North Long Beach geared towards multigenerational families

ice Mayor Rex Richardson and developers celebrated the groundbreaking of a new townhome development in North Long Beach on Thursday, June 9.

Nestled between a furniture store and a carpet store on Artesia Boulevard, the lot has been vacant for nearly two decades after a fire destroyed the original building.

Going in it's place will be a townhouse development from Urban Pacific Group that will contain five units intended for multigenerational families—each with five bedrooms and five bathrooms. One unit will be deed-restricted for low-income housing.

The townhome project is the third groundbreaking that Urban Pacific has undertaken in the past year.

"Now what you see with this incredible townhouse project, you're gonna see modern architecture that's gonna improve the standard of architecture here on [the] Artesia Boulevard corridor," Richardson said.

This is the first development of its kind in North Long Beach as

part of the UPLAN Zoning Initiative—otherwise known as the North Long Beach Uptown Plan— aimed at "making it easier to build things like housing and grocery stores and healthcare and more difficult to build thing like liquor stores and nuisance motels," Richardson said.


The new units have a modernized mediterranean style of design, and Richardson hopes that adding denser housing options on Artesia Boulevard will stimulate some of the local businesses on the street.

"The project is a contemporary design," said Scott Choppin, founder and CEO of Urban Pacific Group. "It'll be really, I think, a fresh and outstanding new addition to the Artesia Boulevard corridor."

Just a few blocks away from the development is the popular Uptown Commons complex that opened in 2020.

"We look forward to welcoming new residents to North Long Beach community when this project is done," Richardson said.

The townhouses are expected to begin receiving residents by next summer.



Project Title: 2021-2029 Housing Element Update

Project Location: All lands within the City General Plan Planning Area which is located in the southwest corner of Los Angeles County (County) and covers approximately 2.2 square miles in size.

Project Description: The City is preparing an update to the Housing Element of the existing General Plan for the October 2021 to October 2029 Planning Period. The Housing Element is one of seven required elements of the General Plan per the California Government Code, beginning at Section 65583. Generally, State law mandates updating the Housing Element every eight years. The Housing Element serves as a policy guide to address the comprehensive housing needs of the City. The primary focus of the Housing Element is to ensure decent, safe, sanitary, and affordable housing for current and future residents of the City, including those with special needs. The City is required to ensure the availability of residential sites, at adequate densities and appropriate development standards to accommodate its fair share of the regional housing need, also known as the Regional Housing Needs Assessment (RHNA) allocation.

The Southern California Association of Government (SCAG) RHNA allocation for the City identified a housing need of 517 housing units with approximately 45 percent of the 517 units needed for very low- and low-income households. The RHNA allocation for the City includes 161 very low-income units, 78 low-income units, 90 moderate-income units, and 188 above moderate-income units. Housing Inventory Sites will be identified within the Housing Element for the development of up to 718 housing units, in line with the recommendation of the California Department of Housing and Community Development to allot for 15 to 30 percent above a local government's allocated housing units. The Project also identifies four Housing Inventory Sites as required by Government Code section 65583.2 (a).

Billie Jean King Library will host exhibition of essay-writing submissions from youth

The Billie Jean King Library will showcase words of hope, identity and race from the perspective of high school students across the nation as part of an essay writing exhibition touring Southern California this summer.

Creative agency InterTrend Beyond 30 and its Make Noise Today initiative reached out to thousands of students and teachers to find out what high school students think about race, ethnicity and identity for its national writing contest,

The result was over 900 essay submissions—heartfelt letters to a loved one, a peer, a bully, to one's parents or one's self, explaining feelings of identity and racial equity.

The letters will be on display in the library all summer on large panels for residents to read.

The goal was to "provide a voice

for the youth, especially with everything going on in the world right now," said Tanya Raukko, chief strategy officer at InterTrend.

Raukko, who read each entry, said she was shocked at the strong level of writing from the contestants. Many entries focused on the need for mental health, she said.

"I think these kids are enduring a lot," Raukko said. "That's why I think mental health is a big theme coming out as a need that they have, but also, some of those challenges that they would speak of, it would transform a little bit into positivity and hope for the future and how they intend to change the world."

Long Beach is kicking off the summer-long series, which will travel to various Southern California museums, libraries and multicultural centers to amplify student's voices on the matter of racial identity.

Under InterTrend's Make Noise Today initiative, the agency has partnered with educators across the country to provide educational toolkits that "create a space for discussions of race" with an emphasis on storytelling, according to the initiative's website.

The initiative was started in May of 2020, as a response to the increase in hate crimes against the Asian American community. According to the Center for the Study of Hate and Extremism, anti-Asian hate crimes increased by 149% in 2020. The same center published a study stating that the number jumped to 339% last year.

Long Beach has an Asian population of over 54,000, making up almost 12% of the city's population, according to Data USA.

The subject matter encourages self reflection, and Raukko says the impressionable age is what makes high schoolers perfect for this kind of contest.

"We really wanted to think hard about where the deepest impact would be to combat racism. And we knew that [high school] was where people ... their value system is formed at that stage and they're still a little bit malleable and open minded," Raukko said.

The roughly 900 entries were narrowed down to the top 200 by an internal panel of Make Noise Today judges. An external panel of three people—an educator, an author and a journalist—then chose the top 10 winners, who received a total of \$10,000 in winnings.

The Billie Jean King Library is located at 200 W Broadway and is open on Tuesdays from 10 a.m. to 7 p.m., Wednesdays from noon to 6 p.m., Thursdays from 10 a.m. to 7 p.m. and Fridays and Saturdays from 10 a.m. to 5 p.m.
