

Women pleads guilty to providing alcohol to minor involved in deadly crash

A woman who prosecutors said operated a liquor store pleaded guilty today to furnishing alcohol to a 20-year-old man who was subsequently involved in a DUI crash that killed a Long Beach couple and their 3-year-old son on Halloween night in 2019.

Just over a week after Carlo Navarro was convicted of murder and gross vehicular manslaughter while intoxicated for the deadly crash, Amor Potestades Amacio of Norwalk pleaded guilty to a misdemeanor count of furnishing alcohol to a minor who consumed the alcohol and "thereby proximately causes great bodily injury to themselves or any other person," according to the Long Beach Prosecutor's Office.

She also pleaded guilty to one count of conspiracy to obstruct licensing provisions of the Alcohol Beverage Control Act because she was operating a liquor store, Green Diamond Liquor, without approval from ABC, according to the Long Beach City Prosecutor's Office.

A video obtained by prosecutors shows Amacio, now 60, handing a bottle of whiskey to Navarro without asking for identification or paying for the bottle, according to prosecutors.

The young man said in a statement that the woman knew he was under 21, had sold him alcohol multiple times in the past and had directed him to return to the store the following day with \$25 to pay for the \$16 bottle of whiskey,

HERITAGE POINT PARK OPENS TO THE PUBLIC

ver three dozen people gathered for a ribbon cutting ceremony of the newly renamed Heritage Point Park in Signal Hill on Friday, July 8. "One of our greatest assets that we have in our city is our wonderful parks, playgrounds and walking trails that are enjoyed by our residents," Mayor Keir Jones said to the crowd. "As a longtime resident myself, I have enjoyed many of our trails and parks over the years, and I'm very excited that Heritage Point Park has come to

The park contains a walking trail that connects Skyline Drive to Creston Avenue, and provides pedestrian access to Signal Hill City Hall.

The park was originally going to be named View Park, but Jones expressed an interest in changing the park's name to one that better represented Signal Hill's history. The City Council began asking residents to submit ideas for names in August 2021, and the name was officially changed to Heritage Point Park in October 2021.

City of Long Beach will give away 1,000 cans of infant formula in wake of supply chain shortages

Long Beach will distribute 1,000 cans of infant formula in the wake of a supply chain shortage that's left many families unable to obtain this vital source of nutrition for their babies.

In February, supply chain pressures, a sudden formula recall and the subsequent shutdown of an Abbott formula factory in Michigan caused a nationwide shortage of baby formula.

For months after, formula was sparse at local grocers, with stores such as Target, Ralphs and CVS limiting the number of containers customers could purchase.

Nonprofits and community groups tried to fill the void. Toi Nichols, founder of the nonprofit M.O.R.E Mothers, personally experienced the impact of the shortage. Her nonprofit provides resources to new and expecting mothers.

"With the formula shortage, we had an influx of new mothers that

were looking for resources based around feeding their children," Nichols told the Signal Tribune. She began referring mothers to

nutrition classes when she didn't have enough formula on hand.

In late May, as mothers struggled to find food for their infants, other organizations and providing Los Angeles County purchased

\$750,000 worth of formula, according to a news release from Supervisor Hilda Solis.

On Tuesday, the Long Beach City Council approved a motion to receive 1,000 cans of formula from the county.

To receive infant formula from the City of Long Beach, parents must meet a set of qualifications set by the County, such as receiving Medi-Cal benefits, being employed without insurance, having a Housing Choice Voucher, or enrollment in public assistance programs like CalWORKS, and Special Supplemental Nutrition Program for Women, Infants and Children (WIC) benefits.

The cans will also be distributed at WIC locations in the city and community-based events, according to Long Beach Health and Human Services Director Kelly Co-

Once the city receives the formula, it will be distributed within 30

Corked in Bixby Knolls has windows smashed; Long Beach police seek suspects

Over the weekend, a man smashed the windows of the Bixby Knolls Corked liquor store just one day after a customer allegedly struck the owner with a bottle during an altercation.

An investigation is underway to find the suspect or suspects responsible for the alleged attack and later vandalism, a spokesperson from the Long Beach Police Department said in an email.

On Friday, an adult male suspect reportedly entered Corked on Atlantic Avenue and got into a verbal dispute about his parked vehicle with the business owner, police

The dispute escalated when the suspect struck a store employee. All three individuals then got into an altercation, police said.

During the altercation, the suspect allegedly struck the business owner in the upper body with a nearby bottle.

A relative of the business owner was present at the time, and sprayed the suspect with pepper spray. The suspect then fled the area in a vehicle before police arrived at approximately 2:43 p.m., police said.

Personnel from the Long Beach Fire Department arrived at the scene and treated the victims for non-life threatening injuries.

The next day, at around 7:12 a.m., officers responded to Corked for a reported incident of vandalism. When they arrived, police reportedly saw that the business's front windows had been shattered.

Through a preliminary investigation, police determined that an unknown male suspect approached the closed business and smashed the windows with an object before fleeing the area on foot.

Police said the investigation into both crimes is ongoing and detectives are actively working to uncover whether the two crimes are connected.

The owner of Corked was not immediately available for comment.

The Bixby Knolls Business Improvement Association made a post on Instagram on Monday asking people to support Corked by stopping by and buying drinks.

"This family left Syria to pursue a quiet life and the American dream by starting a business and we do not want to see this happen to anyone, personally and/or to their livelihood," the Instagram post reads. "Corked is a beautiful, well-maintained business in our district that has lots to offer."

Corked is located at 4100 Atlantic Ave., and is open from 10 a.m. to 10 p.m. on Sunday, Tuesday, Wednesday and Thursday, from 10 a.m. to 11 p.m. on Friday and Saturday and from 10 a.m. to 9 p.m. on Monday.

"This is one of the most tragic events to ever happen in Long Beach, and it was entirely preventable," City Prosecutor Doug Haubert said in a statement. "There is nothing a misdemeanor case can do to bring justice to the Awaida family, but we hope this will help prevent a similar tragedy in the fu-

Amacio's daughter, Syntyche Amacio, 28, also of Norwalk, pleaded guilty to conspiracy to obstruct licensing provisions of the Alcohol Beverage Control Act for being the "paper owner" of the liquor store while allowing her mother to operate it, according to the City Prosecutor's Office.

Prosecutors contended that Syntyche applied for and was issued a license to operate the liquor store in North Long Beach, but that the store was operated by her mothlicense after being convicted case involving food stamps.

The younger Amacio was not present when alcohol was provided to Navarro and there was no evidence she had provided alcohol to minors on previous occasions, prosecutors said.

Like her mother, Syntyche Amacio was also banned from holding a liquor license or participating in any business or other commercial activity involving the sale or distribution of alcoholic beverages in California.

She was also ordered to serve one year on probation, complete 40 hours of community service and to donate \$1,000 to a local charity selected by the Awaida family, according to the City Prosecutor's

for the 39th annual Pride Parade on the morning of Sunday, July 10. Various organizations and prominent members of the City showed up and showed out in rainbow attire to celebrate the LGBTQ+ community after a two-year hiatus.

The parade began at 10:30 a.m. at the intersection of Ocean Boulevard and Lindero Avenue and went down to Shoreline Drive as onlookers waved rainbow flags and held up signs supporting Pride, Planned Parenthood and the right to safe, legal abortions.

"Pride is so important. If we don't stand up and actually appreciate the rights that we earned and that people before us have fought for, we can lose them," said Jaredd Reese, a member of Service Employees International Union, which advocates for the fair and equal treatment of healthcare workers. "Especially the way this country is

Reese said he has attended Long Beach Pride before, but that this year had an undeniable energy to it, whether it's from post-pandemic excitement or the state of the country.

Pride Parade was the cherry atop Long Beach's three-day Pride Festival weekend, which included live music performances from Iggy Azalea, Natalia Jiménez and others, a drag queen makeup booth, a silent disco, an S&M (sex and mischeif) playground for adults, a roller rink, a Transcendence Dome pop-up museum about the transgender community, artist walls from local artists, a family fun zone and the chance to see houses battle each other in between musical acts.

"It was fantastic, baby!," said Jessica Coleman. "We celebrated and loved and embraced one another. [This year] I felt more empowered because we embraced each other."

Once the parade was over, residents flocked to the surrounding streets, dancing, laughing and meeting other members of the community.

Demolition work begins on Gerald Desmond Bridge

eginning the weekend of July 9, workers began dismantling the Gerald Desmond Bridge—once a signature feature in the Long Beach skyline—opening the port's waterways to larger cargo ships.

The 5,134-foot-long bridge was closed to traffic in October 2020, when a higher replacement bridge opened. But starting Saturday, June 9 crews began disassembling the 410-foot portion of the bridge that crosses over the port channel.

Continuing through Monday July 11, the Port of Long Beach's back channel was closed to ship traffic to accommodate the work. On Saturday, crews dismantled the suspended portion of the bridge and lowered it onto a barge for removal. Vehicular traffic on the new bridge will not be impacted.

The effort is only the first step in the demolition process, but the rest of the work is not expected to significantly impact vessel traffic in or out of the port. The demolition work is scheduled to be completed by late 2023.

The bridge opened in 1968, named for former city attorney and Councilman Gerald Desmond, who helped secure funding for the construction project. He died while the bridge was under construction.

The original bridge rises 155 feet above the water below. But with

newer, larger ships now carrying cargo, the port needed more clearance. That led to a roughly \$1.6 billion bridge-replacement project. The replacement bridge rises 205 feet above the water.

"The Gerald Desmond Bridge served Southern California's regional transportation network for over 50 years, carrying more than 60,000 Southern California commuters and cargo-hauling trucks

The bridge opened in 1968, named for the former city attorney and Councilmember Gerald Desmond, who secured funding for the project.

every day by the time construction started on the new bridge," Steven Neal, president of the Long Beach Board of Harbor Commissioners, said in a statement. "The new bridge is safer and serves as a symbol of the Port of Long Beach's position as a primary gateway for trans-Pacific trade."

The roughly \$60 million cost of demolishing the old bridge was included in the \$1.6 billion replacement-bridge project budget.

"City council members felt that the new name would effectively represent the culture and values of the city while also serving as a catalyst for a diverse and inclusive telling of the Signal Hill history," said City Councilmember Ed Wilson.

The \$3.3 million construction of Heritage Point Park was funded mostly by a \$2.4 million grant from the San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy.

The Conservation Corps helped construct the park, and multiple members were present during the ribbon-cutting event.

The park features native plants

and a natural watershed to capture stormwater run-off.

The Heritage Point Park subcommittee is working on adding one or more historical markers that share the city's past with visitors, which are expected to be added to the park in the next year and a half.

Councilmember Lori Woods said the City wanted to ensure "Heritage Point Park would instill feelings of pride, respect, welcome and belonging among all residents and visitors."


