### These tattoo legends are teaming up to start the first national tattoo art museum in Long Beach

fter over 65 years of tattooing, legend "Good Time Charlie" Cartwright is worried about the preservation of the craft. To do something about it, the father of black and gray tattooing has rounded up a group of artists in the industry to create the first ever national American tattoo art history museum in downtown Long Beach.

Cartwright founded The Heritage Project in 2021 in hopes to "create a space solely dedicated to archiving and displaying American tattoo art," according to a press release from the nonprofit.

"In eight different states in the U.S., there are 22 tattoo museums connected with shops, but there is no national place to go ... the big one like the Smithsonian of tattooing or something like that," Cartwright said. "I'm a retired man anyway and have been for several ears, so you know, why shouldn' I contribute my energies towards something meaningful like that?"

The past year and a half has consisted of Cartwright and board members-Kari Barba, JD Crowe, Corey Miller, Chuey Quintanar and Jack Rudy-diving into various

points of tattoo history, contacting people who own personal collections throughout the country and meeting with prominent members of the city to discuss a timeline and location for the museum.

Long Beach was the obvious location for the museum, Cartwright explained, due to its connection

to the tattoo community. The Pike has been home to a vast number of tattoo legends since the 1800s, including Bert Grimm, Charles "Red" Gibbons, Dorothy "Dainty Dotty" Jensen, Jack Julian and many, many more.

The museum will delve into the rich history of tattooing in America and around the world, from its roots in ancient Japan to the transformation of American traditional to Chicano-style black and gray and realism. It will also teach attendees about legendary tattoo artists who have their hands-and ink-all over the art form.

### An inkling about "Good Time Charlie" Cartwright

"Good Time Charlie" Cartwright lives up to his name. Over a phone call and 350 miles of distance, Cartwright is laughing about whiny customers who leave bad Yelp reviews, reminiscing on old projects he worked on and contemplating the future of the tattoo industry.

"Well, I'm afraid it's gonna be ... I almost want to say mechanical," Cartwright said. "I think the human element will be completely gone. Except for maybe a few diehards that want to stay primitive, but I'm pretty sure it's all gonna be when he started tattooing out of the backseat of his car in Texas. He practiced the hand poke method, where a tattoo artist uses his hands to deposit ink pigments into someone's skin rather than a machine, for five years without the use of any stencils or tracings.

"I was always a custom tattooer, I didn't even know what stencils were and so forth as a kid, because I just drew directly on people," Cartwright said. "I avoided the professional tattoo world for so many years for that reason, because I thought, 'Well, those guys don't draw, they just trace everything.' So that was a turnoff

Like any respectable tattoo artist in that time, he traveled to the Pike in downtown Long Beach, where the American traditional style was flourishing. It was not common practice to walk into a tattoo shop and request anything different than the flash on the wall.

"They all gave me the cold shoulder so you know I had a hard time even respecting these guys because they were just so corny and flippant about that and I thought, 'Well I want to put good art on people I don't want to just give them a wham bam thank you ma'am type thing."

Cartwright also had a natural affinity towards black and grey tattooing, a style made popular by Chicano artists in California prisons in the '70s. To create different shades of black and grey convicts would use ash, ink from a pen—as well as guitar strings for needles and deconstructed tape recorders for motors.

The varied shades of black and gray gave tattoos more dimension than the American traditional style. Cartwright and fellow board member Jack Rudy are credited for taking the Chicano style to a national level by opening up their shop Goodtime Charlie's in East LA in 1975.

Decades later, Cartwright is once again reaching out to the tattoo community in hopes of changing it for the better. He said he has "grand ideas" for the museum once it opens, including docuseries covering different points in tattoo history, an open marketplace where artists can sell their work, a rotating exhibit from private onloan collections and the opportunity to preserve the culture.

### Long Beach's tattoo history

Boardmember Kari Barba, herself a tattoo history enthusiast, shared a similar reason for wanting to create a national tattoo museum. She owns Outer Limits Tattoo, the oldest operating tattoo shop in America, and the second oldest in the world, at-you guessed it, The Pike.

The Pike was the premiere tattoo destination on the West Coast since the early 1900s, as it used to be home to a dozen different shops owned by various legends of the

Each tattooer was adamant about keeping the culture purefor decades only American traditional pieces were offered: thick black lines and vibrant reds that made up anchors, hearts with arrows or knives piercing them, roses and red-lipped women, popular with the U.S. Navy sailors on ship leave.

Since then, all but one shop has closed its doors as the tattoo world moves on at light speed.

"There's tattoo artists all over the nation who are housing huge collections that nobody sees. It might be in their garage, it might be in the back of their tattoo shop and some of it is displayed but not much," Barba said.

Barba has done her part in preserving tattoo history. After purchasing the oldest tattoo shop in America, she uncovered panels and found perfectly preserved tattoo flash stencils, machines, stained windows and an unopened safe.

She echoed Cartwright's fear about the future of tattooing losing its personal touch, and said she hopes the museum will help preserve the communal aspect of the art.

"The idea of what a tattoo shop is, is going to kind of become historical in itself. Tattoo shops where you walk in and see flash on the wall, or you walk in and can get a walk-in, I think in 20 years, [it] will be very individual and the majority of tattoo shops won't be like that," Barba said. "And so the history of tattoo is kind of going to be a little bit lost if we don't do this



Long Beach kids are back in school this week across the city's 85 campuses. This year the City will implement optional full-day kindergarten classes. For parents who need more time before they take their kids home (be it because they're still at work or simply need some free time), the city offers a slew of after school programs for children ages 5 to 12 at over 20 parks from Monday through Friday. the museum's creation. Southern California tattoo lovers can congregate to Long Beach on Nov. 5 to participate in a fundraiser hosted by Jeremy Hanna and Ryan Smith's company Sullen Clothing. The company put out a call to artists on social media to its more than one million followers, asking them to donate original pieces of artwork following the theme, "What does tattooing mean to you?"

So far, almost 100 pieces of original art have been sent to the Seal Beach headquarters, from tattoo artists all over the world. The works submitted have a maximum price of \$300, a vast difference from the thousands of dollars people usually pay for some of the participating artists.

The fundraiser was originally planned for a smaller scale on Sept. 10, but the "big response" from the community forced the board to search for a larger location. All sales from the art will go

Sullen's connection to the tattoo community has spanned around the world in its 20 years of operation, regularly collaborating with artists and raising funds for causes that speak to them. Hanna heard about the project through small social media posts on Instagram for months before realizing he had to be a part of it.

"To be a part of this legacy, to be a part of this tattoo museum excites me the most," Hanna said. "I know this Tattoo Heritage Project is going to be Charlie's legacy. You know, he's 83 years old and this is going to be you know what he's leaving behind for the tattoo community."

Their call to action has put the Heritage Project on a global scale, and Hanna predicted a "line down the street" the night of the fundraiser.

### **SUMO OPEN RETURNS** TO WALTER PYRAMID

The 22nd Annual Sumo Open will be held inside the Walter Pyramid on the Cal State Long Beach campus on Saturday, Sept. 10.

The Sumo Open is the largest sumo event in North America, with over 60 total competitors this year. The doors will open at noon when preliminary matches begin. The wrestlers who win their preliminary matches will move on to the main event from 2 p.m. to 4 p.m.

There will be over 100 total matches throughout the afternoon, making the event the "largest and longest-running annual sumo competition" outside of Japan, according to the website. The wrestlers competing in the Sumo Open come from 40 countries across the globe, including Japan, Egypt, Mongolia, Poland, the United States and others.

According to the World History Encyclopedia, Sumo is a form of wrestling that began in Japan during the Yayoi period. The sport incorporates elements of the Shinto religion, and is believed to have originated as a ritual practice. Legends say the first sumo wrestler was Nomi no Sukune, a descendant of the sun goddess Amaterasu.

Japanese drinks such as Sapporo Beer and Hakutsuru Sake will be available for purchase.

Ticket prices vary depending on seat location. Ringside seats cost \$100, VIP floor seats cost \$75, lower bleacher seats cost \$45 and upper bleacher seats cost \$30. CSULB students can qualify for a discount on general admission tickets by contacting the box office.

### New cafe in Cambodia Town will sell coffee, Guatemalan meals and art from local artists

Long Beach's newest art exhibit allows residents to shop for locally sourced paintings, order coffee and enjoy a home-cooked Guatemalan meal all in one place.

Cafe Chapin will host its grand opening on Saturday, Sept. 10, with work from eight local artists adorning its walls. The exhibit will be the first in a monthly series curated by Art, Music and Culture, a Long Beach-based one-man small business that curates and hosts art and music shows throughout Los Angeles County.

Chapin is a common Guatemalan slang term which originated in Spain as a chapín, a style of shoe worn by nobles in the fifteenth century.

Efren Luna often uses his network of artists as a call to action for various causes, the latest being to help boost the Guatemalan family-owned and run cafe. Esvin Orozco and his family have lived in Long Beach for over 18 years, and have long dreamt of expanding their family's business in Guatemala to the United States, according to Luna.

"Here's this family who put all their resources together to start something," Luna said. "The way I see it is they need the support because it's the mom-and-pop shops, you know, they need the artist support and vice versa, right?"

After graduating from Cal State Long Beach with a Bachelor's of fine arts in 2007, Luna started curating art shows that combined physical art, music and culture in hopes of finding his own style. The shows were so well received that he has continued to plan and host art shows for over a decade.

He is a longtime advocate for arts in Long Beach, and was voted advocate of the year by the Long Beach Post in 2015.

When he heard that his friend Orozco would be the owner of soon-to-be-open Cafe Chapin, he pitched the idea of making the cafe double as an art venue in order to engage the community. Each month the art on the walls of Cafe Chapin will be switched out for

all new pieces, creating a constant opportunity for local artists to sell their work.

"Right now it's a small group but we've only had a month to get it together," Luna said. "So as we speak, like I'm already thinking, I got to start getting artists for the next month and for the next and the next."

Each month's exhibit will be unveiled on the second Saturday of each month at the cafe, accompanied with live music and performances from local artists. On Sept. 10, Cafe Chapin will host Ferri Boy DJ, a Long Beach musical artist. Luna said they also extended an invite to Councilmember Suely Saro, but have not received a

September's show will showcase pieces from five artists throughout Long Beach, and three artists from Los Angeles. The paintings submitted embrace Long Beach and Latino culture, depicting calaveras, or sugar skulls, pinup style men and women donning "Long Beach," "562" and "213" on their glasses.

There is no professional requirement for art, as Luna emphasized that he wants the exhibit to be open to any and all artists. The only guideline is that the art can not contain explicit material, since Cafe Chapin is a family-owned and run business.

"In my shows, there may be someone who's a self-taught artist alongside someone with a college art degree," Luna said. "I just feel like you know what, it's an opportunity for both [artists] but also at the same time, it's acknowledging both individual's passions."

As of now, there is no set time for each exhibit, as this month will act as an experiment for future exhibits. Luna said they are also exploring the idea of hosting themed exhibits, where each entry follows the same sentiment.

The cafe has enough space on its walls to display art from 20 artists at once, if each person submits one to two pieces, Luna said. Submissions can range from drawings, paintings, photography, and mixed

### **Holland Festival returns to Long Beach**

The Holland Festival will be returning to Long Beach for its 32nd iteration, for what the United Netherlands Organization says is the largest gathering of Dutch Americans in the nation.

The event will feature vendors, Heineken craft beer, Dutch and Indo Dutch food, dancing, live music and more.

"Back in the day, we had different Dutch organizations and social clubs and they all did their own thing," said festival organizer Jeff Keasberry. "And then we said, 'Well, why don't we just work together once a year at least, come together and volunteer to make something like this?"

The nonprofit United Netherlands Organization is an amalgamation of various Dutch clubs throughout Southern California. The goal of the festival is to bring together Dutch Americans across the state and nation to celebrate their heritage.

Keasberry has been involved in planning the festival for the past twelve years, and was the youngest organizer when he joined in 2010.

"[The festival] was organized by the first wave of immigrants post World War II and they were getting older," Keasberry said. "The whole thing about cultural heritage was on the line and they needed fresh blood and I thought, 'Why not join the team and make sure that the younger generations get this every year as well?'"

According to a 1987 article by the LA Times, the largest numbers of Dutch immigrants arrived in Southern California in 1948 and 1949, when the Netherlands was recovering from the economic devastation caused by World War II.

Keasberry said he's seen up to four generations of Dutch Americans represented at the Holland Festival.

"The fun thing that I see is that it's a generational event," Keasberry said. "It's a family picnic and a reunion among friends. Family can come from different states."

The Holland Festival will be held at Gemmrig Park (7390 E. Carson St.) from 10 a.m. to 5 p.m. on Sunday, Sept. 4. Tickets can be purchased for \$11.71 on Eventbrite or for \$10 cash only in-person the day of the festival. If tickets are purchased online be sure to print them and bring them to the festival.

Children ages 12 and under are free. Dogs are not permitted at the festival. Attendees can park at El Dorado Park for \$8.

### Long Beach asks Cambodian residents for feedback on future cultural center

he City of Long Beach is offering Cambodian residents the chance to give their feedback on the planned Cambodian American Cultural Center (CACC) by taking an online survey.

Residents can take the survey until Monday, Sept. 5 at 5 p.m.

The survey includes prompts such as:

historical/important events/holidays/ceremonies

- What themes and priorities are important for the CACC?
- What are programs, services, classes, or exhibits you would include at the CACC?

The visioning process for the CACC began in September 2021 after a unanimous vote by the Long Beach City Council. The item was drafted by Suely Saro, Long Beach's first Cambodian American councilmember.

Although the City approved the visioning process, a budget analysis found that the cultural center could cost over \$50,000 with no funding sources were identified as of yet. The council said it may have to allocate additional resources or use its reserve funds.

# POW! WOW! Long Beach returns with a new name, same wow factor

Atop the Burnett Neighborhood Library in Long Beach, artist Thao Huynh French stands tracing the outline to her latest mural, her first in the city. Before deciding what to paint, she asks two kids walking by what they want to see. Their response: more color in their neighborhood.

"I thought flowers would be a great gesture, almost like I'm giving flowers to the neighborhood," French said. "The idea behind this was to come into the neighborhood and add to what was there rather than changing it all ... I hope it gives them a form of refuge, a place to feel safe ..."

French is one of many artists participating in the largest outdoor week-long community event in Long Beach, bringing with them 10 new original murals for residents to "ooh," "ah" and take pictures in front of. Volunteers have been buffing and painting massive buildings throughout the city to prepare for new art that will breathe life into the community.

Long Beach Walls is one facet of World Wide Walls, the global organization whose goal it is to "bring art and culture to public spaces by beautifying the city while cultivating community pride," according to its website. The organization has connected with 13 cities around the world, though Long Beach is one of its oldest collaborators.

Along with Long Beach, Tokyo and Kaka'ako are the only other cities that have teamed up with Worldwide Walls-formerly-known as Pow! Wow! Worldwide-since 2015 to beautify their surroundings.

This year's city-wide paint party features a slate of all-female artists, five from Long Beach, five from around the country and three from places around the world including Nepal, Lancaster and Taiwan.

The international connection is the very essence that makes Long Beach Walls stand apart from

other festivals, Cassandra Leeman, executive director of Creative Class Collective, and director of Long Beach Walls explained.

"I think there's always the thought about not having enough international artists or not having enough local artists and there's this constant combat between the two ... and it's not about one or the other," Leeman said. "It's about really bringing both and creating a space for artists to have-essentially an artists retreat where they can learn from each other."

This year's artists retreat also offers a full week of events and activities for residents to learn about the art, meet the team behind the movement and volunteer if they feel so moved.

Tuesday night Grey LB hosted a merch pop-up where Long Beach Walls unveiled this year's exclusive content—T-shirts, hats, tote bags and buttons-while participating artists offered their own goods.

Wednesday night, residents are invited to participate in "yoga under the stars," at Grey LB at 6

p.m. which will display new Art Renzei installations. Friday there is an artist talk featuring founder Wong and artists Mr. B Baby and Imagine at Studio One Eleven at 6 p.m.

Saturday residents will get the chance to tour the 2022 murals, along with many old favorites while they pedal through the city and learn about the artists and organization. The tour will begin at 5 p.m. at the GoActiveLB Hub in downtown Long Beach. Pedal Movement will be offering bike rentals.

The festival ends with a "summer nights" and Labor Day weekend party, featuring multiple DJ sets, food trucks, lawn games, live painting, a beer garden and various workshops for different ages. The party will take place at Lincoln Park, where an installation by Debra Scacco sits.

An eventual goal of the festival is to bring a permanent sculpture park to Long Beach. It's part of Creative Class Collective's goal to make the city an "arts and culture destination," Leeman told the Signal Tribune in May.

There are over 34 sponsors, both local and international, helping to

fund the event or provide swag, along with 21 Art Renzei and Long Beach Walls team members and countless volunteers, all working together to create a space for the guest artists.

"I think it has brought the community together in a way that I've never seen an art festival or any type of programming [do],' Leeman said. "We're planning for months and then you get a little bit drained, but once we get to prep, we can see all of our volunteers, and we see all the community and how excited they are about what we're doing and what they get to participate in. It makes it all worth it."

Leeman said the idea sprung organically last year, in conversations between volunteers while painting, buffing and climbing the walls for the 2021 festival.

Founder Jasper Wong welcomed the idea of an all-female team of artists, Leeman said. Now, months following the Supreme Court's decision to overturn the landmark Roe V. Wade case, she said "it just so happened" to be "pertinent, or ample timing."

"So now you know we're in 2022 and the environment where we are

in and it is all fitting for the wrong reasons," Leeman said. "So beyond just highlighting women we wanted it to be more about standing up for women, women standing up for our rights."

There are 10 new murals this year in the following locations:

While the theme for this year's festival is Stand Up, the organization recently stepped away from their old name, Pow Wow Long Beach, following years of outside criticism, Leeman explained.

Pow Wow is a term used in Native American culture to describe a celebration of food, dancing and

"We don't want to take claim or ownership of anything, especially if it makes people feel uncomfortable, and that was something that always came up whenever we celebrated our festivals was, 'Why the name if they're not a Native American group," Leeman said. "If that was something that was holding the event back and our community back, we wanted to mitigate that."



A timeline for completion of the cultural center has not been announced yet.

Long Beach has the highest rate of Cambodian residents of any area outside of Cambodia, making up roughly 4% of the city's population, according to Asia Matters for America. Many Cambodian people were forced to flee their homeland due to the violence and instability caused by the Khmer Rouge. Some refugees spent years in camps before finally being able to come to the United States.

In the 1950s and '60s, the United States and Cambodia had a student exchange program in which

Cambodian students attended California schools. Some students stayed in California after receiving their degrees, and these former students eventually formed the Cambodian Association of America based in Long Beach.

When their countrymen began arriving to California as refugees in the '70s, the services offered by Cambodian Association of America attracted many refugees to the Long Beach area, according to Respectability.org.

"Given how arts and culture was almost completely lost during the genocide, it's so important to many of our Cambodian elders that our culture and history are not lost," Saro said in September 2021 during a city council meeting. "But

that it's not only celebrated and promoted, but preserved so the next generation—such as myself—of Cambodian Americans can learn and understand."

A kick-off event for the CACC planning process was held in MacArthur Park on Aug. 20, where the City handed out physical copies of the survey.
