#### Long Beach purchases 78-room Luxury Inn to be converted to temporary housing for homeless residents

The Luxury Inn in North Long Beach, which has long been considered a "nuisance" hotel, has been purchased by the City to provide housing for over 100 people experiencing homelessness.

Council unanimously approved the \$16.5 million purchase of the Luxury Inn on Tuesday night—a 78-room hotel at 5950 Long Beach Blvd. in an effort to both "address homelessness and improve quality of life," said City Manager Tom Modica.

The housing facility is expected to open in October 2023, with a prioritization on people who have been homeless for over a year and have a mental disability. There will be on-site case management to help people facing mental health problems and to assist in finding permanent housing.

The purchase is for Project Homekey, a statewide effort to "rapidly expand housing for persons experiencing homelessness or at risk of homelessness," according to the program's website. The program was introduced in September 2020 and entered a second round in September 2021.

Long Beach saw a 23% increase in people living on the street or in encampments last year, according to the City's annual homelessness count. City staff estimates another \$4.7 million in renovation costs, which will be split by the City and Project Homekey, bringing the state's contribution to a little over \$21 million. Renovations may include repairs and upgrades to the laundry room and common areas, HVAC and electrical system as well as individual room upgrades including flooring, painting, furniture and ADA-compliant upgrades.

## Knitting and Tai Chi: fiber art exhibit opens at Flux Art Space in Long Beach

Fiber art and soundscapes created by artist Amabelle Aguiluz will surround viewers with the feelings of nature, home and healing at Flux Art Space in Long Beach until Oct. 8.

The installation of various knitted artworks centers around concepts of "home," as indicated by the installation's name. "Balay" means home in Ibanag, a language of the northeastern region of the Philippines, where Aguiluz's family originates. The name of the Indigenous ethnic group and language—"Ibanag"—means "people of the

# Long Beach Gives prepares for its fourth year of online giving

Christmas is coming early for the 200+ nonprofits involved in Long Beach Give's fourth annual online fundraiser.

The biggest day of the year stretched out to be the biggest week of the year—for Long Beach nonprofits is taking place on Sept. 22, inviting residents to support their favorite community organizations with a click of a button. The event raked in over \$2 million last year, benefitting over 200 various nonprofits.

This year, Long Beach Gives has a goal of \$2.2 million for its participating nonprofits and 410 grassroots fundraisers.

"We think the time is right to really expand and kind of increase what we're doing as far as our marketing and outreach and just trying

Long Beach Gives provides more than just funding for its participants. The citywide event increases visibility for nonprofits by connecting similar organizations with each other and using the Long Beach Gives hashtag and website to promote organizations.

"It's just a great opportunity, especially for grassroots organizations. We're small, we don't have a lot of money for budgeting and we don't even have staff," said Maleka Chris, founder of Love Beyond Limits. "So to be a part of this ... really helps us and also encourages us as leaders and executive directors to just know that there are people that are alongside us, helping us and cheer[ing] for us."

Chris founded her nonprofit in 2013 to assist families emotionally and financially by teaching life skills to both parents and their children. The organization also provides families with school supplies, Thanksgiving dinners and a 13-step program teaching interpersonal skills such as love, respect, accountability and more. raise over \$3,000. Last year Chris said they received over \$6,200 from donations.

"Seeing that kind of excitement is really invigorating for me because it helps me see, helps remind me that the work that's being done by organizations in this city is—on top of being important—is exciting," Guardabascio said.

Guardabascio said that for a nonprofit to participate in the annual event, they must be established for at least three years so they have a chance to "build internally before they start looking externally." The only other requirement is that the services provided are for residents of Long Beach or Signal Hill.

Each organization also receives up to 20 hours of professional development for any staff on their board.

#### Long Beach expands monkeypox vaccine eligibility

Long Beach is expanding access for additional groups to receive the Jynneos monkeypox vaccine. This decision is in alignment with Los Angeles County in an effort to provide more equitable access to the vaccine and include groups at risk of future exposure.

As of Sept. 13, there were 97 confirmed and probable cases of monkeypox in Long Beach according to the City's online data portal. To date, the city has administered over 5,900 doses of the Jynneos vaccine.

"Increasing access to MPX vaccines is essential to keeping our community healthy," said Mayor Robert Garcia in a recent statement. "This expansion is an important step in our response and means we can start vaccinating people who may be at future risk of exposure."

The City's eligibility requirements for the Jynneos vaccine now include:

New: People living with HIV, especially people with uncontrolled or advanced HIV disease.

New: Gay or bisexual men and transgender people who have sex with men or transgender people


Update: People who had skin-to-skin or intimate contact with someone with suspected or confirmed monkeypox, including those who have not yet been confirmed by the Health Department.

Update: People of any gender or

to get the word out there," said Matthew Guardabascio, campaign manager for Long Beach Gives. "There's a lot of people who have seen the logo ... But they don't really know exactly what we are and that was intentional. We focused very much on building something very strong within the nonprofit sector and getting that buy-in."

There are over 15 different categories for the types of resources provided by the participating nonprofits including education, LGBTQ+, children and families, mental health, social justice, seniors and more.

Beach—who regularly give grants and sponsorships to nonprofits in the city.

While going through grant applications, Julie Meenan of the Josephine S. Gumbiner Foundation realized as the years progressed, the amount of donations from individual contributions continued to shrink.

"It stemmed from a desire to increase awareness, to help really connect individuals who live and work in the city, [and] the nonprofits that are serving the city ... and help really strengthen and provide Love Beyond Limits intentionally focuses on the entire family in order to "keep the family together and as strong as possible," Chris said.

Love Beyond Limits is one of the nonprofits hosting events for the community throughout the week of Long Beach Gives. They will be hosting a youth flag football game on Sept. 19 from 5 to 7 p.m., a small business volleyball game on Sept. 20 from 5 to 7 p.m. and a nonprofit softball game on Sept. 21 from 5 to 7 p.m. All games will take place at King Park at 1133 E. Rhea St.

In the first year Chris' nonprofit participated, they were able to throughout the week include:

• Long Beach Gives will host its virtual kickoff on Sept. 19, from noon to 2 p.m.

• The Long Beach Blues Society will host a concert on Sept. 22 from noon to 8 p.m. The concert will also be streamed online.

• Bluff Park Neighborhood Association will host "A vintage night under the lamp light," a fundraiser benefit featuring live performances, food, drinks and the chance to win prizes on Sept. 17 from 6 to 9 p.m.

• Love Beyond Limits will be serving free food to-go for residents on Sept. 22 at King Park. From 6 to 11 a.m., they will be handing out pancakes, from noon to 2 p.m. they will hand out sandwiches and from 3 to 7 p.m. they will be handing out tacos. The monkeypox vaccination site at Long Beach City College, Pacific Coast Campus is located at Parking Lot 1 on the corner of Orange Avenue and Pacific Coast Highway. The site offers appointments and non-appointments to those who are eligible Tuesdays through Fridays from 10 a.m. to 1 p.m. and 4 to 7 p.m. and Saturdays from 10 a.m. to 1 p.m.

The city's Multi-Service Center is also offering the vaccine to unhoused people who are eligible. Anyone seeking the Jynneos vaccine is required to self-attest they are eligible before receiving the vaccine. Those interested in scheduling an appointment may do so by visiting the State's vaccination portal at MyTurn.ca.gov.

## Free shuttle rides will service Downtown, Alamitos and Belmont areas four days a week

Long Beach city council approved funding for the creation of a micro-transit shuttle program that will transport residents from downtown to Alamitos Beach and from Belmont Shore to Alamitos Bay Landing for free.

The 100% electric, six-person shuttles will run Thursdays through Sundays, but hours and days of operation may change due to incoming data. Users will be able to request a ride through the app Ride Circuit or hail down an available shuttle like a taxi cab.

The shuttles are "tentatively" expected to begin transporting residents in mid to late October, according to Joy Contreras, Community Relations Officer for the of the city, encourage the use of already-existing public transit, reduce Greenhouse Gas Emissions and stimulate foot traffic around businesses.

There is also a \$200,000 contingency to expand the hours and days of the shuttle if there is a demand. The City will base this decision on monthly reports conducted by Circuit Transit.

The total cost of the project is a little over \$1.6 million, with \$1.15 coming from the Long Beach Recovery Act, a fund that contributes to the social and economic recovery of the city post-pandemic, and the remaining \$450,324 being supplemented by Measure A funds.

Circuit Transit will provide the charging and storage of vehicles servicing the Belmont Shore/ Alamitos Bay area while the City will provide the charging and storage for the vehicles in the downtown/Alamitos Beach area. same company which served the downtown area for two months.

"It really is connecting the downtown with 2nd street and we've been missing that for a while ever since the passports went away," Councilmember Mary Zendejas said. "I think it's a great way to showcase both sides of our city."

Zendejas also pointed out that there is one ADA-compliant shuttle per route, which she said she was "really excited about."

Users may only be picked up and transported within the bounds of the geo-map, Public Works Director Eric Lopez explained. The shuttles servicing the downtown area to Alamitos Beach will span from Magnolia Avenue to Cherry Avenue and from Ocean Boulevard

## Man arrested in fatal stabbing in Long Beach

A man suspected in two stabbings in Long Beach, including a fatal one, is in custody today.

Long Beach Police Department homicide investigators identified and arrested 56-year-old Michael Smalls on Monday in connection with the killing of Christopher Finley 28 of Long Beach, according to a statement from the Long Beach Police Department.

Police were called at approximately 11:47 p.m. Friday to the 1700 block of Broadway regarding an assault with a deadly weapon and found Finley and another man suffering from stab wounds, the statement said.

Both men were taken to a hospital, where Finely died of his injuries Saturday.

Police said they believed the fatal stabbing stemmed from two altercations. In the first confron-

tation, Finely and the second stabbing victim were involved in an altercation in front of a business with a man who was armed with a stun gun.

In the second altercation, Smalls allegedly was involved in a fight with both victims, which escalated to Smalls stabbing them, police said.

Smalls then fled on a bicycle. The man with the stun gun was detained at the scene and arrested on an unrelated charge. Smalls was booked into the Long Beach City Jail on one count of murder and one count of attempted murder. He is being held on \$2 million bail, according to court records.

The City is entering into a 15year covenant to keep the Luxury Inn as housing for the homeless, though the funding from the state will only cover the first two years of costs.

"Past that [time period] we will be looking at other opportunities [for funding]," Modica said. The estimated yearly cost to run the interim housing site is \$1.9 million.

The acquisition marks the fourth nuisance property—a location in which the activity conducted there negatively impacts the community or neighborhood—purchased by the City to provide temporary housing for people.

A Motel 6 in East Long Beach with 43 rooms and a Best Western in downtown with 102 units, were both purchased with grants from the state. The City has only purchased one hotel without state funding—a Holiday Inn in Central Long Beach.

Modica explained that Luxury Inn was chosen due to the "tremendous amount of calls" to the Long Beach Police Department and "illegal activity" happening at the location.

Councilmember Suely Saro said that she would like her district to be considered for future interim housing projects to "address some of the crime along PCH."

Residents attending the city council meeting lined up to express their concerns about the cost of the hotel and the chosen location.

"This does not generate any economic activity," said Julie Jones. "Yes, the hotel is a problem. I'm very happy to see the hotel go, but I dont think a homeless shelter should have to be a solution."

"I have to listen to all of our residents and I understand that not all of our residents are happy ... I would ask that they be completely engaged in the planning process and push for more security," said Councilmember Al Austin, who represents the district where the Luxury Inn is located. "But they are necessary and I'm going to

stand on that. We need to create housing."

Mayor Robert Garcia said that he has heard "very positive things" about the neighborhoods around interim housing hotels, and reiterated that "the city isn't spending an enormous amount of resources on it."

Residents also asked if the people that will live in the Luxury Inn are going to be from Long Beach or will be transplanted from surrounding cities.

"Folks that end up at these sites, some are from the city and some in the surrounding neighborhood and areas," Garcia said. "Some might be on Skid Row one month and somewhere else in another."

City staff mentioned that the next "big step" in the process is to find a service provider that will work with the Long Beach Continuum of Care to assist people living in the Luxury Inn with addiction, mental illness as well as connections with food, transportation and crisis management.

Vice Mayor Rex Richardson voiced his support for the purchase of the Luxury Inn, stating that there should be an emphasis on the Long Beach Boulevard corridor.

"The problem is systemic," he said. "We've had human trafficking in that area for 40 years."

Richardson pointed to the Uptown Planning Land Use and Neighborhood Strategy (UPLAN) as a way to address the issue, which focuses on removing "outdated or underused" buildings in North Long Beach. Existing hotels however, are grandfathered in.

"The main goal is to provide a living environment for the most vulnerable people in the city," Austin said. "[The] North Long Beach corridor for the past few decades has not received the amount of service and attention it deserves."



The motion also included the approval to build 30-35 "tiny homes" in the Multi-Service Center in West Long Beach.



river." Aguiluz evokes this relationship to water in its many forms throughout her artwork. Her large parallel hoops with interconnected webs of yarn "suggest flow and transformation," according to a statement by Flux Art Space.

"I think there's so many connections with water," Aguiluz said. "I grew up in Long Beach, close to the water. Our bodies are water. I think I've always just been thinking about how water relates to my life."

As viewers take in the "Balay" installation, they will hear an auditory collage of water sounds from the artist's daily life as well as from local beaches.

"The actual movements of my body [...] transferring the energy into the threads, those are mim-

icking nature and water flows and shapes that just are slow and repetitive, similar to the pieces in my work," Aguiluz said.

To make her large knitted creations, Aguiluz attaches a knitting machine to her waist with a custom-built belt and knits while simultaneously practicing movements from Tai Chi, meditations and breathing exercises. Viewers will be able to see Aguiluz demonstrate this process in person during the installation's reception on Sept. 17.

"I want to make sure that it's not lost on the viewer that, yes, Amabelle is using fairly traditional techniques in terms of using weaving and knitting in her work; But her work is directly linked to her healing practices of Tai Chi and Qi Gong and meditation," said Betsy Lohrer Hall, director and curator of Flux Art Space.

"So it's nice to have that in mind when viewing the work because the overall installation is beautiful and calming and you get a sense of the artist's presence in the space." Aguiluz began regularly practicing Tai Chi in 2017 after watching a live performance by a colleague during her time as an artist-in-residence for the Helms Design Center in Culver City. After suffering an injury, Aguiluz began to contemplate the abilities and limitations of her own body—eventually integrating Tai Chi with knitting.

"I really just experimented and tried different things," Aguiluz said. "And that is something that just worked for me and stuck with me and I was able to allow my body to do whatever it needed in this process."

For Aguiluz, she explained, art is a healing modality for the body and spirit. Aside from physical works of art, her installation will also include a sound performance informed by her experience studying sound healing and therapy at the Globe Sound & Consciousness Institute in San Francisco.

"I just want to also share insight to alternative perspectives of healing the body and mind," Aguiluz said. "I guess my hope is also just that people can find those tools for themselves."

During the sound performance "Agî" on Oct. 1, Aguiluz will also give a live performance with various instruments, including the tongue drum (a metal circular drum with tongue-shaped slits carved around the top). "It'll just be a very intuitive, meditative project that just emulates the idea of water and flow and connection," Aguiluz said of her planned performance for "Agî". "Balay" will be on display at Flux Art Space, located at 410 Termino Ave., until Oct. 8. Flux Art Space is open to the public on Saturdays from noon to 5 p.m. or by appointment on Fridays and Sundays. The reception will take place on Saturday, Sept. 17 from 2:30 to 5 p.m. and the sound performance "Agî" will take place on Oct. 1 from 1 to 2 p.m.

## Aquarium of the Pacific holding 18th annual Moompetam American Indian Festival

The Aquarium of the Pacific is spending its weekend honoring the first caretakers of the ocean and sea at its 18th annual Moompetam American Indian Festival on Sept. 17 and 18.

The event will teach families about the cultural importance the ocean represents for the Tongva, Chumash, Acjachemen, Costanoan, Luiseno and Kumeyaay tribes. Moompetam means "people of the ocean," and is derived from the Tongva tribe's word for saltwater.

A small group of tribes that were among the first to settle along the coast of California in what is now known as Long Beach—Tongva, Chumash and Acjachemen tribes worked with the aquarium almost 20 years ago to organize the first festival.

Longtime educator and Indigenous California storyteller, Jacque Nunez, called the festival "a commitment to integrity and honor" from the aquarium. She and her husband have been traveling across California for the past 30 years to teach families about their culture.

"If we can share knowledge of who we are, that's where the respect begins," Nunez said. "It's very important we continue this for our families, our tribes, our elders who did so much for our community."

Nunez belongs to the Acjachemen tribe and has been involved with the Moompetam Festival since its inception in 2004.

Nunez said the "creme de la creme" of educators will be leading a variety of activities, including cultural songs, dances and basket weaving. They will also teach participants about the various inventions and artifacts of the coastal tribes, items of adornment and the history of California Indigenous tribes.

Children will also be led in Native American songs, one of Nunez's favorite parts of the festival. She emphasized the importance of allowing children to have a hands-on educational experience that's also fun.

"When a child is able to touch and feel an object, they remember the moment, they remember the activity ...," Nunez said. "To know you're not just speaking to deaf ears, but you're speaking to people who have the heart to listen and the soul to remember."

Each year the tribes nominate an individual or organization for the Heritage Award for outstanding community service. This year the tribes selected Cindi Alvitre, a member of the Tongva tribe and educator at Cal State Long Beach.

Alvitre is also the Native American Graves Protection and Repatriation Act coordinator and served as the first woman chair of the Gabrieleno/Tongva Tribal Council. The award ceremony will take place on Sunday at 1:00 p.m. in the Honda Pacific Visions Theater.

Nunez is herself a past recipient of the Heritage Award from 2016. This year, she will help present the award to Alvitre.

"I can't think of many other places in Southern California who have this kind of partnership," Nunez said. "That we've continued this for 18 years really shows the commitment to everyone wanting to keep this education alive and ... hopefully, be the template for other organizations to do the same."

The Moompetam Festival will be held at the Aquarium of the Pacific at 100 Aquarium Way on Saturday and Sunday from 9 a.m. to 5 p.m. Entry is included with a general admission ticket, or free for aquarium members and children under three years old. Advanced registration is required to attend. Purchase tickets at https://www.aquariumofpacific.org/visit/tickets.

**'Protect the cookie': Cue Bakeshop uses peace, power and strength for its cookie creations**

ver the years, Kystra Cue has gone from shopper to vendor at the Bixby Knolls Farmers Market, running the Cue Bakeshop stall every Thursday to sell her baked goods for a little over half a year.

"I just really want to build more clientele in my community," Cue said. "Because we're very much community-based, and I want [people to know] I'm from here locally and this is a local business."

Cue's grandmother began teaching her how to bake when she was 3 years old. By the time she was attending Hughes Middle School, she was recording herself baking cakes in cooking show-style videos. Cue would later hand out slices of her creations to schoolmates.

She combined her love of baking with her natural business savvy while attending Polytechnic High "I'm like 'I'm in Long Beach, I need to build a presence in Long Beach," Cue said. "When I have a storefront this is where I want to be, so let me become a part of the Bixby Knolls market. I grew up going there. I went to school at Longfellow and Hughes. So it was just like, 'Oh, this is home."

Cue Bakeshop's menu contains classic options such as snickerdoodle, oatmeal raisin and chocolate chip cookies and unique creations like matcha blondies and the chocolatey yet refreshing "encourage mint." Cue takes inspiration from old family recipes and other baker's recipes, tweaking them to suit her own tastes and those of her customers.

According to Cue, the shop's best sellers include the chocolate chip cookies, available with the original recipe or sans walnuts, as well as the newly released matcha blondie.

The golden brown chocolate chip cookies boast a generous ratio of chocolate chips embedded in them. The sweetness of the cookie is countered by a light sprinkling of sea salt on top, a welcome balance for the decadent flavors. The matcha blondie, which has quickly become a crowd pleaser at the Bixby Knolls Farmers Market, combines matcha green tea powder, brown butter and white chocolate.

After losing her job and leaving an abusive relationship over a year ago, Cue started pursuing her baking business full time.

Her experiences as a survivor inspired Cue Bakeshop's motto, "Protect The Cookie."

"We're here to protect the cookie, and my cookie, it's my peace, it's my power, it's my strength," Cue said. "It's all these things that I had to regain as I started going to my DV (domestic violence) group."

Cue has big plans for her business' future, and hopes to be successful enough to make donations to nonprofits and provide jobs and other resources for survivors of domestic violence through Cue Bakeshop.

She began her business endeavors by participating in pop-ups around Los Angeles before bringing her brand back to Long Beach. Although the green squares are currently one of the most popular items, they almost didn't make it onto the menu.

"I did not love [the matcha blondies] but I let a friend taste my samples and he loved it and then I tested it, people loved it [...] it's a crowd favorite ... and I learned it's not about me, it's all about the people," Cue said.

Cue Bakeshop is at the Bixby Knolls Farmers Market, located at the intersection of Atlantic Avenue & E 46th Street, on Thursdays from 3 to 7 p.m.





THE 6TH CYCLE HOUSING ELEMENT GENERAL PLAN AMENDMENT, will amend the Signal Hill General Plan by adopting the 2021-2029 6th Cycle Housing Element Update (hereafter the Housing Element Update). In accordance with State law, the Planning Commission reviewed the Housing Element Update at its June 21, 2022 meeting and, thereafter, recommended approval by the City Council

The City has received a letter from the State Department of Housing and Community Development (HCD) with a determination that the Housing Element Update complies with State law and can therefore be approved by the City Council and submitted to HCD for certification. In connection with this effort, on July 12, 2022, the City Council held a duly noticed public hearing and, thereafter: (1) certified the 2021-2029 Signal Hill Housing Element Environmental Impact Report ("EIR") (SCH No. 2021050296) for the Housing Element Update; (2) approved General Plan Amendment No. 22-02 updating the Land Use Element: (3) introduced Zoning Code Amendment Nos. 22-01, 22-02, 22-03, and 22-04 to rezone four non-vacant sites to accommodate the Citv's Regional Housing Needs Assessment (RHNA). The City Council subsequently adopted the Zoning Code Amendments on July 26, 2022.

RECOMMENDATION: At the June 21, 2022, Planning Commission meeting, the Commission recommended City Council approval of GPA 22-01.
