Council approves development of wireless cell tower, denying resident's appeal on medical basis

For over a decade, Long Beach resident Moira Hahn suffered from debilitating migraines, cluster headaches, nausea, ear pain and vertigo. After seeing four neurologists, trying multiple coping strategies and taking various medications, she was left with no relief.

When she and her husband finally removed the WiFi from their home, as well as a cellular meter in the wall of her studio, suddenly her symptoms stopped, according to a written statement from her doctor.

On Tuesday night, 66-year-old Hahn—who is diagnosed with electromagnetic sensitivity—was denied an appeal by the City Council to stop an AT&T small cell wireless facility from being built on a street light in front of her home.

"The City's attorneys refused to follow my doctor's recommendations for accommodations," Hahn said. "There are many accommodations we would have accepted, but the city did not consider them. We were forced out of our home and to use our retirement savings."

Hahn's doctor sent a letter to Long Beach Public Works, the City Clerk and AT&T Mobility detailing Hahn's condition on Oct. 11.

The National Library of Medicine describes electromagnetic sensitivity as a clinical syndrome, stating that it can "induce changes in calcium signaling cascades, significant activation of free radical processes and overproduction of reactive oxygen species (ROS) in living cells as well as altered neurological and cognitive functions and disruption of the blood-brain barrier."

The scientific community has not come to a consensus regard-

Berlin Bistro says final goodbye, Alder & Sage brings new beginnings

A beautiful mid-century building on Retro Row, with large gaping windows and natural, exposed Alder wood—once the location for small children to run about before entering grade school—will soon house two of Long Beach's most iconic eateries under one harmonious roof.

Kerstin Kansteiner is set to open Alder & Sage in just a few weeks, which will combine the handbrewed coffees and teas from Portfolio Coffeehouse with the organic, sustainable breakfast and lunch ideas from Berlin Bistro and add one more long-awaited element: a full dinner menu equipped with spirits to pair with meals.

"It feels like a good match and the building is really made to do this," Kansteiner said. "We can have pockets where somebody can just sit down and work away on their laptop and have a cup of coffee and then somebody can have an amazing meal right over there. I think the neighborhood is very receptive and I feel like that's kind of my home turf. I've been here forever."

When Kansteiner was forced to close the doors to Portfolio Coffeehouse on 4th Street after 32 years back in July, she had no plans to revitalize the beloved coffee shop.

"I couldn't even fathom moving Portfolio or doing this again," Kansteiner said. "I didn't even look, I never asked a realtor and never looked around. I was just done and done."

To the relief of the many loyal customers she's gained over three decades at Portfolio and 12 years at Berlin Bistro in Downtown Long Beach, Kansteiner was approached by a realtor with whom she'd done business before. A preschool was closing on 4th Street and Cherry Avenue, and the building—which Kansteiner had never even noticed before—was about to become

available.

It took months of consideration: Kansteiner said she "felt so burned" from the previous experience at Portfolio. Ultimately, the large windows, natural elements and, most importantly, the idea of returning to Retro Row grew on her.

The downtown location of Berlin Bistro served its last plates of wild baby arugula pomegranate salad, salmon flatbread, artisanal burgers and more on Oct. 18. As chefs carefully crafted the menu for Alder & Sage, patrons at Berlin Bistro were surprised with sneak peeks of dishes that may appear on the new restaurant's menu.

The menu at Alder & Sage, which will nearly double the current menu at Berlin Bistro, will be cooked in a kitchen finally fit for the iconic entities under one roof.

"[At] Berlin our kitchen was tiny there. So it was never conceived to actually queue the amount of food that we did there," Kansteiner said. "It was just short of a miracle [what] they performed in the kitchen. It was meant to be a small coffeehouse kitchen."

Breakfast and lunch will not lose their flair at Alder & Sage, as Chef Robert Fry, who crafted dishes for Berlin Bistro, teased a new breakfast burrito on Sept. 14, now slated for the new menu. It was the first dish that Kansteiner insisted they attempt for the new restaurant.

"I thought ... we're gonna go over this burrito item a million times so we're just gonna have to taste test a million burritos," Kansteiner said. "But literally, the first burrito he [Chef Robert] made was so fantastic. I was like, 'Wow, this thing!' I mean, I couldn't believe it. So I'm very excited... and then we specialed it and we ran out."

The burrito plays with spicy and sweet elements: habanero maple pork sausage, farm-raised eggs, Weiser potatoes, caramelized

Long Beach mayoral race: a look at which PACs candidates have accepted donations from

It's election season, and residents have until Nov. 7 to visit the polls or drop off their mail-in ballots. During this election, Long Beach will choose its new mayoreither Suzie Price or Rex Richardson, both current city council

Both mayoral candidates have accepted hundreds of thousands of dollars in campaign contributions from hundreds of donors. Among the donors are various Political Action Committees formed by unions, associations, industry professionals and elected officials.

Political Action Committees are organized specifically to raise money to donate towards political campaigns. They wield significant power in the nation's democratic process, as the winners of elections are often the candidate with the largest budget for their campaigns.

In 2020, 87.71% of elections for the house of representatives and 71.43% of senate races were won by the top spender, according to opensecrets.org. A multicandidate PAC (one that has over 51 contributors and contributes to at least 5 federal candidates) can donate a maximum of \$5,000 to a candidate's campaign during an election cycle, while smaller PACs can donate a maximum of \$2,900 to a candidate's campaign during an election cycle, according to the Federal Election Commission.

So far, dozens of PACs have donated to either candidate in the Long Beach mayoral run-off

Candidate Price has accepted more donations from PACs connected to police associations and the real estate industry. Meanwhile, Richardson has attracted

donations from multiple PACs connected to organizations that represent the interests of healthcare workers and the construction industry.

Both candidates received donations from labor unions in various fields, with Richardson getting donations from PACs that support the interests of healthcare, retail health, grocery, packing and cannabis workers and Price receiving donations from PACs that support the interests of longshoremen and marine clerks.

Some organizations have donated to both candidates. Different chapters of the International Brotherhood of Electrical Workers donated to both candidates. The Long Beach Firefighter Association PAC and the Plumbers Local Union No. 78 PAC also donated to both candidates.

Below is a list of PACs that made monetary donations to each mayoral candidate:

Richardson:

ARTPAC Artists Reforming Tomorrow - According to ARTPAC's website, it is led by artists and political professionals with the goals of getting "pro-artist" politicians elected in the Los Angeles area.

Building California Together PAC – The mission and members of this PAC could not be confirmed through an online search. However, this PAC donated another \$10,000 to the AA Victory PAC and \$2,000 to the state senate campaign of Scott T Wilk in 2020, according to Power Search.

California Metals Coalition PAC – This PAC was established in 2003 to raise funding from the metalworking industry to support candidates, officials and policies that benefit the metalworking industry, according to its website.

California Nurses Associa**tion PAC** – A PAC formed by the California Nurses Association (also called National Nurses Organizing Committee), an organization of registered nurses that claims to have over 100,000 members across the nation. According to its website, the California Nurses Association is in favor of expanding Medicare. The California Nurses Association advocated for the passage of AB 394 in 1999, which established the maximum number of patients a nurse can be assigned during one shift.

Evergreen PAC - According to opensecrets.org, this is what's known as a "leadership PAC," a

PAC created by a politician to raise and donate money to other politicians. According to opensecrets. org, Evergreen PAC is affiliated with Democratic Washington D.C. congresswoman Suzan Delbene.

Community Legacy Fund Local PAC – No information about this local PAC was available online, however a federal PAC under the same name is connected to a Sacramento-based certified public accountant named J. Richard Eichman who has worked with PACs in California since the 1980s. The local PAC is listed in Richardson's campaign contribution documents as also being Sacramento-based. Documents on opensecrets.org lists Eichman as the treasurer for the Duck PAC, Pacific Coast Producers, Almond Alliance of California PAC, the American Olive Oil Producers Association, California Cotton **Growers & Ginners Association** and the Gold & Silver PAC.

California Professional Firefighters PAC – California Professional Firefighters is a state-wide organization with over 30,000 members that supports firefighters.

IBEW PAC Educational Fund – A PAC representing the interests of the International Brotherhood of Electrical Workers.

ImPAC California – This PAC donates funds to candidates it believes will support Black communities, especially in terms of economic opportunity.

PAC – A PAC that makes political donations in the interest of the 400 members of the Long Beach Firefighters Association.

Plumbers Local No. 78 PAC - A PAC of a chapter of a plumbers' association.

UFCW Local 324 PAC - A PAC for a Buena Park-based chapter of a union representing healthcare, retail health, grocery, packing and cannabis workers in Southern California.

California Sierra Club PAC According to its website, this PAC donates to candidates it believes are "pro-environment."

Laborers Local 652 PAC - The PAC of a chapter of the

Laborers' International Union of North America, which represents workers in the construction and energy industries across the U.S. and Canada.

UFCW Local 770 PAC – A PAC for a Los Angeles-based chapter of a union representing healthcare, retail health, grocery, packing and cannabis workers in Southern California.

Plumbing & Pipefitting Industry Local 345 PAC – The PAC for a chapter of a union that represents over 3,000 members working in landscaping, irrigation, sewers, storm drains and specialty piping.

International Brotherhood of Electrical Workers Local Union 40 PAC - The PAC of a North Hollywood-based chapter of the International Brotherhood of Electrical Workers.

SEIU United Healthcare Workers West PAC - The PAC of a union representing over 100,000 healthcare, public sector and property services workers.

Service Employees International Union Local 99 Independent Expenditure PAC

 The PAC of Los Angeles-based chapter of a union representing healthcare, public sector and property services workers.

Pro-labor Candidates PAC No information about this PAC could be found online. Southern California Con-

tractors Association PAC – This PAC donates funding to candidates it believes are "pro-construction," according to its website.


Orange County Professional Firefighters Association PAC - The PAC of a union that represents firefighters in Orange County. According to a story by the OC Register, this PAC donated nearly \$634,000 to political campaigns between 1999 and 2009.

First cases of Avian flu include Night Heron in Long Beach

Eight cases of bird flu have been detected in wild birds in Los Angeles County, the Department of Public Health confirmed Monday, marking the first sign of the virus in the county.

The cases were detected in three Canada Geese and a black-crowned Night Heron in Long Beach, three Canada Geese in the city of Los Angeles and one Canada Goose in Cerritos, according to DPH.

The cases are part of the ongoing nationwide outbreak of bird flu, also known as H5N1.

County health officials stressed that the risk to the general public's health from the virus is low. The bird flu is a viral disease of birds caused by type A influenza viruses.


The illness is a concern for domestic poultry, because it is highly contagious and may cause illness and death in backyard and commercial flocks. The virus can spread through direct bird-to-bird contact or indirectly when virus is on clothing, footwear, vehicles,

rodents, insects, feed, water or feathers, health officials said. Birds shed the virus in bodily fluids such as respiratory droplets, mucus, saliva, and feces.

While the risk of human transmission is low, health officials said human infections can occur when the virus is inhaled in droplets or dust, or when it enters a person's eyes, nose, or mouth, either through unprotected contact with infected birds or contact with contaminated surfaces.

Health officials also noted that like other viruses, the bird flu could potentially mutate with wider spread transmission, potentially becoming more easily passed to

Authorities urged residents to avoid handling wild birds, and observe them only from a distance. People who have job-related exposure to birds—including animal shelters, veterinary clinics, or poultry processing plants—or recreational exposure should wear personal protective equipment when handling them, according to

Burglar shatters door at Ten Mile Brewing Company, makes away with safe

For the second time this year, Ten Mile Brewing Company in Signal Hill was broken into.

A single burglar dressed in a ski mask and black hoodie threw a pry bar into the front door of the brewery and kitchen early Monday morning, shattering the glass before searching through the building.

The brewery's alarm didn't go off initially since the door was never opened, but as soon as the bandit stepped inside the brewery, motion sensors triggered a different alarm to the Signal Hill Police Department.

Signal Hill police received a call at 6:10 a.m. Monday about an alarm going off at Ten Mile Brewing Company, according to the Signal Hill Police Department. When officers arrived, the suspect had already fled the scene.

A previous burglary incident at Ten Mile in July saw three bandits attempt to break the front door with a crowbar before prying it open. They were able to remove a cash register which contained about \$250.

Since the last incident, co-owner Dan Sondstrom said the location has gone fully cashless except for the employee tip jar, which was kept in a safe. Monday's burglar made away with the safe which Sondstrom estimates contained about \$600.

"I'm suspicious that he's been there before because he knew right where to avoid the cameras on the outside and what little nooks and crannies to hide in," Sondstrom said. "And when he did pass in front of the exterior cameras, [he] simply ran by real quickly, as if he was trying to avoid it."

Video footage of the incident shows the burglar avoiding the cash registers and instead searching behind glassware, breaking about \$50 worth of supplies before running off with the safe.

The door will cost about \$3,000 to replace, Sondstrom said. He explained that after this most recent incident, the brewery is looking into added security measures, such as a steel sliding door that covers the entrance and windows or a gated sliding door to prevent break-ins.

Sondstrom said that multiple

loyal customers have offered to sit in the parking lot and watch for future burglars.

"We've received literally hundreds of support messages on Facebook and Instagram and we love our community there .. they're super supportive and we're gonna be open tomorrow like we usually are on Wednesdays," Sondstrom said.

Ten Mile's taproom location in Bellflower was also broken into earlier this month on Oct. 7. The lone burglar broke the window, climbed inside the storefront and made away with a safe. Sondstrom said the Bellflower location has also been cashless for months, so the safe had no money in it.


"I wish I could see their face when they get that [safe] open," Sondstrom said. "One of our employees had been to Thailand and he bought a can of Pringles potato chips that was like a collectible one that you could only get in Thailand. He had put it in the safe ... so they're gonna find the can of Pringles in there.'

Spirits remain high at Ten Mile, as many new customers are flocking to the brewery after Sondstrom and his son took home a gold medal at the Great American Beer Festival for their "Hooked on Onyx" black IPA.

Signal Hill Park receives \$5 million investment for outdoor amphitheater

The Signal Hill Park amphitheater will receive a full redesign and upgrades thanks to a \$5 million check presented to City officials Tuesday morning from California State Senator Lena Gonzalez.

The money will go towards vast improvements and redesigning

efforts of the outdoor amphitheater that is often used for Concerts in the Park and various holiday events. The city approved the purchase of over 6,000 square feet of land behind the current stage in July 2021 that will be used to expand the park's footprint.

Suspect in custody for four Long Beach stabbings, one fatal

A 21-year-old man was in custody Monday in connection with a series of stabbings in Long Beach that left a woman dead and three men injured.

Yohance Sharp was arrested at the Ocean Boulevard and Fourth Place scene and was in possession of a knife, police said. He was booked on one count of murder and his bail has been set at \$2 million, according to jail records.

The first stabbing occurred about 5:35 a.m. Monday in the 1100 block of Atlantic Avenue, Brandon Fahey of the Long Beach Police Department told City News Service.

A woman with stab wounds to her upper body was taken to a hospital, where she died, Fahey said. Her name was withheld, pending notification of her relatives. She

appeared to be in her 60s, police said.

About 6:25 a.m., officers were sent to the 700 block of Olive Avenue on a report of a stabbing. A man with stab wounds to his upper body was taken to a hospital with non-life-threatening injuries.

About 7:05 a.m., officers were sent Ocean Boulevard and Fourth Place on a report of a stabbing and found two men with stab wounds to their upper bodies. One victim was taken to a hospital with non-life-threatening injuries, and the other victim was treated at the

The motive for all attacks remains under investigation. However, detectives said they believe the stabbings were unprovoked and the suspect and victims did not know each other, police said.



LBUSD to offer new enrichment programs for Black students

The Long Beach Unified School District is creating several programs to combat the academic achievement gap between Black students and their peers.

During their regular meeting on Wednesday, Oct. 19, district staff presented an update on current and future strategies to close that gap based on recommendations from parents and stakeholders.

\$750,000 of state funds from the 2021-2022 Learning Acceleration and Support Plan were allocated to the Black Student Achievement Initiative to develop an advisory committee as well as fund its recommendations.

The Black Student Initiative Advisory Committee's purpose is to "ensure that all Black students achieve academic excellence," according to Elyssa Taylor-Stewart, one of the advisory committee's leads. Taylor-Stewart also said that the committee is dedicated to engaging stakeholders concerning issues that directly impact Black students and subsequently making recommendations to the district about what kind of support and actions they need.

One of the main goals of the initiative is to create programs that enrich Black students' experiences as well as look into and analyze data to identify specific areas of need.

Some of the challenges Black students face include higher drop out and disciplinary action rates. The lowered expectations when it comes to Black students is another obstacle to academic excellence, according to chief communications and engagement officer Justin Grayson. Grayson said these low expectations result in honors and other more rigorous academic courses not being offered to Black students.

"We've been sharing data over the last few board meetings that directly confront our own internal failures ... all of which point to a set of brutal facts; we know to have contributed to those harmful and unsupportive environments for those Black students," Grayson said.

Black students have one of the largest academic gaps in terms of student achievement, including an 86% graduation rate and 49% A-G completion rate, compared to the 90% graduation rate for white students and 58.6% A-G completion rate of all students.

One of the pilot programs, stemming from the Advisory Committee's recommendations for more enrichment opportunities is Sankofa Summer Academy, a

create a state-of-the-art venue for all to continue to enjoy the wonderful events that have become signature in our cities such as Spring

Fest and the Halloween carnival,' said Joe Hoefgen, Signal Hill's interim city manager.

The city has slowly been buying up the land along E. 21st St.-adjacent to the south side of the park near the intersection of Cherry Avenue and 21st Street-over the last three years.

The redesign will allow for larger and more varied performances throughout the year as a way to highlight local artists.

"This is a facility that will allow us to host events and activities that will generate cultural diversity and

inclusion and interest in the arts and provide a platform for performances," said Signal Hill Mayor Keir Jones.

Funds for the \$5 million investment came from the California State budget that was approved over the summer and were secured for the park by Sen. Gonzalez.

"I'm thrilled to see the outcome of the reimagining of the community amphitheater with so many imprints for many of you putting your insight and your vision and your feelings and emotions into this beautiful site," said Sen. Gonzalez.

spent over \$770,000 in the 2019-2020 election cycle, according to opensecrets.org. The same website reports that this PAC has donated \$226,500 to democratic candidates and \$244,560 to republican candidates in 2022.

The California Grocers Association filed a lawsuit against the City of Long Beach in an attempt to get the ordinance repealed. Attempts to have the ordinance repealed were unsuccessful, and Kroger closed a Ralph's in East Long Beach and a Food 4 Less in North Long Beach. The Signal Tribune was unable to confirm whether or not Kroger was a contributor to the California Grocers Association, but a 2020 publication by the association confirms that Kroger is one of its advertisers.

ing electromagnetic sensitivity, and there are multiple theories and studies that still require peer review.

Hahn has been fighting the appeal since Feb. 2021, although the appeal only applies to the California Environmental Quality Act, leaving out concerns due to radiation and American Disability Act compliances.

"There have been other claims and disputes with the City but that's not part of what's in front of the council tonight," City Manager Tim Modica explained.

Recommendations from City staff to deny the appeal cited chapter 15.34 of the Long Beach Municipal Code, saying "this appeal is limited to the CEQA determination for the project and does not pertain to the approval process."

The same chapter, made to "regulate the establishment and operation of wireless facilities" also states that the City intends to "minimize the negative impacts" of wireless telecommunication facilities and "protect the health, safety and welfare of the City of Long Beach."

Long Beach approved a wireless ordinance in 2019, granting CEQA exemption "intended to cover most, if not nearly all, small cell wireless telecommunication permits," according to a staff report.

Councilmember Suzie Price said she could not bring herself to agree with City staff's recommendation, citing numerous residents who have expressed concerns to her "

regarding wireless facilities.

"I'm asked all the time by our residents about 5G and I always tell them, 'You have an appeal process," Price said. "But if someone with a medical condition is saying it's impacting their quality of life and they have to move and she can't get an appeal, then who can? There's got to be some room in the process for an actual appeal."

City staff also cited section 1455 of the Telecommunications Act, which says that "local government may not deny, and shall approve, any eligible facilities request for a modification of an existing wireless tower or base station that does not substantially change the physical dimensions of such tower or base station."

A dozen residents lined up for public comment to condemn the City's consideration to deny Hahn's appeal, pointing out that the light pole is not already an existing wireless tower, and therefore should not be subject to the Telecommunication Act.

"The idea that the City is completely hamstrung has been repeated by the City," said Kathryn Pettit, legal representative for Hahn. "Local government still has authority over wireless communication facilities."

Shivaun Cooney, a legal representative for AT&T, says the proposed wireless facility falls under the regulations set by the Federal Communications Commission and requested the council deny Hahn's appeal.

Councilmember Cindy Allen asked if another location for the wireless facility was considered. Long Beach Development Services Director Christopher Koontz replied that the location is not under review by the council, only the CEQA portion of the appeal is.

Resident Mark Hotchkiss expressed his frustration with the appeal process, pointing out that the appeal pertains to electromagnetic radiation, yet the council and appellants were not allowed to talk about the effects it would have on Hahn

"I want clarification on why these appeals never seem to be successful," said Councilmember Doug Supernaw. "Can we decide on a case and show compassion ... I think that's what's at stake tonight. Hopefully tonight this will send a message."

The City council had a 3-3 split decision on the hearing, denying Hahn's appeal and approving the construction of the wireless facility adjacent to her home.

onions, Fiscalini cheddar, avocado and a homemade chipotle salsa.

Lighter dishes include a wilted spinach and cabbage salad with seared ahi tuna as well as a traditional Egyptian dish of grapes, sunflower dukkah, sunflower sprouts, watercress, saba, basil oil and locally made bread.

The restaurant will close around 4 p.m., according to Kansteiner, then re-open for dinner service an hour later.

For dinner, Alder & Sage will pull out all the stops. The open kitchen will allow patrons to see chefs preparing fresh seafood each night, including oysters and sashimi. Guests will be able to enjoy their food inside the mid-century building facing Retro Row with full table service, or they can eat at one of the fire pits that will adorn the large outside patio.

The Alder wood that the building is made of, which inspired the restaurant's name, was stripped of its yellow paint by Kansteiner's husband and left in its natural state. The second part of the restaurant's name came from Kansteiner's past.

"I just felt like, you know the space deserves some saging after the experiences we had with Portfolio," Kansteiner said. "So it seemed like a good fit and because it's mostly an outdoor venue—I would say it's a third inside and two-thirds outside—it kind of just evokes a really natural environment and I really liked that."

Longtime patrons of Berlin Bistro and Portfolio Coffeehouse are likely to see familiar faces when they come to Alder & Sage. Kansteiner made it a point to combine both staffs during her homecoming, saying, "it's all about community."

Alder & Sage is hopeful to open the day after Thanksgiving, according to Kansteiner. The restaurant will be located at 366 Cherry Ave. Hours have yet to be announced.

program for students grades four and five to engage in culturally relevant instruction, restorative justice practices and mentorship centered around Black joy and excellence. The first Sankofa Academy took place this past summer and hosted around 93 students. The district intends to offer the program next summer as well.

Pam Lovett, the Black Student Achievement Initiative academic support lead said that parents have been vocal about wanting to ensure their children see themselves and their history outside of just slavery. Hence, the program is centered around upper elementary students, as that is when students are first formally introduced to the subject of slavery in the curriculum.

"Our kids think that's the only thing that we were . . . stolen people, not having self-determination, not being innovative, not being creative, being folks that are just prepared to be told what to do," Lovett said.

Sankofa Summer Academy is just one of the programs listed in the district's Local Control and Accountability Plan (LCAP)—a three-year plan that describes the district's goals, plans and actions to support and address local and state priorities—to support Black student achievement.

Other programs include Sankofa Saturdays, Sankofa afterschool, Sankofa parent workshops as well as repeating and expanding upon the Black Student Achievement Initiative Symposium.

Additional Advisory Committee recommendations include creating a database of Black student-centered clubs, activities and sponsors, identifying a Black Student Achievement Initiative Liaison at each school site and building partnerships within the community.

Despite these promises to center Black student achievement, some parents expressed the feeling that the district has not been as communicative or active when it comes to implementing their plans.

"There've been a lot of promises, many of them broken," said Kim Tobari, LBUSD parent and member of the advisory committee. "[There has been] a lot of what feels like gaslighting to me, not a ton of conversation, not a ton of transparency, not a kind of visible action."

"There were some things where you all fell short and part of it was the communication of what's next," LBUSD parent and advisory committee member Jerlene Tatum said. "We are partners in this. We're not enemies, and we're not appendages, so please do not treat us as such."

Board Member Erik Miller said he acknowledges the frustration of parents.

"[These] emotions were exacerbated by communication or the lack thereof when it comes to the [initiative]," Miller said. "But all things considered, this is not about the shortcomings of this early part of the process, but more about making sure that we capitalize on this moment."

Miller said that this was an opportunity for the district to "course correct" and support Black students.

"I'm going to hold this challenge to the admin team here and to my colleagues, that with all the information that we received today, we understand this as the baseline of where we need to go," Miller said

"I think if we're going to lead with building on the past and addressing the present and the future, I think that's also based on coming in with a sense of urgency around outcomes," board member Juan Benitez added.

Billie Jean King Main Library reopens to the public after temporary closure

The City of Long Beach announced the reopening of The Billie Jean King Main Library to visitors Thursday, Oct. 20 following a temporary closure. The Main Library will maintain special operating hours through Nov. 1 and return to regular operating hours starting Nov. 2, the City announced in a statement Wednes-

Starting Sept. 23, the library transitioned to to-go services only and closed the interior for public use. Additionally, library staff directed residents to satellite branches for other library services. The temporary closure was enacted to address security staffing levels and specialized library staff

According to the City's statement, the library had to create a temporary security plan to meet the needs of the facility until a long-term plan was finalized to ensure the library continued to serve as a "positive and inspiring environment for all who entered the doors."

This security plan was needed due to "mental health challenges that many are experiencing locally and throughout the country,"

which was taking a toll on the high-volume downtown facility.

Additionally, the City said it will continue to develop strategies to manage individual events of visitors with unresolved trauma, medical issues and mental health challenges negatively impacting other library patrons and staff.

Through this process, the City "emphasizes that the Long Beach Public Library system is a safe place for community members" and welcomes all patrons.

The City also acknowledged the

increased mental health concerns affecting individuals locally and nationally since the onset of the COVID-19 pandemic, and said the Department of Health and Human Services is working to create more mental illness prevention and treatment access in Long Beach.

The library's special operating hours—subject to change—are currently as follows:

- Wednesdays, noon to 4 p.m. • Saturdays, 10 a.m. to 4:30 p.m.


