## Long Beach Running Club celebrates 8 years with \$5,000 donation to city's women's shelter

For the past five years, the Long Beach Running Club (LBRC) has celebrated each birthday with a 10k relay race and a donation to a local nonprofit. Their \$5,000 donation made on Oct. 30 to the WomenShelter of Long Beach (WSLB) marks the club's largest gift yet, despite being the smallest anniversary gathering in years.

"When it comes to the anni-

versary I always let my girlfriend decide. We pick someone local in Long Beach and we discuss it; what we think will make the biggest impact, what the club would relate to the most," said LBRC founder, Gus Esparza. "We have all these different backgrounds and people, this year that resonated a lot with us, after reading their story and their mission and what they're about."

The WSLB was founded in 1977 to help families "overcome the trauma caused by domestic abuse," according to its website. The shelter provides safe housing for families, an emergency shelter, a 24-hour crisis hotline, counseling, social services support, legal advocacy and more.

Esparza created the Long Beach Running Club eight years ago out of Signal Hill. He and his girlfriend Sandy Nevarez have chosen local nonprofits to donate to for the past five anniversaries, with past recipients including the Long Beach

Rescue Mission, His Little Feet and the Casa Youth Shelter.

Esparza said more than half of club members are women, making it "a no-brainer" to choose the WSLB as this year's recipients.

"For me I'm a Long Beach native so it has to be from here. I want to make a difference here first," Esparza said. "As soon as I announced it right away everyone was like, 'Wow thank you for choosing them."

The relay race allowed entries

for men's teams, women's teams, co-ed teams and individual runners. Each participant paid a \$25 entry fee, which went directly to the women's shelter. The race was followed by a raffle with donated prizes and a celebration at Steelcraft Long Beach.

The Long Beach Running Club has 150 active members, 120 of which participated in the relay

# Long Beach reaches agreement with police bargaining unit, including wage increases

Following 17 meetings and bargaining sessions over the last month, Long Beach city council unanimously approved the three-year, \$28.78 million Memorandum of Understanding with the Long Beach police officer's bargaining unit Tuesday night.

The agreement, which expires in September of 2025, includes wage increases for the department, modified skills pay for certain officers, recruitment and retention bonuses, longevity pay for those who have been with the LBPD for at least 10 years, bilingual pay increases, police officer referral bonuses, updated military leave policies and more.

Rich Chambers, president of the Long Beach Police Officers Association, said it will help address staffing retention and recruitment issues, the "most critical issues" the department is facing at the moment.

"The number of people applying to the academy is lower than ever," Chambers said. "We think this contract takes a solid and important step toward making sure the Long Beach Police Department can remain competitive in the hiring market."

The City's general fund short-fall—money already budgeted that Long Beach still needs to gain—is now at \$38.30 million for fiscal year 2024. The shortfall was previously at \$28.1 million.

Long Beach police officers will receive wage increases of: 5.5% effective Oct. 8, 2022; 3.5% effective Oct. 7, 2023; and 2.5% effective Oct. 5, 2024. Active, full-time employees—police recruits not included—will also receive a \$5,000 retention bonus on Oct. 5, 2024.

Police officers, corporals, sergeants and lieutenants who have held one of those positions for at least 10 years will receive a 5%

increase from the base hourly pay. Those who have held an aforementioned position for at least 15 years will receive a 7.5% increase in pay, and those who hold 20 years under their belt will receive a 10% increase in pay.

"This is a process that is painstaking that we go through every few years but this contract ... I'm very confident will help us with recruitment and retention of valued employees in the city that do very important work," Councilmember Al Austin said. "The priority of the government is to ensure that our residents are safe and healthy and this workforce is obviously important to our mission."

Positions that will receive pay increases include homicide detectives (12.5%), police officers routinely placed on patrol (3%), officers that regularly provide relief to those patrolling (3%) and bilingual officers (80 cents to \$1.20 per hour). Eligible second languages include Spanish, Khmer, Tagalog, Vietnamese, Samoan, American Sign Language or other languages designated by the City Manager.

Officers are now eligible to receive referral bonuses for bringing in successful police recruits. A

member of the police department can receive \$3,000 for successful entry-level recruits and \$4,000 for lateral police officer recruits.

"One of the biggest challenges facing many police departments, including Long Beach, is staffing," Councilmember Cindy Allen said. "Retirements and resignations have outpaced hiring over the last several years and has created a lot of vacancies in our ranks... I think the competitive pay will also attract lateral officers, which is always good because they can get started and put into service right away."

The bonuses will be paid in two parts—the first part when a recruit completes police academy or when a lateral officer completes six months in the Long Beach Police Department, and the second part when the officer completes their established probationary period. There is no limit to the amount of referrals an employee can submit.

The contract also includes vacation accrual policies for lateral officers, meaning those who have been sworn in as a police officer in a different department. Vacation

## 122 monkeypox cases in Long Beach; infection rates level out

There have been 122 confirmed or probable cases of monkeypox reported in Long Beach, as of Oct. 31. According to data shared by the City on its online monkeypox dashboard, infection rates have decreased significantly compared to the summer.

There was a spike in reported cases from July 9 to Sept. 10, and the highest number of new infections were reported the week of Aug. 20, when 18 confirmed or probable cases of monkeypox were discovered.

Of these 122 cases, 3 people have required hospitalization, and no one has died.

According to a statement by the City, most cases locally and nationally are contracted through skin-to-skin contact.

Symptoms of monkeypox can include the following:

- Fever
- Chills
- Headache
- Muscle achesSwollen lymph nodes
- Exhaustion
- Respiratory symptoms such as a sore throat, nasal congestion or cough

The risk of exposure to monkeypox may increase when engaging in any kind of sexual or intimate touching with multiple or anonymous partners (including hugging or kissing), at an event or area where there is skin-to-skin contact with multiple people and while attending venues such as clubs, saunas, bathhouses, sex parties and circuit parties where there is skin-to-skin or face-to-face contact with multiple people, especially if those present are wearing minimal clothing, according to the Health Department.


According to the City's monkeypox dashboard, 97.5% of confirmed or probable monkeypox cases in Long Beach were found in men and 70.5% were found in individuals who identify as "lesbian, gay or same-gender loving."

While monkeypox has been disproportionately impacting men and the LGBTQ+ community, anyone can get the disease regardless of gender or sexual orientation.

The City's eligibility requirements for the Jynneos monkeypox vaccine include:

- People living with HIV, especially people with uncontrolled or advanced HIV disease.
- Gay or bisexual men and transgender people who have sex with men or transgender people
- People who had skin-to-skin or intimate contact with someone with suspected or confirmed monkeypox, including those who have not yet been confirmed by the Health Department.
- People of any gender or sexual orientation who engage in commercial and/or transactional sex (e.g., sex in exchange for money, shelter, food and other goods or needs).

The Long Beach Public Library (LBPL) has broadened its Digital Library by partnering with popular online learning platforms Coursera and Skillshare.

Both Coursera and Skillshare are a part of CAreer Pathways, a collection of online learning platforms specializing in job training and career path preparation. Each platform contains thousands of creative and career development classes originating from universities, companies and industry leaders.

CAreer Pathways programs, as well as the rest of the Digital Library, can be accessed for free by LBPL cardholders, allowing Long Beach residents to pick up essential educational and job expertise.

Coursera and Skillshare are funded by the State and administered to city libraries by the California State Library.

"The digital resources available through our public library system are an incredible asset to our community," said Mayor Robert Garcia are grateful to the California State Library for helping residents access these online tools."

Coursera has previously partnered with more than 275 American universities and companies such as Google and Intel to teach necessary skills to students and employees.

Skillshare's primary focus is on short online classes instructing users on how to grow their own businesses or pursue their passions.

Classes revolve around a range of topics including business, technology, user experience and freelancing, and are taught by experts with experience in their respective fields.

"The resources available through CAreer Pathways are another way for the Long Beach Public Library to aid patrons in self-directed learning, increase digital equity, and support the intellectual curiosity of Long Beach's diverse community," said Library Director Cathy De Leon in a statement.

## MOLAA receives \$2.5 million grant from Perenchio Foundation

The Museum of Latin American Art (MOLAA) announced Nov. 1 that it has been awarded a grant of over \$2.5 million by the Perenchio Foundation.

"This grant acknowledges the work MOLAA has been doing for the past 26 years to share Latin American and Latinx art and provide support for our community," said Lourdes Ramos-Rivas, President and CEO of MOLAA, in a statement.

The Multi-Year Operating Support Grant will be paid out to the museum over the next three years. The funds will go towards increasing the museum's capacity, day-to-day expenses, organizational learning and hiring more staff.

The Perenchio Foundation was

founded by the late A. Jerrold "Jerry" Perenchio to support the arts in Los Angeles County. The foundation provides grants to small and medium-sized organizations that provide arts programming for the public.

"The Museum of Latin American Art (MOLAA) is deeply honored and appreciative of the grant awarded by the Perenchio Foundation that allows MOLAA [...] to continue offering exhibition and education programming of the highest quality to the Los Angeles County community and all our visitors," Ramos-Rivas said in a statement.

The Housing Authority of the City of Long Beach ("HACLB") will be accepting applications from property owners for a project-based voucher program ("PBV") under the Section 8 Housing Choice Voucher Program (HCV). This Request for Proposals ("RFP") is established pursuant to Title 24, Chapter IX of the Code of Federal Regulations, 24 CFR, Section 983.

Under the PBV Program, HACLB will attach a HCV Housing Assistance Payment ("HAP") Contract to a unit if the owner agrees to rehabilitate or construct the unit in accordance with regulations for the PBV Program and HUD's Housing Quality Standards ("HQS") The rent for each designated unit in the selected structure(s) will be subsidized by HACLB when the owner leases the unit to an eligible family. The purpose of this program is two-fold-- l) to encourage property owners to construct standard or upgrade substandard rental housing stock and 2) to make housing available to low-income families at rents within HUD's Fair Market Rents for the region.

Rehabilitation or new construction of selected projects cannot begin until HACLB and the owner(s) have executed an Agreement to enter into HAP Contract.

HACLB estimates that up to 200unitsof multi-unit housing in the City of Long Beach will be assisted under the funding available for this purpose.

## City exploring ways to reuse and revitalize Downtown Long Beach's vacant buildings

In response to the rising vacancies among office buildings in Downtown Long Beach, on Tuesday night city council directed staff to explore ways to utilize the empty spaces, one of which includes housing for homeless individuals.

According to a report from the Downtown Long Beach Alliance, 22.4% of the office buildings in the Downtown area are currently vacant. Before the COVID-19 pandemic, that number was at 13.5%, as many companies have switched over to either fully remote work or a hybrid model.

The number of spaces being rented out but not utilized each day is estimated to be about 67.4%, based on rates for Los Angeles County, according to staff reports.

"The problem is not just for our Downtown community, but for our city's economic viability," Vice Mayor Rex Richardson said. "... It impacts city revenues, lowers property values which impacts tax revenues.'


The study also states that 16% of businesses currently renting out Downtown buildings are planning on minimizing their office space.

Rather than push for companies to return to in-person work, Long Beach is following a trend seen in cities such as Washington D.C., Denver and Boston, where vacant spaces are being converted into mixed-income housing as well as resources for homeless individuals.

City staff will look into tax incentives for developers to create affordable housing and zoning changes that would allow residential development on commercial-zoned properties. Long Beach's current inclusionary housing policy mandates that 11% of housing development must be affordable.

They will also consider giving one-year tax breaks to attract new businesses and working with the Downtown Long Beach Alliance and city homelessnes resource providers for a homelessness outreach plan.

Long Beach saw a 22% increase in people living in homeless en-

campments and a 380% increase in people living in their cars in the past two years according to the 2022 Point in Time Count.

The state of California passed Assembly Bill 2011, or the Affordable Housing and High Road Jobs Act of 2022, which streamlines the approval process for multi-

family housing development. The state also passed Senate Bill 6, the Middle Class Housing Act of 2022, which defines housing developments as an allowable use within a zone where office, retail or parking is the principal use.

California's 2023 budget included a \$400 million fund for adaptive reuse of vacant spaces, specifically focused on residential conversions of downtown areas. Adaptive reuse is when a city modifies an existing commercial or office property into affordable housing.

City staff will inspect whether the Downtown area is compatible with the measures defined in AB 2011 and SB 6.

"I thought it was concerning and a bit disheartening that we have all this vacant space," said Councilmember Mary Zendejas. "It's time to take these steps and be innovative."

President of the Downtown Long Beach Alliance, Austin Metoyer spoke in support of the item, and asked the council to also look into ways to revitalize vacant spaces on the first floors of

Richardson said that the City should be working with the police department, local stakeholders and homelessness services to create new ways to utilize the vacant spaces, stating that "[there] is not one trick to solve homelessness."

## Patchwork Festival invites the community to a 'shop local' party

Over 200 of Long Beach's local artisans and makers will be selling handcrafted items and teaching do-it-yourself (DIY) crafts at the 16th annual Patchwork Festival in the Marine Stadium parking lot on Nov. 13.

The festival celebrates the creativity of local artists and artisans by connecting residents directly to some of Long Beach's hidden talents, including 15 junior vendors under the age of 18. Long Beach is the second city on Dear Handmade Life's five-city tour across California and the largest festival in the

"We activate the community by getting these folks who make their livelihood by doing a small craft and sharing their story a little bit with the community," said Nicole Spaulding, operations director for the Patchwork Festival. "Also by letting the community members get their hands on something fun and small to make and take [home] at the event so it also kind of feels like a modern festival."

Along with the 200 plus artists who will be selling their items, there will be 17 different arts and crafts booths run by local vendors. Residents will get the chance to create holiday gift tags, succulent planters, stick and yarn woven art, children's hair bows, henna creations, cardboard ornaments, crystal wish bottles and more.

Attendees will also be able to participate in a community chalkboard mural, where anyone is invited to add their own art throughout the event. All of the DIY booths will be offered for free, as Spaulding explained the company's belief that "communities shouldn't be charged to support

local makers."

The festival is pet-friendly and will offer free biking valet. There will be nine food trucks, mostly local, offering "a good mix of sweet and savory" options. Los Angeles-based rock duo Francis Retronome will be performing at the festival from noon to 1 p.m.

Vendor applications began months in advance, with the option for each vendor to send pictures of their booth setup, items they plan to sell, price ranges and any ideas for DIY crafts they would like to teach. Applicants are vetted by a jury made up of Dear Handmade Life's employees and were selected to offer residents a

mix of "diehard local Long Beach vendors" and new, undiscovered artists.

There is no qualification for how long a vendor has been creating in order to enter the festival.

"I think one of the most important things that our Long Beach festival does is build community,' Spaulding said. "When you know who made the clothing you're wearing, if you know who made that cool piece of art on your wall, if you know their stories, then you also know their needs and also understand their perspectives. And it creates this rich tapestry of understanding and empathy."

The Long Beach show also

boasts the largest roster for junior makers. The 15 young creators will have their own section at the festival where they will be able to sell items, connect with older vendors, network with one another and create a name for themselves.

Junior vendors were able to enter the festival for a \$20 fee, minimizing barriers to participation.

"This company was founded as a way to really encourage and create a space for emerging makers, so we purposefully keep our booth fees really low because we really want to support and encourage creative makers that are just maybe starting out," Spaulding said. "Essentially it is to encourage and create

a safe space for kids to be able to express themselves creatively."

Dear Handmade Life also produces a five-day conference, Craftcation, every April in Ventura, California. Spaulding called it "a more intense experience," where workshops focusing on goal-setting, price setting, creativity, wellness and more are offered.

This year's conference is taking place from April 19-23 and already has over 50 creatives leading workshops. Early bird registration is open with tickets starting out at \$598.

Dear Handmade Life has a members-only community mentorship program for creative business owners who can learn tips on building their brand and setting goals for themselves from other professionals.

The company offers online workshops through their website and often shares tips for creative business owners through their Instagram @dearhandmadelife.

For those unable to attend the Patchwork Festival on Nov. 13, the second round of festivals will take place in the spring, where two new locations will be added to the tour.

"The thing I'm always most excited about is watching creative makers and vendors interact with the local community and seeing them get excited," Spaulding said. "Often those small business owners are leaving behind stability and a certain amount of income that they can be guaranteed by having a job and I think our show really gives a lot of those vendors confidence and really makes it worth that risk."

The Long Beach Patchwork Festival will take place at the Marine Stadium parking lot at 490 Bay Shore Ave. on Nov. 13 from 11 a.m. to 5 p.m.

## Long Beach updates Code of Ethics for City employees

The Long Beach Ethics Commission introduced the updated Code of Ethics for Long Beach employees and staff and shared their plans to create a more equitable city. The code was passed unanimously and adopted as part of the City's ordinances.

The new code is a four-page document for City employees, elected officials, volunteers, board members, commissions and committees, which includes a values statement and specific principles for City staff to pledge to.

Values highlighted in the code are accountability, equity, impartiality, diversity, transparency and integrity.

Ethics board member Susan Wise said the ordinance will also serve as the "foundation" of all of the Ethics Commission's work for the next few years, specifically for the education training aspect.

"Our goal is to create an ethical culture within the city to have everyone look at their work and what they're doing and how they're treating people through an equitable lens," Wise said.

The City drafted its first Code of Ethics in 2003, and in 2020 the Ethics Commission recognized the

need for an update as well as a formal Ethics Education Program, An ad hoc committee was created to draft an update, which then went through rounds of edits following feedback from City departments,

labor organizations and internal stakeholders.

The Ethics Commission is a seven-member team that focuses on implementing the City's Charter, statutes and ordinances particularly pertaining to campaign financing, lobbying, conflicts of interests and developmental ethics.

The creation of the Ethics Commission was part of Measure CCC approved by Long Beach voters on

"I think updating our code of conduct is smart. As I look through it I see a lot of things that we're being held accountable to by state law and it's all presented in one way," Vice Mayor Rex Richardson said. "I also want to note, based on conversations with board members, there was really a need to expedite the implementation [of the code of ethics] or have more capacity to deal with issues as they arise. I know there were issues over the course of the last year."

The Ethics Commission received a one-time allocation of \$100,000 in Long Beach's 2023 budget with the goal of "furthering transparency" and supporting the Public Records Act, according to City Deputy April Walker.

Walker said the funds are being used to recruit temporary staff, since there are not enough funds yet allocated for permanent hires.

"I would say our current team has the capacity to build the framework for compliance and further support, but we do not have the capacity to actually deliver that day-to-day," Walker said.

Richardson said he thinks the City should be looking into permanent ways to support the

accrual can be adjusted to give an officer credit for their previous services.

The cost of referral bonuses and vacation accrual is not included in the total cost of the contract, since it depends on how many officers participate and qualify for these benefits, according to a report from City staff.

"This is a contract that's fair, it's responsible and it absolutely works to address some of the real challenges in policing right now, it really speaks to our need internally, within our police department and the current team that we have," Mayor Robert Garcia said. "It's focusing on community, it's focused on reform, it's focused on serving the public, building trust."

The monkeypox vaccination site at Long Beach City College, Pacific Coast Campus is located in Parking Lot 1 on the corner of Orange Avenue and Pacific Coast Highway. The site offers appointments and non-appointments to those who are eligible Tuesdays through Fridays from 10 a.m. to 1 p.m. and 4 to 7 p.m. and Saturdays from 10 a.m. to 1 p.m.

The city's Multi-Service Center is also offering the vaccine to unhoused people who are eligible. Anyone seeking the Jynneos vaccine is required to self-attest they are eligible before receiving the vaccine. Those interested in scheduling an appointment may do so by visiting the State's vaccination portal at MyTurn.ca.gov.

Commission so they can look more closely into issues of conflicts of interest and compliance with the City's Charter.

Current projects the Commission is working on include finishing the Ethics Education Program then implementing it across City departments, a city-wide survey on Long Beach's motto, symbol and catchphrase, an ethics helpline, new employee orientation and professional development.

Future goals are micro-trainings and workshops for City employees, an employee's handbook update, an ethics guide for City officials and tracking data through the Disclosure Reports and Ethics Portal.

Councilmember Al Austin said that he will volunteer to sign the Code of Ethics and encouraged his fellow council members to do the same.

"I think it's very important that we lead on ethics," Austin said. "It starts with the leaders, and it starts with the elected officials ... it has to permeate through the culture of this organization."

Deborah L. Betance, president of the Women's Education Circle for Democracy in Long Beach, suggested the City replace the word "diversity" with the word "inclusion" and that the code aligns itself more closely with the United Nations goals.

"We send our children out into the world ... I think it's important in the education system and legal system in our city that we make sure that we're focusing on a global vision, so I think we need to have higher goals as we set this policy,"

Betance said.

"It's good to see this progress, us having a value statement, us having a code of conduct that will be codified into an ordinance ... and us showing a real commitment to ethics," Austin said. "This is going to increase accountability for all of the employees in the city of Long Beach, including elected officials."

## **Updated LBUSD facilities** timeline pushes HVAC projects forward by two years

The Long Beach Unified School District's projected timeline for Measure E facility upgrades has been updated to prioritize Heating, Ventilation and Air Conditioning (HVAC) projects, according to information presented at the Wednesday, Nov. 2 board meeting.

Measure E is a \$1.5 billion bond measure the district passed back in 2016 to fund repairs, technology, air conditioning and safety across school sites.

A shift in funding due to the governor's budget that allocated one-time state funds to school facilities projects as well as unused contingencies from past projects are some of the main factors that prompted rebaselining.

The new timeline proposes advancing HVAC-type projects at Charles A Buffum Elementary, Patrick Henry Elementary School, Herbert Hoover Middle School, Beach K-12 Independent Study, James Monroe High School and Benjamin Tucker Elementary by two years.

Other school sites such as Stanford Middle School, Minnie Gant Elementary School, George Washington Carver Elementary School, Tincher Preparatory School and John Marshall Middle School can only be advanced up to a year, as Executive Director of Facilities Development and Planning, David Miranda, stated it would not be feasible to start and finish construction in the span of two years.

Miranda explained that what he describes as the "runway" portion of these projects is not yet finished for these schools. He said that the process the facilities team takes to meet legal state requirements can take around a year and a half to two years.

"We just don't have the time to select an architect, calculate design work, go through the state

processing and start construction within that time," Miranda said. "The big benefit here that you see in terms of HVAC projects, is we'll

finish every one of those projects by 2026-27, so that's a good push forward."

In order to advance these projects, the facilities team is proposing pushing back or pausing athletic projects such as indoor swimming pools at Wilson High School, Lakewood High School and Millikan High School. The new timeline proposes pushing these projects back one to three

Miranda said that the district will continue to pursue State-matching funds, which could once again change the timeline of these specific projects.

The proposed timeline also promises to finish the last portion of Measure E projects by the 2029-30 school year; a year earlier than the last proposed timeline.

Aside from working on HVAC updates, the district is also working on additional projects outside of Measure E such as:

- bottle filling stations
- shade-offering structures
- new playgrounds
- skateboard racks
- backpack hooks These additional projects are

## Long Beach launches new website to assist first-time homebuyers

The City of Long Beach launched a new website on Monday, Oct. 31 as part of its First-Time Homebuyer Assistance Program.

The goal of the program is to provide around 100 eligible families with up to \$20,000 in down payment and closing cost assistance. The application process for qualified residents is expected to open in early 2023.

"We are incredibly excited to support eligible first-time homebuyers with up to \$20,000 in grant assistance," said Housing and Neighborhood Services Bureau Manager Patrick Ure in a statement. "This program helps ensure greater equity in the city by eliminating social and economic disparities in our most impacted communities."

The First-Time Homebuyer Assistance Program is facilitated by the Long Beach Development Services Department and will provide grants to assist low and moderate-income families traditionally underrepresented in homeownership.

The program aligns with Goal 4 of the City's Racial and Reconciliation Initiative, which explores funding of down payment assistance programs and silent second mortgage programs while providing further opportunities to increase homeownership in the

Long Beach City Council directed the creation and funding of a Down Payment Assistance Program as part of the Everyone In **Economic Inclusion Implementa**tion Plan, unanimously approved by the council in June 2019.

The plan was proposed by Vice Mayor Rex Richardson and cosponsored by California State Senator Lena Gonzalez, Fifth District Councilwoman Stacy Mungo Flanigan and Seventh District Councilman Robert Uranga.

Enhanced funding for the program was included in the City's Recovery Plan in March 2021 through a motion introduced by Richardson.

"Long Beach is proud to help support pathways to homeownership for local families," said Richardson in a statement from the City. "By investing in down payment assistance, we are ensuring that our housing programs meet the needs of our diverse community, making sure residents can achieve the dream of homeownership."

Following the extensive selection process to determine a vendor to administer and implement the program, the City selected the California-based program HPP CARES CDE to facilitate the program, including conducting applicant outreach and screening.

The program has received \$5 million in funding from the Long Beach Recovery Act, which helps to fund economic and health initiatives for Long Beach residents and businesses affected by the COVID-19 pandemic. The \$5 million in funding has been allocated to support housing assistance, including \$3 million for funding and administrative costs for facilitating the program and \$2 million for additional housing programs.

Residents who are interested in participating in the grant program can sign-up now to receive program updates and additional details when available, including information regarding orientation sessions to assist with the application process. funded by Elementary and Secondary School Relief funds (ESSER) meant to address the impact of COVID-19 on elementary and secondary schools.

According to Miranda, there will be over 280 new bottle-filling stations installed across the district within the next year and 79 new shade structures over the course of the next two to three years.

Board member Juan Benitez pointed out that despite the timeline shift, it is likely that current LBUSD students will not experience the culmination of these projects. At previous board meetings, parents have been vocal about the need for HVAC upgrades across schools and expressed frustration regarding the slow progress from the district.

Miranda said that the school district, being a public agency, is constrained on how bond money is issued and on how quickly these projects can be done.

"We cannot go in one fell swoop and issue bonds in the amount of \$1.5 billion," Miranda said. "Typically those are broken up into chunks we call 'issuances' or 'series.' Those series typically spend roughly three years on average."

According to Miranda, a typical bond issuance has been around \$300 to \$350 million. Since those funds need to be spent within the three-year period, the district needs to be intentional about which plans to commit to during that particular time.

"We can't overcommit ourselves to a number of different projects and start perhaps on 20 projects at any given time because we can't finish those construction efforts within a three-year window," Miranda said.


