### Long Beach Cheer delivers city pride in pleated skirts

Residents who have attended City events such as runs, walks and Long Beach Pride may have heard a catchy tune being shouted from the crowd: "We're here, we're queer; We're Long Beach Cheer!"

Long Beach Cheer is one of the city's newest teams and can regularly be found shouting cheers of encouragement to residents helping their community. They have brought color-coordinated cheers and stunts to marathons, 5Ks, 10Ks, Fourth Fridays and animal adoption events throughout the

The club was founded by two cheer enthusiasts, Kita Staubitz and Andre Mueller, who moved to Long Beach as adults and immediately felt at home in the city. Staubitz wanted to support her community in a way that allowed her to express her creativity, and Mueller, who came across adult cheer while still living in Germany, was the first member to eagerly join.

"If you do cheer in middle school, elementary school, high school, college and all that, when you're an adult, you kind of don't have an outlet to express yourself the way cheerleading allows," Staubitz said. "So these adult nonprofit teams are really great for being able to do something that you really love,

When Marissa De La Torre was in high school, her teacher asked her to write down two things she enjoyed that might help her think of a career. Only two things immediately came to mind: photography and dogs.

Over a decade and hundreds of thousands of photos later, De La Torre is returning to her roots to bring a celebration of canines to the Long Beach community with her photography book "Dawgs of LBC."

"It's a great way for me as a photographer to basically blend street photography and dog photography," De La Torre said. "It's just such a fun project that gives me a creative outlet because I love dogs so much!'

De La Torre is releasing her second ode to street photos of dogs: a coffee table photography book filled with candid photos of over 80 of Long Beach's furry friends. The book will take viewers on a tour through iconic Long Beach loca-

### New website hopes to provide better resources for LBUSD **English learners**

The Long Beach Unified School District has implemented a new website to better track the academic growth and progress of English Learner (EL) students across the district.

According to data presented at its Nov. 16 board meeting, of the 66,180 students in the district, 11,031 are currently EL students.

ELLevation, a platform designed specifically to help EL students and educators, was described by Office of Curriculum, Instruction and Professional Development (OC-IPD) director Angelica Gonzalez as a "one-stop-shop for LBUSD's English learner data and English Language Development instructional resources."

The site was launched throughout LBUSD schools in June of 2022 with curriculum and instruction preparation and training among OCIPD staff. Training on how to use ELLevation and how to incorporate learning strategies was implemented at the middle school and TK-12 levels during October and September. Throughout November, the district plans to have counselors participate in ELLevation professional development.

"It really has become and grown into exactly where it needs to be, which is the shared responsibility across our sites, across our departments, across our district," Gonzalez said in reference to the expansion of the multilingual learners

doing it with other people that feel the same as you and also helping in your community. So it's kind of just a win-win all around."

Staubitz found a like-minded community while living in San Francisco, and spent years with the city's team cheering on various organizations and joining in adult cheer competitions. Once she moved to Long Beach in 2020, she wanted to continue her tradition of cheering for her community, but couldn't find the opportunity in Long Beach.

Los Angeles has their own team, but Staubitz wanted to spread joy in her own backyard rather than venture across the 710 freeway.

"The goal is to help and support the community in Long Beach and give back to everyone from LGBTQ to the homeless to children's hospitals, we want to focus on the whole community," Staubitz said.

Long Beach Cheer has worked with The Little Lion Foundation at adoption events, cheered on runners at the Long Beach Marathon and helped raise money for suicide prevention at the Catalina Pride parade. The club has also hosted several "old school girl scout" bake sales, featuring homemade cookies and pies from Staubitz's small business Kita's Kitchen.

While their regular events are very much rooted in community, Long Beach Cheer has plans to travel to Guadalajara, Mexico for the 11th annual Gay Games next November. The 2023 Gay Games will take place in two countries: Mexico and China. The adult cheer competitions will take place in Guadalajara.

The Gay Games are a multi-sport competition that includes over 90 countries and is organized by but not limited to the LGBTQ community. The first games took place in 1982 in San Francisco from Aug. 28 to Sept. 5 and included 1,350 participants from 12 countries who competed in 17 sports.

During a time when queer Americans were fighting to create a space for themselves in sports and pop culture, the U.S. Olympics Committee attempted to file a lawsuit barring the event from using the "Olympic" moniker in its name. The lawsuit only garnered more support for the event, which has

grown more popular each year

Staubitz and Mueller met at the 2010 Gay Games which were held in Germany.

"Cheer isn't very big in Germany and I was one of the people who didn't have any skills," Mueller said. "It's really for everyone. It's for ages between 18 and 99 and that's what makes it so diverse and interesting."

Staubitz and Mueller started recruiting members in March, the first a mutual friend from San Francisco cheer, and the other two from Cal State Long Beach's cheer team. Another member of Long Beach cheer, Bridgit, designed the vintage-inspired outfits herself.

The team can be seen at events donning their aqua green and bright yellow pleated skirts, high necklines and long sleeve spandex.

"Finding people has been the biggest challenge, finding people who know what we are and want to work with us," Staubitz said. "The more people we get the more we'll be able to do."

The team sits at six total members at the moment, and they are always hosting tryouts for people interested in joining. Anyone willing to come to a Monday night practice should contact @longbeachcheer on Instagram. Participants will be taught a handful of cheers, choreography and simple stunts if there are enough people.

The only requirements to join Long Beach Cheer are to be a Long Beach resident over the age of 18 years and "A want to help your community [and] willingness to learn," Staubitz said. "We are an LGBTQ team, you have to at least be an ally."

the easy part of the Long Beach issue was getting people involved.

"People love their dogs so they're excited, especially if their dog is in the book they're excited to see their babies in a published, local book," De La Torre said. "I think it's really cool just to have this moment and piece of history."

"Dawgs of LBC" will be celebrated at a book launch and signing "pawty" at the Ashtanga Yoga studio in Long Beach on Dec. 4. Dogs are welcome to join in on the celebration.

De La Torre announced free photoshoots for dogs of all kinds through various Facebook groups, and dog lovers flocked to her for the chance to see their pups shine. Beloved pets make up a bulk of the book, though the unpredictable nature of the photos don't give a staged sense.

"It's a city so you have so many factors with traffic and street stuff, you don't know what's going to be going on...the dogs are universal so they don't pay attention to you anyway, they don't know what's going on," De La Torre laughed.

De La Torre began her photography journey in Oakland, where she fell in love with street photography while observing the surreal, chaotic mess of humans running through the bustling streets. She moved to an even busier city in 2010, when she found herself in the middle of Los Angeles, living above a PetCo.

She offered to take photos of the animals available for adoption, and found herself shooting portraits of loveable animals in need of a home for the next nine years. De La Torre worked with shelters and rescue foundations in Los Angeles to provide them with pictures while also running her own dog-walking busi-

"I love celebrating people who love their dogs," De La Torre said. "Dogs don't know that we're taking their photos, they're just quirky, and they are who they are. And Long Beach is such a dope city, so to see that in print and to celebrate people and their pets is just a cool moment in time."

"Dawgs of LBC" is more than a bright, beautiful book to adorn a coffee table. A portion of the proceeds will go towards Live Love Animal Rescue, a foster-based rescue in Long Beach specializing in dogs with medical and behavioral issues.

Rescue pups are close to De La Torre's heart, as she has two chihuahuas, Odetta and Little Richard, adopted from rescue shelters.

"I really want people to adopt dogs," De La Torre said. "Some dogs in the book are from breeders and that's fine but L.A. is so populated. The big takeaway from all of this is to go adopt a shelter dog. We love our pets no matter where they come from, but it's important to take care of the community we

# Long Beach community gathers to remember lives lost to anti-trans violence

Mourners gathered in Harvey Milk Promenade Park on Sunday, Nov. 20 to honor the 32 transgender and gender non-conforming people killed across the nation in 2022.

The Transgender Day of Remembrance vigil is an annual event in Long Beach, but this year's event was especially somber due to a deadly mass shooting at an LGBTQ+ club in Colorado Springs on Nov. 19, 2022.

"It was really tough because

this is a tough event already, but something needs to be said," said Melissa Marquette, the transgender wellness project manager for AIDS Project Los Angeles (APLA) Health. "We woke up to sad news. As we mourn five people that were killed and [25] that were injured in the shooting in Colorado Springs last night, the senseless acts of violence and the hate that [has] been increasing have left many of us shocked and overwhelmed. We want to let you know that we stand with you as a community."

According to the Human Rights Campaign, 32 transgender or gender non-conforming people were reportedly killed in 2022 so far.

According to UCLA's Williams Institute, transgender people are four times more likely than cisgender people to be the victims of violent crimes.

"Communities are made up of people of all walks of life and they all deserve dignity and acknowledgement," mayor-elect Rex Richardson said. "And it's important for a city like Long Beach to make sure that people feel seen and acknowledged, particularly now, when we saw the tragedy in Colorado Springs."

After short speeches by community organizers and local politicians, people lined up to take turns reading off the names of the 32 transgender and nonbinary people killed in 2022. As each of the names were read, a candle was lit in their memory.

According to the Gay & Lesbian Alliance Against Defamation, the first Transgender Day of Remembrance was organized in 1999 by Gwendolyn Ann Smith in honor of Rita Hester.

Hester was fatally stabbed multiple times inside her Boston apartment. After her death, activist

and educator Nancy R. Nangeroni brought attention to the way local media outlets misgendered Hester and reported on her murder in a salacious manner. Since then, Transgender Day of Remembrance has served as a public way to bring attention to the high rates of violence faced by transgender and gender non-conforming people.

"We are the same. We are equal," said Camila Vásquez of social services organization Bienestar. "And we have to continue to fight over our rights."

The cost of processing the annexation application is borne by the applicant, pursuant to the District's existing Master Annexation Fee Ordinance and Annexation Fee Rate Ordinance, both adopted by the Board in 2007, which establish the basis on which the annexation fee is to be imposed and how the fee is calculated. The current method of calculating the fee is based on a tiered acreage-based approach. The proposed Annexation Fee Ordinance establishes a flat fee of \$2,000 per annexation application, regardless of the number of parcels involved or their acreage. The site has a separate dashboard for data-providing overall/ detailed language level information and student progress-including a bank of classroom activities to support teachers.

The platform has district and school-specific viewing options so individual schools can access the data that is most relevant to them. In school view, teachers can see the overall detailed language level information to track student progress and review assessment data.

The dashboard also identifies which students have met reclassification standards.

Reclassification refers to the process by which a student transitions from being an English learner to fluent English proficient status.

According to the assistant superintendent of OCIPD, Kristi Kahl, the district has been working on new reclassification criteria as well as a Khmer language program and professional development to meet the needs of multilingual learners.

"What we're presenting today is a work in progress. We're going to focus on the progress and we're going to celebrate the progress, but understanding that we are not there yet," Gonzalez said.

Some of the district's other plans to uplift and support multilingual learners include:

Planning daily support for EL students to access the content to understand "how language works."

Addressing foundational skill gaps through integrated and designated English Language Develop-

Guiding students to create and refine connections between concepts through question and analysis.

Designing experiences that allow students to orally, visually and in writing, express their thinking to Communicating the belief that

all students can achieve high levels of success with the necessary sup-

to Kahl, as EL learners are one of the district's disadvantaged groups.

According to the assistant superintendent of middle and K-8 schools, Christopher Lund, one of the main challenges of the English learner subgroup is that there are two broad categories-newcomers and long-term-of students with very specific and different needs.

Over 3,000 EL students are Long Term English learners, and nearly 2,000 are at risk of becoming Long Term English learners (rather than English proficient), according to data presented at the meeting.

Board member Juan Benitez expressed his concerns with what the data implies.

"I'm coming from a spirit of hope, but we're having a conversation about why we still can't get traction with one of our most vulnerable student subgroups," Beni-
