New salon in East Village to provide job training for young women

With the anticipated opening of Amber M Aesthetics, Amber Miller is fulfilling her dream while inspiring others to do the same. The small business owner has partnered with Pacific Gateway Workforce Innovation Network to provide mentoring and job training to young women seeking guidance.

"[Skincare] was something that I connected to and I feel like I can give back in that way," Miller said.

Miller grew up watching her mother work as a makeup artist and naturally developed an interest in the beauty industry from a young age—specifically in skincare. Miller said she would often get compliments about her skin, with women coming to her for tips on how to take care of their skin.

She decided to turn her passion for skincare into a business, in part to serve as an example for her younger siblings and other youth in her community.

"What inspired me to start my own business was my family, just being a role model to my siblings, just to show that they can do it as well," Miller said. "And I wanted to help empower young women, to be a role model to them and just show them a young girl from Long Beach can do it and so can they."

Miller began a mobile business in 2020 during the pandemic, bringing skincare to customers in the comfort and safety of their homes. After nearly three years, she's ready to open her first brick-and-mortar location in Long Beach's East Village Arts District on Jan. 28.

Long Beach declares state of emergency for homelessness crisis

n the first city council meeting of the year, Long Beach's leaders unanimously declared a state of emergency in response to the homelessness crisis.

"This declaration of emergency allows us to move faster, it allows us to establish some priorities and place some focus," said Mayor Rex Richardson, who authored the item with councilmember Mary Zendejas. "This allows us to say very clearly right at the beginning of this year that homelessness is our very top priority."

The declaration will give City Manager Tom Modica more freedom to request assistance from state and federal resources, streamline contracts with homeless service providers, hire supplemental staff and reassign City staff and resources to address the issue. It also increases Modica's hiring budget from \$200,000 to \$1 million and allows the city council to approve purchases up to \$1 million.

Modica and City staff will return every two weeks with an update to the council on the state of emergen-

nearly 70% increase in people living unhoused in Long Beach from Feb. 2020 to Feb. 2022, when the most recent Point in Time Count was conducted. Los Angeles Mayor Karen Bass introduced a state of emergency due to homelessness for LA on Dec. 12 and the Los Angeles County Board of Supervisors did the same for LA County on Jan. 11.

"Prior to the pandemic we had a homeless problem in the city," Richardson said. "We had a housing crisis in our region, but the pandemic has exacerbated that crisis, and when you add on top of that skyrocketing housing costs, inflation and a mental health crisis ... you find yourself in an emergency."

Although Long Beach has increased the number of interim and permanent low-income housing in recent years, Kelly Colopy, director of Health and Human Services, said that Los Angeles County now has half the number of winter shelter sites than it did last year, and twothirds the number of beds available for those unhoused.

Nearly half the people who were homeless in Long Beach in 2022 said it was their first time being homeless, and there was a 143% increase in individuals who are homeless and suffer from mental illness. Thirty-six percent of people who were homeless in 2022 suffered from a physical disability and 31% had a chronic medical condition.

"The systems that we have in place are not at the levels to serve these physical and mental health issues," Colopy said.

The state of emergency will classify City workers as disaster workers, giving Modica more flexibility to shift positions and priorities as needed. Modica said one of the priorities will be speeding up the recruitment and selection process for unclassified government positions. The Civil Service Department and Civil Service Commission will review and modify the same process for classified positions in order to speed up the hiring process across the board.

City staff laid out a number of metrics that the City will follow to measure its success in addressing

Invasive insects bring disease to citrus trees in North Long Beach

An outbreak of the citrus plant disease Huanglongbing (HLB) has been reported in North Long Beach, according to the California Department of Food and Agriculture (CDFA).

HLB is spread by the Asian citrus psyllid, an invasive insect. When the psyllids feed on a plant infected with the bacteria that causes HLB, it then carries the disease to every healthy plant it feeds on afterwards.

HLB eventually kills trees, but

versity of California Agriculture and Natural Resources.

There is currently no treatment or cure for HLB. The disease can affect all species of citrus trees, such as lemons, oranges, grapefruits, pomelos, calamansi and more.

According to Victoria Hornbaker, director of the CDFA's Citrus Pest and Disease Prevention Division, the disease was first discovered in North Long Beach in December 2022, and seven infected trees have been found in the area since then.

According to Hornbaker, citrus tree owners should watch for



trees can be asymptomatic for years. Symptoms can include yellowing leaves, bitter-tasting fruit, and limb and twig dieback (when parts of a plant progressively die, spreading from the outer edges to the inside), according to the Uni-

signs of HLB such as: yellow shoots sprouting from the middle of the tree, blotchy yellow leaves, misshapen fruit, fruit that won't ripen and excessive dropping of fruit. The CDFA has the authority to

Long Beach seeks community input for 2024 City budget

Long Beach is inviting residents to participate in the City's fiscal year 2024 (FY 24) budget development process by sharing their priorities at one of five upcoming community budget meetings or by completing the Long Beach Budget Priority Survey.

Four community budget meetings will be held in person at locations throughout the city, and one meeting will be held virtually.

"Public input is extremely valuable to ensure our City budget is reflective of the diverse needs of our community," said Mayor Rex Richardson in a statement from the City. "I encourage residents to share their service priorities by attending a community meeting, completing the online survey, or both."

The community budget meetings and online survey will gauge what community members believe the city's budget priorities should be. Feedback will be shared with the city council prior to the development of the budget, and public input will be weighed as part of the decision process.

The five community budget meetings for the FY 2024 budget will be held at the following dates, times and locations:

•Thursday, Jan. 19 from 6 to 7:30 p.m. inside the Gymnasium (4000 Building) at Stephens Middle School (1830 W Columbia St.)

•Monday, Jan. 23 from 6:30 to 8 p.m. inside the Teen Center at El Dorado Park West (2800 N Studebaker Rd.)

•Wednesday, Jan. 25 from 6 to 7:30 p.m. inside Meeting Room A at the Billie Jean King Main Library (200 W Broadway)

•Tuesday, Jan. 31 from 6 to 7:30 p.m. inside the Community Room at the Michelle Obama Library (5870 Atlantic Ave.)

•Monday, Feb. 6 from 6 to 7:30 p.m. virtually through a Zoom Webinar. Advanced registration for the virtual meeting is required in order to receive the link to the Zoom meeting.

Community members who are unable to attend any of the budget meetings may submit their budget service priorities online through the Long Beach Budget Priority Survey. The survey will be available

to complete beginning Wednesday, Jan. 18 through Tuesday, Feb. 7.

Surveys will be available to fill out in English, Spanish, Khmer and Tagalog. Interpretation services will also be available for all meetings.

Those without computer access may visit one of several Long Beach Public Library locations to take the survey in one of the public computer labs.

Online survey opens for future Scherer Park improvements

The City of Long Beach is asking the public to assist in creating a vision plan for Scherer Park in North Long Beach by taking an online survey by Feb. 7.

If and when funding becomes available, the vision plan will guide future improvements to the park.

Scherer Park spans 26 acres in North Long Beach, between Long Beach Boulevard and Atlantic Avenue.

Scherer Park was founded in 1944 by developer Lloyd Whaley and the Home Investment Company. The park originally measured 11.14 acres, but was extended after the City added adjacent parcels of land to the park between the '40s and '80s. In 2001, Scherer Park

was reduced by 2.6 acres in order to make room for the construction of a police station.

Long Beach searching for fresh produce partner for neighborhoods in food deserts

Long Beach is looking to partner with one or more qualified organizations to expand the availability of low-cost, culturally relevant produce in neighborhoods that are considered food deserts through its Produce to Market Program.

Food markets within these neighborhoods, considered to be fresh food deserts, are hindered by high procurement costs in their ability to stock and sell fresh produce.

Priority neighborhoods in need of fresh, low-cost produce in Long Beach include a several-block radius stretching east from Santa Fe Avenue to Redondo Avenue and a large section in North Long Beach stretching north from Carson Street to the Artesia Freeway.

The Health Department will support the selected organization(s) to plan, implement and evaluate a sustainable program to allow small and medium-sized food stores in the city to procure fresh quality produce at prices similar to larger grocery stores..

The program will include grants up to a maximum amount of \$250,000 per award to markets who best demonstrate how funds will be used to reach this goal and increase access to fresh produce in priority neighborhoods.

Long Beach has launched a Request for Proposals for eligible organizations to submit proposals through Long Beach Buys, the

City's vendor portal, by 11 a.m. on Feb. 16.

Eligibility requirements for submissions include proposed programs focusing on implementing a food procurement system that reaches small or medium-sized markets and food stores located in fresh food deserts, as indicated on the priority zone map. The City will prioritize funding for projects that reach households living within the priority zone.

The Produce to Market Program aligns with the goals of Long Beach's Racial and Reconciliation Initiative to increase access to fresh foods for communities in food deserts through healthy market partnerships, community gardens and farmers' markets.

Signal Hill approves salary incentive program for City management positions

In an effort to retain and attract high-performing workers in management positions for the City of Signal Hill, city council approved salary increases on a case-by-case basis on Tuesday, Jan. 10.

"Signal Hill is an employer in an increasingly competitive environment when it comes to attracting and, importantly, retaining employees, really at all levels of the organization," said Interim City Manager Joe Hoefgen. "What we've heard from [city council] is that you want to put in place measures that help ensure that Signal Hill remains an employer of choice so that when we're casting a net and looking for employees, we have a competitive compensation plan to offer to attract and retain the best and the brightest."

Under the new Management Incentive Pay Program, salary increases will be given at the discretion of the city manager and city council to workers in city management that have taken on additional duties and responsibilities. The new program provides three levels of salary increases—with an additional 10%, 17% or 25% increase to the worker's original salary.

"Circumstances where we go to

25% are probably very, very small," council member Keir Jones said. "But there could be an occasion when somebody's really stepping up to do extra work, and at least we'd have it there in place."

The city manager will decide if a worker receives a pay increase under the Management Incentive Pay Program, and city council will review the decision yearly to decide whether they should continue to receive the pay increase.

Councilmember Edward Wilson was the only vote against the salary

increase program, while the rest of the council members voted in favor of it.



the crisis:

• Decreasing the number of people experiencing homelessness

"We're already putting out calls to our departments to see who's able and willing to join this effort and then if we need to, we can also do assignments to help with the staffing as well," Modica said. "We're also looking for employees who have specific expertise to help in our emergency response."

Long Beach's state of emergency to homelessness is similar to its state of emergency during the pandemic, Modica said, since it gives the City more flexibility to streamline the approval of shelters, safe parking sites, mental health care and other land uses as well as permits and inspections for homeless-related projects.

It differs however, in that the money spent to address the COVID-19 pandemic was reimbursed by the Federal Emergency

Management Agency since it was a nationwide emergency.

This state of emergency is local and will require City staff to find the funds internally, either through one-time funds or previously unspent appropriations. Modica emphasized that they are not working with "unlimited resources."

"Other projects and priorities may experience some delays as we rapidly shift more resources to homelessness," Modica said.

As of Jan. 11, Long Beach established an Incident Command Center, similar to the one established during the pandemic. The model allows employees from various agencies and departments to work together to use resources from federal and state entities throughout the city for a prolonged period of time.

Colopy from the Health and Human Services Department and Eric Lopez, director of Public Works, will lead the Emergency Operations Center which comprises nine work groups and nearly 100 City employees.

The nine work groups will focus on different areas of the homelessness crisis and include: intergovernmental work, public health and safety, communications, data and technology, housing and land access, procurement and finance, human resources and staffing, logistics and educational institutions, businesses, faith-based organizations and nonprofits.

Multiple residents voiced their support for the declaration and cited the need for preventative services to keep more people from becoming homeless. The state and LA county eviction moratorium, which protected residents from evictions due to COVID-19 hardships, will end on Feb. 1 and risks an even greater increase in homelessness.

test for HLB in areas where an infection has been confirmed, and will go door-to-door looking for citrus trees to test. To test a tree for HLB, CDFA personnel will take around 20 leaves and send them to a laboratory in Sacramento for testing. If a tree is found to be infected with HLB, it will usually be sprayed with pesticide and removed within a week.

Property owners who believe their citrus trees may be infected with HLB are urged to call CDFA's exotic pest hotline at 1-800-491-1899, so CDFA can take samples and conduct testing to confirm if the tree is infected.

"We don't advocate for removing healthy trees in the area at all," Hornbaker said. "What we do want folks to do though, is keep an eye on their tree."

The California Citrus Growers Association, a cooperative of industrial citrus growers, provides funding for CDFA to remove HLB-infected trees from residential properties, at no cost to property owners.

The citrus industry has a vested interest in preventing the spread of HLB since the disease poses a significant risk to citrus crops.

While HLB hasn't infected agricultural citrus in California yet, the disease has plagued Florida's citrus farms, severely impacting crop production.

In 1998, the first Asian citrus psyllids discovered in the U.S. were found in Florida, and in 2005 Florida suffered the first domestic case of HLB. As of 2013, Florida's citrus industry had lost around 20 million trees, according to the United States Department of Agriculture.

"Florida has been devastated by HLB," Hornbaker said. "Their production is the lowest it's ever been [...] And what you see with, for in-

fruit." To keep California's citrus industry from meeting the same fate as Florida's, Hornbaker said it's important to immediately address HLB infections in residential areas before it spreads to California's rural areas.

the off taste of an HLB infected

"The main thing is it could potentially be an industry-ender for us in California," Hornbaker said. "If it gets a foothold in our commercial groves and moves into other commercial groves, we will really see a decline in our citrus industry."

While HLB only recently arrived in Long Beach, the disease is already rampant in the cities of Anaheim, Orange, Garden Grove and Santa Ana.

To help curb the population of Asian citrus psyllids, the CDFA

has released a species of parasitic wasps, tamarixia radiata, in Long Beach and throughout Southern California. This parasitic species of wasp lays an egg on the Asian citrus psyllids, and when the larvae hatches it devours the host.

Homeowners who want to protect their trees before they get infected with HLB can purchase pesticides or protective mesh nets from home & garden centers and online. While these options provide protection against Asian citrus psyllids, both have drawbacks. Certain pesticides are toxic to bees and should not be used when a tree's flowers are in bloom. Mesh nets prevent pests as well as pollinators from accessing the tree, so residents will have to pollinate these trees by hand.

To find out how close residents are to a confirmed outbreak of HLB, they can visit http://geodata. ucanr.edu/hlb_proximity/ to use an online map created by the University of California Agriculture and Natural Resources.

Signal Hill Petroleum (SHP) is requesting a permit extension of 20 years for Conditional Use Permit (CUP) 97-03 to continue their existing oil and gas production, storage, processing, and shipping of materials at seven existing drill sites located throughout the City of Signal Hill. The Signal Hill Petroleum Conditional Use Permit 97-03 Extension Project (Project) would not alter the scope of SHP's existing operations. No physical expansion of existing facilities is proposed and all operations (existing and proposed) would continue to occur within the existing permitted CUP site footprints. SHP proposes es to install new equipment within the existing natural gas processing facility at CUP Site #2 and drill up to 46 new wells within the seven drill sites over the 20-year period of the CUP. All other operational activity, such as site maintenance, inspections, redrilling and well operation, and fluid processing would remain the same. SHP would continue to operate the CUP facilities (drill sites and central processing facilities) in accordance with the existing City Municipal Oil and Gas Code, CUP conditions of approval, and fielderal requirements, including those published by CalGEM.

SHP is seeking to modify CUP 97-03 with the following objectives:

 Extend the life of the CUP by an additional 20-year term, to expire in 2042.
 Continue existing consolidated drill site operations, including drilling new wells within the existing CUP footprint on an as needed basis, to continue providing a local source of high-quality oil, natural gas, and electricity, and install upgrades to a natural gas processing system.


