n a cloudy January weekend, surrounded by props from thrift stores, hefty cameras and 20+ other teenagers, 17-year-old Bethanie Langendorf officially became a filmmaker. Over the course of three days, her film "Couchettes" came to life, and will premiere to the world on April 6.

Langendorf became interested in filmmaking when she was a freshman at Millikan High School. At 14 years old she was writing out comedy sketches during her free time. Then she graduated to writing screenplays, then short films, then working behind the scenes on other people's films and interview sets.

It was through working on professional sets and throwing herself into improv and theater classes at Millikan High School that Langendorf realized she was capable of pursuing her dream as a filmmaker.

"I was kind of enamored by it all," she said. "It was kind of an eye-opening experience."

In January, Langendorf accomplished her goal of directing a film at 17 years old. "Couchettes" is a film about seven distinct stories that all tie into each other—Langendorf's metaphor for "humanity and these really bizarre connections that we have and how we all really are connected in some way."

Long Beach tables law that would make 'targeted residential picketing' illegal



n ordinance which would prohibit protests within 300 feet of residential homes in Long Beach was tabled for future discussions following community opposition Tuesday night. The ordinance was brought forward by the previous city council

The ordinance was brought forward by the previous city council in 2021, following multiple incidents of protests outside of public of-



ficial's homes. Over a dozen residents stayed in the council chambers until almost 11 p.m. to protest the law once it was brought forward.

Cities such as San Jose and Los Angeles have similar laws in place. The proposed ordinance would allow Long Beach police to charge protestors who "target" a residence with a misdemeanor or infraction and impose penalty fees up to \$1,000.

Residents who lined up for public comment all shared the same sentiment-that a law of this kind would be an infringement upon freedom of speech. Multiple residents said that the fines would disproportionately affect low-income people who may be protesting issues.

"You chose to represent these folks, your constituents, and you need to exercise that power," said Erik Garcia. "When you don't, we organize, we disrupt until a change is made. This has been the case historically as long as people have been resisting unjust systems and conditions."

Councilmember Daryl Supernaw cited an incident in 2020 when people protesting the COVID-19 regulations placed moving vans in front of government officials' homes. He said he had to cancel his Thanksgiving plans with his family out of fear of there being explosives in the moving vans.

Supernaw said he was reminded of the 1995 bombing in Oklahoma City, when an ex-Army soldier planted a rented-out moving van filled with explosives. The incident killed 168 people. Residents shouted disagreements from the chambers as Supernaw said he feared for his life when the moving vans showed up in front of his house.

One of three men responsible for the moving vans had pictures up on his social media wearing a "Make America Great Again" beanie and holding an automatic rifle.

"There was nothing that can be done about this," Supernaw said. "I have no problem with people meeting with me, in this case it was the unknown that was the big issue here."

In 2020, a resident protesting rent increases in front of Suzie Price's home was attacked by one of Price's neighbors, one resident recalled during public comment. He went on to say that "violent protesting is already illegal, so this policy is not necessary."

Council support for the law came to a halt with Councilmember Al Austin, who said that in 2020 "the protests that went on during that time were an outlier, and I don't ate policy based on what happened at that time."

"I think the spirit of this was, 'Let's do something before some-one gets hurt." Austin suggested a motion to table the law to "come back at a separate time and talk about the safety of the public."

The Long Beach Airport will temporarily close some of its runways from March through July as critical lighting improvements are installed.

The \$9.5 million project is funded by an Airport Improvement Program grant from the Federal Aviation Administration (FAA), which will bring the airport's main runway in line with the current FAA standards and add to the airport's sustainability efforts.

The improvements include adding over 500 new energy-efficient

LED lights to the electrical system along Runway 12-30, replacement of all electrical cable powering runway lights and navigational aids, replacement of the runway touchdown zone lights that allow aircraft to land in low visibility conditions safely, and restoration and improvements to asphalt and concrete.

For safety, Runway 12-30 will be closed nightly on Sundays through Thursdays from March 29 to mid-July. In addition, Runway 12-30 will be closed daily on Tuesdays and Wednesdays between April 18 and May 24.

Resident Anna Christensen cited peaceful protests where community members organized in front of Cal State Long Beach President Jane Close Conoley in 2019 to sing Indigenous songs, dance and pray as a form of protest.

"This is an honor for you to be here and have people taking a role in democracy," Christensen said. "If democracy comes to your front yard, you don't have to be scared, you don't have to be intimated ... Don't assume that protestors are threatening, it's people trying to protect democracy and public health."

District three Councilmember Kristina Duggan supported the item at first, saying that residents can state their opinion through social media, email, voicemail or schedule a time to speak with public officials.

"I am against this. Why is protesting important? Because we come here and we come here and

The majority of Long Beach officials quickly supported Austin's item, citing "ambiguous language" and the need to protect freedom of speech.

District one Councilmember Mary Zendejas said she felt it would be wrong to support the item on the same day that the council recognized Cesar Chavez and Dolores Huerta day in Long Beach. Both historical figures were notorious for civil disobedience in order to advance education and worker's rights for Mexican-Americans.

"Thank you for everyone staying late and sharing their thoughts and I did want to share with you that you made an impact," Zendejas said. "I feel that today, particularly on the day we're celebrating Dolores Huerta and Cesar Chavez, it would not feel right in my heart to support this."

The decision to file and table the law passed 7-1. Supernaw was the only vote against tabling the item.

Long Beach council sets Concealed Carry Weapon license fees

Residents hoping to obtain a Concealed Carry Weapon (CCW) license in Long Beach will have to pay some of the highest fees in LA County, after the city council approved the new fees Tuesday night.

A CCW license allows residents to carry a "pistol, revolver or other firearms capable of being concealed on the person," according to staff reports. Fees will be the same for standard (two-year) and judicial (three-year) licenses, while reserve officer licenses (four-year) will be waived by the city since they are obtained for volunteer positions.

Though the city gets a portion of the \$1,108.84 total fee, it must cover \$395.24 of each application which includes third-party vendor costs

Long Beach Chief of Police Wally Hebeish presented the proposed fees to the council, which includes a \$150 psychological evaluation needed to obtain a CCW license. Councilmember Mary Zendejas suggested a \$215.34 increase to the final fee which allows someone to obtain a license, saying "if someone wants a gun they should be able to pay for it at a higher cost."

Most of the council supported the increase since it allows Long Beach to obtain the highest possible amount of money from licenses. With the approved increase, the city will get \$495.74 from each license issued.

need to obtain a CCW license for their job, such as private security officers.

"When we talk about adding costs, particularly for vocational reasons, that may be a slippery slope. I don't want to put anyone in a position where they can't do the work they are required to do," Austin said."We're not talking about tens of thousands of residents who are going to be impacted here, it's going to be a handful of people."

Vice Mayor Cindy Allen responded by saying that usually employers will cover the cost of obtaining a CCW license for their employees.

Councilmember Daryl Supernaw argued that the initial fee of \$350 was already "exorbitant" and said he could understand why "the average person" would consider the increased fees "out of line." He requested the Master Fee and Charges Schedule to label the increase as "cost recovery," since it will be going back into the city's pockets.

CCW licenses were issued by the Los Angeles Sheriff's Department until August 2022, when the county discontinued the program for the 44 agencies it was serving. Issuing CCW licenses is now a municipal duty. Since November 2022, Long Beach has been searching for a third-party to help process licens- rently capped at \$25. The motion amount of staff work it will take to

complete the tasks. In order to receive a CCW license, the applicant must be a Long Beach resident, at least 21 years old, be free of criminal convictions, pass the psychological eval, provide proof of ownership and register the firearm with the Department of Justice, complete firearm training, pay fees and be of "good moral character."

The chief of police may request an additional interview following the psychological evaluation, though Hebeish did not clarify what would make another interview necessary.

Councilwoman Megan Kerr asked if residents with a CCW license are required to store their weapons safely in their homes. Hebeish replied that under state mandates, anyone in possession of a firearm must store them safely.

"We're not going to go into somebody's home to ensure that, but if something happens that's something we would investigate," Hebeish said. Once someone is convicted of a criminal charge, such as unsafe possession of a firearm, their CCW license would be rescinded, he said.

The motion also includes a suggestion to advocate with the state of California to allow cities to raise CCW renewal fees, which is cur-

City of Long Beach asks public to share opinions on homelessness through online survey

The City of Long Beach is gauging the publics' thoughts about homelessness in the local area through an online survey. Data gathered from the survey will be used to inform the public responses, services and resources the City uses to combat homelessness.

Survey-takers will be asked to fill out demographic information about themselves, such as whether they live in Long Beach, if they're homeowners or renters, their year of birth, gender, ethnicity, household income level and more.

Questions in the survey ask about various facets of homelessness, including what residents believe are the main causes of homelessness and what should be done to address the issue. Question formats

include multiple choice, one short written-answer, and asking whether survey-takers agree or disagree with a given statement on a scale of 1 to 5.

Some questions include the following:

•What are your top concerns associated with homelessness in Long Beach?

·How much should the city invest in addressing homelessness in relation to what is currently invested?

•In your opinion, what should be done in order to reduce the issue of homelessness locally in Long Beach?

The survey is available in English, Tagalog, Khmer and Spanish, and can be accessed at longbeach. gov/homelessness.



The full list of approved fees include:

•Online application and initial fee: \$70.10

•Background investigation: \$93 (with rolling fees from vendor)

• Psychological evaluation: \$150

• Firearm training: \$300

•Issuance fee and license: \$425.64

The set fees are expected to be in place by mid-April 2023. Applicants who do not pass the psychological evaluation the first time will not be issued a CCW and will not be refunded for the fees incurred.

Councilmember Al Austin said he was concerned about how the increased fees may affect those who es and conduct analyses on the passed 7-1, with Supernaw being the only vote against.

Long Beach, Signal Hill teens arrested in connection with Silverado Park shooting

Two teenage boys were placed in custody Friday, March 17 in connection with a shooting at a Long Beach park that killed a 17-year-old boy and wounded two men.

According to the Long Beach Police Department, the two teens—a 16- year-old from Long Beach and a 17-year-old from Signal Hill—were arrested Thursday and booked on suspicion of murder and attempted murder. Both were being held without bail, police said.

Police said they are suspected in a shooting that occurred at 1:51 p.m. Jan. 21 at Silverado Park in the 1500 block of West 31st Street near John Muir Elementary School. Police said at the time that the suspects were in an SUV that was driven up to a basketball court, and the occupants opened fire.

Khalil Saleem, 17, of Long Beach, died in the shooting, and two men suffered non-life-threatening inju-



ries, police said.

Investigators have not released any details about a possible motive for the shooting. It was unclear what led investigators to the two teens who were arrested Thursday.

LBPD Chief Wally Hebeish said in a statement, "Unfortunately, gun violence continues to impact our most vulnerable populations and we will continue working with our partners to identify ways in which we can disrupt violence in our community."

In-custody death of suicidal man under investigation

A man who repeatedly stabbed himself in an apparent suicide attempt and was Tasered by Long Beach police officers trying to prevent him from doing so died at a hospital after being disarmed and detained, police said Friday.

According to the Long Beach Police Department, officers responded around 1:50 p.m. Thursday to the unit block of West 53rd Street after receiving reports of an attempted suicide.

The woman who called the police said she was a friend of the man and was concerned for his well-being, because he had threatened to kill himself and hurt others, according to the LBPD.

Officers went into the home and found the man suffering from multiple self-inflicted stab wounds to his upper body. He was still holding a knife and bleeding profusely, police said. Officers tried to negotiate with the man to get him to drop the knife, but the man continued stabbing himself, prompting them to deploy Tasers and handcuff him, police said.

The man was treated at the scene

His death is being investigated as an in-custody fatality due to the use

an in-custody latanty due to the use of force and the fact the man was Tasered and handcuffed, police said. The District Attorney's Office will also investigate the death, according to the LBPD.

Langendorf wrote the script for "Couchettes," which is a French word for small private rooms on a train, from May 2021 to December 2022. From the inception of her first short film, she knew it was going to take place on a train-and shot in one continuous take.

The unbroken-shot format of the film would be an ambitious undertaking for even the most seasoned director. For Langendorf, it was non-negotiable and crystal clear in her head.

"Somewhere in my brain, my little controller dude in my brain said, 'It has to be one shot,'" Langendorf said, half-joking, half-serious. "I wrote it down and I have not changed that since."

The first thing Langendorf says when describing the film is "there's no linear plot." Instead, viewers will be taken through numerous character's stories, from one end of a train to the other, each with their own situations connected by the end of the film.

"A lot of the characters are intertwined, and they say things that connect," Langendorf said.

In the original script for "Couchettes," the film takes viewers through various rooms to tell the character's stories. She wasn't able to find a train that would accommodate this vision, but chose to keep the name since she "wanted to include an element from that beginning process of just starting to write the screenplay and incorporate that into the finished product."

Since shooting her first short film in one take wasn't difficult enough, Langendorf has also mixed in hidden Easter eggs through a constantly changing film set. As the camera travels from one end of the train to the other, a production

assistant changed and added in different props that "reveal" things about each character.

And since Langendorf had to rent out a train museum in Downtown Fullerton to shoot "Couchettes," she and her cast of fellow high schoolers-and two elementary schoolers-had to shoot the entire film in three days.

"I don't typically like that level of discomfort and not having everything known," Langendorf said prior to shooting. "I think the hardest part of this whole film personally, has just been trusting myself and the process that everything will come together and everything will be solved and everything ... Everything's gonna be okay.'

Most people would be overwhelmed, discouraged even, while overseeing a project like "Couchettes." Langendorf is not most people.

"Beth just comes in with a ton of curiosity, a ton of knowledge and a lot of skill for everything artistic, but also a lot of humility because she is excited to learn more," said Michael Bradecich, Langendorf's improv teacher at Millikan High School, who looked over her first drafts, gave her advice and answered constant questions.

"I mean, she is just curious and humble, but also brilliant, and it's just kind of an ideal combination for any teacher ... All I really have to do is answer the questions which are always brilliant and insightful and make me think of things in ways I haven't always thought of before," Bradecich said.

Langendorf not only got advice for her script from her time in improv, but much of her cast for "Couchettes" came from that same class. Once the script was finalized

in December, Langendorf and her assistant director Mia Iavine had to go through dozens of auditions to cast the roles.

True to the spirit of improv (and to help ease the pressure of filming the movie in one take), Langendorf said that there was no expectation for actors to say the exact same lines each time. As long as each character's motives and storylines remained true, it would stay in the film.

Langendorf chose to trust in her actors and create a sense of collaboration throughout the filming process.

"There was not a single moment where I wasn't in a good place. Even if i'm feeling uneasy about things I've still been having a great time, especially because it's all so experimental and we're exploring our creativity, I think my favorite see STUDENT FILM page 7





part has been working with everybody," Langendorf said.

Most of the equipment used during the film came from the actors and crew, who luckily already owned cameras, lighting and sound equipment. The only major piece that the cast rented was a stabilizer to keep the camera steady while moving through the train.

Most of the prop pieces, such as vintage coloring books, salt and pepper shakers and friendship bracelets, came from months of digging through thrift stores. The rest came from yard sales and from the cast and crew's homes.

Langendorf said that crew members would send her pictures of random prop ideas which eventually made it onto the film's set. There are also branches of broccoli set atop a cardboard backdrop which will resemble the blue skies and trees surrounding the train.

"She really inspires that kind of enthusiasm in the people around her, not only to help her but to kind of stretch their own talents to see what they can bring to the project," Bradecich said.

Langendorf explained that she learned how to communicate her vision with the cast and crew more clearly through her improv and theater classes. As a visual artist who started off drawing and painting, Langendorf had a definitive picture in her head of how each scene would look.

Bradecich said that this likely helped Langendorf while she was in the writing process.

"With the script, I think the thing that stood out to me was I got a clear vibe and a tone from it," Bradecich said. "It felt like I could see exactly what it was going to look

like on the screen based on what she had put on the page. And that is a high-level thing for a screenwriter to be able to do, is to paint pictures in somebody's head who's just reading words on a page."





Long Beach Poly High School and Washington Middle School to receive major facility renovations in 2024

Following the Long Beach Unified School district's master plan to update multiple facilities in July 2022, research from the facilities team prioritized two school sites in dire need of renovations.

Executive Director of Facilities Development and Planning David Miranda said that when developing the facilities master plan—a data-driven roadmap for facility enhancement and improvement— Long Beach Polytechnic High School and George Washington Middle School stood out as needing more renovations than other campuses.

The emphasis on the Poly High School and Washington Middle School sites will not affect the updated Measure E timeline.

"While it's a large effort within that six-year stretch, it doesn't preclude us from still embarking on additional improvements on schools that need these improvements as well in other parts of the district," Miranda said.

> "Sometimes the buildings and the codes and so forth dictate what we can do or cannot do, but we're definitely going to tread lightly and go carefully with respect to respecting those monuments on the campus," Miranda said. Some of the more recently renovated buildings on campus, like the auditorium and the synthetic turf track and field, will not be renovated since they are fairly new—both completed in 2018—and in good shape.

Butler Middle School as construction is underway.

The lack of gathering spaces for lunch and outdoor activities are some target areas Miranda highlighted. Based on that need, the plan proposes to build a cafetorium—a cafeteria that also serves as an auditorium space for the school to gather. The school will also receive a new two-story classroom building as well as a new gym.

Miranda said that topography presents another major issue for the campus, which is why the team is suggesting building a field on top of a parking structure.

"The field on top of the parking structure actually helps us solve this density issue, find a home for parking space, but also solve that accessibility and topography issue on this particular site," Miranda said.

Board member Juan Benitez said that although he acknowledges these efforts will have a great impact on the school and neighborhood, he worries that closing the school for construction will take away a community resource, as some local organizations use the campus for community-building events. "This is a neighborhood in a school community that has expressed for years now feeling neglected, not just from our school district but from the city," Benitez said. "I think this is an opportunity for us to do as much as we can with the city, with community partners, and with those residents, to make sure that part of the community doesn't just go dark." Miranda said that the facilities team has already started conversations with the site's principal to reach out to neighborhood groups and start an early discussion regarding that issue.

Renovations planned for Poly High School

According to information presented at the board's March 15 special meeting, the district hopes to start the Poly High School's sixyear-long project by late 2024. Renovations will cost around \$400 million and will be funded through Measure Q funds–a bond measure approved by the district in July 2022 and passed by voters in the November 2022 elections.

For Poly High School's master plan, the facilities team met with around 10 different focus groups consisting of folks from various district departments, sent out a survey and hosted a town hall open to students, teachers and community members.

"We wanted to hear feedback specifically from all the various stakeholders to tell us what's working and perhaps what's not work-

ization and interim housing and the second on athletic components. Interim housing refers to the introduction of portable units to the campus so students have a space to take classes while buildings are being renovated.

"We want to go about this effort while keeping students on site and not missing out on that Poly effort and engagement," Miranda said.

Miranda explained that a few buildings and functions on the campuses like the softball field will be relocated from one particular end of the campus to the other to better coincide with athletics and share a large outfield space. There will also be a new gymnasium facility as well as an aquatics center and an additional classroom building.

Despite the modernization attempts, Miranda said the district and facilities team are aware of the

Renovations planned for Washington Middle School

According to Miranda, George Washington Middle School presented similar issues as Poly High School and required more than just the traditional Measure E modernization.

The Washington Middle School renovations will also begin in late 2024 but since it is a smaller campus, it will cost around \$150 million and take about three years to complete. The plan would also involve interim housing offsite at


