These two friends are revitalizing one of Long Beach's historic musical landmarks

Friends of Recreation Park Bandshell hopes to restore the outdoor venue to its former glory

The bandshell at Recreation Park has gone through many iterations in its nearly 100-year history, being declared a historical landmark

It started as a stage for bands and actors to perform. Then it was a place for temporary classrooms after the 1933 Long Beach earthquake, and in the 1940s, Richard Nixon gave a speech early in his political career in front of the stark, curved arch and intricate tiled bor-

But now most days the elaborate

Long Beach released its preliminary plan for the city's "gayborhood;" the Broadway corridor in the Alamitos Beach neighborhood that will soon become an LGBTQ+ cultural district.

Although the area has long been a hub for the LGBTQ+ community to congregate, celebrate and establish businesses, it has never been officially recognized. This time last year, Long Beach City Council appointed city staff to create a visioning process and feasibility plan for the creation of an LGBTQ+ cultural district.

Nearly 500 residents shared their priorities, ideas and requests for the cultural district through a community survey and engagement events.

Long Beach is inviting residents to look over the plan and send their feedback and ideas about historical context, community events and requested improvements to LGBTQVisioning@longbeach.gov from now until Aug. 25. The city will host an engagement event about the plan at the 40th Annual Long Beach Pride Festival on Aug. 4 and 5.

Signal Hill adopts budget for fiscal year 2023-2024

The Signal Hill City Council approved a nearly \$33 million budget for fiscal year 2023-2024 on Tuesday, allocating the largest portion to the police department.

The budget lays out how much money each public department will receive in a fiscal year. While the City usually plans and adopts the budget annually, in 2022 the City Council approved a biennial bud-

As part of the biennial budget, the City Council adopted a budget for fiscal year 2022-2023 while simultaneously approving a prospective budget for fiscal year 2023-2024.

The 2022-2024 budget book states "The purpose of preparing a two-year plan is to promote stability and consistency in operationsincluding programs, services, and staffing-over a two-year period while still maintaining the flexibility to respond to new information."

The budget approved on Tuesday had some changes compared to the proposed budget for the 2023-2024 fiscal year that was approved by the City Council in 2022,. The budget proposed in 2022 allocated \$30.9 million for this upcoming fiscal year, compared to the adopted budget of \$32.9 million approved on Tuesday.

The City's overall budget has increased by over \$10 million over the past two years, from around

\$22 million for fiscal year 2020-2021 to \$32.9 million for fiscal year 2023-2024.

Each year the Signal Hill Police Department receives the most funding. The money allocated to police has steadily increased alongside the overall budget each year, from \$9.1 million in fiscal year 2020-2021 to \$12.9 million in fiscal year 2023-2024.

Among the purchases the SHPD will make in the coming year are the continued upgrading of the police radio system, the purchase of new cameras and a cloud-based storage system.

The fiscal year 2023-2024 budget allocates the following amounts to each City department:

• \$12.9 million for Police

• \$6.3 million for Public Works

•\$4.9 million Finance, IT and non-department expenses

•\$4.3 million for Legislative & Administration

•\$2.5 million for Parks, Recreation & Library Services

•\$1.5 million for Community Development

•The money in the City's budget comes mostly from sales tax, which accounts for 75%. The second highest earning source of revenue for the City is property taxes, which accounts for 7% of money in the City's general fund. Oil production taxes account for only 1%.

Signal Hill City Council meetings are held biweekly on Tuesdays at 7 p.m, and can be watched online live or as a recording on Granicus.

LBUSD approves \$1.3 billion budget; projects deficit spending in upcoming years as enrollment declines

The Long Beach Unified School District (LBUSD) unanimously approved a \$1.3 billion budget for the 2023-2024 school year at their Wednesday, June 29 meeting, following previous discussions of impending budget deficits.

The district receives different local, federal and state grants and entitlements as well as allocations from the Local Control Funding Formula (LFCC)—the state funding of K-12 education.

Over the past three years, the LBUSD budget has also received significant one-time COVID-19 relief money. However, 2023-24 is the last year the district will receive these funds.

"We have done our best to stretch that money as far as we possibly can, looking at the various expiration dates of some of the funding and really wanting to sustain some of the programs that we rolled out over multiple years," Chief Business and Financial Officer Yumi Takahashi said at the board's June 7 meeting.

The district received \$146.8 million in COVID-19 relief funds for the upcoming school year. Takahashi said the money will be used on one-time resources and that the district will assess which programs and investments made over the past years will survive without these funds.

Some of these programs include: Counseling services for students and families

 Bilingual education/realistic and relevant curriculum

• The hiring of mental health personnel like counselors, psychologists and social workers

School climate support

The district plans and actions on how to spend the relief and LFCC funds are found in the Local Control and Accountability Plan (LCAP), which was also approved at Wednesday's meeting.

State funds depend on declining enrollment numbers

Of the \$1.3 billion LBUSD budget, \$891.6 million are unrestricted funds, meaning the district can decide what to use them for—a \$23 million increase from last year.

Every 1%of enrollment or attendance loss represents about \$7-8 million less in state funding.

Most of the district's unrestricted funds come from the LCFF, which is provided through base and supplemental and concentration grants.

The base LCFF \$729.8 million grant is based on the district's enrollment, whereas the \$134.2 million in supplemental and concentration grants are based on unduplicated pupil percentage.

Unduplicated pupil percentage represents specific student populations such as emerging bilingual, economically disadvantaged, foster and homeless students.

Though the LCFF grants increased from last year, the board predicts that LBUSD's declining enrollment numbers will result in less funds from the state. Every 1% of enrollment or attendance loss represents about \$7-8 million less in state funding.

LBUSD enrollment has been steadily declining with a 2.5% enrollment loss for 2022-23. The district has an unduplicated pupil percentage of 64.98%, which has also been declining.

To maintain staffing and programs the district would have to use money from its reserves, which Arkus said is at about \$1 billion. Arkus said the district is projecting to have deficit spending as soon as the 2024-25 and 2025-26 school

central arch, ornately decorated pillars and maroon-colored stage sit empty, as do the rows and rows of aqua-green benches facing it.

Two friends and local music supporters want to change that.

Steve Pruitt and Hans Hellsund, both Long Beach residents, are breathing life back into the bandshell and hoping to "return it to its glory days," Pruitt said. It won't be easy, given the plants growing out of its crevices, cracked paint, broken windows and faded tiles.

Hellsund and Pruitt started their nonprofit organization, Friends of Recreation Park Bandshell (FORPBS), in 2022 to revitalize the stage and accompanying building.

While the stage and benches are often used by skaters and people who need a place to rest, the duo hopes to transform the underused and underappreciated bandshell into a mecca for local talent, live music, theater and education.

The two said they've driven past the bandshell for years, often wondering why such a perfect location for live music and performances goes unused. Since retiring from the same sound engineering company, the friends have devoted their time to giving it a sense of pride.

There's enough room for 600 people on the benches (even more on the grass), a raised stage framed by a 1920's Spanish Baroque Revival style arch covered in colorful mosaic tiles and perhaps most importantly, one of the city's largest and newest playgrounds is within shouting distance.

The bandshell was constructed in the 1920's, though there's no date confirmed, according to the city's website. The stage and building's last update was in 1995 to provide structural integrity to meet earthquake standards.

The bandshell used to have arbors, shade provided by woodwork and climbing plants or trees, and the City had plans to replace those arbors but couldn't find the funds, according to the city's website.

FORPBS functions under Part-

ners of Parks, the nonprofit branch of the Long Beach Parks, Recreation and Marine Department.

Pruitt said the next step is to have someone inspect what updates are needed on the bandshell, building and benches. So far, they can tell the bandshell and building needs a

new coat of paint, plumbing, electrical wiring, additional lighting and probably more.

"It's functional, but extremely rough," Pruitt said. "It looks like nothing's been done to it for 50 years."

FORPBS has already hosted three events at the bandshell in the past month in an effort to remind people of the possibilities. Pruitt said that with each event, people share memories of the bandshell with them, ranging from concerts in the '70s to high school graduations and summer camp meet-ups.

They're hoping that local talent will soon see the bandshell for what it is: an ideal jumping point to create a live music scene in Long Beach, as well as a free place for youth to showcase their talent through concerts and plays.

Next on the fundraising and word-spreading schedule is a Long Beach Student Battle of the Bands contest, where local high school students will be invited to enter a musical contest. Bands don't need to have an affiliation with their school, but school-ran ensembles will also be able to perform.

Since Pruitt is a seasoned sound engineer, he said he hopes to teach people who are interested in learning the technical side of putting on a show. Pruitt said if any high school students want to learn and help produce the Battle of the

Bands contest, they can reach out

Hellsund said they are also planning a Blues Festival sometime in the fall. Along with events, Pruitt said that the group is interested in working with local high school bands to host their performances, as the bandshell did in the past.

The nonprofit is actively accepting volunteers and donations through its website forpbs. org. People can fill out a form on the site to volunteer, become a patron or perform at the bandshell or email forpbs.org@gmail.com.





The district was originally planned to span from Alamitos to Junipero Avenues, but the city has extended the border to Temple Avenue to include more businesses, according to staff reports.

The creation of an LGBTQ+ cultural district is intended to honor the history the community has in the city, from hard-fought battles for equality to the central figures who helped shape the culture since the early 1900s.

A Brief History of Long **Beach's LGBTO Community**

In 1914, two well-known gay bars in Long Beach were raided by police, where they arrested 31 men and accused them of fellatio. One of the men arrested, Jonathan Lamb, eventually committed suicide and soon after the city passed a law prohibiting oral sex.

In the '60s, Long Beach resident and gay bar owner Lee Gaze organized a "flower power" protest where he and several other people bought out a nearby flower shop and brought the bouquets to the police department. They were at the department waiting for their friends-men who had been arrested for dancing with other men-to be released from jail.

In 1973, the city's first gay dance club, Club Ripples on Ocean Boulevard, was firebombed.

Despite these acts of violence and discrimination, Long Beach residents continued to protest, organize and fight for equal rights. Many bars, restaurants, clubs and other stores became community hubs for members of the LGBTQ+ community looking for a place to feel safe and welcome.

A Los Angeles Times article from 1985 estimated that 25 to 50% of the businesses along Broadway at that time were gay-owned. Residents estimated that 30% of the people living in the immediate vicinity were part of the LGBTQ+ community.

The area became even more important for gay people during the HIV/AIDS epidemic. As businesses and newly established organizations began to shut down due to sickness and deaths, the remaining establishments made it their mission to educate and support their

community.

Today, many Long Beach organizations still make it a point to provide services such as health screenings, medication, housing services and more. Well-known establishments such as Hot Stuff, Mine Shaft, The Brit Bar among others have continued to create a sense of pride for the gayborhood.

Community Responses & Requests

One of the most popular responses from the preliminary plan is an emphasis on this history so residents can learn about the contributions and struggles of local activists before their time.

Residents overwhelmingly requested improvements to lighting and a more activated corridor to create a stronger sense of community and safety. Suggested decorations included art installations, murals, historical plaques, banners and decorative lighting.

The report will be presented to Long Beach City Council in the fall of 2023.

Once receiving the report, the city can begin developing designs, identifying funding and applying for grants. Small improvements such as tree planting, street furniture, signage and murals can be expected within a year after the council receives the plans.

Larger improvements such as lighting upgrades and construction, are expected in the following

26 with local band King Salmon and the Funk Yard Horns.

Families, friends and dogs filled the parking spaces in front of Bixby Joe Coffee & Tea with lawn chairs and coolers, but most attendees were out of their seats and busting dance moves for the duration of the concert.

Roughly 30 parking spots were taken over by the minimal set up, as King Salmon and the Funk Yard Horns serenaded the crowd with a cocktail of popular R&B, funk, soul and rock song covers.

The beloved Concerts in the Park(ing lot) began over a decade ago as a saving grace for the local concert scene. Blair Cohn, executive director of the BKBIA said that the city scaled down the number of concerts in the park around 2009 due to budget cuts, which left a gap in ways for residents to enjoy live music.

One pun and brainstorm session later, the BKBIA created Concerts in the Park(ing lot), and a monthly summer tradition was born.

"It's a guaranteed good time," Cohn said. "It's unique. It's on a Monday night. I think because in

Cohn said the parking lots made more sense for the business association since it encourages residents to get food, coffee, drinks, ice cream and more from nearby businesses before and during and after the concert. Especially on a Monday, Cohn said, it's invaluable to the small businesses that provide dancing fuel for attendees.

"I look around and I see an absolute mix of the crowd in ages and the type of folks I mean, it's a full rainbow of people," Cohn said. "They're all dancing, they're all socializing with neighbors, they're just hanging out. That's the satisfaction right there. It's just the true sense of community."

Two more parking lot shows are slated on the schedule for this summer. Blanco Y Negro will play at the Bixby Joe Coffee & Tea parking lot (4245 Atlantic Ave.) on Monday, July 24 at 6:30 p.m.

The following month, Western Standard Time Ska Orchestra will perform at the Howard CDM parking lot (3737 Long Beach Blvd.) on Monday, Aug. 21 at 6:30 p.m.

Residents will be treated to an extra Concert in the Park(ing lot) this year, as the association is working with district eight to add a second August show. More details will be released soon on the @BixbyKnolls Instagram page and on the Bixby Knolls website.

Retrial begins this week for Long Beach man accused of killing ex-girlfriend with homemade bomb

The retrial of a man accused of killing his ex-girlfriend in 2018 by bombing the business they coowned in Aliso Viejo began this week.

The first time prosecutors took Stephen Beal to trial for the killing of Ildiko Krajnyak, the jury was deadlocked, and a mistrial was declared in Aug. 2022.

Beal and Krajnyak both owned Magyar Kozmetica day spa in Aliso Viejo and were previously in a romantic relationship.

During the first trial, Assistant U.S. Attorney Annamartine Salick claimed that Beal became obsessed with Krajnyak after the couple broke up and she began seeing

other men.

Beal is accused of planting a cardboard box containing an explosive device at the spa. When Krajnyak opened the box, the device inside was triggered and exploded. Krajnyak was killed, a nearby mother and daughter were critically injured and the building was decimated.

Prosecutors told the jury that pieces of wire found at the scene of the bombing matched wire found in Beal's home.

Prosecutors also said that Beal was caught on security cameras purchasing the same kind of battery used in the bomb, and that Beal allegedly bought three cardboard boxes similar to the one the bomb was placed in.

Beal's defense attorney claimed

that none of these materials were related to the bombing, and that Beal's hobby was making rockets and fireworks.

During a search of Beal's Long Beach home that took place after the crime, investigators allegedly discovered over 100 pounds of explosive material, two explosive devices and three unregistered fire-

Beal has been federally charged with use of a weapon of mass destruction, malicious destruction of a building resulting in death, use of a destructive device in a crime of violence and possession of an unregistered destructive device.

Beal's retrial began on Tuesday with jury selection, said Thom Mrozek of the United States Attorney's Office in an email. The jury heard opening statements Wednesday and witness testimonies on Thursday.

Mrozek said in an email that the trial will last several weeks.
