### Long Beach to spend at least \$740 million to prepare for 2028 Olympics

### With the new Elevate '28 plan, the city will receive much needed investments in parks, culture and community

ong Beach released a detailed plan of investments over the next five years in order to prepare for the global spotlight of the 2028 Summer Olympics.

Its Elevate '28 plan lays out \$747 million in park, cultural and infrastructure improvements, some of which still require sources of funding.

In 2026, Los Angeles will be one of 16 cities hosting a game for the FIFA World Cup, bringing an influx of tourists to Long Beach.

Two years later, Long Beach will host various events for the 2028 Summer Olympics including rowing, handball, BMX, canoeing, water polo and open-water swimming. Like many other cities that have hosted the games, Long Beach is planning on spending hundreds of millions in order to prepare for the roughly 10,000 athletes and many fans who will visit.

"We have to make sure that our youth and diverse neighborhoods in our city not only feel included in this, but also receive direct benefits from the city's planning efforts leading up to these large-scale events," Mayor Rex Richardson said at a public budget meeting on Aug. 1.

Public Works Director Eric Lopez joked that the City took the "five-year plan and gave it a more exciting name," but the City has also given it an extra \$214.6 million from Measure A funds, grants, bonds and "other funding sources."

Historically, nearly every city that has hosted the Olympics spends billions on infrastructure improvement, security and indirect costs. According to the *Council on Foreign Relations*, Beijing, China spent \$52.7 billion to host the 2008 Olympics and only made \$3.6 billion in revenue.

London invested \$13.3 billion to prepare its city for the 2012 Olympics and made \$5.2 billion.

A Marketplace article from 2022 pointed out that cities that choose to build entirely new stadiums such as Montreal, Canada and Athens, Greece were left with buildings that cost taxpayers millions for many years after the games were completed, while remaining empty most of the year.

Much like when Los Angeles hosted the Olympics in 1984, LA and Long Beach plan to use already existing infrastructures, improving those landmarks and the areas around it rather than creating something new.

Last year's projected five-year investment infrastructure plan was \$533 million. Through \$55 million in Measure A funds and \$158.9 million "from other funding sources," the City now has a total of \$747 million to prepare to "showcase Long Beach to the world."

Richardson said this money will be funneled into park improvement, youth sports facilities, arts and cultural centers and historical landmarks.

The Elevate '28 plan can be broken down into the following sections:

#### 2028 Olympic Legacy

This category is receiving the largest investment from the new-ly-identified \$214 million in funds. The 2028 Olympic Legacy, which includes Queen Mary improve-

ments, Convention Center improvements and Belmont Pier improvements, will receive \$179.98 million.

#### The City now has a total of \$747 million to prepare to "showcase Long Beach to the world."

Lopez said that some of the funding for these projects requires discussion and approval by the City Council. He identified the Convention Center, Alamitos Bay and Belmont Pool investments as top priorities, adding that these locations will be hosting Olympic events.

#### **Gold Medal Park Refresh**

Though the parks in Long Beach will not be hosting Olympic events, Public Works Director Eric Lopez said part of the City's five-year plan is "not just to help us prepare for the Olympics, but to benefit our youth and our families for generations to come."

The City has laid out \$24.83 million in the following park and open space improvements:



# Signal Hill will improve its livestreams of public meetings

The Signal Hill City Council approved a contract with Studios Spectrum, Inc. on Aug. 8 to install new video software and update its broadcasting services in order to improve the quality of live-streamed and recorded public meetings.

Studios Spectrum, Inc. is a Burbank-based company that provides audio visual equipment and related services. City documents state that the company has previously been hired by the cities of Long Beach, Alhambra, Arcadia, South Pasadena, Pasadena, Burbank, Cerritos, and more.

The contract will cost the City up to \$198,088.79, and a 10% contingency has been put in place in case of unforeseen costs. The contingency funds can only be used with the authorization of the City Manager.

A \$141,368.79 chunk of the contract will be spent in the first year, and will cover the costs of the new equipment, installation, maintenance, closed captioning and production staff. During the following two years, the annual cost will be \$28,360, and will only have to cover maintenance, closed captioning and production staff.

Key upgrades to Signal Hill's livestream capabilities will include:

• Two high-definition monitors, featuring an 85-inch display on one wall of the city council chamber and a 75-inch monitor on the opposite side

• Relocation of the control room from City Hall's basement to a dedicated IT room upstairs

•Introduction of a touchscreen control system for the audio visual system

•A portable microphone system adaptable to various meeting formats

•Inclusion of closed captioning and high-definition options

As well as installing the new equipment and setting up the new broadcasting systems, the contract also includes three years of supportive services from Studios Spectrum. Inc.

City documents state that the current streaming service used to broadcast city council meetings, Granicus, would cost \$53,000 more annually if closed captioning was added. City staff determined it would be cheaper to add a second streaming service, Cablecast, which will provide closed captioning for a lower charge.

The Cablecast livestream will be available through the City's website, smart television platforms such as Roku, Apple TV, and Amazon, and the Cablecast smartphone application.

The City will also be paying to upgrade the current standard definition video feed shown on the City's website to 720P high-definition, which will cost approximately \$1,000 for a 12-month period. City documents state that users can expect the updated video quality to be available by mid-September 2023.

According to City documents, this project is in line with the Signal Hill Strategic Plan's sixth goal, to "promote a transparent and open government."

Signal Hill City Council meetings are held biweekly on Tuesdays at 7 p.m, and can be watched online live or as a recording on Granicus.

# Signal Hill creates new program to teach residents about local government

The City of Signal Hill is introducing a new program to inform residents about the inner workings of their local government, and encourage them to be more civically engaged.

"We want to be able to create some interactivity, some ongoing two-way dialogue between our residents and the city staff," City Manager Carlo Tomaino said during a presentation at the Aug. 8 city council meeting. "Then we can facilitate some interactions talking about what we're doing and foster really good relationships."

The Signal Hill Leadership Academy will be a four-week course held each Thursday at the Signal Hill Public Library.

Topics covered during the course will include the following:

• Mayor

- City attorney's office
- City attorney's office • City administration
- City administration • Police and fire departments
- •Community Development Department
- Finance Department
- Public Works
- Parks, Recreation and Library Services

The directors of each city department will lead the lesson on what their department does.

The Signal Hill Leadership Academy is only open to Signal Hill residents. The 20 available spaces will be filled based on who signs up first.

In an email to the *Signal Tribune*, City Manager Carlo Tomaino said the City will spend around \$2,000 on the program, with most of the costs going towards providing attendees with a light dinner at each workshop.

The Signal Hill Leadership Academy will run from Sept. 28 to Oct. 19 each Thursday from 6:30 p.m. to 8:30 p.m. in the Signal Hill Public Library's Multi-Purpose Room.

There is no cost to sign up for the program, but registrants must be at least 18 years of age.

In July, the Signal Hill City Council approved a contract of over \$218,000 with John Kaliski Architects, Incorporated (JKA Inc.) to develop the Civic Center Master Plan. The plan will guide changes made to the area including the existing community center, a community garden, City Hall and its parking lots, Signal Hill Park, Signal Hill Public Library, Spud Field and certain properties along 21st Street.

The City has multiple opportunities throughout the rest of the year for locals to learn about the public project and give their input.

The public outreach for the project kicked off with an online sur-



### Three people in custody for June homicide in Long Beach

Three people were in custody Wednesday—one facing a murder charge—in connection with the shooting death of a man in Long Beach in June, authorities

David Nevarez, 35, was shot about 10 p.m. on June 16 in the 5500 block of Ackerfield Avenue, and he died at a hospital, according to the Long Beach Police Department.

On June 29, Roland Barber, 40, of Long Beach, was arrested in a shooting that occurred that same day, police said.

"While Barber was in custody, detectives gathered evidence identifying him as the suspect for the June 16 murder of David Nevarez," police said in a state-

According to the Los Angeles County District Attorney's office, Barber pleaded not guilty to one count of murder. He remains in custody on \$3 million bail.

"Detectives believe both

Barber and Nevarez were not known to each other," police said. "However on June 16, they were involved in a dispute, which escalated into a shooting, which resulted in Nevarez's death."

On Aug. 3, detectives arrested Maytte Barber, 35, of Long Beach, police said. She was booked on suspicion of accessory to murder, and is being held on \$1 million bail, police said.

Also on Aug. 3, detectives arrested Edward Williams, 59, of Long Beach, police said. Williams was booked on suspicion of accessory to murder, and he is being held on \$1 million bail, police said.

A new mural will help brighten the Community Center at Bixby Park after its unveiling by local artist, Myisha Arellano.

The mural titled "Long Beach Embrace" covers most of the southern wall of the Community Center with a vibrant depiction of two people hugging. Within the larger painting of the embrace is a collage of different scenes—called vignettes—important to the LGBTQ movement in Long Beach, and a story about the vignettes at the bottom of the mural.

"I encourage people to walk around the park and see the mural from different distances," Arellano said during the event. "I hope people can create their own meanings and connections with a piece."

The mural in Long Beach is one of five planned across Los Angeles County over the next few months in connection to LA vs. Hate's "Summer of Solidarity" campaign. The campaign aims to use art as a method to combat hate through artistic visual representations of love, diversity and inclusion.

The LA County Commission on Human Relations published a 2022 California Hate Crime Report that states anti-homosexual biased events rose 32.8% in 2022. Hate crimes based on sexual orientation rose by 29% in the same time period.

Hate crimes involving gender biases, such as a transgender or gender non-conforming person rose by 55.6%, according to the report.

Vice Mayor Cindy Allen spoke during the event and reiterated the need for monuments like Bixby Park's new mural. During the creation of the mural, residents were surveyed through workshops about what they would want included.

"Something that the respondents said over and over again in these workshops is that Long Beach is where they found their people; Long Beach is where they found their family," Allen said.

Speakers at the event stressed the importance of combating the rise of hate and extremism in the United States in recent years.

The creation of the "211" hotline from LA vs. Hate is used to report hate crimes in Los Angeles County and provide outreach and education, service navigation, or care coordination to access and obtain services that best meet individual needs.

In between speakers, attendees enjoyed performances by local drag stars Sabreena and Envi, both of whom often sing and dance at bars and clubs around Long Beach. Sabreena also serves on the board of directors for the AIDS Food Store of Long Beach, which is also depicted on the mural.

"We need each other more than ever," Allen said. "The mural is a clear indication to everyone who visits this park that hate against the LGBTQ community is unacceptable here in Long Beach; It will not be tolerated."

When he graduated the following year, he returned for full-time work and found his career path.

Rose said he worked for multiple contracting and construction companies, including Suffolk Construction Company in Los Angeles. He helped work on projects such as the Stadium Lofts near Angel Stadium of Anaheim and the Temecula Ridge apartments in Temecula.

"I worked my way from kind of like an apprentice to a superintendent project manager," Rose said.

Rose said the constant commuting and moving that came with his jobs began to take a toll on him. After moving with his family to Long Beach in 2005, he earned his General Contractor license and left Suffolk in 2007 to begin his own contracting company, MTR Construction.

Rose's first solo job was renovating his grandmother's kitchen in Glendora. He offered to do it for free so he could have a kitchen renovation on his resume.

Rose's grandmother was so impressed by his work, she advertised his business to her fellow volunteers at the Children's Hospital of Orange County. These referrals kept Rose busy and kickstarted his career as a contractor, both as his own boss and his only employee.

"I worked like seven days a week," Rose said. "I think because I was super cheap and I was just doing everything myself, I stayed busy."

Presently Rose and MTR Construction specialize in designing and building luxury spaces inside homes within Los Angeles and Orange County. While almost all of their work is relegated to homes in Southern California, Rose and his company's work may be familiar to millions outside of the state, as the general contractor for "Christina on the Coast."

The series follows Christina Hall, a longtime HGTV personality known for her other show "Flip or Flop," where she helps Southern California homeowners reimagine

their spaces.

Since the first season of "Christina on the Coast," Rose and MTR Construction have been an integral part of the reimagining process.

Two years before Rose was involved with "Christina on the Coast," MTR Construction collaborated with HGTV on its series "House Hunters Renovation" in 2016. For the third episode of the 14th season, MTR was brought on to renovate the owner's loft of the Bay Theatre in Seal Beach.

According to Rose, what was supposed to take two months ended up turning into a year and a half of work. Afterwards, the production company reached out to him and offered possible future work on reality TV. In 2018 he was called on midway through filming of the first season of "Christina on the Coast," and has been on the show since.

"They asked me, 'How many houses do you want to do?' and then it just kind of kept growing from there," Rose said.

Most of the passion for his work on "Christina on the Coast" comes from Rose's affinity for design. He said that as opposed to "Flip or Flop" and other HGTV shows, where the purpose is to increase property value, "Christina on the Coast" is focused on making a space perfectly fit the needs of a homeowner and their family.

"It's a fun process, but nevertheless, it's still a process," Rose said. "Just making sure that everyone's on the same page and working towards the same thing and making sure the homeowners are ultimately super happy at the end of it, I think to me is always the big challenge."

The setting for the show is another important aspect to Rose, he said. While preparing for new seasons, Rose said he will sometimes try to persuade clients in Long Beach to be featured in the series, which primarily showcases Orange County homes.

Rose said he likes to give back to his communities as a donor to the Long Beach fire and police departments as well as Saint Joseph Catholic School sports and to other local sports programs.

The newest and fourth season of "Christina on the Coast" is currently airing new episodes Thursday nights at 9 p.m. on HGTV and can be streamed on Discovery+.

### LBUSD hopes to increase parent involvement with new engagement plan

In an effort to strengthen the relationship between parents and the Long Beach Unified School District (LBUSD), the district is launching a parent engagement plan with strategies to increase communication and collaboration between the two.

Presented at the board's Aug. 9 meeting, the plan's mission is to "cultivate authentic and inclusive partnerships between families, schools and the community rooted in trust, respect, and recognizing parent and caregiver assets."

The plan is set to begin in the 2023-24 school year and has three goals:

· Enhance family-school partnerships by addressing perceived barriers

• Increase engagement in parent groups like the District English Learner Advisory Committee and Sankofa Parent Village.

• Build partnerships between parents, school site staff and community groups.

Deputy superintendent Tiffany Brown said that while engagement work was once considered simply "nice to have," it is now viewed as integral to the district.

"Engagement is oxygen for our system," Brown said. "The concept of equity cannot exist without en-

The plan was rooted in the portraits illustrated in the Vision 2035 plan—a 12-year plan to reimagine what the future for LBUSD students will look like-that advocated for things like building strong relationships with the community.

Director of Equity and Engagement Partnerships Lucy Salazar said her team took an evidence-based approach when creating the goals and strategies of the

The district staff took into account feedback they received in previous engagement opportunities. Salazar said this approach is meant to foster trust, transparency and a shared sense of ownership.

"This is essential to addressing the academic, behavioral and social-emotional needs of our students," Salazar said.

Some of the strategies to increase engagement in parent groups include reimagining the district's Parent University program, which has provided different workshops, resources and parent involvement activities since 2019.

Salazar said the enhanced pro-

gram will consist of a series of different videos ranging in topics from "LBUSD 101" to "Thriving Beyond High School." Workshops will be held in-person and virtually, either live-streamed or prerecorded and will be offered in English, Spanish and Khmer.

The plan highlights the importance of viewing parents as assets and experts on how to best serve their children. Salazar said recognizing this is essential to the plan's success and creating a culture of open communication.

"We will continue to ensure that we not only keep our community members actively involved and consulted, but we also find ways to increase communication," Salazar

While the plan intends to make sure parents can access district materials and events, board member Juan Benitez emphasized the importance of also meeting parents and the community where they are.

"It shows [that] this isn't just a one-way street. We're building [parent's] capacity to engage with us, but it's also about building our capacity to engage in communities that have a lot of challenges," Beni-
