A small group of climate activists are asking the city to deny Signal Hill Petroleum's request for 20 more years of new oil drilling.

hat started as a conversation between friends over brunch has become Signal Hill's latest environmental protest, targeting Signal Hill Petroleum's plans for the next 20 years.

Local group Climate Brunch has been spreading a petition for the last few

months to protest the 20-year Conditional Use Permit (CUP) that Signal Hill Petroleum is requesting from the Signal Hill City Council. A Conditional Use Permit allows operations not generally permitted by zoning codes.

Signal Hill has granted the oil company with 10 CUPs since 1998, allowing Signal Hill Petroleum to drill more than 1 million barrels of oil a year from its seven drilling sites in the city. If passed, the extension would allow operations to continue as they have for the past 39 years as well as allowing the company to drill up to 46 new wells.

If denied, Signal Hill Petroleum can still continue to drill its existing wells, which they say has at least 50 years of production remaining, but will not be permitted to drill new wells.

In the past 20 years, permits have ranged from six months to two and a half years, potentially making this the longest permit extension ever granted to Signal Hill Petroleum. The permit process is currently in the stage of compiling an Environmental Impact Report, which analyzes the effects a project will have on the health of the surrounding communities.

The report is expected to be published sometime this month, followed by a 45-day public review period where residents can voice their support or opposition for the permit. After that, the report will be sent to the Planning Commission and pending its approval, to the Signal Hill City Council.

Long Beach resident and founder of Climate Brunch, Madison Hobbs, started the petition as part of her New Year's resolution to combat climate change. Hobbs said she's been interested in climate change from a young age, inspired by her father, a conservationist.

She started Climate Brunch in January to make an environmental impact with her friends in a "fun, uplifting and motivating way." Over pancakes and mimosas, the group of friends would brainstorm ways to make a difference in their community once a month.

Conscious Cinema creates connections, inspires change

The Black-centered historical film series tells stories of social justice followed by panel discussions with modern day activists.

group of residents, friends and budding activists sat and viewed a film documenting the might of small communities during the Civil Rights Movement at the Expo Arts Center on Aug. 31. The audience got a reprieve from the summer heat while connecting to their history and learning through a panel discussion afterwards.

The viewing was the first of three Conscious Cinema Black-centered social justice screenings being hosted this summer by Long Beach Forward and Hannibal Media Group.

The goal is to connect social justice movements of the past with modern-day organization efforts and encourage dialogue between generations.

When Pastor David Zaid watched "Lowndes County and the Road to Black Power," he was moved by the power of community in the documentary. He held a viewing of the film for his congregation at the Long Beach Philadelphian Seventh-Day Adventist Church, which led to its inclusion as the first Conscious Cinema film.

The documentary, which originally began streaming on Peacock in 2022, follows Black residents and activists in Lowndes County, Alabama as they fought for voting rights and against discriminatory redlining following the passage of the Voting Rights

'A Dream for King Park' enters final stages of visioning, heading to City committees

On a warm night in late August at Martin Luther King Jr. Park, six children kick around a soccer ball in the unmarked field as a woman jogs along the sidewalk, a small group of friends sit at one of the picnic tables and a nearby church holds a Spanish service.

A few feet away in the park's community center, over 50 residents-many of whom grew up at the park and its surrounding neighborhoods—put the finishing pieces on "A Dream for King Park," the vision plan for the 5-acre park's future on Aug. 29.

The visioning process began this year and has included over 10 steering committee meetings, community workshops, surveys and audits. Almost 500 responses and suggestions have been collected through these efforts.

While Long Beach has created 10 vision plans for various parks in the past 10 years, Public Works Director Eric Lopez told the Signal Tribune that it's the first time funding has been identified and approved before the vision plan is complete.

Long Beach has set aside \$2.5 million for the MLK Jr. Park Vision Plan through Measure A funds and Park Impact Fees, a fee developers are required to pay the city when undergoing a project in Long Beach. The city is waiting for Congress to approve another \$3 million that Congressman Robert Garcia requested in April.

"There's a lot of interest and community engagement already," Lopez said. "That usually happens during and after the master plan, so it's coming together really quickly and really well."

Nearly 500 community responses and suggestions have been collected through the visioning plan efforts

Lopez added that the "unique timing" of proposed federal appropriations has also helped move the process along.

Residents were joined by multiple City officials who wanted to commemorate the closing of the visioning process and remind people that the process is just beginning.

These things take time but they get done," said Mina Roades, director of landscape design with City Fabrick. The developing firm has been working on the MLK Jr. Park Vision Plan since the first city-run

community meeting in October.

Mayor Rex Richardson gave opening comments about the need for improvements at an area in the city that has historically served its Black residents. He said the park will serve to "recognize Black legacy in Long Beach" and allow residents to "walk in the same footsteps as the people who built this community.'

Two options of vision plans were presented with roughly 20 design elements and residents were asked to fill out a feedback card choosing their preferences for each design.

Design elements included new or improved baseball fields, a new or improved concession stand, a cultural walk or cultural plaza, an expanded playground or an activity lawn, removing the perimeter fence or improving access along the fence and more.

Forestine Young stood among

two of her longtime neighbors, whom she referred to as Ms. Park and Sister Katherine, mulling over their options. The trio reminisced on amenities at the park that have since disappeared or gone out of use, such as handball courts and a concession stand, and contemplated which options would give people the most access.

Young has been going to the park for over 30 years, and her father used to play baseball at Martin Luther King Jr. Park before that. She attended nearly every community workshop to hear about the plan and give her feedback.

"If you live here, you can't complain about something you don't show up for," Young said.

She said the indoor pool and playground area have been renovated, but the community center has never been updated and is "long overdue for a refresh."

The Houghton Park Vision Plan was referred to multiple times as a fair comparison for how long the process of full renovation may take.

The plan was approved in 2015 and received \$1 million to kick off updates. Since then, Houghton Park has received \$23 million towards its new community center, a digital reader board, upgrades to the Veterans Plaza and a sound-

Richardson proposed another set of funding for continued updates to Houghton Park in his Elevate '28 plan: \$2 million for a sports complex and \$500,000 for community center improvements. The city is also in the designing process for a playground and is planning to install a soccer field with seating and another field with soccer overlay.

The MLK Jr. Park Vision Plan will now be sent to a steering committee before the final plan is sent to the Parks & Recreation Commission. Following its approval, the plan will be presented to the City Council.

Lopez said in his experience, park vision plans take about a year to 15 months to get approved. Since the plan was officially kicked off by the city in October 2022, a rough estimate for approval by the City Council would be January 2024.

Long Beach receives \$5.3 million state grant to address homelessness in downtown

The City of Long Beach has secured a \$5.3 million grant from the State of California's Encampment Resolution Funding (ERF) initiative to address homelessness in Downtown Long Beach.

The ERF grant program was established by the State of California to address the needs of individuals living in homeless encampments, while freeing up these public spaces to be used as intended.

These funds will be used to address homelessness in parts of Downtown Long Beach that have shown a high level of need, such as Lincoln Park, Billie Jean King Main Library, segments of the Downtown Entertainment District, the Metro platforms, the Promenade and Harvey Milk Promenade Park.

"This significant new funding will enable us to get our unhoused neighbors the supportive services and housing they need and support a healthy, safe and welcoming environment for library and park patrons," said Mayor Rex Richardson in a statement from the city.

The decision to concentrate efforts on this area stems from data indicating that a significant number of individuals experiencing homelessness here face particularly acute physical and behavioral health service needs. Additionally, this location has witnessed the highest number of overdose-related deaths, often linked to untreated trauma and mental health conditions

The grant will enable City Outreach staff to conduct outreach efforts and provide services to individuals experiencing homelessness in the area. Moreover, the funding will also support immediate interim and emergency shelter

solutions, with the long-term goal of transitioning people into permanent housing.

Sixty non-congregate shelter units will be made available for one year, offering immediate refuge. Simultaneously, the initiative aims to transition 125 encampment residents into permanent housing through the provision of rental assistance and supportive services.

"It is of the utmost importance to me that everyone in our community is able to enjoy our parks, libraries and public spaces. At the same time, I want everyone to be able to go home to somewhere safe and stable with peace of mind," First District Councilwoman Mary Zendejas said in a public statement. "This funding is going to allow us to create more of those possibilities for people experiencing homelessness and that is very meaningful."

This isn't the City's first encounter with the State ERF grant. In June 2023, Governor Gavin Newsom announced the newest round of funding at MacArthur Park in

Long Beach, a community that had benefited from the first round of ERF funding.

The initial efforts resulted in 40 individuals gaining access to immediate shelter. In the last year, 13 people transitioned into permanent housing, while 25 individuals continue to receive case management to secure their own permanent residences.

"We have successfully done this before, and we will do it again—supporting our neighbors with critical services, helping them achieve housing stability and creating welcoming public spaces for all," Health and Human Services Director Kelly Colopy said in a public statement.



Dead body found in ocean nearly nine years ago still unidentified

Nine years after his body was found floating in the ocean off the coast of Long Beach, no one has yet come forward to name the unknown man found in September 2014.

According to the National Missing and Unidentified Persons System (NamUs), on Sept. 6, 2014, a body was discovered on the surface of the Pacific Ocean and was subsequently brought to shore by Long Beach Port Police.

The body was too decomposed to tell many of the man's features.

According to NamUs, the man had gray or partially gray hair and was

He is estimated to have been between 55 and 70 years old, around 187 pounds and 6 feet tall.

Although the victim's body was too decomposed for NamUs to share his photo, pictures of his watch and glasses are available.

At the time his body was found, he had on a medium-sized light blue shirt, gray briefs, a cloth belt, gray shorts with a blue stripe, a Casio watch, a rope-type necklace with an "S" charm, keys to a General Motors vehicle and Ironman

Hobbs was searching on the California Environmental Quality Act website and came across Signal Hill Petroleum's proposed permit extension. She immediately decided to make it her next project.

"There's a lot of attention ... behind stopping oil drilling in Long Beach, it seems like there's more [of a] focus there, and Signal Hill has kind of flown under the radar," Hobbs said. "So this is something that I thought could be impactful."

From there, Climate Brunch teamed up with other local environmental activist groups such as The Sierra Club, which advocates for environmental projects around the nation, youth-led climate advocacy organization Sunrise Long Beach and alternative transportation proponent Car-Lite Long Beach.

As of Sept. 7, the petition has gained 179 signatures.

Signal Hill Petroleum Chief Operating Officer Dave L. Slater said that the company wants to shorten the "time-consuming" process of issuing a new permit every few years.

The company has already confirmed their reserves will produce oil for at least 50 more years, and has to undergo annual audits from the City as well as routine and surprise checks from the Air Quality Management District.

"There's tremendous staff hours and tremendous hours for us and

going through the whole process again, that would just be wasted time," Slater said. "[...] Whether it's a one-year or a 20-year [permit extension], there's going to be an annual audit."

Slater said that they were "concerned" at learning about the petition against the permit, and wants to start a dialogue with the public about their operations. Once the Environmental Impact Report becomes public, the company plans on hosting public tours.


LIQUID GOLD OR HEALTH HAZARD?

A 2021 study published in the scientific journal "Science of The Total Environment," analyzed the

air quality near oil wells across California, and found evidence that oil wells release harmful levels of air pollutants. Other peer-reviewed studies have found evidence to support a connection between oil wells and health problems, such as cancer and asthma, as well as other issues related to cardiovascular and perinatal health.

The company has been cited for over a dozen violations from the Air Quality Management District in recent years. Slater said that most of these instances are "immediate fixes" caused by minor leaks.

For a brief time at the beginning of this year, it was illegal to drill new oil and gas wells within 3,200



of homes, health care facilities and schools, after Senate Bill 1137 went into effect.

But after a successful campaign against the legislation by Signal Hill Petroleum and other oil and gas companies, the new legislation was suspended, and drilling new wells within 3,200 feet of homes and other sensitive areas will be allowed until voters decide on the issue in the 2024 elections.

All seven of Signal Hill Petroleum's drilling sites are within 3,200 feet of six schools, 10 parks and one hospital total.

In a May 24 interview with the *Signal Tribune*, Slater called SB1137 "a deceitful attempt to really hurt oil and gas production in California."

"There's kind of a propaganda campaign underway trying to tear down oil and gas, but it's not factually based and we're very diligently in fact, documenting the cleanliness of our operations and we're pushing back," Slater said, adding that the company supports a mix of clean energy and oil production.

Slater said that toxic air issues in Los Angeles County stem "mostly from transportation, not from oil and gas" and mentioned the 710 and 405 freeways which surround Signal Hill and Long Beach.

A 2021 study from the University of Southern California examined air quality in a LA neighborhood populated by both oil production sites and freeways. It found a 23% reduction in air toxins such as benzene, methane, propane and eight other toxins during periods when oil production was halted, but nearby transportation continued.

Jill Johnston, one of the researchers of the study and others around Los Angeles, told the *Signal Tribune* that studies like this are what urged the creation of SB1137.

"If you don't meet the thresholds set by the state, it doesn't mean there's no harm," Johnston said.

Nicole Levin, a representative for The Sierra Club's Beyond Dirty Fuels Campaign, urged local residents to learn about the issue, attend the public hearing and share their concerns

"We'd love for the community to turn out," Levin said. "[...] In the past, it's been like three people."

Act of 1965.

Zaid said a crucial moment in the film was when the Student Non-Violent Coordinating Committee reached out to Dr. Martin Luther King Jr. for help. King was not able to extend much support to Lowndes due to other obligations, but Zaid said seeing the strength of the community coming together in spite of that inspired him.

"That message in the film resonated with me because I think when you grow up on cartoons and superheroes, you're always going to believe the hero is going to rescue you," Zaid said. "Sometimes you realize that the hero is not always coming, the hero is you."

The film also inspired non-profit Long Beach Forward Communications Director Melissa Morgan, who helped organize the film series and said she was pleased with the diversity in the audience.

After the film, a live panel consisting of Long Beach civil rights activists and experts, including Hannibal Media Group President Greg Johnson, discussed the film with the audience.

Johnson, a seasoned broadcaster and former United States Marine Corps aircraft weapons technician, said that since now is a "critical time" with the upcoming primary election, he wants to see more young people being enriched by the films in the series. He also acknowledged the film series can benefit a multigenerational audience.

"As we look at our place in America, I would hope that people really learn that it is essential to exercise their right to vote," Johnson said. "These are the messages that are being transmitted."

On Sep. 14, "The Black Power

Mixtape 1967-1975" will play at Grey Long Beach (237 Long Beach Blvd. unit B) at 5:30 p.m. This Swedish documentary provides a view of the Black Power movement in America over eight years juxtaposed with interviews of famous Black artists and activists such as Angela Davis, Questlove and Erykah Badu.

The final showing will be on Sep. 16 at 2 p.m. at Martin Luther King Jr. Park (1950 Lemon Ave.), with a screening of "The Big Payback." The film tells the story of the first tax-funded reparations for African Americans, a movement led by an Illinois woman in government.

Long Beach restaurants and bars will soon provide 'roofie' drink testing kits through SipSafe program

The Long Beach Department of Health and Human Services is launching a new initiative that will distribute drink safety test kits that can detect illegal substances in beverages—SipSafe Long Beach.

The Health Department has already procured these drink safety testing kits and plans to distribute them equitably to businesses and organizations across the city upon request.

"By providing drink safety test kits to local businesses and organizations, we are taking proactive steps to prevent drink spiking and promote a safe environment for all," said Mayor Rex Richardson in a statement from the City. "This \$25,000 initiative is a significant investment in our community's safety, and we are proud to be promoting personal safety."

The drink safety testing kits are designed to detect the potential presence of drink-spiking drugs, including GHB (gamma hydroxybutyrate), commonly known as the date rape drug, and ketamine.

The kits can be used at any location and time. Long Beach is modeling its SipSafe program after similar initiatives that have already been established in other Southern California cities.

A 2015 study in San Francis-

co found evidence that one third of sexual assault cases involved the use of a date rape drug.

"It is comforting to see this initiative launching, and that we will begin providing drink safety kits here in Long Beach through our SipSafe program," said Vice Mayor Cindy Allen in a statement from the City. "As the city continues to grow, it is important that we take additional steps to ensure the safety of patrons at alcohol-licensed establishments. Especially for our women patrons, this program makes our city so much safer and more inviting."

A 2015 study in San Francisco found evidence that one third of sexual assault cases involved the use of a date rape drug.

To facilitate fair distribution of the kits across businesses and organizations citywide, the Health Department has developed a Drink Safety Test Kit Request Form. This form is accessible online in English, Spanish, Khmer and Tagalog.

"SipSafe Long Beach is a step forward in our efforts to advocate

for personal safety and wellbeing in our community," said Health Director Kelly Colopy in a statement from the city. "Our commitment to ensuring the safety of our community remains unwavering, and we are confident that this program will have a meaningful impact in preventing drink spiking incidents."

The idea of a drink safety program in Long Beach was first brought to the City Council by Vice Mayor Cindy Allen, and was co-sponsored by First District Councilwoman Mary Zendejas and Sixth District Councilwoman Dr. Suely Saro.

The program was approved by the City Council with a unanimous 6 to 0 vote in December 2022.

set to receive \$600,000 from Long Beach

The City of Long Beach's Office of Youth Development and The Nonprofit Partnership will distribute \$600,000 in grant funding to support 59 summer projects aimed at serving youth in Long Beach.

Fifty-five smaller projects have been funded through the Youth 100 Fund, which gives mini-grants to community groups engaged in activities that benefit the city's youth. Additionally, four larger projects have received funding through Intergenerational Youth Development Grants, which focus on programs that involve youth and their parents or caregivers.

"The Measure US Youth Fund has been critical in supporting positive youth development these past two summers," Mayor Rex Richardson said in a statement from the city. "We are confident the selected organizations will continue to empower and uplift Long Beach youth."

The Youth 100 Fund grants range from \$500 to \$2,000, and have been awarded to nonprofit organizations, school groups and youth/community leaders that will provide summer programming for young people aged 8 to 24.

The grant applications were evaluated by a panel of youth advocates, including the City's Office of Youth Development Youth Advisory Council and local youth interns. The grantees represent a diverse range of organizations focusing on arts education, academic readiness,

mindfulness and more.

Intergenerational Grants, each amounting to \$50,000, have been awarded to nonprofit organizations that plan to take a holistic, family-based approach to youth violence prevention and youth development. The selection process involved leaders from community-based organizations, The Nonprofit Partnership staff, youth leaders and their parents.

A comprehensive list of the awardees and their summer programs is available at longbeach. gov/youthfund.

These grants build on previous efforts to support Long Beach's youth. In September 2022, the City awarded grants to more than 70 local groups and organizations using Measure US funds.

Earlier in the summer, seven projects were funded through the Youth Power PB Long Beach process, which is also funded by Measure US.

The Youth 100 Fund and Intergenerational Grants are in line with the goals set by the City's Youth and Emerging Adults Strategic Plan.



Ground Education plants seeds for Signal Hill expansion

With the goal of building 10 more LBUSD school gardens in the next year, Ground Education makes a move for Signal Hill with new headquarters

Local environmental nonprofit Ground Education is moving its home base to Signal Hill with a new headquarters on E. 28th Street.

Ground Education currently teaches at 22 schools throughout the Long Beach Unified School District (LBUSD) with a hands-on educational curriculum that embraces nature and gardening. They facilitate the building, planting and managing of local school gardens with the goal of reaching every elementary school student in the dis-

The new rented headquarters includes roughly 900 square feet of warehouse space, plus a small office in the front, and the 26-person team has spent the summer making the space feel like home

Previously, Ground Education shared space with other organizations within a co-op, but this new space resembles not only a fresh start, but a rewarding reminder of the organization's rapid growth since its founding in 2017.

"It's been a fun summer of pulling it together and letting the excitement of having a space where we all fit to get us ready for the school year to come and all the growth that's still ahead of us," said Holland Brown, Co-Executive Director of Ground Education.

To Brown, the move to Signal Hill is geographically significant, as it puts them within 10 minutes of every school they are involved with. Plus, with the positive reception received from the students and teachers at the 22 participating schools, the new space allows them to continue planning their expansion to eventually cover 54 elementary and K-8 schools in LBUSD.

"It's exciting that so many schools and the elementary office of the district seem equally as excited about bringing nature spaces to ultimately all of the Long Beach Unified elementary campuses," Brown said.

Within Signal Hill, Ground Education has been teaching at Alvarado Elementary since 2018 and taught summer school at Signal Hill Elementary this past summer. Brown says they are hoping to rehabilitate Signal Hill Elementary's garden and start teaching on campus during school hours within the next year.

Ground Education's immediate goal is to build 10 new gardens by this time next year, along with furthering connections with the 22 school gardens, two after-school programs and two Boys & Girls Club sites.

Currently, Brown and the Ground Education team are trying to finish setting up the new space, and Brown says the collaborative effort has reinforced the organization's message.

"We have a lot of creative people inside of Ground Education and they've really enjoyed being part of thinking through how to make the space not just efficient, but inspiring and how to help it reflect our mission and the work we do," Brown said.

Though there is no official date for when the headquarters will be ready, Ground Education is aiming to have an open house in October, giving community members the chance to stop by and see up close what goes into the garden program.

The new headquarters for Ground Education is located at 2633 E. 28th St in Signal Hill.

The Pride Tower Node is poised to encompass several new features, including the further restoration of

the Progress Pride Tower, the establishment of an inclusive and accessible boardwalk path to enhance shoreline access and the construction of a versatile deck/platform suitable for special events and casual observation.

Additionally, new mobility access mats, aligning with those already in use citywide, will facilitate easier access to the water.

The City intends to seek regulatory approvals to display public art in the vicinity during Pride Month and other special events.


