# Quiet comfort and curly hair care: the unique offerings of **Black Sheep Salon**

This Long Beach salon focuses on curly-haired, neurodiverse and disabled clients.

oes a haircut free from the obligatory small talk with your stylist sound like a dream? Then Black Sheep Salon in the Wrigley neighborhood of Long Beach is the place for you. Owner Marie Rolla opened Black Sheep Salon in 2021 to provide special-

ized services for neurodiverse, disabled and curly-haired clients. As an autistic woman herself, Rolla's personal experience informs the services she provides for her

Those who book an appointment can expect a wide range of accommodation available upon request: earplugs to prevent water and shampoo from getting in their ears; fragrance-free products or a product-free haircut; barber chairs that can hold up to 800 pounds and can be moved to make space for a wheelchair; a portable shampoo sink for clients who can't get out of their wheelchair; and a chat-free service for a blissfully silent experience.

'The places I was working weren't the best situations for my clients that I was bringing in, and there was just definitely a big disconnect in the level of discomfort, where a lot of my textured-hair clients weren't being served as correctly or safely," Rolla said of hair salons she worked at before. "As well as just noticing [...] that there really wasn't a lot of access to hair care for disabled people, or people with limited abilities to do their hair. There's a large demographic of people that just were not being serviced and I didn't necessarily feel comfortable in the spaces that I was servicing them."

# Updates on Long Beach services following last week's cyber attack

Long Beach is still investigating he cyber attack that occurred on Nov. 14, and most City websites remain out of service.

City departments have been communicating via email, phone, social media and in-person offices in the meantime. The Technology and In-

novation Department is continuing to identify solutions in partnership with specific departments, the City said in a public statement.

Long Beach sent out an on Nov. 22 to identify which services remain operating as usual, and which ones are out of service.

Services operating as usual in-

Street sweeping schedules are still operating as normal, and parking citations are still being issued. There will be no street sweeping or parking enforcement on Thursday, Nov. 23 or Friday, Nov. 24.

•Flu and COVID-19 vaccine administration

·Gas Dispatch and Water Dispatch Centers remain open 24/7; people may report a gas leak at 562-570-2140. To report a water leak, people may call 562-570-2390

People may now pay parking citations online, in person in the City Hall lobby (cash, check or money order only) or over the phone by

calling 562-570-6822. People are encouraged to pay citations on time to avoid any late fees or penalties.

Utility billing late fees and shutffs for non-payment remain suspended. Customers are still unable to make payments online, over the phone or at any previously established offsite locations. All previously scheduled customer service



operations will continue but could be delayed.

Library locations remain open, and people can check out and check in books. Digital amenities, such as e-books, public computers and printers, and catalog searches are not currently available.

Online registration for Parks, Recreation and Marine classes is now available through LB Rec Connect, where registrants can pay by credit card. People enrolling for classes in person at the department's administrative offices (2760 N. Studebaker Rd.) will be able to pay by credit card or gift card. Facility reservations need to be handled in person.

Long Beach Animal Care Services continues to offer pet adoptions and licenses. People cannot view lost or adoptable animals online and are encouraged to visit Animal Care Services in person to view animals.

The Health and Human Services Department continues to connect people experiencing homelessness with services and shelter via the Multi-Service Center and Mobile Access Centers, and the REACH line is still taking calls during normal business hours. Homeless outreach also continues.

The Resource Line is online and taking live calls. Environmental Health is able to continue operations, but working around the systems issue is causing delays. Some records related to permit fees and other account information may not be available. Communicable disease clinical programs continue

and enrollment in Medi-Cal, WIC, and other social services continue.

The city-run COVID-19 testing and vaccination clinic at Martin Luther King, Jr. Park will continue to provide rapid testing only until the system is restored. Travel vaccines are also available at the Immunization Clinic at 2525 Grand Ave.

The Go Long Beach mobile app is operational, but the public can expect a slight delay to service fulfillment and Public Works permit application approvals will experience minor delays.

People may visit the Community Development Department Permit Center at City Hall (411 W. Ocean Blvd.) for permit and license dropin services, but all online permit and license systems are currently unavailable.

Depending on the transaction size and type, Permit Center customers may be able to make payments by cash, check or credit card using a third-party service provider. In some instances, there may be the option to defer payment to a later time.

Previously scheduled inspections are being honored and new inspections are being handled by phone request at 562-570-LBCD (5223). While the department is maintaining permitting operations for those who need immediate assistance, some delays may be experienced during this time. For all permitting needs that can wait until after the Thanksgiving holiday, customers are encouraged to consider waiting until Nov. 27 to submit a new request.

The Economic Development Department encourages people to contact their BizCare team at 562-570-4BIZ or 4biz@longbeach.gov for assistance while the website is offline.

While there have not been any major service disruptions at this point to the main services the City provides, people may experience some delays with non-emergency systems and services.

Any pertinent updates will be provided as the investigation continues, the City said in a public statement.

# Signal Hill seeking member for Parks and Recreation Commission

The City of Signal Hill is looking to fill an open position on its Parks and Recreation Commission.

The position opened unexpectedly due to a member of the commission moving out of Signal Hill. The individual hired to fill the position will finish the previous commission members' term, which lasts until May 31, 2025.

The application period will open on Nov. 17 and close on Dec. 15, and applicants will be told if they have to return for an interview by Dec.

If there are 10 applicants or less, the city council will interview and appoint the new commission member on Jan. 23. If there are more than 10 applicants, the council will conduct the interviews on either Jan. 30, or Feb. 6 2024.

The Parks and Recreation Commission meets on the third Wednes-

day of every month at 6 p.m. in the City Hall Council Chamber. Members of the commission will receive \$75 per meeting.

The commission acts as an advisory for the Signal Hill City Council, by informing the council of residents' recreation needs and making recommendations on policy related to the city's parks.

# This Christmas bake-off raises food and supplies for people and pets

Residents can enjoy homemade baked goods and a free concert by donating food, clothing or pet items.

Decadent fluffy cupcakes decorated with green and red swirl frosting and topped with sprinkles. Triple-tiered chocolate cake with powdered sugar, made to look like snow, blanketing its surface. Intricately shaped sugar cookies lined with royal icing to imitate snowmen, Christmas trees, gifts, snowflakes and other holiday icons.

Residents can enjoy all of these tasty creations and many more at the ninth annual Christmas cookie decorating and bake-off contest hosted by the Long Beach nonprofit Community Action Team.

At least 30 participants will enter their homemade cookies, cakes, pies, brownies, cupcakes and other delicacies for a chance to place in one of six prizes. Winners will receive \$50 to donate to their favorite charity, school, organization or place of worship, while residents

will get the chance to taste the contested creations for themselves.

The event has gone through many iterations, first beginning with a fall-themed bake-off with a separate Christmas cookie decorating contest held during one of the nonprofit's monthly clean-ups.

Now the bake-off is held at the Bay Shore Community Congregational Church, complete with a 25-person professional brass and percussion band with the Southern California Brass Consortium. The 90-minute concert is free for attendees while judges in the next room will decide the winners for the bake-off contest and the Christmas cookie decorating contest.

Justin Rudd, who runs the Community Action Team, said he combined the two baking events in order to ease his workload while planning the monthly beach cleanups and back-to-back holiday events. He's now realized that adding a free concert is his "gift to the

community."

While the concert and tasting reception is free, residents are asked to bring a donation of pet supplies for Operation Santa Paws, or food and clothing for people experiencing homelessness.

Rudd said the homeless shelters his nonprofit partners with are mostly requesting packages of men's black socks during this time of the year.

The baking contests are free to enter as well, and people of all ages and skill levels can enter.

"We want to take away anything that might keep someone from being able to enter," Rudd said. "The rules are simple, it has to be baked, it can't be store bought or from a box. We want it to be from scratch."

Additional rules include:

• Cakes must be brought in whole, not with slices taken out or served individually

•Participants must bring their own serving utensils and cutting

• For those bringing smaller entries such as cupcakes, brownies, bars etc., there is a minimum entry amount of 24 items for judges and the community to taste.

• Participants can enter more than one item, but the contest is for individuals, not teams or partners.

Entries will be judged by the current Ms. Long Beach and Ms. Southern California, as well as a food critic, restaurant writer, as well as a baker or culinary teacher who is yet to be announced.

For those participating in the baking contests, items must be dropped off, ready to present, from 4 p.m. to 4:45 p.m. Judging will begin at 4:45 p.m., the Christmas concert will begin at 5 p.m. and the tasting reception will begin at 6:30 p.m.

All events are free and will take place at the Bay Shore Community Congregational Church at 5100 E The Toledo in Long Beach. Though the events are free, residents must reserve their spot online since seats for the concert are limited.

## **BLACK SHEEP SALON -** continued from page 1

When the pandemic hit in 2020, salons were closed and Rolla had extra free time on her hands. She used that time to educate herself online about how to specifically care for curly hair and natural hair patterns.

She began to envision a salon that would not only focus on those with curly or kinky hair, but also the disabled and neurodiverse communities—people who are not typically catered to in the average salon.

"I have had clients that haven't been able to fit into chairs and I've seen a lot of really uncomfortable experiences," Rolla said. "And I had a really hard time finding an owner that was on board with the things that I was on board with. And I got really frustrated. And so I had a vision and I decided to go for it and I'm here now."

Rolla was surprised by the level of support her business received after she began offering specialized services.

"I began taking a lot of clients and I was shocked at a lot of things, I was shocked at the number of my clients that were comfortable with me doing their hair having little to no experience working with textured hair, being comfortable seeing, you know, a non-Black person and being able to service them. And I realized that was because there was really not anybody else doing that kind of work."

At first glance, potential clients may balk at the relatively high prices Black Sheep Salon charges. A haircut can range from \$95 to \$250 depending on the stylist and type of haircut, with the addition of bleach or hair dye, services can reach up to \$500.

But Rolla explained that their prices are set to provide a livable wage to the stylists, who she says are all breadwinners for their families, and many of whom are disabled.

Besides a lower-than-average annual income, many hairstylists don't receive benefits from their job, such as health insurance. This is particularly concerning in light of the health risks involved.

According to a 2022 article published in the International Journal of Environmental Research and Public Health, hairdressers have a higher rate of certain health problems compared to the general population, including rhinitis, asthma, contact dermatitis and reproductive issues. The same study found evidence that this is caused by the chemicals hairdressers are exposed to during their work day, including ammonia and formaldehyde.

"It's not even just color, the styling products that I'm touching all day for 12 hours a day, 10 hours a day, just constantly exposed to chemicals, like the air quality from the blow dries, from the chemicals that I'm breathing in all day [...]," Rolla said "It's hard when you see the high service price points to understand what it might feel like to be in our shoes and what this looks like. But it's a very, very hard job. And it's not a very safe job. It's a very dangerous job."

Despite the challenges intrinsic to her line of work, Rolla and the rest of the stylists at Black Sheep Salon remain dedicated to providing a safe place for everyone to get their hair done.


