Flying pugs to forever homes: The heartwarming mission of Pug Rescue of Korea

Across an ocean, three women are working together to save the lives of neglected, abandoned and abused pugs. Their nonprofit organization, Pug Rescue of Korea, ships dozens of the smushed-faced dogs from South Korea to their forever homes in the United States.

Korean native Hye Sook Kim, the founder of the organization and a passionate pug rescuer, adopted her own pugs from a shelter for stray dogs. Quickly gaining an affinity for the little creatures, in 2009 she began trying to find homes in Korea for pugs in need, but had a difficult time finding enough homes for the ongoing number of pugs.

Thanks to the wonders of the internet, Los Angeles-based Happy Angels Dog Rescue heard about what Kim was trying to do. The dog rescue reached out to her and asked if she would be able to send pugs she rescues in South Korea to Los Angeles to be adopted.

"I thought what a jackpot," Kim said in an online message to the *Signal Tribune*. "[...] I was so happy to get the suggestion. That was the start."

After Happy Angels Dog Rescue stopped operating in 2013, the new "pawrents" of pugs that had been rescued by Kim wanted to continue the mission of rehoming pugs from South Korea in the U.S.

Kim currently has two helpers in Long Beach: pug enthusiasts Melody Chalaban and Jinny Chi.

"You see how much you're helping these dogs who are neglected or abandoned or sometimes abused," Chalaban said of volunteering with Pug Rescue of Korea. "And then when you see them with their new adoptive families, it's very, very rewarding. And that's actually what motivates our rescue in Korea."

Chalaban, who oversees adoptions and marketing for the nonprofit, adopted her pug Gumbo through Happy Angels Dog Rescue after he was saved by Kim. Chalaban has been volunteering with Pug Rescue of Korea since 2018.

As Chalaban spoke to the *Signal Tribune* on Feb. 13, her pug Gumbo laid safe and snug in her lap. Before he was rescued and adopted in 2014, Gumbo was in a more precarious situation, stuffed in a cage waiting outside a meat market in Korea.

Chalaban emphasized that it was not common for Koreans to eat dog meat and that it is only done by a small percentage of older generations, with the South Korean government recently passing legislation to ban the practice.

Long Beach family has home and business destroyed by suspected drunk driver

One Long Beach family is starting from scratch after their art gallery and home was destroyed by a suspected drunk driver over last weekend.

Two vehicles came barreling through the floor to ceiling windows of Open Gallery in the early hours of Saturday morning, Feb. 24, narrowly missing parents Liz Garibaldi and Artos Saucedo, as well as their son.

"We just have a bunch of scrapes and bruises," Saucedo told the *Signal Tribune*. "We're all in complete shock and we're also devastated."

Police arrested the driver of one of the vehicles, 32-year-old Luis Medinas Amador of Long Beach, on suspicion of drunk driving. His bail has been set at \$100,000.

The family founded Open Gallery in 2019 in order "to bring a thriving art scene to Long Beach as a whole, as well as to local artists and creatives," Saucedo said.

Saucedo said that around 20 artists had their work damaged or destroyed in the crash.

As of Monday, Saucedo said contractors were still assessing the damage to the building, and that the family isn't sure if they'll be able to rebuild at that location or have to move. The family was renting all three units in the building.

"It took us five years to get here," Saucedo said. "How do we come back from losing five years of work and efforts?"

A GoFundMe campaign has been started to aid the family, and as of Wednesday it has raised \$37,270 of its \$150,000 goal.

On the GoFundMe campaigns webpage, the family wrote that their insurance provider recently stopped providing coverage in California, and that the family was uninsured at the time of the crash.

Signal Hill increases budget for Hillbrook Park improvements

The Signal Hill City Council increased the budget for planned improvements to Hillbrook Park and approved a contract with a company for the required labor.

The increased budget stems from public feedback that showed building new playground and shade structures would enhance residents' experiences at the park.

The City of Signal Hill compiled its Parks and Recreation Master Plan in 2021 to outline the public's priorities, interests and needs. The creation of the Parks and Recreation Master Plan led to the development and adoption of the Preparation and Implementation Plan in January 2022, which laid out how the City will prioritize capital improvement projects identified as important to the community.

Redesigning Hillbrook Park was identified as a priority by the City, and in October 2022, city staff asked that a design company be hired for the needed improvements. In January 2023, the City Council approved a contract with Architerra Design Group to conduct public outreach and design plans for park improvements.

After the Architerra Design Group gave presentations on their findings to the Parks and Recreation Commission and City Council, a design was selected in June 2023. The City originally budgeted \$1,520,000 to complete the Hillbrook Park improvements.

On Tuesday, the City Council approved a contract for Green Giant Landscaping, Inc. to physically build the designs made by Architerra Design Group for an amount not exceeding \$1,799,000 for 120 days of work. The City also set aside \$60,000 in case of unforeseen circumstances and unexpected costs, bringing the total amount the City can spend on construction services

by Green Giant Landscaping, Inc. to \$1,859,000.

City staff said that with the newly included shade structure, the playground will be mostly, if not completely, shaded.

The dry creek bed in Hillbrook Park will be removed as part of the project and replaced by a water conservation system that will divert stormwater from Temple Avenue to the east side of the park. Rainwater will be retained and infiltrated naturally by a mass of vegetation in a shallow depression, known as a bioretention swale.

Because this aspect of the project conserves water, the City was approved for a reimbursement of \$173,000 for the project from the Metropolitan Water District.

The City Council unanimously voted to approve the budget increase for the project, as well as the contract with Green Giant Landscaping, Inc.

City staff said the construction at Hillbrook Park is tentatively expected to begin in March, and to conclude in October.

LBUSD considers cutting positions that serve students with disabilities

The Long Beach Unified School District is considering slashing roles that serve students with disabilities due to budget cuts and funding issues.

During its Feb. 21 meeting, the LBUSD board was presented a classified personnel report to approve. The report included recent appointments and resignations, but also a section on "abolishments." If approved, the positions on this list would be at risk of being cut, including six Behavior Intervention Supervisors in special education.

Behavior Intervention Supervisors are responsible for providing behavior support for students with disabilities. This can look like attending Individualized Education Program meetings and helping teachers with classroom management. They are also first responders when students leave school unattended.

According to Deputy Superintendent Tiffany Brown, the board's approval of the report does not mean the positions are officially terminated, but rather that the district will begin notifying the people in those positions that they are at risk of losing their jobs.

However, upon a motion from board member Juan Benitez, the approval vote for the section on abolishing those six positions was tabled for the March 6 meeting.

"Not taking away all the work that's been done to make this very difficult and strategic decision," Benitez said. "But I want to be able to be responsive to caregivers and parents to make sure that I'm un-

derstanding how we're going to mitigate [this]."

April Acuña is a behavior intervention supervisor for the district and a board-certified behavioral analyst. She said she was surprised not only about the potential of the positions being abolished but also what she described as a lack of understanding about what her position does.

"We act as liaisons between contracted agencies and the district personnel in order to advocate on behalf of our students for a least restrictive environment," Acuña said. "Like many roles, ours is multifaceted and very valuable to the success of our students."

There are currently 24 Behavior Intervention Supervisor positions in the district, and the abolishment would impact six people—those with the least seniority. Behavior Intervention Supervisors hired on contract will be removed before those who are district staff, according to Assistant Superintendent of

School Support Services Erin Simon.

She also said that the remaining 18 positions will continue to carry out some of the role responsibilities and that the district is looking at other positions that could take on some of the workload.

Long Beach tells residents to prepare for return of full-priced internet as Affordable Connectivity Program runs out

A program that has helped nearly 50,000 Long Beach residents to afford wireless internet since 2021 is set to go offline at the end of April.

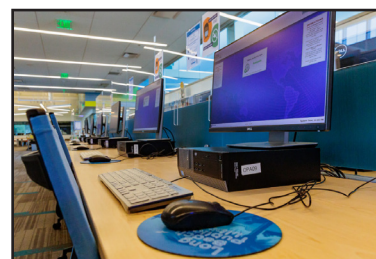
The City is urging residents signed up for the Affordable Connectivity Program (ACP) to check with their provider and bill cycle to prepare for the return to full-priced costs.

The program began nationwide in 2021 and through \$14.2 billion in allocations from the federal government, provided internet discounts of up to \$30 a month to low-income residents.

Long Beach saw a 60% enrollment for residents eligible for the program. Due to an end in federal funding, the program is set to expire at the end of April.

Long Beach's Technology and Innovation Department is encouraging residents to take the following steps:

- Frequently check your emails and mail from your internet service provider for more information and

further updates regarding the ACP benefit. Additional information will also be available at affordableconnectivity.gov and fcc.gov/acp.

- Contact your internet service provider for questions about how the end of the ACP will affect your monthly bill, then choose to opt in or opt out of your internet plan.

- Visit fcc.gov/acp to review a list of frequently asked questions, available in English and Spanish, and other guidance about the ACP wind-down process, including what households need to know about retaining internet service after the end of the ACP.

- Contact the Universal Service Administrative Co. (USAC) ACP Support Center at 877-384-2575 for any other questions about the ACP wind-down and information about their benefits.

"We strongly encourage everyone enrolled in the ACP to contact their Internet Service Provider to review their plan in order to avoid bill shock if and when the funds run out," said Lea Eriksen, Director of Technology and Innovation, in a public statement.

The Long Beach City Council adopted a resolution on Feb. 20 to support the Affordable Connectivity Extension Act. If passed, it will provide \$7 billion to continue the ACP program past this spring.

"Additional funding from the federal government will continue the ACP and ensure that low-cost internet access remains accessible to our enrolled residents and businesses," said Councilmember Roberto Uranga in a public statement. "This resolution reiterates our efforts to address the internet gap by encouraging Congress to support closure of the digital divide."

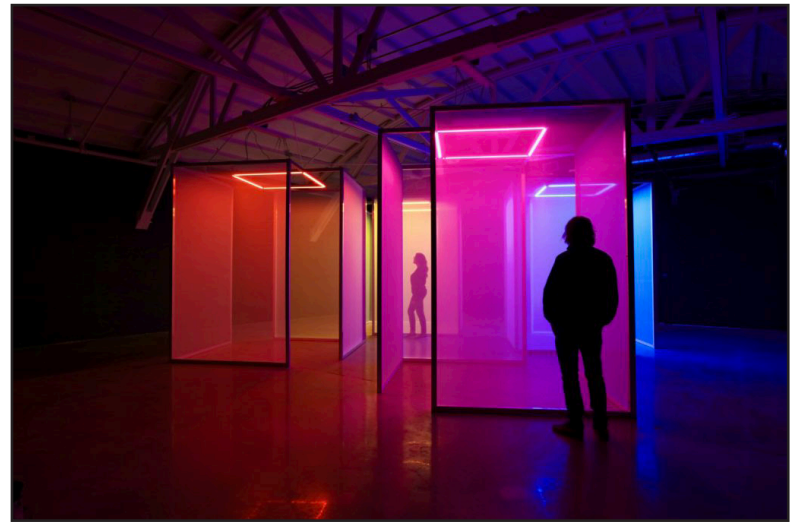

Signal Hill Panorama Trail closed for repairs following damage from February storms

Panorama Promenade Trail in Signal Hill will be closed to the public for at least eight weeks following a storm on Feb. 6 that caused significant erosion to the land and slope.

The slope along Molino Avenue and 20th Street is also in need of critical repairs, as the hillside experienced similar levels of erosion during the February storm. The roads were temporarily shut down immediately following the storm, but have since reopened.

Signal Hill has contracted Zimprich Engineering to complete the necessary repairs at both sites for a total of \$431,910, with an estimated completion date of March 29. In the event additional repairs are needed, Signal Hill has set aside \$368,090.

City Manager Carlo Tomaino said in an email to the Signal Tribune that the City is anticipating “minor ancillary work” for repairs on the slope past March 29.

The City identified a “threat to the public and property” if the structures are not repaired, according to staff reports. The Panorama Promenade Trail’s damage is localized to two areas, creating a potentially dangerous situation to the thousands of residents who use the trail on a weekly basis if not repaired.

Priority Repairs for the Panorama Promenade Trail Slope Stabilization project include:

- Securing currently exposed utilities near the top of the road
- Grading and backfilling the slope by:
 - Using plastic sheeting on compromised areas during rain
 - Excavating the wet materials
 - Importing dry materials for slope repair
 - Removing trees
 - Installing a retaining system consisting of 600 feet of metal pipes and 12-foot pressure-treated wooden planks. Placing gravel bags at the top of the slopes

Erosion to the hillside along Molino Avenue and 20th Street means repairs are needed to avoid damage to vehicles parked on the street, and to protect adjacent residential properties and roadway hazards from falling debris, according to staff reports. Zimprich Engineering is planning to build a retaining wall along the slope.

Priority repairs for the 20th and Redondo Slope Stabilization and Retaining Wall Project include:

- Covering compromised areas of the slope with plastic sheets and importing dry materials for slope repair in order to grade and fill the area
- Installing a retaining wall along the slope from 2 to 6 feet tall
- Placing gravel bags at the top of the slopes

Tomaino signed a Proclamation of a Local Emergency on Feb. 7 due to the storms and the Signal Hill City Council ratified the emergency on Feb. 13. The state of emergency allows cities to take quicker action on items without the guardrails of municipal codes regarding costs and timelines.

A local state of emergency means that “the public interest and necessity demand the immediate expenditure of public money to safeguard life, health, or property” for “any sum required to mitigate the emergency,” according to city documents.

Due to the local state of emergency, Signal Hill Public Works

did not have to undergo the regular bidding process. The City met with three companies who conducted a site review of both locations and contracted Zimprich Engineering on Feb. 11.

The state of emergency must be reviewed every 60 days according to the city’s municipal code, so Signal Hill City Council has the option to extend the local emergency or end it at its April 9 meeting.

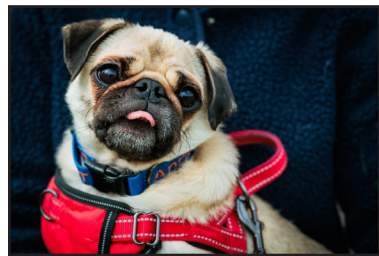

However, it is all too common for dogs to be abandoned in Korea. The Korean Animal Welfare Association found that around 135,000 pets are abandoned in Korea annually. Chalaban attributed this to pet ownership being relatively new to Korean culture, and said that many pet buyers don't realize the work it takes to care of a pet, and don't consider them a family member.

Korean media outlets, such as *The Korea Herald*, have identified that the low legal barriers to purchase dogs, irresponsible buying and over-breeding are also factors that contribute to South Korea's high rate of abandoned dogs.

Pug Rescue of Korea brought 76 pugs to the U.S. in 2023, and 53 pugs in 2022. Chalaban said the nonprofit rescues an average of 60 to 80 pugs each year. It costs at least \$1,000 to fly each pug from South Korea to LAX, and the nonprofit relies entirely on donations.

They're also working on an annual deadline. In May of each year, airlines place an embargo on flat-faced dogs traveling in their plane's cargo holds in order to mitigate the risk of them overheating. Only pugs small enough to fit in a carrier under a seat can travel by air after the cut-off.

This severely limits the amount of pugs that Kim can send to the U.S., and all three members of the nonprofit hustle to get as many pugs rehomed as possible before the May deadline.

Adoption fees range for the pugs based on their age, ranging from a fee of \$700 for pugs under a year old to \$350 for pugs six years and older. There is also a shipping fee of \$600 for pugs that fly in through LAX, or \$1,000 to \$1,500 for pugs flown to the JFK airport on the east coast. Adoption fees are tax deductible.

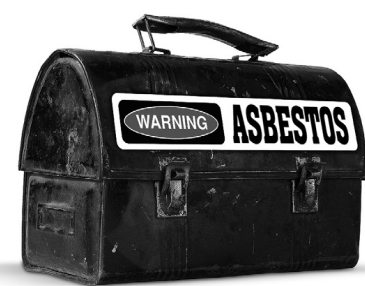

HISTORY On the Hill



The Black Gold Rush Begins

Although June 23, 1921 lives in history as the day wildcat oil well Alamitos Number One blew a gusher and began the Signal Hill oil boom, it was only one incident in a chain of many which lead to the discovery of one of the world's richest oil fields per acre. As early as 1916 the Union Oil Company of California had leased acreage just west of Signal Hill near what is now the corner of Wardlow Road and Long Beach Boulevard. Union Oil drilled to a depth of 3,449 feet but mistakenly stopped just short of tapping an oil reservoir.

Oil companies drilling in nearby coastal regions were luckier. On May 24, 1920 Standard Oil of California tapped a meager 40-barrel well at Huntington Beach, about 20 miles southeast of Signal Hill. But the following November, the historic Bolsa Chica Number One Oil well blew a gusher at 2,549 feet down. It flowed 20,000 barrels per day.

According to Walker A. Tompkins, author of *Little Giant of Signal Hill*, the oil strike of Huntington Beach's Bolsa Chica No. 1 "focused the attention of geologists on the chain of topographic highs which extends vertebra-like, from Newport Beach on the south to Beverly Hills. Each vertebra was underlaid by a well-known oil field- Huntington Beach, Seal Beach, Signal Hill, Dominguez Hills, Rosecrans, Baldwin Hills and Inglewood."

After surveying the geology of Signal Hill in 1920, Royal Dutch Shell, a British and Dutch owned oil corporation, leased 240 acres on the east slope of Signal Hill. Shell began drilling Alamitos Number One on March 23, 1921 at the corner of

Temple Avenue and Hill Street. O.T. "Happy" Yowell was the man in charge on site. True to Yowell's nickname, drilling proceeded "happily" without a hitch. At a depth of 2,724 feet, Yowell found definite indications of oil and natural gas. Shell soon leased additional acreage on Signal Hill in anticipation of an oil strike.

At a depth of 3,114 feet, exactly three months after Yowell had begun drilling, Alamitos Number One suddenly blew out. The well blasted a gusher of crude oil over 114 feet above the top of its wooden derrick. This geyser raged out of control for four days, drenching everything around it until it was finally capped and its flowing crude diverted into a storage tank.

It was estimated that Alamitos Number One's gusher yielded 1,200 barrels of oil. The state registered landmark plaque which commemorates the site credits this well as once "flowing 590 barrels of oil a day. *To Be Continued...*"

Why A Yes Vote on Measure RW is Good for Long Beach

This opinion editorial was written by Tom Reed and Jorge Valdez, co-owners of Iguana Imports in Long Beach and by Gary Hytrek, professor of geography at California State University, Long Beach.

Long Beach's tourism and hospitality industries came roaring back in 2023, delivering a nearly \$1.8 billion economic impact city-wide. While this was great news for those at the top, our city's struggling small businesses and working families have been shut out of the windfall, left instead to scramble to make ends meet every month.

We have a chance to fix that. On March 5, Long Beach voters will have the opportunity to vote in favor of small businesses and working families by supporting Measure RW. A "Yes" on Measure RW will raise the minimum wage for hundreds of Long Beach hotel workers, putting more money in their pockets to spend at local businesses. Its passage would be a win for families, a win for small businesses, and a win for the city of Long Beach.

This is because, unlike global corporations like Hyatt and Hilton, the more than 1.3 million small businesses in L.A. County, many of them women and BIPOC-owned, are the backbone of our local economy. Working families spend their money where they live, which

makes Measure RW an even bigger deal for this amplified impact, known within economics as the multiplier effect.

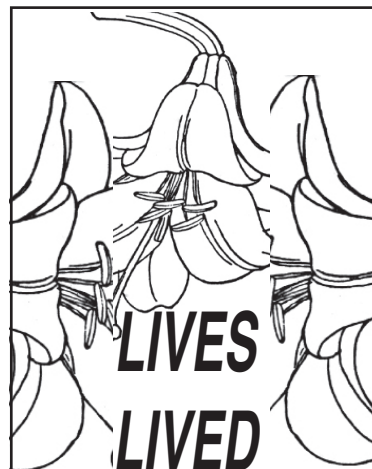
