# Long Beach hopes to open youth-only homeless shelter in early 2025

ong Beach announced the beginning of its youth-focused homeless shelter Tuesday morning, for people between the ages of 18 and 24 at risk of or already experiencing homelessness

The Youth Shelter and Navigation Center will be located at 1718 Hayes Ave., and will provide 12 beds for temporary shelter year-round for Long Beach youth.

"The Long Beach Youth Shelter and Navigation Center will provide a safe haven and lifeline for young adults who need our support at their most vulnerable moments," said Mayor Rex Richardson at a press conference Tuesday morning. "By placing a focus on youth, we can prevent a lifetime of homelessness for future generations."

Long Beach will begin the \$4.1 million renovation of the 5,400 square-foot building in February, with an expected opening estimated for early 2025. Once open, the center will offer beds, supportive services, connection to case management, restroom and shower facilities, laundry facilities, a kitchenette and a lounge area.

The center will also offer daily storage for people experiencing homelessness and working to access resources through the Multi-Service Center (MSC) in Long Beach, regardless of their age.

In order to access the center, people will need to obtain a referral from the MSC or one of the city's Mobile Access Centers. Transportation to the center will be provided by the city, if needed.

hen PLACE Long Beach co-founders Ashley Aguirre and Sarah Bennett received a 30-day vacate notice for their downtown Long Beach storefront, they questioned, briefly, if it was a sign to hang up their ink-stained aprons and take a break.

Long Beach and the surrounding community responded with a resounding opposition to that notion by donating over \$5,000 in 24 hours, guaranteeing the affordable print-studio-workshop-hub-media-lab (and much more) will not be forced to shut its doors.

"We have a group chat right now and we keep talking about how we've been crying all day, to see that happen," Aguirre told the *Signal Tribune* on Monday. "Seeing what people are writing about us has given us a new resolve that we're going in the right direction, there's a community benefit with what we're doing."

# LB releases plans to update two of city's oldest parks along Ocean Blvd.

ong Beach released its plans for two of the city's oldest park spaces downtown which span over 100 feet across multiple blocks and haven't been updated since the 1980s.

Victory Park and Santa Cruz Park, established in Long Beach in 1889 and 1919 respectively, act less as traditional park space and more as independent strips of green space adjacent to downtown buildings along Ocean Boulevard from Golden Avenue to Shoreline Drive.

The City hopes to link these areas to create a cohesive recreational area, and the Long Beach City Council will review the updated guidelines for those plans on Feb. 6. The guidelines identify the different ways the City can redesign the spaces through furnishings, landscaping, signage and other elements to link the 19 spaces with one another.

Each park segment is designed to have 15 feet of a "Frontage Zone," with a cohesive design to link all the segments, and 30 feet of a "Flex Zone," where various uses and designs can be implemented. Those elements can be seating, plants, monuments, hydration stations, bike racks, public art or lighting.

The guidelines restrict any park space from being within 80 feet of the already existing buildings in that space, which are all privately owned, and require clear pathways to the buildings that run parallel to the park space.

All costs associated with the design, installation and maintenance of the park segments will be covered by the property owners of the buildings adjacent to the park spaces.

Core principles for the guidelines include offering a variety of experiences

Center is funded by \$1.8 million from Measure A funds, \$1.4 million from California's AB32 Global Warming Solutions Act and \$900,000 from California's Homeless Emergency Aid Program.

"We are proud to welcome the Youth Shelter and Navigation Center to our West Long Beach community," said Councilmember Roberto Uranga at the press conference. "Our goal is to ensure that youth who are experiencing homelessness in Long Beach have a safe place to stay and the resources they need to thrive."

The building will need new interior walls, doors, showers, restrooms, interior ceilings, lighting and exterior paint. Long Beach will also provide sidewalk and driveway improvements in front of the building.

Residents can visit longbeach. gov/homelessness for updates on the City's efforts to reduce home-

and uses across the areas, not interfering with existing residential uses, using sustainable materials and improving pedestrian access.

Other cities with linear parks helped to inspire some of the design elements in the plan, including Patricia's Green in San Francisco, Ricardo Lara Park in Lynwood, the Lincoln Road Mall in Miami, Rail Park in Philadelphia and Klyde Warren Park in Dallas.

Long Beach hosted a community outreach event covering the guideline update for Santa Cruz and Victory Park in 2019. Since then, the City has had multiple meetings with property owners who will be impacted by the park spaces.

For the flex zones, the staff report encourages shaded areas for community gathering, moveable furniture and areas that are designed with safety and accessibility at all hours. The guidelines also identify multiple ways to redirect stormwater, such as porous surfaces, decomposed granite floors and green-focused infrastructure.

Plans for the parks include historical design elements highlighting the history and culture of Downtown Long Beach, such as large-scale maps etched into the ground across the segments, public art and signage explaining its connection to the city, images etched into benches and more.

Other recommended features include pet waste collection stations, rubber surfaces or swings for play and spaces for temporary rotating art installations.

The Long Beach City Council will review the updated guidelines for Victory and Santa Cruz Park at its Feb. 6 meeting, taking place at the Long Beach City College Liberal Arts Campus (4901 E Carson St.) in Building T, Room 1100 at 5 p.m.

Parking is available at the PS1 Parking Structure (on map, entry off Clark Avenue). The meeting will also be live streamed on longbeach. gov/LBTV or youtube.com/longbeachtelevision/streams.



# Long Beach's Youth Participatory Budget kicks off second year

The Long Beach Department of Health and Human Services will partner with youth organizations like Khmer Girls in Action for the return of the Youth Power Participatory Budget.

The participatory budgeting process allows Long Beach residents ages 13 through 26 to vote on how to spend public dollars in their community for youth-oriented projects and organizations.

"Long Beach is a leader in empowering youth and young adults," said Mayor Rex Richardson in a press release. "The youth participatory budgeting process allows young people themselves to decide on which projects best support positive youth development.'

A total of \$400,000 will be funded through this process. Projects with budgets ranging from \$10,000 to \$75,000 will be voted on by youth who live, work or play in Long Beach. The winning proposals will be funded this summer through Measure US.

An information session took place at the Office of Youth Development (6335 Myrtle Ave.) on Thursday, Jan. 25, from 4 to 6 p.m. to kick-off the idea collection phase

and submit ideas.

"We're thrilled that the Youth Power PB Long Beach process can continue to strengthen shared governance, build community connections and expand a multi-racial democracy in Long Beach," said Acting Health and Human Services Director Alison King in a press re-

The Youth Power PB Long Beach will be carried out in three phases:

Phase 1: Idea Collection. Through Feb. 18, youth ages 13 to 26 years old and youth-serving organizations in Long Beach can submit ideas for projects to be funded with Measure US Youth Fund dollars.

Phase 2: Proposal Development. In late February, youth participants will select from the pool of project ideas. Those selected will move on to the proposal development phase. The selected project ideas will be developed into proposals to be put on a ballot for youth to vote on.

Phase 3: Voting. Youth throughout Long Beach will be invited to vote over a 10-day period on which projects should be funded. Voting will begin in April and will be open to people ages 13 to 26. Voting must be done in-person at designated voting sites such as teen centers, libraries and high schools. More information about voting centers will be available at a later date.

Last year's Youth Power PB Long Beach included 60 initial ideas submitted with 19 selected by youth budget delegates and placed on the ballot. A voter fair was held at Long Beach City College, and voting locations were placed at high schools, teen centers and public libraries throughout the voting week. A total of 823 votes were validated.

Programs prioritized by youth voters centered on community care, housing, health and wellness and transportation - aligning with four of the six goals in the Long Beach Youth & Emerging Adults Strategic Plan.

Youth Power PB Long Beach, the first citywide participatory budget pilot process, funds projects by non-profit organizations who are doing work aligned with the Youth and Emerging Adults Strategic

# Long Beach may expand electric shuttle program to more locations

Long Beach is looking to expand the operation of the micro-shuttle program that was launched in November 2022.

The micro shuttles run by Circuit Transit offer free rides in Belmont Shore and Downtown Long Beach near the waterfront in small electric golf cart-like shuttles.

Currently, the shuttles operate from Thursday to Sunday in the service areas and can be hailed via the Ride Circuit app.

On Feb. 6, the City Council will vote on an agreement with the

South Coast Air Quality Management District to receive \$410,734 in grant funding and expand the shuttle program's area of operation to connect the two current service areas until early 2026.

By connecting the Downtown Long Beach and Belmont Shore areas, the shuttles will also be operating in Alamitos Beach and along Ocean Boulevard.

The Council hopes that the program will attract new riders and visitors to move around the high-traffic areas of Long Beach with less reliance on personal vehicles.

Along with expanding the routes, City Council will also consider ex-



The month-long festivities will include musical performances, special storytimes and much more.

PLACE instead will be moving 10 blocks north into the Wrigley neighborhood, and perhaps by a stroke of kismet, or maybe good karma, they are entering a larger location with more sinks, cheaper rent and an artsy next door neighbor: the Xela Institute of Art.

They expect to be moved in by March and have doubled their donation goal to help the shop pay back the \$3,000 they owe for their printer's service contract through April.

Aguirre and Bennett created PLACE LB in 2022 with one core value: to provide a community space with creative resources where no one is turned away.

Bennett, with a journalism and zine-making background, had been hosting creative Sunday gatherings with friends and wanted to share her artistic piety; Aguirre, whose passion lay more with audio and visual media, wanted to expand her physical media interests.

Bennett dug up an eight-year-old manifesto for hosting a community space, which became the pillar for their values, and still hangs in the shop. Shortly after, they were joined by Beaux Mingus, a filmmaker and arts educator who runs Long Beach Community Arts Media which is housed in PLACE.

Mingus leads the arts education programming alongside Cindy Macias, who is responsible for the Second Sundays programming.

"We've been sustained by teaching each other and maintaining the space and the ethos that art and arts education should remain accessible to people," Aguirre said. "We've transformed into a gathering space and a community space with access to resources."

PLACE LB is now exploring ways to deepen their community roots and allow for a greater sense of ownership and pride by turning their mission into a co-op, or cooperative. The business model functions by having the people who use the products and services also run and operate the company.

The trio hosted their first meet-

ing with longtime supporters on Jan. 29 to discuss what this may look like and what the community would be able to invest. Before the meeting, Aguirre told the Signal *Tribune* that they want people to be able to invest through time running the shop, using their skills to run a workshop or through a financial investment.

"When we're talking about models and the core of what's important to us, it's about meeting people where they're at," Aguirre said. "We always want to have the core value of 'If you want to create something and don't have the means, you don't get turned away."

Running the shop has been a continued display of faith and flexibility. They fronted the money to rent a storefront and purchase equipment, and were thanked through donations, high praises for their workshops and an outpouring of advice and inspiration.

Thanks to donations, the shop has been able to experiment with a sliding scale for the costs of printing, allowing anyone to afford their services.

Part of the transformation has also been through the programming that PLACE offers, which changes based on the suggestions and needs of the community. The print shop has hosted workshops about shooting film on Super 8 cameras, sewing, zine-making and more as well as synthesizer labs, artist talks and panels, 16mm film screenings and Second Sunday pop-ups.

neighborhood of Long Beach on Jan. 29, 2024. The shop will be relocating to the Wrigley neighborhood in March.

"We're proud of building something alongside what the community needs and what they're asking for," Aguirre said. "It's been an affirmation that that's how you build community."

They've also turned to various organizations around the country for inspiration, from the Soapbox in Philadelphia and Rock Paper Scissors Collective in Oakland to Oregon's Independent Publishing Resource Center and Wasted Ink Distro in Arizona; all groups that have given their community the chance to document their history and tell their stories.

A book diving into the sinceclosed The Detroit Printing Coop was also a source of inspiration, Aguirre said.

Aguirre mentioned her "pie in the sky" dream would be to occupy a city-owned space for local creatives who can have 24-hour access. She said during zine fests, the group is often in the store well into the morning, and would like to offer others "a safe place to work at, so you don't have to go to a bar and have a drink to have that community with other artists."

As of now, PLACE will continue hosting the workshops slated for February in its current location at 930 Pacific Ave. and is asking for donations to pay off printing equipment services on GoFundMe.

The shop is planning on throwing "one last, big loud community party" through a synthesizer lab slated for late February.



# HISTORY On the Hill



# The Yankee Dons

In the 1840s the area now called Signal Hill, contained within the Ranches of Los Alamitos and Los Cerritos, fell into the hands of merchants Abel Stearns and Jonathan Temple. Stearns bought Rancho Los Alamitos in 1842 for \$6,000. One year later, Temple purchased Ranches Los Cerritos for \$3,025.

Stearns and Temple were of a class of immigrants to California known as "The Yankee Dons." Both had migrated from a New England, converted to Roman Catholicism, and become naturalized citizens of Mexico. (In the 18405 Mexican citizenship was required of all California landowners.) Both merchants learned to speak Spanish and married daughters of local prominent families. ~ '

Stearns married 14-year-old Arcadia Bandini in 1841. In those days it was not unusual for young women to marry early. Stearns, however, was 43. Despite the couple's age difference, it was said to be a happy marriage.

Stearns, also known as "Don Abel" to the locals, renovated a four-room adobe on Rancho Los Alamitos for his young bride. On a bluff overlooking the Rio San Gabriel, "Duan Juan" Temple built the central adobe structures of Rancho Los Cerritos: a 100-foot long, twostory main living area adjoined by\_two 140-foot long

Stearns and Temple both ran successful cattle ranches which, until 1848, supplied a lucrative hide and tallow market. That year, after the California Gold Rush began, Stearns and Temple switched to raising feed cattle, to supply meat to the rapidly growing population of Northern California. Stearns recorded that during this population boom about 25,000 to 30,000 cattle were sold annually from Los Angeles County, at prices as high as \$75 per head (compared to a pre-1848 price of \$3 per head.)

During the heyday of The Yankee Dons, a friendly rivalry broke out between Stearns and Temple. Each of their Ranchos staffs, including field hands, cooks, maids, dairymen, blacksmiths and vaqueros (cowboys), would gather in late spring atop Signal Hill for an annual horse race. These racing festivities including 'feasting, drinking wine and dancing. Betting was heavy. Their racetrack was a dirt path that ran from the crest of Signal Hill to the bluff overlooking the ocean (near the current site of the Villa Riviera on Ocean Boulevard.) There, the horses would round a stake and race back up to the Hill. The most famous winner of these races was "El Beserero", 'a prize bay owned by Don Juan Temple.

By the mid 1860's, the prosperity of Stearns and Temple came to an end. Successive years of flooding and severe drought killed thousands of cattle. Facing financial ruin, Steams defaulted on his mortgaged Rancho Los Alamitos in 1866. The Rancho passed into the hands of Micheal Reese. That same year, Temple sold Rancho Los Cerritos to a land company, Flint, Bixby and Co., for \$20,000. In a little over 20 years time; both Yankee Dons had made and lost a sizable

daring escape from Georgia in 1848 by posing as master and slave. The couple's resilient plan takes them through hundreds of miles to freedom in the North before being forced to travel overseas to escape slave catchers.

"MASTER SLAVE HUSBAND WIFE" received widespread critical acclaim, was named on the New York Times "10 Best Books of 2023" list and was declared the best book of the year by publications such as Time, National Public Radio and The New Yorker.

In the Deep South during the 1950s and '60s, Preacely fought against segregation, taught literacy and registered Black voters as a Freedom Rider and (still active) member of the Student Non-Violent Coordinating Committee. She is also one of the nine great-grandchildren of the book's subjects Ellen and William Craft.
