The youth have spoken: nine nonprofits chosen for youth summer projects

From driving lessons and financial literacy to self-defense and poetry, Long Beach youth have used voting power to fund summer projects of their choosing.

Nine local nonprofits were awarded a total of \$400,000 through the second annual Youth Participatory Power Budget. Over 600 Long Beach youth between

the ages of 13 and 26 voted online or in-person for summer programming of their choosing.

"Participatory budgeting is the first foray into civic engagement for many young people in Long Beach," said Mayor Rex Richardson in a statement from the City. "This process supports and empowers youth by making a direct impact on their community."

Voters could nominate up to four nonprofits to receive funds, with LGBTQ-focused Devotion

Fitness garnering the most votes from youth with 208. Some summer projects will run for one week, while others will last for the duration of the summer.

Funds are being distributed by the Long Beach Department of Health and Human Services, The Nonprofit Partnership, Invest in Youth Coalition anchored by Khmer Girls in Action, and the Cal State Long Beach Department of Geography. Grants range from \$25,000 to \$50,000. Funding for

the Youth Power PB Long Beach program is provided by Measure US.

The nine nonprofits and accompanying summer programs include:

208 Votes: Devotion Fitness (Health & Wellness) \$50,000 – Sunset Boxing and Wellness will offer 12 weeks of outdoor boxing, sound baths and picnic-paint & skate nights this summer for emerging adults ages 18 to 26

 105 Votes: *West Coast Credible Messengers (Health & Wellness)* \$50,000 – Artful Resistance and Break the School-to-Prison Cycle will address the community priority area of physical, mental and emotional wellness in Long Beach by providing teens and emerging adults with opportunities for creative expression, personal development and community engagement. Through workshops focused on art, poetry and collaborative projects, participants will explore themes related to the school-to-prison pipeline, build awareness of systemic barriers, and develop skills to resist oppression and advocate for change.

(13-17 year olds may participate by completing a parental consent form). Devotion Fitness programs help young adults navigate life by relieving stress, providing an inclusive space to exercise, and creating a lifelong community.

175 Votes: *Our Generation Cares (Transportation)* \$50,000 – Car and Driver 101: Drive Smart, Own Responsibility will take a comprehensive approach to increasing access to safe and affordable transportation for youth and emerging adults. From interactive lessons to exciting field trips, Car and Driver 101 transforms beginners into skilled drivers and instills a sense of control and independence. With classroom instruction, practical driving lessons using a real-car-driving simulator and a loaner vehicle for youth to take the DMV test, this program ensures

that participants have access to the resources necessary to obtain their driver's license.

150 Votes: *spcaLA (Community Care)* \$25,000 – spcaLA Friends for Life Summer Camp will provide 40 scholarships for their Friends for Life Summer Camp to youth ages 12 to 15 who reside in the 90804, 90805 and 90813 zip codes. In addition to regular camp activities – dog training, cat care, games and activities – this week-long camp will offer an expanded curriculum around anger identification, conflict solving, empathetic choices, anti-bullying and kindness towards others.

136 Votes: *Success in Challenges (Housing)* \$50,000 – YEAH! - Youth Education and Adjustment Housing will provide stable housing, community support and life skills training. Their holistic ap-

proach addresses the distinct needs of homeless transitional-aged youth. Workshops include financial literacy covering topics like credit scores and budgeting. The program ends with a graduation, stipend and certificates.

132 Votes: *Mission Muay Thai (Community Care)* \$42,700 – Punch to Protect, Kick to Defend will provide youth with a self-defense program that helps foster personal growth, discipline, and community spirit to empower and protect our youth through situational awareness. Youth will access the protective knowledge by learning the art of eight limbs including punches, kicks, knees, elbows and defensive tactics to protect the body from potential threats.

131 Votes: *Elite Skills Development (Planning for the Future)* \$50,000 – EmpowerED: Life

Skills for Success will provide youth and young adults of Long Beach the knowledge, practical skills and abilities to set themselves up for future success. They will provide workshops and hands-on experiences with expert mentorship from field professionals that will help build individual independence, resiliency and economic equity.

128 Votes: *M.O.R.E. Mothers (Health & Wellness)* \$50,000 – Summer Full of Art Program provides youth ages 8-13 a safe and supportive environment to grow, learn and develop creatively. This program allows youth to explore their creativity through painting, drawing, creating vision boards, clay making, photography and free admission to local museums. Designed for youth with all abilities, this program will teach awareness, acceptance, community building

85 Votes: *Future Innovators (Transportation)* \$32,300 – Career CruiserLB – Youth Transport provides a weekly accessible and reliable transport service to support the youth and emerging adults of Long Beach in getting to career workshops, job fairs, hiring events, networking opportunities, visiting corporate campuses, and other job search activities. This weekly transport service will be provided to all those keen to participate in a weekly Career Workshop which will prepare youth with the skills and confidence needed to land a great job, internship or perhaps even explore further education.

Mayor Richardson to award five Long Beach community members with 2024 Keys to the City

On Tuesday, Long Beach Mayor Rex Richardson announced five recipients for the 2024 Keys to the City.

Gabriel “Fluffy” Iglesias, Samuel “Skip” Keesal, Beth Keesal, Rev. Dr. Leon Wood and Paula E. Wood will receive this civic honor for their service to Long Beach.

“Each of these extraordinary people represent the best of Long Beach, whether it be through philanthropy, service to the community, or representing our city to the world at large,” said Mayor Rex Richardson in a public statement from the City. “We are thrilled to celebrate their contributions to our community.”

Iglesias spent much of his youth in Long Beach, is an alumnus of Woodrow Wilson High School and is a world-renowned stand-up comedian. Iglesias’ Long Beach origins served as the inspiration for the semi-autobiographical television series “Mr. Iglesias,” about a history teacher who returns to teach at his former high school.

Iglesias will receive his Key to the City from Mayor Richardson during a special comedy show on June 18 at the Long Beach Terrace Theater.

Prior to the show, there will be a job and resource fair for local youth beginning at 6:30 p.m., as well as food trucks and bars for 21+ attendees. The show will begin at 8 p.m. and feature Iglesias’s long-

time collaborator comedian Martin Moreno as the opening act.

Long Beach youth between the ages of 16 and 24 years old may request a free ticket for the show from their city councilmember’s office while supplies last. General admission tickets for the performance are on-sale for \$15 via Ticketmaster. Partial proceeds from ticket sales will go towards The Mayor’s Fund for Long Beach and Mayor Richardson’s S.T.R.O.N.G. Beach initiative.

“I’m honored to be recognized by my hometown in this way, and I’m proud to be able to support Long Beach’s youth at the same time,” said Iglesias in a public statement from the City. “If you’re a kid growing up in a tough situation, you might not believe that there’s a whole other world out there waiting for you—but there is. I’m proof of that, and you can be too.”

Skip Keesal is a graduate of Cal State Long Beach and founded the law firm Keesal, Young & Logan in Long Beach in 1970. The firm now has five offices worldwide and has donated close to \$7 million to local charities since 1991 and the firm hosts an annual luncheon in support of the Boys & Girls Club of

Long Beach.

Skip and his wife Beth have several local philanthropic ties and continue to serve on boards of community charitable organizations. Skip currently sits on the Board of Governors for Cal State Long Beach, is an active participant of the Long Beach Police Foundation and the Los Angeles Coalition for the Economy & Jobs in Los Angeles, and is a member of the Century Club of Long Beach.

Rev. Dr. Leon Wood has had a lengthy career in education, ministry and activism and he serves as the president of the local social service nonprofit Success in Challenges.

Paula E. Wood is the executive director of Success in Challenges and has engaged with local youth through various agencies such as the Long Beach YWCA, Children’s Home Society of Long Beach and the United Way. Paula is also an active member of several local organizations such as Freedom School and the African American Network for Violence Free Relationships.

The Keesals and the Woods will receive their Keys to the City at the start of the Long Beach City Council meeting on July 16 at 5 p.m.

50 City internships up for grabs through the Long Beach Public Service Corps

Local college seniors can apply for 50 paid City internships through the second round of the Long Beach Public Service Corps.

The fellowship program launched last year to connect students to roles in local government, nonprofit management and public service by partnering with multiple City departments. Participants will gain practical experience and develop hands-on skills for various “in-demand occupations,” according to a statement from the City.

Students at Cal State Long Beach, Cal State Dominguez Hills and Long Beach City College with a senior standing or those with 30 completed units at LBCC are invited to apply by June 30. Long Beach Public Service Corps applicants must be between the ages of 18 and 30 before the first day of the program, which will run from October 2024 to May 2025.

“We are committed to nurturing the next generation of leaders in public service,” said Mayor Rex Richardson in a public statement. “The Public Service Corps program

provides college students with a unique chance to make a meaningful impact in our community while gaining invaluable real-work experience. Paired with wraparound services and job counseling, this program is changing the way we offer workforce development opportunities for our residents.”

The 50 students chosen for the program will work alongside professionals, learn the inner workings of local government, contribute to City projects and have a direct impact on the Long Beach community. Participants will also be invited to developmental workshops with topics such as public service, budgeting, community engagement, crisis management, sustainability, ethics and policy.

The Long Beach Public Service Corps is intended to foster economic inclusion by developing career paths for local youth.

City Politics in Chaos

In October 1958, a disruptive power struggle broke out between Signal Hill's City Council and its Police Department. It continued for the next 18 months. The smoldering issues underlying this political clash were the unmet demands for a raise by the police and fire departments and a petition before City Council to reinstate legalized gambling in Signal Hill. When the president of the Signal Hill Police and Fire Association became frustrated with the uncooperative stand that City Council took on these issues, he led a fight to recall some members of the Council.

This dispute really heated up, however, when the City Council unanimously ordered the dismissal of Captain Travis F. Oltman for misconduct. Captain Oltman was accused of changing the booking of a Mr. George Cilley from drunk driving to "plain drunk," and directing that his bail be reduced from \$525 to \$25. At the time of his arrest, Cilley's drivers license had been suspended due to a pending drunk drive charge in Los Cerritos Court. Cilley's Signal Hill arrest records were falsified and his sobriety test result destroyed, allegedly upon Oltman's orders.

The Signal Hill Police Department reacted to the City Council's action against Captain Oltman with a fury. Protests at the October 6, 1958 council meeting which approved Oltman's dismissal were loud and frequent. One resident even invited Mayor Benjamin Moyle to "come out and fight."

Two weeks later a hearing on the dismissal of Oltman was held by the Los Angeles County Civil Service Commission. The hearing lasted nearly six hours and was full of conflicting testimonies from all witnesses and parties involved. One witness, Officer Bellot, even went so far as to accuse Mayor Moyle himself of requesting that the drunk driver's auto tow records be falsified!

On October 29, 1958, the Civil Service Commission ruled that Oltman was not guilty as charged. They cited the witnesses' conflicting testimonies as problematic, making a clear decision of guilt or innocence impossible. The City Council, in turn, voted four to one to overrule the finding of the Commission. Oltman responded by vowing to take the case to Court and seek reinstatement. His attorney, Robert Buck also headed the movement to petition a recall of City Council.

When City Council subsequently asked Police Chief Heier to fire two other patrolmen involved in testimonies given before the Civil

Service Commission investigating Oltman, Chief Heier refused and resigned. The crowd who witnessed Heier's resignation at the November 3, 1958 council meeting were in an uproar. City Council then appointed Sergeant Robert Hunnicutt as acting Police Chief.

By early December 1958 the recall petitions filed against Mayor Moyle, Councilman Hautly, and Councilman Vaughn were rejected by the City Clerk. The petitions carried only 453 signatures, 98 short of the 551 needed to represent 25% of Signal Hill's registered voters.

In February of 1959, Oltman filed suit against the City, asking for reinstatement to his former position and full back pay. He charged that the Council did not have the right to remove him after the Civil Service hearing had failed to find him guilty.

One month later, the battle between City Council and the Signal Hill Police and Fire Association developed a new twist. The City Council met with officials of the Los Angeles Sheriffs Department to discuss the Sheriffs department taking over the operation of the Signal Hill Police Department. A meeting was also planned with the County Fire Department to discuss a take over of the Signal Hill Fire Department.

Meanwhile, on March -18, 1959, a Superior Court Judge ordered the City to reinstate Oltman as Police Captain, effective immediately. According to the Court, City Council was technically wrong to fire Oltman, as this must be done by the Police Department head.

By the end of March, City Council (in a vote of four to one) approved a contract with the County of Los Angeles for the operation of the Signal Hill Police Department. The dissenting vote was Councilwoman Nellie Combellack's. She made a motion to set up a citizen's committee to examine the issue before any action was taken, but her motion did not get seconded. Ten citizens present at the council meeting spoke up and opposed the move, expressing that there had not been enough time to find out all the ramifications of the contract before it had been approved.

Little did this City Council foresee that their rush to replace Signal Hill's Police Department with a County Sheriffs' operation would ultimately hasten their own political downfall in the fall of '59.

As Long Beach continues its Pride Month celebrations, LGBTQ+ artists will take center stage during “The Power of Visibility: Boldness in LGBTQ+ Art,” on display at the Rod Briggs Gallery through July 20.

For this group exhibition, 58 pieces by 29 artists were selected by jurors Lucas Gordon, Brian Trimble and Jenson Titus. The Long Beach Creative Group (LBCG) will celebrate the exhibition with two opening receptions on June 22 and June 23 at the gallery.

“Visibility is the first step towards equality. Art has the power to make the unseen seen, and the unheard heard. Through the lens of art, we can shatter stereotypes, challenge prejudices, and pave the way for a more inclusive and understanding world,” said Travis Stock-Tucker, exhibit coordinator, in a recent statement from LBCG.

Long Beach Creative Group is a collective of locally-based artists and art lovers who banded together to empower Long Beach artists by

showcasing their work in a community setting. LBCG has hosted several art exhibitions at the Rod Briggs Gallery since 2019 as well as several art-focused community events.

LBCG is supported by the Briggs Family Trust and receives sponsorships from the Port of Long Beach and the Arts Council for Long Beach.

“This exhibit is a continuation of our commitment to connect with, and showcase, the diversity of our city’s complex creative community, and to amplify voices that might not find opportunities elsewhere,” said LBCG president and founder Marka Burns in a recent statement from the art collective.

LBCG will be host three special events tied to “The Power of Visibility: Boldness in LGBTQ+ Art” during its month-long display:

The History of Stonewall: Friday, June 28 at 6 p.m. This event will be a discussion of the ongoing history and legacy of gay activism, with a special focus on the Stonewall uprising in 1969, a pivotal moment in the gay rights movement.

Movie Night: Friday, July 12 at 8 p.m. LBCG will host a screening of the 1990 documentary film “Paris is Burning,” which provides a heartfelt insight into New York City’s drag ball culture in the late 1980s. While looking into the lives and passions of African American and Latino members of the various “houses,” director Jennie Livingston documents the subjects’ experiences with poverty, AIDS, racism, homophobia and transphobia.

Strut Your Stuff: Saturday, July 20. The exhibition will close with a costumed ball inspired by the drag performances depicted in “Paris is Burning.”

“The Power of Visibility: Boldness in LGBTQ+ Art” will be on display from June 22 to July 20 at Rod Briggs Gallery, located at 2221 E. Broadway. Tour Long Beach’s smallest art galleries this Saturday

Several pint-sized galleries across Long Beach are reshaping how art is experienced and appreciated in the community. Step into the whimsical world of micro-galleries this Saturday, when front yards will be transformed into tiny art havens during this first-of-its-kind art crawl.

The public is invited to tour seven of Long Beach’s littlest art galleries during the art crawl on Saturday, all located in front of the homes of local residents and displaying a wide variety of work by different artists: including paintings, 3D art, collages, multi-media art and more.

Micro-galleries are similar in size and shape to the Little Free Libraries that have grown in popularity

throughout Long Beach. The first micro-gallery in Long Beach, The Monarch Gallery, splits its time between functioning as a Little Free Library filled with books and a gallery displaying the work of independent artists.

“I think we sort of proved the concept worked, which was to create a tiny opportunity, but a consistent opportunity, for artists to show their work and people to get involved,” said Sean Cully, creator and curator of The Mantel Gallery. Sean and his wife Nicole, who runs the Little Free Library, started planning the art crawl months ago after remarking on the spread of micro-galleries in the area.

During the art crawl, The Mantel Gallery will be displaying work by Los Angeles-based multidisciplinary Xiaoxiao Wu. Her work will be on display in the micro-gallery through June 30.

“We noticed that there are all these other little galleries like ours that have popped up, and we know we’ve been to other art crawls for larger galleries and it seems like those always get better turnout [...]” Sean told the *Signal Tribune*. “It felt like a fun way to highlight the work that we’re all doing and to create buzz around our gallery and other galleries that are doing the same thing.”

One of the artists that exhibited at The Mantel Gallery, Dave Clark, and his wife Carol were inspired to create their own micro-gallery in

front of their home.

“My favorite thing is when I’m sitting in the kitchen, and I look out and see people come across it and are totally blown away by it [...] You can tell by the way they are responding,” said Carol Clark. “That’s what means the most to me.”

Dave built the couple’s micro-gallery, and organized an inaugural exhibit by local artist Cody

Lusby in June 2023, during which one of the Clark’s neighbors expressed his desire to have his own gallery in front of his house. Dave obliged, and began offering to build a micro-gallery for anyone in the area who wanted one.

He charges \$450 for materials, and said he doesn’t want to make a profit or turn it into a business. So far he’s created six micro-galleries

throughout Long Beach, as well as two others in San Pedro and Lomita.

Four of the micro-galleries included in Saturday’s art crawl were built by Dave: Gallery 17 (2483 Eucalyptus Ave.), Gallery 23 (2489 Eucalyptus Ave.), Gallery 30 (2543 Eucalyptus Ave.) and Gallery 99 (3461 Woodruff Ave.).

Gallery 17 is displaying an abstract painting by Amy Hernandez; Gallery 23 is displaying a 3D work of painted plexiglass by Stephanie Sherwood; Gallery 30 is displaying a colorful collage by Kellie Crackle; and Gallery 99 will be displaying a mixed media work on wood by Kevin Sarabia.

The Black Box Microgallery and the Tiny Art Gallery have not yet publicly announced which artist’s work will be on display during the art crawl.

“Our goal was to build an alternative venue for artists to show in that allows the public to see it without having to worry about, you know, business hours or whatever,” Dave told the *Signal Tribune*.

The art crawl will be held on Saturday from 1 p.m. to 6 p.m. Artwork will be displayed at Gallery 17 (2483 Eucalyptus Ave.), Gallery 23 (2489 Eucalyptus Ave.), Gallery 30 (2543 Eucalyptus Ave.), Gallery 99 (3461 Woodruff Ave.), The Mantel Gallery (3539 Fanwood Ave.), the Tiny Art Gallery (5140 E Brockwood St.) and Black Box Micro-gallery (7119 E Metz St.).

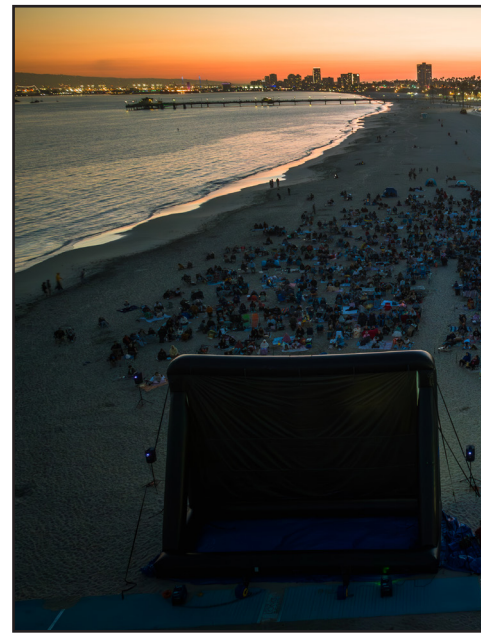

Children 18 and under can get free lunch at 25 locations all summer

School is out for the summer, but kids don't need to miss out on a nutritious, free lunch Monday through Friday. For the 45th year in a row, Long Beach and the United States Department of Agriculture (USDA) will hand out daily lunches to kids 18 and under from June 17 through Aug. 23.

"Ensuring that our children have access to nutritious meals over the summer school break has been a cornerstone of our summer youth services for over 40 years," said Mayor Rex Richardson in a statement from the City. "The Summer Food Service Program not only helps combat food insecurity but also promotes healthy eating habits among our youth."

The 25 parks and libraries in Long Beach and Signal Hill will provide a well-balanced meal consisting of milk, juice, fruits and vegetables. No registration is required to receive a lunch, but infant meals will not be provided. Meals must be eaten at the location.

Lunch will not be offered on holidays: June 19 and July 4.

The Summer Food Service Program began in Long Beach in 1979 and has since provided more than two million meals to children and teens ages 1 to 18 years. The program was established to ensure that during the school summer break, children would be able to receive the same well-balanced meals they

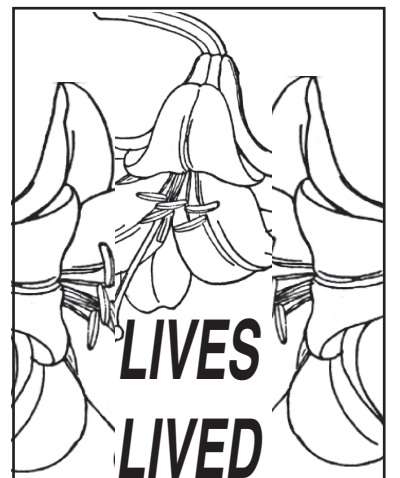

The Signal Hill Petroleum Conditional Use Permit 97-03 Extension Project (Project) would not significantly alter or expand the scope of SHP's existing operations. No significant expansion of existing facilities or structures is proposed, and all operations (existing and proposed) would continue to occur within the existing CUP drill site footprints. SHP proposes to install new equipment at the existing natural gas processing facility at CUP Site #2 and drill up to 46 new wells at the seven drill sites over the 20-year period of the CUP. All other operational activity, such as site maintenance, inspections, redrilling, well operation, and fluid processing would remain the same. SHP would continue to operate the CUP facilities (drill sites and central processing facilities) in accordance with the existing City Municipal Oil and Gas Code, conditions of approval, and mitigation measures, and in continued compliance with existing county, state, and federal requirements, including those published by the California Geologic Energy Management Division (CalGEM), the State Division with authority over oil and gas operations.

SHP is seeking to modify CUP 97-03 as follows:

1. Extend the life of the CUP by an additional 20-year term, to expire in 2042.
2. Continue existing consolidated drill site operations, including drilling new wells within the existing CUP footprint on an as needed basis.
3. Install upgrades to a natural gas processing system at Drill Site #2.

The Alamitos Beach Wibit is located south of Ocean Boulevard and east of Shoreline Drive and features springboards, bouncers, monkey bars and other elements. The Bay Shore Avenue Wibit is lo-

cated at 5415 East Ocean Blvd. and includes multiple climbing structures, bouncers and domes.

The following rules apply to all Wibit participants during Long Beach Lifeguard supervised hours of operation, from 10 a.m. to 7 p.m. daily, at both aquatic playground locations:

- All participants (adults and children) are required to pass a swim test prior to accessing waterplay features.

- Each child under 9 years old must be accompanied by a parent/guardian.

- Life jackets and personal flotation devices are not permitted while utilizing waterplay features.

“Residents have been waiting for the return of these fun floating structures at Alamitos Beach all year,” said Vice Mayor Cindy Allen in a public statement. “I’m glad they are back for the summer, and I look forward to seeing residents and visitors climbing, jumping and having a blast in the water.”

Lifeguards are not guaranteed to be on duty if they are called to an emergency, according to a statement from the City.

Juneteenth holiday schedule for City buildings and services

This weekend, multiple Juneteenth celebrations will take place in Long Beach to celebrate Black culture and unity. The Long Beach Juneteenth Celebration will feature music performances, poetry and activities at Rainbow Lagoon Park Saturday.

Also on Saturday, the Juneteenth Festival and Block Party will feature vendors, games, music, dancing and live entertainment at St. Luke Holy Baptist Church from 10 a.m. to 4 p.m.

Juneteenth celebrations will also take place around the Los Angeles region, but the actual holiday falls on Wednesday, June 19.

The history of Juneteenth dates back to June 19, 1865 when African American slaves in Texas were freed at the conclusion of the Civil War, over two years after President Abraham Lincoln signed the Emancipation Proclamation.

In 1979, Juneteenth became a state holiday in Texas, and after decades of legislative efforts at the national level, officially became a federal holiday in 2021 with the passing of the Juneteenth National

Independence Day Act.

Several Long Beach City offices and services will be closed or halted for the federal holiday:

Online Services

Permits, Cashiering/Payment Processing, Utility Customer Service, Billing and Collections, and Parking Citations all have online services. The public is encouraged to continue taking advantage of the online resources available on the City website, including building permit services and bill payment options.

Street Sweeping

There will be no scheduled street sweeping or enforcement of street sweeping violations on Wednesday, June 19. Street sweeping will resume its regular schedule on Thursday, June 20.

Parking Enforcement

Read your parking meter: City-wide parking violations, including parking meters, will be enforced on Wednesday, June 19, unless the meter states “Exempt on Holidays.”

The days and hours of enforcement are displayed inside the meters.

Refuse/Recycling

Refuse and recycling will be collected as scheduled on Wednesday, June 19.

Towing and Lien Sales

The Towing Operations and Vehicle Storage Facility (3111 E. Willow St., between Temple Avenue and Redondo Avenue) will be closed on Wednesday, June 19. Normal business hours are:

- Monday through Friday, 8 a.m. to 5 p.m.
- Saturday, 8 a.m. to 4 p.m.
- Closed Sunday and holidays.

Vehicles and property are available for release outside of the hours listed above for an additional fee. More information can be found online.


Libraries

All Long Beach Public Library locations and services, including the main phone line, will be closed on Wednesday, June 19. Libraries are not open Sundays per their nor-

mal schedule. Library patrons are encouraged to utilize the Library’s vast collection of digital resources, including the Library catalog, downloads, and databases, available 24/7.
