# Second public hearing will be held for Signal Hill Petroleum's oil drilling permit extension

The June 24 public hearing is the last day residents have to comment on Signal Hill Petroleum's proposed 20-year permit extension before the issue goes to the Planning Commission.

he City of Signal Hill will hold a second public hearing on June 24 regarding a possible 20-year permit extension to Signal Hill Petroleum.

Over 50 residents and multiple local environmental organizations attended the first public hearing on June

4 to review and ask questions about the drafted Environmental Impact Report. All of those in attendance asked the City to deny the extension, and several residents asked the City during the meeting to hold a second public hearing due to lack of space and public awareness of the meeting.

The second public hearing will be held in the Signal Hill Public Library's Community Room, which has a capacity of 48 people with tables and chairs, according to the City's Parks and Recreation Department.

The *Signal Tribune* emailed Signal Hill Petroleum on June 6 and June 17 to ask for the company's response to the first public hearing and has not yet heard back.

Public hearings are held in order to give residents the opportunity to ask questions and comment on matters that affect the community. The project under review is the Conditional Use Permit Signal Hill Petroleum has for its seven drilling sites, which contain 62 oil wells.

# Signal Hill adopts budget for Fiscal Year 2024-2025

ignal Hill City Council approved a nearly \$35 million budget for Fiscal Year 2024-2025 on Tuesday, June 11.

"The overall goal is to adopt a structurally balanced budget that serves as the city's financial plan, control city appropriations to pay for city services and activities, and reflect the city council's priorities and strategies," said Deputy Finance Director Siamlu Cox during the presentation to city council.

The budget lays out how the City will spend its money during a fiscal year, and what funding sources it will draw from.

"The budget represents a cautious, optimistic perspective while remaining vigilant of existing challenges," Cox said.

Per usual, the largest portion of the budget was allocated to the Signal Hill Police Department. Of the City's \$34.9 million budget, \$13.9 million was earmarked for the police department.

The amounts set aside for other expenditures are as follows:

- Legislative & Administration \$4.3 million
- Community Development \$1.3 million
- Parks, Recreation & Library Services \$3.1 million
- Finance, IT and Non-department \$5.1 million
- Public Works \$6.9 million

The previous budget for Fiscal Year 2023-2024 was \$34.6 million, with this year's total budget increasing by over \$300,000. In Fiscal Year 2023-2024, the amount allocated for the police department was approximately \$13 million, with that amount increasing by over \$900,000 for this year.

During the budget presentation to city council, staff said that the City plans to bring in \$37.8 million in revenue, with the vast majority of it (\$27 million) coming from sales tax.

As part of its biennial budget planning process, the city council adopted a budget for fiscal year 2024-2025 while simultaneously approving a prospective budget for Fiscal Year 2025-2026. The proposed Fiscal Year 2025-2026 budget

After nearly two years of construction, the El Dorado Duck Pond is ready to reopen, and the public is invited to waddle over and celebrate.

Long Beach will host a grand reopening of the El Dorado Park West Duck Pond on Thursday, June 27. City officials such as Mayor Rex Richardson, District Four Councilmember Daryl Supernaw, along with Public Works and Parks, Recreation and Marine representatives will take part in the ceremony.

"I am excited for the El Dorado Park West Duck Pond to reopen for residents to enjoy once again just in time for summer," said Mayor Rex Richardson in a public statement. "This project is a symbol of our commitment to preserving our city's natural beauty and is a testament to our dedication to creating healthy, safe spaces that foster community, recreation and environmental stewardship."

Long Beach began the \$10 million rehabilitation project in September 2022 with the goals to improve water quality, restore the

pond's liner, benefit the wetlands and forebay, remove invasive species, and plant native plants.

Recreational spaces surrounding the pond will also be open for people to enjoy including a soccer field, amphitheater, playground, open green space, two parking lots and restrooms. Additional upgrades include the walking paths, a new filtration and disinfection system and conservation efforts to allow reclaimed water to service the adjacent golf course.

"The El Dorado Duck Pond is a beloved part of our community. It is a place where folks come to relax, connect with nature, and create lasting memories with family and friends," said District Four Councilmember Daryl Supernaw in a public statement. "I am pleased to see the restoration of this beloved landmark finally complete, and I look forward to celebrating its reopening with members of our community."

The project is supported by Long Beach Measure A, Los Angeles County Measure W grant funding from the Los Angeles County Regional Park and Open Space District Grant, in addition to federal grant funding in partnership with Long Beach Utilities (formerly the Long Beach Water Department).

# Monthly workshops for early childhood development will run from July to December

Parents and caregivers can gain access to speech development, special education and intervention resources for children ages o to 5 through Long Beach's Parent Informational Workshop series.

The second round of this series will be hosted by the Long Beach Public Library and the Department of Health and Human Services. These workshops aim to "ensure Long Beach families experiencing developmental concerns about their child are connected to services in a timely manner."

"These workshops have become a safe space for parents and caregivers to learn about their child's early development, ask questions from trusted local experts, navigate available resources, and connect with other families about shared experiences," said Health and Human Services Director Alison King in a statement from the City.

The Parent Informational Workshops Series will feature six sessions, running from July 18 to Dec. 7 at several Long Beach libraries.

Families will also be connected to a myriad of services and experts at the workshops.

The Parent Information Workshop series also supports the Library's Dive into Learning program, an early learning initiative that supports early education for children ages 0 to 5 by incentivizing reading and providing school readiness and parent education workshops.

The workshop series is supported by Help Me Grow LA, which is a collaboration between First 5 LA and Los Angeles County Department of Public Health. In 2022, the City of Long Beach was awarded as one of seven community collaboratives to receive \$500,000 over the course of three years by First 5 LA. This investment from the LA County agency is intended to strengthen and expand referral pathways to better connect families with services and supports to address their child's developmental concerns.

The investment is part of Help Me Grow LA's effort to improve connections between providers so that every child receives support for developmental concerns.

# Long Beach Public Library's SEED Creative City Lab returns for Summer 2024

The Long Beach Public Library (LBPL) and Dramatic Results are bringing back their SEED Creative City Lab for another summer, with six one-week sessions open to local middle schoolers.

This free summer camp will provide seventh and eighth graders with a five-day crash course in STEAM (Science, Technology, Engineering, Arts and Mathematics) education.

Dramatic Results is a nonprofit educational arts agency based in Signal Hill that has worked with local students through community STEAM programs since 1992.

SEED is a five-year initiative led by Dramatic Results, and primarily funded by the U.S. Department of Education, that organizes programs for underrepresented students in an attempt to create more equitable entry into STEAM.

"By partnering with local artists and organizations, we're creating pathways to success and inspiring the leaders and innovators of tomorrow," said Mayor Rex Richardson in a public statement from the City. "The SEED Creative City Lab embodies Long Beach's spirit of creativity and inclusivity, offering middle school students a platform to explore their passions and un-

lock their potential."

Students will learn skills under the tutelage of STEAM professionals as well as art and design elements from workers in areas of public safety, urban planning, sustainability and more.

If approved, Signal Hill Petroleum (SHP) will be able to drill up to 46 new oil wells and build 46 accompanying well cellars across its seven drill sites over the next 20 years. SHP has received 10 permit extensions since 1998, ranging from six months to 10 years.

Signal Hill City Councilmembers will make the ultimate decision of whether to grant the 20-year extension, approve the extension for a shorter period of time or revoke the permit altogether.

The preliminary finding of the report states that the "environmentally superior" option would be to approve the 20-year permit extension. Multiple residents at the June 4 meeting questioned this conclusion, and Signal Hill Community Development Director said the City would attempt to explain it in later public meetings.

Residents who speak at the meet-

Proposed expenditures for Fiscal Year 2025-2026 are as follows:

Police - \$14.6 million Legislative & Administration

\$4.1 million Community Development - \$1.4

Parks, Recreation & Library Ser-

vices - \$3.1 million Finance, IT and Non-department \$5 million

Public Works - \$7 million

The City plans to have \$69 million in the General Fund at the start of the new fiscal year on July 1, and to end the fiscal year on June 30, 2025 with \$67.1 million. In turn, the City plans to start Fiscal Year 2025-2026 with \$67.1 million in the General Fund, and end it with \$65.1 million.

"Each year we seem to get better and better, and that should always be our goal in everything we do, doesn't matter if it's in finance or whatever. We should always be striving to get better and I think we're doing that," Councilmember Edward Wilson said after the presentation.



# The Astute Politics of Nellie Combellack

There was a group of Signal Hill Councilmen in power in 1959 who became known to their political opponents as "The Four Wise Men" (our town's version of The Gang of Four.) This quartet, consisting of Mayor Benjamin Moyle and councilmen Harold V. Clark, Emil B. Hautly and Frank B. Vaughn, unwittingly committed political suicide when they hastily pushed through legislation which approved contracts with Los Angeles County officials for the operation of Signal Hill's Police and Fire Departments. The maneuver was, in reality, designed to strip the Signal Hill Police and Fire Association of any political clout, while, supposedly, saving the city money.

Councilwoman Nellie J. Combellack cast the only dissenting vote in this matter. At a Signal Hill City Council meeting in March 1959, Combellack made a motion to establish a committee of 25 citizens, each member of the Council to appoint 5, to consider the matter. Her motion was not seconded.

Signal Hill's residents did not react kindly to The Four Wise Men's politically motivated elimination of the city's independent police and fire departments. Moreover, a brand new \$90,000 police station that was no longer being used, stood as a continual reminder to Signal Hill's citizens of the poorly thought of fiscal impact of the contracts for county services.

By October 1959, a special election was held to recall the Four Wise Men from office. The candidates who ran against the incumbent councilmen were endorsed by The Citizens Committee of Signal Hill on a platform dedicated "to restore the voice of the people of Signal Hill" and reestablish Signal Hill's independent Fire Protection, Police Department, free emergency ambulance

Voter turnout was impressive: 75% of the city's registered voters ousted the incumbent councilmen at a margin of two to one and elected Einar R. Solo, Ernest J.Hippen, Loring R. Jones and Morris I. Shoup to replace them. Unaffected by the outcome was Councilwoman Combellack, who had endorsed the recall slate.

Combellack's staunch opposition to contract services in Signal Hill became her ticket to the Mayor's seat following the recall. She was always mindful of her constituents need to have an active voice in all significant political decisions affecting the quality of life in Signal Hill. It came as no surprise when Combellack was re-elected Mayor in 1960, a position she filled until April 1961.

Combellack's previous term as Mayor, (April 1953 to April 1954) followed a period of similar political upheaval in city politics. In the early 1950's however, Combellack was a strong and vocal opponent to legalized gambling of any form within the city. As once before, she had the majority sentiment of Signal Hill's residents behind her throughout her public career. She consistently remained unsullied by underhanded motives of personal, or financial, gain.

# Port of Long Beach releases 2024-25 budget with 19.5% increase in spending

A Long Beach commission approved a \$760 million budget for fiscal year 2024-25, representing a 19.5% increase from last year's adopted spending plan, officials announced Monday.

Last week, the Long Beach Board of Harbor Commissioners approved the port's spending plan, which includes \$368 million for capital improvements in rail, zero-emissions and other infrastructure. 
