# Election, pollution and online safety: What did Long Beach's federal and state reps do in July?

his installment of the Signal Tribune's monthly series covers actions taken and statements made by Long Beach's federal and state representatives throughout July.

Elected officials were involved in debate and legislation surrounding the presidential election, pollution, online safety and more.

The purpose of this ongoing series is to help the public stay abreast of their elected officials and hold them accountable beyond election day.

#### **Robert Garcia**

U.S. Representative for California's 42nd Congressional District

Wastewater Surveillance: Garcia and Congressman Don Bacon introduced the Surveilling Effluent Water for Epidemic Response (SEWER Act) on July 11, which aims to support the CDC's National Wastewater Surveillance System. The bill allocates \$150 million annually for the next five years to improve and expand the detec-

tion and monitoring of infectious diseases through wastewater. "Early in the COVID-19 pandemic, while I served as Mayor of Long Beach, we were in the dark about the spread of illness in our community. We didn't have test infrastructure to keep people safe. We have learned from that dark time, and will make sure that we're not blind in the next crisis," Garcia said in a public statement. "The

"We're trying to show that a different way is possible," the founders of the festival said in a press release. "Concert tickets and music festivals have become pricey and somewhat detached and we're trying to provide a more grassroots approach which benefits everyone involved. There's more music out there than what's on the radio and there's alternatives to paying high ticket prices and hidden fees. This is the first year as a two-day fest and we'd like to eventually expand





# The public can learn of existing policies and zoning changes, and weigh in on developments.

The City of Long Beach will host three public meetings in August and September focused on housing and zoning policy with the intent to inform the community and gain resident input.

Residents can learn about initiatives the City has been discussing with the goals to grow housing production, increase housing affordability, reduce tenant displacement and attract innovative developments in high-resource areas.

"We want to invite the public into these important conversations, so that they can be a part of the process," said Mayor Rex Richardson in a public statement. "These innovative policy proposals, introduced in May, will help Long Beach families find stable housing through increased production and enhanced tenant protections. From assisting community members experiencing homelessness with access to housing, to opening up the dream of homeownership to a young family, we can address the multifaceted housing needs of our diverse city."

These policies are part of the sixth cycle of Long Beach's Housing Element, crafted by the Community Development Department to help the City reach its housing goals. Some of these goals are state mandates, while others intend to help Long Beach lead the way in af-

fordable housing and housing production.

Long Beach youth who are interested in expanding the City's youth outreach are encouraged to apply for a spot on the Office of Youth Development's Youth Advisory Council.

The Youth Advisory Council, originally formed in 2022, consists of 11 members and is responsible for overseeing the design and application of the Youth and Emerging Adults Strategic Plan, the Measure US Youth Fund, the yearly Youth Summit and various youth development initiatives.

"The Youth Advisory Council is a chance for youth to make a real difference in shaping the future of our community," said Mayor Rex Richardson in a public statement. "We invite young people to apply for a spot now and be part of driving positive changes together here in Long Beach."

The council engages youth in their district by gathering different perspectives and learning the most effective community outreach approaches. It also helps disperse Measure US Youth Fund money to local youth-serving organizations as part of the Youth Power Participatory Budget.

The council has representatives from all nine council districts, along with at-large members that focus on health equity in historically underrepresented neighborhoods, and action teams to pursue the goals of the Youth and Emerging Adults Strategic Plan.

"Being on the Youth Advisory Council is a very informative experience that has opened my eyes to the way that City Departments work and how various youth-focused organizations impact our city," said former Youth Advisory Councilmember Faith Mack in a public statement. "The Council encourages youth empowerment and has been helpful with providing youth with the tools that they need to become productive and prepared citizens of Long Beach."

The Youth Advisory Council has expanded its outreach efforts with engagements regionally and statewide to voice its viewpoints on youth health. In January, the council held the City's inaugural Youth State of the City address, served as an integral part of first-ever Youth

Day in the LBC in May and recently introduced a three-year update on the Youth Strategic plan to the Long Beach City Council.

Anyone interested in serving on the Youth Advisory Council can apply through the the Long Beach Department of Health and Human Services and must meet the following eligibility requirements:

• Be between the ages of 16 to 26 by Sept. 1

• Live in Long Beach

• Be available to meet for two hours, two afternoons per a month, in locations across the city

• Have a passion for issues affecting youth in Long Beach

Members of the council will receive a \$50 stipend per meeting, which adds up to \$1,100 for a one-year term. Applicants who are selected to serve on the council will also be recipients of development opportunities from City staff.

Applications can be submitted online now through Aug. 31; selected members will be notified around four weeks after the conclusion of the application process.

# LB's Shoemaker Bridge and multiple 710 freeway ramps will close for weekend repairs

A repair project this weekend on the Shoemaker Bridge will prompt closures and detours to the northbound Long Beach (710) Freeway from downtown Long Beach and the port area, officials said Wednesday.

Work is scheduled from 5 a.m. to 10 p.m. Saturday and Sunday on the underside of the bridge, which was damaged when cargo carried by a truck struck the span in January. Crews will assess and evaluate

the steel framing on the bridge to determine what will need to be replaced at a later date.

The Shoemaker Bridge spans the Los Angeles River and connects Seventh Street to the 710 Freeway.

Motorists coming from downtown Long Beach will need to access the northbound 710 Freeway from Anaheim Street, port officials said. The Ocean Boulevard, Third Street and Seventh Street ramps will be closed as well.

Crews will close northbound Harbor Scenic Drive at Harbor Plaza. Vehicles will be detoured to Harbor Plaza to access northbound Pico Avenue and the westbound Long Beach International Gateway Bridge. To reach the northbound 710, motorists can take northbound state Route 47 to eastbound Anaheim Street.

The Pico Avenue on-ramp to northbound Harbor Scenic will be closed. Additionally, the northbound 710 on-ramp from Pico Avenue to Ninth and Pier B streets will be closed. Vehicles can take westbound Pier B Street, turn right on Anaheim Way and head south

on Farragut Avenue to access eastbound Anaheim Street and the northbound 710.

The eastbound Long Beach International Gateway Bridge connector to the northbound 710 Freeway will be narrowed to one lane during both days, to allow crews to work under the bridge.

Construction work this weekend may require fewer extensive closures, but motorists should take precautions and plan to use the road detours throughout the weekend, officials said.

Angeles County general election schedule. This year's election cycle will see three city council member seats and the city clerk position on

As of now, incumbents Lori Y. Woods and Robert D. Copeland have filed for another term and will be on the November ballot, according to the city's website. Longtime Councilmember Edward H.J. Wilson has not filed to return to his seat on the city council, and newcomer Charlie Honeycutt is running for a city council seat.

City Clerk Daritza Gonzalez has not filed to return to the city clerk position. The city clerk is responsible for administering local elections, arranging ceremonies and official functions, providing access to City records and ensuring compliance for federal, state and local statutes.

City councilmembers serve fouryear terms while the city clerk candidate will hold the position for the remaining two-year term. City clerks usually serve a four-year term as well, but Signal Hill hired Gonzalez in the middle of a term after the previous city clerk left the

Currently, city councilmembers hold part-time positions and earn a base pay of \$722.18 per month, while the city clerk is a full-time position which earns \$438.22 per

The city council voted in May to review the pay for councilmembers, the city clerk and city treasurer positions every two years.

#### **How to File for Candidacy**

In order to run for a City position on the ballot this year, residents should meet with the city clerk at City Hall (2175 Cherry Ave.) to review the required forms and filing deadlines and to receive all necessary documents.

Anyone interested in running must complete the required forms and collect a minimum of 20 or

maximum of 30 signatures from residents and turn them into the city clerk by Aug. 9 at 4:30 p.m.

If an incumbent does not file to return to their position, the nomination period will be extended to

Additional requirements to run for a Signal Hill elected position include:

- · Must be a U.S. citizen
- Must be 18 years or older

· Must be a registered voter and a resident of Signal Hill for at least 29 days prior to the date of filing nomination papers

According to the City Charter, an elected official must reside in Signal Hill for the duration of their tenure.

SEWER Act will provide the necessary support to continue wastewater surveillance testing across the nation, tracking disease spikes by monitoring their presence in sewage. This way, we can directly target prevention efforts and keep our communities safe."

Pier B Groundbreaking: On July 18, Garcia met with the United States Secretary of Transportation Pete Buttigieg at the Port of Long Beach for the groundbreaking of the Pier B Port Project. Last year, Garcia secured over \$283 million in federal grants for this project, which is expected to create over 1,000 jobs locally and 13,000 nationwide. It will improve operations at the port by connecting the port with inland rail yards. The project aims to reduce truck traffic and emissions.

Letter to Biden: Congresswoman Nanette Barragán and 15 other members of Congress sent a letter to Biden urging him to issue an Executive Order to support reducing emissions from the maritime industry. The letter said that greenhouse gas emissions from shipping are expected to rise, and emphasized the need for federal action to address pollution and protect communities. Their recommendations include setting fuel standards for ships, monitoring emissions, electrifying the federal ferry fleet, supporting low-emission shipbuilding, developing alternative fuels and more.

Statement on Biden: On July 22, Barragán issued the following statement on President Joe Biden's decision to end his re-election cam-

"It has been an honor to work so closely with the Biden-Harris Administration to improve the lives of Americans, including Latinos and communities of color. Democrats will work to ensure his legacy is secure and will support the President and Vice President Kamala Harris as the party moves forward, unified, to continue to put the American people over politics."

**Statement on Ballot** 

Measure: Governor Gavin Newsom, Senate President Pro-Tempore Mike McGuire and Speaker of the Assembly Robert Rivas announced a ballot measure to combat theft and the illicit sale of fentanyl on July 1. This ballot measure would increase penalties for repeat shoplifters, introduce harsher penalties for selling drugs mixed with fentanyl to unwitting buyers, make it easier for prosecutors to charge drug dealers with murder if someone dies from their product, increase substance and mental health treatment options and more.

Gonzalez issued a statement in support of this ballot measure the same day it was announced.

"With this proposed ballot measure we can crack down on property crime and fentanyl without reverting to policies that do more harm than good in our communities," Gonzalez said in a public statement. "We can protect our communities and at the same time prevent detrimental social and economic costs that worsen poverty and inequality. 

Homeowner **Protection:** Lowenthal's Assembly Bill 295 became a law this month. It was passed by the California State Assembly on July 1, and signed into law by Governor Gavin Newsom on

The new law aims to protect those who have just been through a foreclosure. When a foreclosure happens, former homeowners are entitled to any remaining funds after the mortgage and fees are paid. This remaining amount is referred to as "surplus money."

AB 295, aims to curb the activities of "surplus hunters," who offer unnecessary assistance to former homeowners in accessing their surplus money, while charging exorbitant fees for their services. Since people are legally entitled to their surplus money, there is no need for surplus hunters, who Lowenthal says exploit individuals already in a vulnerable state. The law mandates that surplus hunters wait at least 90 days after the foreclosure is recorded before contacting individuals about their surplus money.



## SpaceX moving Dragon recovery to Long Beach in 2025

SpaceX is moving its Dragon spacecraft splashdowns from off the coast of Florida to the West Coast starting next year, Long Beach city officials said Sunday.

"Excited to share a Space Beach update! Long Beach will be the new home to @SpaceX's Dragon recovery vessel as their West Coast Recovery Operations team based out of the @portoflongbeach will welcome back both @NASA and other private astronauts who are returning to Earth from orbit and Mayor Rex Richardson said Sunday on X, formerly Twitter. "We'll continue sharing updates as #SpaceBeach continues to soar!"

The Hawthorne-based company said the move is intended to reduce risks associated with re-entering debris from the spacecraft's trunk

The trunk section of the Dragon has been released before the de-orbit burn, re-entering the atmosphere several weeks or even months later. SpaceX officials believed that the trunk would break up on re-entry with no debris surviving, but on several occasions pieces of debris from Dragon trunks have landed in Australia, Saskatchewan and North Carolina, among other places.

SpaceX engineering teams have explored a variety of solutions to eliminate the risk of trunk debris landing on populated areas.

"After careful review and consideration of all potential solutions ...

SpaceX teams concluded the most effective path forward is to return to West Coast recovery operations," the company said in a statement Friday.

"To accomplish this, SpaceX will implement a software change that will have Dragon execute its deorbit burn before jettisoning the trunk, similar to our first 21 Dragon recoveries," the statement continued.

"Moving trunk separation after the deorbit burn places the trunk on a known reentry trajectory, with the trunk safely splashing down uprange of the Dragon spacecraft off the coast of California. SpaceX is working with NASA, the FAA, and other federal agencies to evaluate and assess all potential return locations off the coast of California to ensure safe and reliable Dragon splashdowns on the West Coast."

' ... To support these changes, a Dragon recovery vessel will move to the Pacific, where we will utilize existing SpaceX facilities in the Port of Long Beach to support initial post-flight work and operations on Dragon. Post-splashdown, crew and cargo will transit to California ahead of their final destinations, such as Houston, Texas or Cape Canaveral, Florida. Dragon

refurbishment will continue to primarily take place at our Dragon processing facility at NASA's Kennedy Space Center in Florida to prepare the Dragon spacecraft for its next flight."

Earlier this month, SpaceX owner Elon Musk said he will be moving the aerospace company from Hawthorne to Texas in protest of a state law signed by Gov. Gavin Newsom that prevents California schools from notifying parents if their children identify as transgender.

Musk later announced that he would also move the headquarters of X — which he also owns — out of San Francisco and into Austin, Texas.

SpaceX, founded by Musk in 2002, has been a revolutionary force in the space industry, pioneering the re-use of multimillion-dollar rocket boosters to dramatically cut the cost of aerospace missions. The company has earned multiple contracts from NASA for conducting resupply missions to the International Space Station, and transporting astronauts to and from the orbiting outpost with its Crew Dragon capsules. SpaceX is also working with NASA as part of the ambitious Artemis program aimed at establishing a base on the moon, with the larger goal of using the base as a possible launch point for manned missions to Mars.

SpaceX already has significant operations in Texas, where it developing its massive Starship vehicle — billed as the most powerful rocket ever flown — for use in the Artemis program and human/cargo missions to Mars.

Musk announced in 2021 that he was moving his Tesla electric-vehicle company to Austin, however, the company still has manufacturing facilities in Northern California, along with research and development facilities.


