This Long Beach nonprofit hopes to combat teen depression, anxiety with hyper-focused services

For The Child will soon open its teen-centered counseling center in Bixby Knolls with a bolstered psychology staff in response to a recent rise in teen depression.

Long Beach youth-focused nonprofit is celebrating its 50th birthday by doubling down on what they say is most needed: services combating teen depression and anxiety for children, teens and families. For the Child has served Long Beach families since 1974 by providing child abuse treatments and trauma-informed

mental health care for children and teens through counseling and therapy. On July 18, the nonprofit broke ground on its latest effort to specifically provide more and better care for teens: the 2,299-square-foot John Gogian Teen and Family Center, as an extension to its Bixby Knolls location.

The new center will provide For the Child's (FTC) teen patients with their own entrance and waiting room, two rooms for group therapy and workshops as well as five teen-centered counseling offices. In an effort to reach more teens, FTC will also be hiring five additional therapists, bringing their counseling staff to a total of 25.

FTC Executive Director Michele Winterstein said the nonprofit had been noticing a rising trend of teens in need of their mental health services, but that need "skyrocketed" during the COVID-19 pandemic.

"The trends were already happening; the isolation of being disconnected from social support," Winterstein said. "After COVID we saw a tremendous increase in suicidal [teen] patients."

According to the Children's Health Council, youth depression and anxiety doubled after COVID-19, resulting in a quarter of youth globally experiencing higher levels of depression than before the pandemic.

Teens can receive help with a wide range of issues at FTC, such as help healing from sexual abuse, molestation or sexual assault, witnessing domesting abuse, or problems with their peers. Before the pandemic, teens made up a third of FTC's clientele. Now, half of their services are focused on helping teens, according to the nonprofit.

For the Child was originally founded under two names by the same founders — Cedar House in 1974, and Sarah Center in 1984 assisting children who had suffered abuse, neglect, and sexual assault, respectively. The two organizations merged in 1996 to form For The Child.



Weekend shooting claims life in North Long Beach; stats reveal troubling trend

man was fatally shot early Sunday morning in North Long Beach.

Personnel with the Long Beach Fire Department found

Long Beach Fire Department found 43-year-old Ali Jabbar Phannix at the 600 block of E South Street with gunshot wounds to his upper body and declared him deceased at the scene.

Homicide detectives from the Long Beach Police Department (LBPD) were called to the scene to investigate.

That same night, police responded to a report of another shooting in North Long Beach, in which an unoccupied vehicle had been struck by gunfire in the 5800 block of Lime Avenue.

The day before Phannix was killed, a man reported to police that

his car had been struck by gunfire while he was driving in North Long Beach. The suspect or suspects fled before officers arrived at the scene.

Several shooting incidents in North Long Beach have been in the news over the last few months. The police have yet to release possible suspect information for a handful of the recent shootings.

Residents who keep up with the local news may remember numerous recent cases of shootings in North Long Beach. A 16-year-old boy was killed and his relative was injured earlier this month. A gun-

man fired at two other men during an argument over a car in June. A mass shooting in May injured seven people. In April, a father was killed while standing outside his home.

The police have not released any information about possible suspect(s) in Monday's shooting, the Aug. 4 shooting that killed a teen boy, or the May mass shooting. However, detectives believe there are unidentified witnesses to these crimes, and are asking them to come forward.

Five suspects were arrested in the homicide of 51-year-old Mario Morales-Moreno in April. Taylor Byron Woods, Tyrell Deshawn Louden, Jordan Omarion Stokes, Semaj Lamar Obrien and Jamie Tucker are all being held on \$2 million bail, and are due back in court on Aug. 28.

Signal Hill residents asked to take survey; data will be used to apply for federal grant

The City of Signal Hill is planning to apply for a federal grant, and will include feedback from the public in its application. Residents are asked to take an online survey about electric vehicle charging stations by Aug. 28.

The City is applying for the Charging and Fueling Discretionary Grant Program from the Department of Transportation. The minimum amount given to chosen recipients through the grant is \$1 million.

The survey includes five multiple choice questions, which are as follows:

- How familiar are you with electric vehicles and the types of charging stations available?
- What factors would most influence your decision to purchase an electric vehicle?
- Have you experienced any challenges when finding a charging station for an electric vehicle?

•What type of charging infrastructure would you prefer to see more of in your community?

•In your opinion, what is the most effective way to encourage the adoption of electric vehicles?


"The Ranchos Walk encourages

Marvin Robert Haney, a remarkable and multifaceted individual, passed away at the age of 93 on June 17, 2024. Born in Borneo while his father was drilling for oil, he carried that pioneering spirit throughout his life, creating a legacy of innovation, kindness, and adventure.

An entrepreneur at heart, Marvin was a man of many talents. He ran a successful hydrofoil service in the Virgin Islands, produced the first fiberglass port-a-potty, built and operated a restaurant, started a savings and loan association, and developed and managed commercial properties. His love for creating extended beyond business—he was an artist who found joy in working with wood, clay, metal, and ceramics. The stunning art he created will forever be cherished by those he left behind.

Marvin was a story teller, bringing to life the people, places, and experiences he had encountered. He was immensely proud of his family and always offered unwayering support and interest in their lives. His favorite saying, "Know you are loved," was more than just words; it was the philosophy by which he lived.

His accomplishments were many. He served as President of the Long Beach Chamber of Commerce, graduated from California State University, Long Beach and served on the President's advisory committee.

A world traveler, he visited over 40 countries, sailed his sailboat, rode and trained horses, and participated in the Rancheros Visitadores horseback ride in Solvang. He also served as a soccer referee and was a proud Korean War veteran. His career began as an oil driller in Southern California, and later, he and his brother Pat built their

own office in Signal Hill.

Active in Alcoholics Anonymous since 1971, Marvin remained a dedicated member for 53 years, offering support and inspiration to countless others.

He is survived by his loving children, Shawna and her husband Mike, Tom and his wife Cathy, as well as four grandchildren, Tiana, Ian, Heather, and Mackenzie, who affectionately called him Papa. He was preceded in death by his two brothers, Pat and Norman. His memory will be cherished by all who knew him.

Long Beach will hold DUI checkpoint Friday night

The Long Beach Police Department (LBPD) will hold a Driving Under the Influence (DUI) and driver's license checkpoint Friday from 6 p.m. to 2 a.m.

The checkpoint will be held in LBPD's south division, the area of Anaheim Street to Harbor Scenic Drive and the Los Angeles River to Cherry Avenue. According to a press release from the police department, DUI checkpoints are determined based on data showing impaired driving-related crashes.

"Impaired drivers put others on the road at significant risk," Lieutenant Jose Flores said in a public statement. "Any prevention measures that reduce the number of impaired drivers on our roads significantly improves traffic safety."

Impaired driving is not only caused by alcohol; some prescription medications and over-thecounter drugs may interfere with

driving as well. While medicinal and recreational marijuana are legal, driving under the influence of marijuana is illegal.

Drivers charged with a first-time DUI face an average of \$13,500 in fines and penalties, as well as a suspended license.

Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.



Former LBUSD school safety officer pleads no contest to manslaughter

Just over four months after a jury deadlocked in his murder trial, a former Long Beach Unified School District safety officer pleaded no contest Tuesday to voluntary manslaughter for an 18-year-old woman's shooting death about a block from a high school.

Eddie Gonzalez, 54, is due back in a Long Beach courtroom for sentencing Oct. 8, when he is facing either three years or six years in state prison under a plea agreement, according to the Los Angeles County District Attorney's Office.

He remains free on bail pending his sentencing.

After about two days of deliberations in April, the jury's foreperson told Los Angeles County Superior Court Judge Richard Goul that the panel was split 7-5 — with the majority favoring convicting Gonzalez of second-degree murder. The other five opted for voluntary manslaughter and an acquittal on the more serious offense of second-degree murder for the Sept. 27, 2021, shooting of Manuela "Mona" Rodriguez about a block from Millikan High School in Long Beach.

Trade green for ink at Tattoo Heritage Project fundraiser

his weekend, Fear City Tattoo will host a fundraiser for the Tattoo Heritage Project, a nonprofit with the mission of establishing the first national tattoo art museum in Long

Nestor Zelaya, owner of Fear City Tattoo, has partnered with Happy Sundays and several local tattoo artists who will create old-school original tattoo artwork for \$100 to \$300 to raise proceeds for the future Tattoo Heritage Museum.

"When I first heard about the Tattoo Heritage Project, I could immediately recognize the importance of such a movement, not only as a tattooer but as a long time Long Beach resident," Zelaya said in a public statement. "Tattooing is important culturally throughout the world and yet it still holds such a strong stigma in society. The only way to overcome that is through education."

Happy Sundays is a free twoday festival, created by Scott Montoya and Julia Kugel-Montoya, that takes place annually in the city's Zaferia neighborhood. The festivities will include live music from dozens of bands and South by Southwest-esque programming that includes aerospace panels, comedy shows and now a tattooing

The Tattoo Heritage Project was founded by tattoo artists Charlie Cartwright, a.k.a. Good Time Charlie, and Outer Limits Tattoo & Museum owner Kari Barba. Since its foundation, events have been held locally and across the country in tattoo-rich cities such as San Antonio and Tucson, to fundraise and bring further attention to the Project's efforts.

"As tattooing has grown as a global industry and artform over

the last couple of decades, it's due time it receives an institution to honor and maintain its history and heritage just like many other culturally important mediums," said Josh Chesler, board member for the Tattoo Heritage Project in a public statement. "By bringing the Tattoo Heritage Project to Happy Sundays, we can introduce its mission to many people who may be unfamiliar with it and increase its presence in what is arguably the most important city in tattoo histo-

Long Beach's tattoo history goes back several decades. This includes a thriving period from the '50s to the '70s at The Pike when the area had several tattoo parlors, allowing many aspiring tattoo artists to hone their skills and receive steady business from the nearby naval port.

Cartwright got his start with public tattooing at The Pike in the early '70s and praised Barba for helping keep the local history intact. Cartwright says Outer Limits Tattoo, which has a storied history dating back to 1927, is the only surviving local shop from The Pike's tattoo heyday.

"It's the only remnant that remains, it's in the original spot, and I thank [Barba] for that, and most American tattoo artists and enthusiasts should thank her for that too. For preserving that piece of American history," Cartwright said.

Other tattoo community events to check out this weekend include musical performances by Project board members Chesler and Corey Miller this Saturday at Alex's Bar, right across from Fear City Tattoo. Chesler's group Decent Times will perform at 3 p.m. while Miller's band Powerflex 5 will play at 6 p.m.

In addition, Outer Limits Tattoo and Museum, located at 22 Chestnut Place, is hosting an open house on Friday, August 23 from 6 p.m. to 8 p.m. that will guide visitors through Long Beach's detailed tattoo history.

Fear City Tattoo's fundraiser for the Tattoo Heritage Project will take place this Saturday and Sunday from noon to 8 p.m. at 2912 E. Anaheim St.

More than half the teens that FTC serves live in the zip codes 90805, 90813 or 90806. According to the nonprofit, these areas in the city have shown historically higher levels of abuse than the Los Angeles County average, Winterstein said. She added that their teen services are provided to 65% Hispanic youth and 20% Black youth.

These zip codes also have poverty levels that are higher than the state average, according to the U.S. Census. According to Winterstein, 90% of the youth being served at FTC are low-income. The nonprofit offers help enrolling families in medical coverage, and provides services to those without any medical coverage as well.

The teen counseling center will allow FTC to serve an additional 105 teens with either weekly or twice-weekly individual therapy sessions annually. They will also focus on enhancing their prevention groups and parent workshops, as well as family support.

Parents who receive FTC services to help with their younger children have in recent years begun asking the nonprofit to help them understand their teens more. A shifting social media and technological landscape has made for new and complex issues teens are dealing with, Winterstein said.

"We've seen a great increase in sexual abuse on the internet and social media-based abuse. Some of it is grooming, some of it is pressure in relationships like coercing, bullying, sending pictures, spreading those pictures around, blackmailing," Winterstein said. "They need help dealing with their peers on social media and the laws and how to react to and report blackmailing."

Winterstein said they hope to reach more teens by implementing peer-to-peer counseling as "a sort of front line" to suicide prevention and for allowing teens to have sensitive conversations they may be nervous to have with an adult. FTC hopes to teach its patients how to understand the early warning signs of suicide, which is invaluable since they have more contact with their peers.

For the Child's teen services are provided to 65% Hispanic and 20% Black youth.

FTC's services include teen groups, but Winterstein said that teens often ask for more individualized services. In order to increase immediate access to professional help, FTC's licensed therapists will be training students earning their master's degree in related fields to conduct supervised consulting.

Construction of the John Gogian Teen and Family Center is expected to be complete in January or February 2025. The John Gogian Family Foundation is the main donor for the center, with additional help from the W.M. Keck Foundation, The Ahmanson Foundation, Boeing Employees' Community Fund, and donations from For The Child board members and other individuals.

FTC's upcoming Long Beach Gives fundraising efforts will focus on furnishing the center in a way that is teen-friendly and welcoming. Those who wish to donate beforehand can make a donation on the website and specify that it's for the Teen and Family Center.

Higher population density and rates of poverty linked to more gun violence

The shootings that make it into the news are only a sliver of the gun violence that occurs in the 90805 zip code. According to data obtained from the Long Beach Police Department through a public records request, 1,665 people have been victims of shootings in North Long Beach from January 2007 to April 2024.

The 90805 zip code represents the largest number of victims in any zip code in Long Beach during this period in time. It is one of the City's largest zip codes, encompassing 7.4 square miles of land, and has the third most victims per capita.

Approximately 95,740 people

reside in the 90805 zip code, or approximately 13,000 people per square mile, making it the fourth most densely populated area of Long Beach, according to censusreporter.org, a nonprofit website that aggregates census data.

The 90805 zip code is closest in size to the 90815 zip code, which covers 7.1 miles of land and houses 42,759 people. In comparison, 90815 is far less populated, with approximately 6,000 people per square mile. From 2007 to April 2024, 113 people were victims of shootings in the 90815 zip code.

The 90805 zip code has a poverty rate of 18.9%, while 90815 has a

poverty rate of 7.4%, according to census data. The state average is

In May, LBPD released a memo informing the public that shootings were up compared to last year. In April, there had already been 11 murders citywide since the beginning of the year, compared to six at the same point in time in 2023.

LBPD said it has reallocated staff and resources to create the new High Crime Focus Team, which is supposed to work with the existing Neighborhood Safety Bike Team to provide proactive enforcement in high-crime areas of the city. Each division of the LBPD has two bike patrol officers assigned to it, including the North Division in North Long Beach.

The Signal Tribune emailed the LBPD to ask what areas of North Long Beach its bike officers patrol. The LBPD would not specify where these officers patrol, only that their routes vary based on data.

Long Beach will clear encampments, but enforcement won't be enough to address homelessness

he City of Long Beach plans to crack down on encampments, and may begin citing and arresting homeless people to do so. But it remains clear that a drastic increase in resources is needed to properly tackle the homelessness epidemic.

This change in local enforcement follows the Supreme Court ruling in favor of Grants Pass v. Johnson, which decided that local municipalities could penalize people for sleeping and camping in public, even if there was no space available for them in shelters.

Following this ruling, Governor Gavin Newsom released an executive order requiring state agencies and encouraging local governments to make progress on clearing encampments.

According to the City's Aug. 12 memo, Long Beach police will "generally" issue misdemeanor citations for those camping in public areas only after the City's Interdepartmental Homelessness Team offers them shelter and resources multiple times.

One of the city's encampments is located outside St. Luke's Episcopal Church, a safe haven that offers the unhoused meals, showers and clothing. Reverend Antonio Gallardo told the *Signal Tribune* that while the city's memo sounds promising, he's skeptical about

how the encampment clean-ups will happen due to his past experiences with some city workers.

"One day, I saw the city workers cleaning the encampments, the trash, and I approached them, and I asked them if they were offering resources[...], and they said, 'No, we don't offer resources, we came here to clean," Gallardo told the Signal Tribune. "And then after that, you know, two police officers that were present, they started telling me generalizations about the unhoused that most of the public make, like they said there are plenty of shelters, [...] these people are on drugs, are lazy, right? So that, to me, is not what the City promised."

For years, it has been normal to see tents and sleeping bags set up next to the outer walls of the church. When the *Signal Tribune* spoke to Gallardo on Wednesday, there were about a dozen people en-

camped around the church. Around half of them have been there longterm, and are on a first name basis with the church staff.

"The police told [a church volunteer], 'If the church really loves [the unhoused] so much, why don't you let them encamp in your parking lot?" Gallardo said. "I think it was a very snarky comment, because we can work together. We could work together. But it seems in this whole thing, our job of helping the people most in need is seen by some people, even within the City, as if we're promoting the encampments, when it's an issue that is bigger than all of us."

Gallardo said that some of those encamped around St. Luke's chose that location because it feels safer to them. Having their belongings thrown away by the City can leave them devastated.

"When their belongings are taken away, that's almost everything they have in their lives, so for their things to be taken away from them, it's very painful," Gallardo said. "[...] It doesn't really help them feel stable."

According to an Aug. 21 email from the Long Beach Police Department, no citations or arrests of homeless people sleeping or camping outdoors have occurred since the City's Aug. 12 memo.

Currently, people experiencing homelessness in Long Beach usually have to go to the Multi-Service Center — located on 12th Street in

an industrial area of the city — to receive resources and be placed in a shelter. Gallardo said the location can be hard to access.

According to an Aug. 21 email from the LBPD, no citations or arrests of homeless people sleeping or camping outdoors have occurred since the City's Aug. 12 memo.

"The first time I went there myself, I got lost in my car," Gallardo said. "So imagine people trying to navigate to go there, especially the homeless that are in downtown Long Beach."

In response to this issue, Gallardo said several faith-based organizations came together to work with the City in hopes of creating a more accessible satellite location for the Multi-Service Center at St. Luke's.

Gallardo said that the church and the City were in talks to make this happen: city workers had come down to the church to tour the site, and the city manager even told Gallardo in June 2023 that he was looking forward to signing the contract by the start of 2024.

But by the following month, July 2023, Gallardo said the City stopped answering his calls and emails. In particular, Gallardo said he had reached out multiple times to Homeless Services Bureau Manager Paul Duncan about the status of the proposed satellite location.

The *Signal Tribune* reached out to Duncan via email on Aug. 21 to confirm this, and has not heard back from him as of print time.

As of 2023, there were approximately 1,300 shelter beds in Long Beach, provided by the City and organizations it partners with. Last year's annual count of homeless people found 3,447 people within Long Beach, significantly outnumbering the amount of spaces in shelters.

The City's Aug. 12 memo admits that additional resources are needed to address the homelessness crisis

"Long Beach Homeless Services staff report that there is almost always greater interest in shelter than available shelter capacity on any given evening," the City's Aug. 12 memo states. "In Long Beach's case, further motivation through enforcement will be ineffective without rapid expansion of available shelter and permanent housing capacity."

When asked what he thinks needs to be done to address homelessness, Gallardo advocated for medium and long-term preventative measures such as increasing affordable housing, raising wages and further capping rent increases. He also emphasized that it was necessary for the City, faith-based organizations, volunteers and those experiencing homelessness to work together to come up with solutions.

The City of Long Beach has initiated the search for a company to manage and operate a temporary amphitheater, which will be built near the Queen Mary on the Downtown waterfront.

The Economic Development Department released a request for proposals (RFP) on August 5, inviting qualified firms to submit their

"Long Beach is elevating its status as a premier entertainment and tourist destination in Southern California," Mayor Rex Richardson said in a public statement. "The new Long Beach Bowl will be an iconic music venue on our beautiful waterfront that will highlight the spirit and culture of our community and will bring people together for concerts and festivals, further enhancing our landscape and stimulating our local economy."

The amphitheater, a state-of-theart venue, will cover approximately five to six acres along Queens Highway, positioned between the Queen Mary and Harry Bridges Memorial Park. Designed to hold up to 12,000 people, the venue will host a wide range of live events, featuring major international and local artists.

The chosen firm will be responsible for all aspects of the venue's operations, including booking, programming, marketing, staffing, logistics and noise management, ensuring the highest industry standards are met.

"It's exciting to get started on our very own amphitheater - something that will be iconic and an amazing destination for both locals and tourists to enjoy," First District Councilwoman Mary Zendejas said in a public statement. "Music unites and inspires people, and we look forward to hosting people from all over to share in that spirit."

The amphitheater is intended to be temporary, and will operate for five years. That time period may be extended, as the City considers building a permanent amphitheater in the future. The temporary project is expected to be completed by summer 2025.

"We're building the next great international city and unleashing the creative economy through music, athletics, tourism and hospitality like never before," Economic Development Department Director Bo Martinez said in a public statement. "The new amphitheater will offer a vibrant experience for local visitors and tourists with the spectacular Downtown skyline and waterfront as its backdrop."

The Long Beach Department of Health and Human Services has been given a \$1 million grant from the California Department of Public Health (CDPH) to bulk up its hepatitis B virus (HBV) treatment options for the city's at-risk resi-

Long Beach is the first and only local health jurisdiction in the state to receive a Hepatitis B Demonstration Project Grant, and one of two grantees overall to receive this funding from CDPH.

Long Beach will use the grant funds to begin providing the following healthcare resources:

- · HBV screenings
- · HBV vaccinations
- Linkage to hepatitis B care


The grant will be aimed at assisting Long Beach's Asian American and Pacific Islander residents, as well as populations with a history of substance use, all of whom are
