Long Beach Unified to close Hudson Elementary due to low enrollment

fter dwindling attendance numbers during the 2023-2024 academic year, Hudson Elementary School will be permanently closing due to low enrollment.

Most students will be transferred about half a mile down the street to Garfield Elementary School. Special education students will be transferred to Bixby Elementary School. Families are also eligible to receive priority in their school of choice process if there are other schools they are interested in.

During the Long Beach Unified School District (LBUSD) Oct. 16 board meeting, district staff said the decision to close the school was made based on factors such as space utilization and efforts to create the best learning environment.

According to Facilities Executive Director David Miranda, the process began with the creation of a working group to assess classroom space capacities across the district. Some of the group's tasks included creating a framework to access school facility data such as enroll-

# Long Beach City Council wants to know what caused the Oct. 9 water main break, and what's the plan if it happens again?


wo weeks after a water main break occurred on Orange Avenue in Long Beach, causing water, fear and confusion to flood the area, the City still has more questions than answers.

The Long Beach City Council is requesting the City Manager and Utilities Department to craft a report on the City's water pipe infrastructure, maintenance plan and protocols for future emergencies. The council will review the presentation in roughly 45 days at another

"From this incident it's clear that our citywide emergency response system needs to be discussed," said Councilmember Megan Kerr, whose district was largely impacted and who brought the item forward. "We weren't able to sufficiently spread the word to everyone who needed to know."

Anatole Falagán, general manager for the Long Beach Utilities Department, was just one week into his new role as manager when the water main break occurred. He sat at the council meeting and listened to the councilmember's concerns of confusion among residents and the need for a communication plan.

ment data, capacity utilization, room sizes and program needs.

The group met several times over the course of a year and consisted of different representatives from various district departments such as special education, child development and research and evaluation.

All enrollment in the district has been steadily declining over the years but for the 2023-2024 school year, Hudson Elementary enrolled 231 students. Miranda said that data from professional consultants estimated enrollment at Hudson Elementary would continue to decline under 200 next year and remain that way for the next couple of years.

Miranda said his team also did a spot check to gauge the accuracy of the estimates by comparing the enrollment estimates from five years ago with the actual enrollment numbers of the last five years.

All enrollment in the district has been steadily declining over the years. For the 2023-2024 school year, Hudson Elementary enrolled 231 students.

"It was really accurate, so that really gives us that confidence in the numbers going forward, that the projection is going to be accurate going into next year," Miranda said.

Miranda said the data also helped them look at two different forms of capacity: school site ver-

sus program capacity. School site capacity refers to the number of students a school can hold based on the original design of the building, while program capacity is based on the number of classrooms where instruction happens. Miranda said calculating program capacity more accurately represents how LBUSD uses space.

School site capacity is calculated by taking the total count of classrooms at a given campus and multiplying it by a loading factor - which is the maximum students per room. Program capacity removes certain non-load rooms - such as wellness centers, Head Start or career tech-type labs — from the equation. The Signal Tribune reached out to Miranda on Oct. 22 and 23 for clarification on these terms but did not get a response.

Miranda said the data analysis

showed that Hudson Elementary has a very low utilization rate: under 20% based on program capacity. Additionally, the elementary school has only one teacher per grade level from kindergarten through fifth grade. According to Chief Academic Officer Brian Moskovitz, this can impact the quality of the education students receive.



Attendance at Hudson Elementary School was expected to decline under 200 students next year.

"One of the greatest ways that we can ensure teacher success is that teachers have a partner to collaborate with, somebody to help create assessments, somebody to help to support students," Moskovitz said.

The work group looked at Garfield Elementary and found it was using around 40% to 43% of its capacity at this point in time, which made them confident that the school can take on "quite a bit, if not all" of Hudson Elementary's students, according to Miranda.

Low student enrollment also means Hudson Elementary students have had access to fewer resources such as counselors or a school librarian since state funding is on a per-pupil basis. Schools with fewer students are allocated less funds.

"Educationally, as schools get small like Hudson is right now, it's really hard to continue to maintain a high-quality program, and that really is our number one priority," Moskovitz said.

The district held an informational Hudson parent meeting on Oct. 21, a meeting for Garfield parents on Oct. 22 and is also offering opportunities for parents to visit the Garfield and Bixby campuses. Similarly, Assistant Superintendent of Elementary & K-8 Schools David Zaid said the district has held general meetings for Hudson and Garfield staff as well as one-on-one discussions to talk about their options.

Low student enrollment also means Hudson Elementary students have had access to fewer resources such as counselors or a school librarian since state funding is on a per-pupil basis.

Board member Doug Otto emphasized that the decision is both a difficult but necessary one. It is also potentially the first of many, as the district grapples with declining enrollment across the city.

"We're just on a ride now that we have to be aware of and not just think of this as an isolated incident, but as something that's an outcropping of all kinds of things that are happening with declining enrollments and funds," Otto said.

# Repairs to Shoemaker Bridge on Saturday will close certain freeway lanes and downtown roads

The northbound lanes of the Shoemaker Bridge in Long Beach will temporarily close for repairs on Saturday, resulting in traffic restrictions to several nearby roadways and freeway onramps connecting downtown Long Beach and the Port to the northbound 710 Freeway.

Crews are scheduled from 5 a.m. to 10 p.m. on Saturday to make repairs to the Shoemaker Bridge, which was damaged when cargo carried by a truck struck the span's underside in January.

The work will result in several

The Third Street, Seventh Street and Pico Avenue on-ramps to the northbound 710 Freeway will be closed.

There will also be no access from Ocean Boulevard in downtown Long Beach to the northbound 710.

The eastbound Long Beach International Gateway Bridge connector to the northbound 710 will be narrowed to one lane.


In the Port, northbound Harbor Scenic Drive will be closed from Harbor Plaza, along with the Queensway Drive and Pico Avenue connectors to northbound Harbor Scenic Drive.

Motorists in downtown Long Beach should utilize surface streets to go north to Anaheim Street from which they can access the northbound 710. Vehicles in the port will be detoured to Harbor Plaza to access northbound Pico and the westbound Long Beach International Gateway Bridge. To reach the northbound 710, motorists can take the northbound State Route 47 to eastbound Anaheim Street.

While the project may finish early, motorists should still take precautions and plan to use the road detours throughout the weekend. One additional temporary weekend closure will be needed to complete painting of the repaired area. That weekend has not been scheduled

A full replacement of the Shoemaker Bridge is planned by the City of Long Beach. Additional information is available on the City's project website.

#### What We Know

The first water main break occurred around 11:30 a.m. on Oct. 9 at 3502 Orange Ave., causing flooding along the street. The issue was with a 20-inch main water transmission pipeline, according to a social media post from the Utilities Department.

It's common for one water main break to cause issues with the surrounding pipes, which is exactly what happened along Orange Avenue on Oct. 9 and 10. The break caused water pressure to fall in parts of the 90805, 90807 and 90806 zip codes.

Orange Avenue was closed to cars during this time, between Wardlow Road and E. 36th Street.

According to the California State Water Resources Control Board, a water system pressure loss of less than 5 psi (pounds per square inch) requires a boil water notice. The City claims that the water was never contaminated, and the boil water notice was lifted on the early morning of Oct. 11, after 177 tests were conducted. The City distributed over 70 pallets of bottled water to residents in the impacted zip codes on Oct. 10.

It's been over two decades since the last time Long Beach had to issue a boil water notice, according to City Manager Tom Modica. A study conducted by Utah State University's Water Research Laboratory estimated that about 260,000 water main breaks occur in the United States and Canada each year, costing roughly \$2.6 billion to remedi-

There have been several water main breaks since the Orange Avenue one, Falagán said, but none to the same extent. In a press conference on Oct. 10, he said the Utilities Department budgets \$100 million annually towards infrastructure.

#### **Communication Issues**

Hours after the first water main break occurred on Oct. 9, residents began being notified through a variety of methods such as email, Go Long Beach alerts, phone calls and text messages. Internally, councilmembers say they struggled with where to get information and what to tell concerned residents.

Councilmember Kerr said her office sent out emails to residents notifying them of the situation at 6 a.m. on Oct. 10. These emails however, would have only gone out to residents who signed up for their district email newsletters.

Multiple councilmembers said they didn't know who to contact to

receive updates, making it difficult to explain the situation to residents in their district.

"I was waiting for official notifications to my office around what we could put out, what we could tell residents. A lot of those things were happening, but there wasn't a lot of communication with my office to help disseminate that information," Councilmember Joni Ricks-Oddie said.

The main notification system used was the Alert Long Beach messages that went out to 50,000 people in the evening on Oct. 9. This is the city's emergency notification system that uses emails and/or text messages to notify residents about certain incidents, if they have signed up to receive them. There have been conflicting reports from residents and councilmembers about when these messages went out, with some residents not receiving any text messages until Thursday evening.

Kerr said although her and her husband are both signed up for the alerts, she began receiving messages before he did.

The city also used a location-based system called "We Alert," but someone would only receive the messages if they were in the areas impacted at the time the blasts went out, much like an Amber Alert.

The Utilities Department began posting on social media about the incident on Oct. 9, acknowledging the reduced water pressure and telling residents to expect brown sediment in their water. Their caption read that this was "naturally occurring and not harmful to human health."

LB Utilities posted four times on their Instagram page and five times on their X, formerly known as Twitter, page. The boil water notice was shared onto these accounts at almost midnight on Oct. 9. There were several more messages on Oct. 10 from City departments and councilmember offices, via social media and email blasts.

Before the water main break on Oct. 10, it had been over two decades since the last time Long Beach had to issue a boil water notice, according to City Manager Tom Modica.

Kerr acknowledged that this leaves out people who don't have internet access or who are not as active on social media, like older residents. Modica said the City also made 40,000 automated calls to landlines in the area.

"This was a fifth of our city. If this was a disaster, if there was an earthquake that affected the entire region, we know everybody's going to be using emergency systems. I would like to know that ours is up to the task of alerting as many folks as possible," Kerr said.

City staff also acknowledged that notifications in languages such as Spanish, Khmer and Tagalog went out even later than English ones.

The report will include a plan for

emergency communications relating to utilities and a chain of command on where to get and how to spread information.

#### **What We Don't Know**

The City is still searching for answers as to what caused the main water break, and why it spread so quickly. Councilmember Al Austin requested that the report include "challenges" to the city's water infrastructures and necessary improvements.

"Many of the workers commented to me that they have never seen this type of activity happen all at once," Austin said. "I think we need to understand what the causes were ... so that we can get ahead of [it] and be proactive."

Councilmember Daryl Supernaw asked Utilities to clarify why the boil water notice went out since the phrases "out of an abundance of caution" and "state mandate" were both used in official statements.

"To me, those two phrases have a difference and I think we should be very accurate in our communication," he said.



# Signal Hill City Council approves contract for safety-focused improvements to East Burnett Street


The Signal Hill City Council voted on Tuesday to approve a contract with a Santa Monica-based consulting firm to help plan improvements along East Burnett Street.

The East Burnett Street Historical District Pedestrian and Bike Enhancement Project will introduce new sidewalks between Gaviota and Cherry Avenues, a bike lane between Walnut and Dawson Avenues, and other roadway improvements. These changes aim to make the street safer and more accessible for pedestrians and cyclists by addressing areas of East Burnett Street where sidewalks and bike lanes are currently lacking.

Improvements will include the construction of ADA-compliant ramps, new walkways, bike lane signage and landscaping. These upgrades will help connect East

Burnett Street to other parts of the city, including parks, schools and bus stops.

Catalyst Environmental Solutions Corporation will now provide consulting services for the City. This will include analyzing and documenting potential impacts to the environment such as air quality, water quality, stormwater management, hazardous materials and more.

The City has allocated \$147,260 for the contract with Catalyst Environmental Solutions Corporation, and an additional of \$14,726 is available in case of unforeseen conditions or circumstances, bringing the total amount to \$161,986.


