amazing experience."


Quezada's newborn son Andre Armani laid peacefully in his giant red stocking, waiting to go home for the first time on Monday morning.

Long Beach adds 90 units of affordable housing for veterans

Century Housing celebrated the grand opening of The Cove, its newest affordable housing development specifically for low-income and homeless veterans, on Wednesday, Dec. 18 with a ribbon-cutting ceremony



Century Villages' newest housing development offers 90 units of affordable housing for veterans.

The 90-unit apartment community was developed by Century Affordable Development, Inc., and is the latest addition to Century Villages at Cabrillo, a 27-acre supportive housing campus in west Long Beach. City and county officials joined the ribbon-cutting ceremony and applauded Century Village's growth over the last 30 years.

Officials such as Long Beach Mayor Rex Richardson, former

Mayor and now-Congressman Robert Garcia, Senator Lena Gonzalez, Councilmember Roberto Uranga and many others were present for Wednesday's grand opening.

"The Cove represents a meaningful milestone for this former Navy housing site, now home to the Villages at Cabrillo, where more than 1,500 residents reside each night," said Brian D'Andrea, Senior Vice President of Housing at Century Housing, at the grand opening. "As the newest addition to the Villages, The Cove's 90 apartments embody nearly three decades of Century Housing's mission - creating dignified, supportive and affordable homes for those in need, and standing as a crown jewel in our journey of transformation."

The Cove offers housing for individuals earning 30 to 60% of the area median income, including 60 units of permanent supportive housing for veterans who are experiencing homelessness. Long Beach's 2024 Point in Time Count identified 380 veterans experiencing homelessness within the city, a slight increase since 2023, with 47% of those people lacking any kind of shelter.

Long Beach Unified board lags behind on prioritizing student outcomes

The Long Beach Unified school board completed a quarterly self-evaluation of their progress in prioritizing student outcomes and found they are not on track.

In October 2023, the board selected its five-year goals to achieve student success, which identified objectives of reading proficiency, reading acceleration, algebra proficiency and college and career-read-

The self-evaluation was facilitated by members of the Council of Great City Schools. This education reform coalition has been counseling the district as it moves towards an outcomes-focused agenda. The board began by discussing the importance of self-evaluation.

"We need to be transparent, whether we're in a good place or not in a place we want to be," Board member Maria Isabel Lopez said. "I think transparency is critical in the work that we're doing."

The LBUSD board is currently behind on its five-year goals for student that were set in Oct. 2023

The self-evaluation rubric contains six evaluation areas:

- Vision and goals
- · Values and guardrails
- Monitoring and accountability
- · Communication and collabora-
- Unity and trust
- Continuous improvement

The rubric evaluates if the district is "not" student outcomes-focused, "approaching" student outcomes focus, "meeting" student outcomes

focus or "mastering" student outcomes focus. Each benchmark represents 0, 10, 25 or 35 points respectively, and has a list of criteria that must be fully met to qualify.

The "not student outcomes-focused" benchmark lists statements that, if true, signify the board has not accomplished the foundational actions to move forward. If the statements are not true, then the board can move forward to the next category.

However, while the district might have met some or a majority of the criteria in the "approaching" category, they can not qualify for that denomination unless every single one is met. Because of this, even in areas where the board was able to move past the "not" category, they ultimately received a zero score because one or more criteria in "approaching" hadn't been accomplished.

The board scored zero in each evaluation area. Throughout the self-evaluation process, the Council of Great City Schools consultants made notes of what specific strategies the district can implement moving forward to meet the student outcomes focus criteria and eventually master it.

Some of these improvement strategies include:


• Creating an analysis process for individual board meetings where board members can assess what portions of the meeting involved student outcomes and inputs.

 Board-hosted community events that encourage community

· Having board members go out into the community to hear from people both in and outside their

• Following through on the creation of superintendent interim guardrails that will build upon the board's goals.

The board will reevaluate itself in three months and aims to elevate its score by incorporating these changes.

The Cove features amenities designed to support residents' well-being, including a community room, courtyard, study area and bicycle repair shop.

Residents are referred to The Cove through the Coordinated Entry System and have access to supportive services provided by the VA Long Beach Healthcare System and Century Oasis Residential Ser-

"After serving seven and a half years in the U.S. Army, life took an unexpected turn. In 2017, I lost my job as a mechanic and eventually found myself without a home. For a time, I lived in my car while working full-time," said Jason Smith, a resident of The Cove and a veteran who served during Operation Enduring Freedom, at the grand opening. "By 2021, I was working at a warehouse that supplied materials for what would become The Cove never imagining it would one day become my home. After months in transitional housing, I finally have a stable place to call my own. Life has a way of coming full circle, and for that, I'm deeply grateful."

Construction on The Cove began in 2022 and finished earlier this year. Funding for The Cove comes from a mix of public and private sources, including the City of Long Beach, County of Los Angeles, Federal Home Loan Bank of Dallas, and Wells Fargo.

"The Cove is a testament to what we can accomplish when we prioritize housing for those who have served our country. These new homes offer veterans not just shelter, but the stability and support they need to rebuild their lives," said Supervisor Janice Hahn, who represents the Fourth District on the Los Angeles County Board of Supervisors. "I'm proud to support developments like The Cove that are changing lives and strengthening our community."

The Cove features amenities designed to support residents' well-being, including a community room, courtyard, computer lab, study area and bicycle repair shop that will serve the entire Villages



Long Beach announces additional homeless shelter beds for the winter

In preparation for dipping temperatures and rainy weather, Long Beach is opening up its 2025 winter shelter on Jan. 1, along with 60 overnight cots at the Multi-Service Center (MSC) for people experiencing homelessness.

With the addition of the overnight cots, Long Beach will be providing roughly 490 shelter beds this winter. According to the 2024 Point in Time Count, there were 3,376 people identified experiencing homelessness in Long Beach around this time last year. Roughly 72% of those people had no car or any type of shelter.

Living on the street or in a structure not fit for human habitation makes people extremely vulnerable to adverse weather like cold, rain or wind, creating a higher risk of hypothermia, frostbite, carbon monoxide poisoning, heart attacks from overexertion, and other sickness, the Long Beach Health Department said in a public statement.

Winter Shelter

The city's winter shelter will be located at 702 W. Anaheim St., which is currently operating as the city's emergency shelter. The Anaheim Street shelter will expand its nightly occupancy from 85 people to 125 people from Jan. 1 to March 31, 2025.

The winter shelter will operate 24 hours a day, seven days a week, and will be serviced by nonprofit First to Serve Outreach Ministries and the Los Angeles Homeless Services Authority (LAHSA). In

order to obtain a spot at the winter shelter, people need a referral from the MSC or a Mobile Access Center. The MSC is located at 1301 W. 12th St. and open daily from 8 a.m. to 4 p.m., and closed daily from noon to 1 p.m.

Long Beach will provide an additional 60 overnight cots at the Multi-Service Center for people experiencing homelessness during times of "extreme weather conditions" during the winter.

The winter shelter includes onsite showers and restrooms as well as an enclosed outdoor area and space for service animals and pets. People at the shelter will receive three meals a day and will have access to services such as housing-focused case management, screening for housing programs, referrals to year-round shelter programs, assistance obtaining identification and documents and connections to behavioral health resources.

"The winter shelter is a key component in our strategy to support people experiencing homelessness," said First District Councilwoman Mary Zendejas in a public statement. "By expanding operations, we are not only providing our neighbors who are unhoused a safe and warm place during the winter

months but also access to critical resources and services that can help them on their journey toward stable housing."

Inclement Weather Center

The MSC will provide an additional 60 beds during times of "extreme weather conditions."

The conditions needed for shelter to open up at the MSC must include one of the following:

- Forecasted temperatures of 45°
- •A flood watch or warning has been issued by the National Weather Service
- Weather forecasts predict rain that exceeds light showers

People in the inclement weather center will receive a cot and blanket, access to restrooms and hygiene supplies, a hot dinner and small breakfast, support from City staff and security services, and linkages to supportive services via the MSC.

Those taking shelter in the MSC will be required to leave the facility in the morning before 8 a.m. and may reenter when standard MSC operations commence for connections to supportive services, after 4 p.m.

When the inclement weather center opens, the City's Homeless Services Bureau staff, including general outreach, REACH teams and the Mobile Access Centers, will mobilize to notify people experiencing unsheltered homelessness of the shelter opportunity. City staff will also utilize the Homelessness Text Alert Program and the City's social media to provide information on how to access shelter.



AN ORDINANCE PROVIDING COMPENSATION FOR MEMBERS OF THE BOARD OF DIRECTORS OF COUNTY SANITATION DISTRICT NO. 29 OF LOS ANGELES COUNTY

SECTION 1.0 AUTHORITY

Pursuant to Section 4733 of the California Health and Safety Code, the Board of Directors of County Sanitation District No. 29 (the "Board") of the Los Angeles County Sanitation Districts (the "Districts") may, by ordinance, fix the amount of compensation paid to each Board member for each Board meeting attended or for each day's service rendered as a Board member, together with any incidental expenses incurred as a result of Board duties (the "Incidental Expenses"). Pursuant to Districts Ordinance titled "An Ordinance Providing Compensation for Members of the Board of Directors for County Sanitation District No. 29 of Los Angeles County", the current rate of compensation is \$125 for each Board meeting attended or for each day's services rendered, together with any Incidental Expenses.

Pursuant to Section 4733 of the California Health and Safety Code, the Board may, by ordinance adopted pursuant to Water Code Section 20200-20207, increase the amount of compensation to be paid to Board Members for each day's service.

Pursuant to Water Code Section 20200-20207, the Board may, after holding a public hearing, adopt an ordinance increasing Board Member compensation for each day's service in an amount not to exceed five percent (5%) for each calendar year following the operative date of the last adjustment.

REPEAL OF ORDINANCE

Districts Ordinance titled "An Ordinance Providing Compensation for Members of the Board of Directors for County Sanitation District No. 29 of Los Angeles County" is hereby repealed in its entirety and shall immediately become ineffective upon the effective date of this Ordinance.

SECTION 3.0 COMPENSATION

- A. A member of the Board of this District shall be compensated at the rate of \$175 plus incidental expenses for:
 - 1. Each meeting of the Board attended by that member.
 - Each Service Event, in which a member of the Board renders service on behalf of the Districts either individually or in conjunction with other Districts by request of the Board including, but no limited to:
 - (a) Attending scheduled tours of Districts facilities.
 - (b) Attending meetings, other than Board meetings, including meetings of the Personnel and/or Collective Committees, as those same are defined in the Amended Joint Administration Agreement dated September 10, 2014, as that Agreement may be amended from time to time.
 - (c) Rendering service at the request of the Chief Engineer and General Manager of the Districts on matters the Board has previously delegated authority to the Chief Engineer and General Manager of the Districts and the Board has previously determined are compensable to the Board member and in accordance with the requirements of Sections 53232 et. seq. of the California Government Code.
 - (d) Rendering service on any matter the Board has authorized a member of the Board to act and which the Board has previously determined are compensable to the Board member and in accordance with the requirements of Sections 53232 et. seq. of the California Government Code.
 - In the event that the member attends more than one meeting or Service Event on the same day, the rate of compensation is \$125 per meeting or Service Event.
- Pursuant to Section 4733 of the California Health and Safety Code, compensation payable to a member of the Board shall be limited to a maximum of six (6) days in any calendar month, together with any Incidental Expenses.
- C. If any of the services rendered by a member of the Board of Directors of this District or incidental expenses are common to more than one County Sanitation District of Los Angeles County which has provided for the payment of compensation to Board members, the compensation to be paid by this District shall be equal to the rate provided in Section 2.0 (A) divided by the number of such County Sanitation Districts of Los Angeles County being represented by the member.
- D. On July 1 of each year, beginning with July 1, 2026, the amount of compensation, as laid out in Section 3A above, shall increase by the increase in the Consumer Price Index for All Urban Consumers (CPI-U) for Los Angeles-Long Beach for the 12-month period ending in the preceding March, rounded to the nearest whole dollar, not to exceed five percent (5%) unless said increase is waived by the Board.

SECTION 4.0 SEVERABILITY

If any provision of this Ordinance is adjudged by a Court of proper jurisdiction to be invalid, or unenforceable, it is the intention of the Board adopting this Ordinance that all other provisions of this Ordinance shall remain valid and fully enforceable.

SECTION 5.0 EFFECTIVE DATE

This Ordinance shall become effective January 1,2025, or sixty (60) days following its adoption, whichever is later. The Clerk of the Board shall certify the adoption of this Ordinance and shall cause a summary to be published in a newspaper of general circulation as required by law.
