Hoping to fill vacant storefronts, Long Beach will remove certain parking requirements

The City hopes that more businesses will spring up, boosting the local economy and filling the 300 plus vacancies across Long Beach.

n an effort to fill vacant storefronts across the city, the Long Beach City Council unanimously approved a zoning code amendment Tuesday night to remove certain parking space requirements.

It's the most recent zoning amendment in the City, following its Zone In plan, with the goal to modernize Long Beach's neighborhoods and corridors through separate project areas. A city's zoning codes guide the types of uses (commercial, residential, or mixed-use) allowed

on a piece of land, as well as development standards (required parking, building height, etc.). Long Beach has been updating certain areas of the city, each with its own plan distinct to the neighborhood.

Historically, a building in Long Beach would require a certain amount of parking spaces depending on its use – a retail shop requires four parking spaces, while a restaurant requires five. This means if an empty storefront was previously a retail shop with four parking spaces, in order for someone to turn it into a restaurant, they would have to add a parking space, which is often

'A turning point': Act **Out Theatre finds its** home in Signal Hill


or the past 12 years, the nonprofit Act Out Theatre has created a home for youth theater enthusiasts of all backgrounds with its tuition-free shows, workshops and mentorships. Now, the organization is planting its roots in Signal Hill, with their first permanent rehearsal space to call their own.

The 70 plus students in any given Act Out Theatre show would often travel to whatever school or organization was gracious enough to lend their space for shows and rehearsals. Rehearsals and shows have travelled between Hoover, Hamilton and Hughes middle schools, a North Long Beach church and even Compton City College.

Travis Wade, founder and executive director of Act Out Theatre, said that as the nonprofit grew in size, scope and ambition, they continued to outgrow each temporary space. While the nonprofit used to primarily serve youth, it's now become a unique hybrid youth and community theater, with over 400 participants each year. They've also been slowly increasing the number of productions they put on each year, with a record five shows slated for the 2025 season.

"One of the things people always say is that Act Out is their home away from home, they say, "This is where people get me, this is where I can be myself," Wade said. "To now have our own space where we can paint the walls whatever color we want, where we can hang our pictures and posters from old shows and where we can reflect and see where we come from, that helps foster that culture and strengthen that culture that we already have."

For the several hundred people involved with Act Out Theatre, the move also means no more driving to and from storage for costumes and equipment, no longer being at the whim of other people's schedules and being able to expand their presence in the community through events. Act Out Theatre started hosting free art workshops last summer, and they hope to host more now that they have a space to do so.

New LBUSD policy focuses on suicide awareness for younger students

The Long Beach Unified School District (LBUSD) approved a new Suicide Prevention Policy for grades K-6 at its Dec. 4 meeting.

Policy 5141.53 is a revised version of the district's original K-12 Suicide Prevention Policy 5141.52. The original policy was last reviewed in 2021 and is required to be reviewed every three years. A regular monitoring review from the state found that while the policy is legally compliant, it needed to be separated into two separate policies: one for K-6 and one for grades 7-12.

The new policy contains similar information as the original, but written at a 6th grade reading level or lower so that younger students can understand it. Since the original policy 5141.52 already aligned with the state's model policy, it was only edited to update the dates and to specify that it is for grades 7-12.

The board was presented a re-

vised draft version of the original policy with the minor changes mentioned above and approved it at its Nov. 20 meeting.

The district's suicide prevention and intervention strategies include: •Staff training and development

•Teaching problem-solving, coping and resiliency skills to promote mental and socioemotional well-being for students, as well as how they can identify and respond appropriately to warning signs in

their peers.

•Offering school-wide practices that create an inclusive and supportive learning environment so students can develop healthy relationships and feel connected.

•Informing parents, guardians and caretakers about warning signs, the severity of the suicide problem among young people and available community resources.

• Establishing district and schoolsite crisis intervention teams to ensure the policy is properly implemented.

The policy urges teachers and staff to pay close attention to students who might be at higher risk of committing suicide such as students with substance use problems, mental health issues, those who are in the foster care system or homeless.

All teachers and school staff will participate in a mandatory annual training that will teach them about suicide awareness and prevention.

The Garage Theatre's wonderfully chaotic and whimsical original production, "Steam Powered Rocket Ride to the Moon," is a uniquely Long Beach play that takes place at the Pike in 1933. This interactive musical comedy pulls the audience into the world of its bumbling, lovable cast of characters as they navigate romance, friendships and an evil carnival ride.

The play was thoroughly enjoyable and genuinely fun to watch throughout. Be forewarned though, don't go in with the expectation of quietly observing from a corner seat. Considering how much audience participation was involved, it'd be a good idea to grab a coffee beforehand, to help match the energy the cast deserved.

The play starts with Jeff McGinness and Bobby Zelsdorf providing necessary exposition for the play as Pike owner Gus Palooka and his Auntie Palooka. Their old-timey dialogue was rife with purposefully anachronistic jokes that had the whole audience laughing.

The lead performance of the night was Diana Kaufmann as Rod McGirdlebutt, the blundering yet hilarious roller coaster operator. McGirdlebutt finds his job at the Cyclone Racer endangered by the Pike's newest ride, you guessed it — a steam powered rocket ride to the moon.

Kaufmann's performance is well complemented by leading lady Jess Nuptune as Dixie Troobaloo, a crack reporter with the *Long Beach Press Telegram* who turns the damsel in distress trope on its head as the play progresses.

Diana Rodriguez plays Guillermo Fao, McGirdlebutt's loyal and absolutely adorable best friend. Fao is one half of my favorite couple from the play, alongside invisible-dog-walker Tricia La Rue, played by Curtis Meyer.

Signal Hill City Council names mayor and welcomes new member

The Signal Hill City Council welcomed its newest member and appointed the new mayor and vice mayor during its meeting on Tuesday.

In the November election, Signal Hill voters re-elected incumbents Lori Woods and Robert Copeland, and voted in first-time Councilmember Charlie Honeycutt — who attended his first meeting on the city council on Tuesday.

Unlike in Long Beach, Signal Hill's councilmembers take turns

being mayor and vice mayor. The vice mayor typically succeeds the mayor the following year. However, the previous vice mayor, Ed Wilson, decided to retire this year rather than serve another term as mayor.

Keir Jones will serve as mayor instead, and Tina Hansen will serve as vice mayor.

Outgoing Mayor Lori Woods was honored with a reception at Signal Hill City Hall in her honor after Tuesday's council meeting, and will continue to serve as a member of the council.

Third annual Kwanzaa Experience returns to Long Beach this weekend

Long Beach's third annual Kwanzaa Experience Event will return to the Doris Topsy Elvord Community Center at Houghton Park on Saturday, Dec. 14 from 10 a.m. to 3 p.m.

The event is hosted by the April Parker Foundation and the Long Beach Health Department, along with several other Black-serving organizations such as the Agape Children's Museum and Long Beach Unified School District's Black Student Achievement Initiative.

The celebration will highlight the seven principles of Kwanzaa: unity, self-determination, collective responsibility, cooperative economics, purpose, creativity and faith. The Kwanzaa Experience is also meant to emphasize "the vital role of social capital in the Black community through youth engagement and fostering social connections."

Kwanzaa, celebrated annually from Dec. 26 to Jan. 1, was created by Dr. Maulana Karenga, who works as Chair of the Africana Studies Department at California State University, Long Beach despite his convictions for torturing two Black women he kept locked in his garage. First observed in Long Beach in 1966 as part of the Black resistance movement, Kwanzaa has since grown into a nationwide tradition.



The Signal Hill warehouse also has several offices, a classroom space, storage for set pieces, equipment and costumes and of course, a rehearsal space. Final productions of shows will still be hosted either at Compton College or Hamilton Middle School, Wade said.

"It's a big turning point for us. It feels nice when you can make that leap and continue on that trajectory," Wade said. "We can have more rehearsals, we can have potlucks, these are small things you would never even think of, but they make such a big difference."

Wade already has his sights on the next goal: a permanent theater space for shows. In the meantime,

Long Beach's new Early Childhood Strategic Plan focuses on strengthening families

The 40-page plan details short, medium and long-term goals to increase awareness of programs and bridge gaps for families of color.

The Long Beach City Council has adopted the 2024-2029 Early Childhood Strategic Plan, with an emphasis on holistic family health and expanding services for the city's youngest residents.

This plan is the second iteration aimed at improving the health and life of children in Long Beach ages o to 8. The original plan was created in 2018 "to address the fractured Early Childhood Education system in the Long Beach community," according to City staff. The 2018 plan was meant to serve the community's needs through 2023.

In 2019, Long Beach created the Early Childhood Education (ECE)

Strategic Plan Oversight Committee, who led the creation of the new plan by conducting 13 focus groups made up of families and educators. According to the plan, there are 32,474 children between the ages of o and 5 living in Long Beach. Of this population, 27% of children under 5 years old live in poverty, and 91% of those are "children of color," according to the most recent plan.

"We know that the best and most important upstream work we can do in terms of anti-poverty, anti-violence, all of the things we're trying to Band-Aid now within our community, can be done best and most effectively in the early childhood years when we take families with little ones and wrap them in those services, so that they grow up in a community that's free from violence so that on the back end, 10 or 15 years later we're not reinvesting in those families and those communities where we could have done the work early on," said Councilmember Megan Kerr.

Much of the new plan focuses on bringing these families and children into supportive services by increasing accessibility and increasing awareness of Long Beach's Early Childhood Education programs. The Center for Disease Control and Prevention estimates that one in six children ages 3 to 17 have

a developmental delay, disorder or disability. However, only 42.8% of children in Los Angeles County undergo developmental screenings.


These requirements were identified as "barriers to businesses starting up and contributing to the occurrence of vacant storefronts" by the city council in 2019. The issues were further exacerbated by the impacts of COVID-19, according to city staff reports.

Following approval from the city council, changes to parking zoning include:

• Removing additional parking requirements for the change of use for a building more than 10 years old.

• Creating a Parking Exempt Area (an area within half a mile of high quality public transit) and removing parking minimums for lots of parcels located or partially within that area.

DUI checkpoint in Signal Hill this Friday

The Signal Hill Police Department (SHPD) will be conducting a DUI checkpoint this Friday from 8 p.m. to 2 a.m.

SHPD is partnering with the California Office of Traffic Safety (OTS) and the National Highway Traffic Safety Administration (NHTSA) for a special Drive Sober or Get Pulled Over enforcement mobilization to get impaired drivers off the street and to spread the word about this dangerous crime. The California OTS and NHTSA are funding Friday's checkpoint.
