A sit-down conversation with Signal Hill's mayor

The City's most recognizable pair of glasses, Mayor Keir Jones, talked with the Signal Tribune about his goals for the year, his love for Signal Hill, and yes, oil.

🖌 🚩 eir Jones has always felt at home in Signal Hill.

He can remember the moment he and his husband moved from Long Beach and found their "dream place up on the hill" and never looked back. He's since made it his goal that everyone feels the warm welcome that drew him to the city, and now he's ready to usher in the next chapter.

Jones sat with the *Signal Tribune* on Jan. 14 to talk about his term as mayor, his growth as a councilmember and the future he sees for Signal Hill.

Question: What made you want to get into civic service in Signal Hill?

Answer: In a lot of my leadership roles that I've had in my life, I've been asked to serve, and I'm a very pragmatic person. I try to get inclusion and try to get everyone working towards goals so I listen a lot and I take action. Folks were retiring from city council and someone said, "We really need you to do this" and so I ran.

The first time I ran I lost by one vote and so I'm like, "Oh, I almost won and I really want to do this." So I ran again two years later and was elected. I really love our city, it's really unique, it's a mini version of Long Beach in some ways because it's very eclectic, but it has a small town feeling so you get to know your neighbors. Being on city council, we really do have a lot of opportunity to shape the future of the city and that's why I continue to serve because we really have some great opportunities with our vacant land to build some really special places, to really make Signal Hill continue to be a place where people want to live.

Q: What are some things you're excited for during this term?

A: One of the things I really want to talk about is our opportunity study area. Our economic study area consultant was put into place this year, we'll get reporting throughout the year. So we're looking at redeveloping all of Central Signal Hill, that is north of Willow and South of the 405, and so the report that we get will give us feasibility about what would be successful here, what types of businesses can you attract, what types of residential can you construct? So we'll get the report this year, and then we'll start doing community outreach about that plan and then we hope to create an overlay zone in that area so developers will want to come in and they'll know that this project will be economically viable and they'll already have the zoning in place so that they can construct.

It should be done by the end of the year because it's one of my goals for the year.

Q: What are your other biggest goals for your term?

A: Functional zero homelessness; to continue that. We really made it a priority to hit functional zero last year and we really wanted to make sure we had a sustainability plan to stay functional zero and we're almost at a year now. So, we're still there, and our goal is to continue to serve people in need.

We're really excited to work with the community on, "What does downtown Signal Hill look like?"

Warren G, wage protests, and 10 takeaways from Long Beach's 2025 State of the City

Tuesday night marked Mayor Rex Richardson's third annual State of the City event, where a who's who of city VIPs gather for a recap of the past year's accomplishments and a sneak peak of initiatives and plans in the year to come. This year's theme was "Roots, Rhythm and Connection," as Richardson doubled down on his mission to make Long Beach a cultural and musical destination. To bring the point home, three young musical groups (DJ Jasper X, punk rock band Sugar Skull and R&B trio Daydream) showed off their Long Beach-grown talents.



After Richardson recapped all the artists who grew up in Long Beach or have played at its venues, he brought out legendary hip-hop artist Warren G. The rapper continued on the

These Long Beach locations are giving out free N95 face masks

The Long Beach Health Department is distributing free N95 respirator face masks to Long Beach residents over the age of 18 who are at high risk of health impacts from air quality related to the ongoing fires in Los Angeles County, including older adults, people with disabilities, people with underlying health conditions, or people who are immunocompromised.

N95 respirators filter particles, including fine particles from smoke and coarse particles from ash, both of which are respiratory irritants that can cause coughing, wheezing and difficulty breathing.

These face masks will be distributed at all Long Beach Public Library locations, as well as various community centers and senior centers across Long Beach.

Eligible residents are encouraged to pick up masks at any of the locations listed below during their normal business hours. Operating hours vary, so residents should call their preferred location ahead of time to verify they are open. Phone numbers to community centers are available in the online directory.

N95 masks can be picked up during normal business hours at all Long Beach Public Library locations, including the Mark Twain Neighborhood Library (pictured above) as well as several local community centers.

The Long Beach Health Department notes that N95 face masks do not reduce exposure to other potentially harmful constituents of wildfire smoke such as toxic gases or vapors. The most effective action residents can take to reduce the risk of health effects from the inhalation of wildfire smoke is to stay indoors in cleaner air and minimize the amount of time spent outdoors

However, for those who must be outdoors during smoke events, N95 respirators offer enhanced protection if selected and used properly.

Residents should exercise caution and avoid unnecessary outdoor activities in any area directly impacted by smoke and ash. This includes areas where residents can see or smell smoke. In any area impacted by smoke, residents should take the following precautions:

· Avoid any vigorous outdoor or indoor exertion.

· Remain indoors, especially for people with respiratory or heart disease, those who are pregnant, older adults, and children. · Keep windows and doors closed

or seek alternate shelter.

· Run an air conditioner if available.

· Change the standard air-conditioner filter to a medium or high-efficiency filter. If residents have a wall-unit or window-unit air conditioner, set it to "recirculate."

• Avoid the use of a swamp cooler or whole-house fan to prevent bringing additional smoke inside. if possible.

· Avoid indoor or outdoor wood-burning appliances, including fireplaces, to avoid worsening the health effects of wildfire smoke. To check your air quality, visit

the South Coast Air Quality Management District at aqmd.gov.

Do you want it to be super modern? Do you want it to be throwback? Do you want it to look like a Western town? Do you want it to look like an oil town? We want Signal Hill to have its own distinctive look.

The Civic Center master plan, the first element of that is the groundbreaking for the new amphitheater, so we'll have that this year. The new amphitheater is kind of the cornerstone to our whole Civic Center Master Plan. We're hoping, along with the amphitheater that we approved this year, that the terraces and the green space get improved around Signal Hill Park.

Q: When you were new on the city council, what made you champion the flag raising?

A: Signal Hill was a majority LGBT council in the early 2000s, and potentially one of the first city councils in the country to be majority LGBT. The council members were really about getting the work done for the city. They didn't make inclusion or diversity really a focus. But of course, Signal Hill really did always celebrate diversity, but it wasn't evident. In fact, a lot of folks didn't even realize that we had an LGBT majority city council, right? They didn't celebrate it, they didn't talk about it, they just got work done.

I know that Signal Hill is a very welcoming place, that's part of the reason I live here is that Long Beach and Signal Hill have always been a very inclusive community. Signal Hill is where I know a lot of the LGBT folks from Long Beach all moved to, and I felt like it was really important to celebrate that history and also make sure people always know that Signal Hill is a welcoming place for all. And I felt like the commemorative flag policy was a great visible way to show, "We see you, we welcome you, we celebrate you. You're part of who we are."

Q: What do you think is the biggest challenge facing the city right now?

Our biggest challenge going forward is having feasible projects that are financially viable for developers that help us achieve our goals. We need to continue to diversify our economic base [...] But we face some significant obstacles in economic development being that we are an oil city and those obstacles are really preventing further development when it comes to housing. So in the coming year we hope to work with our state government and our developers so that we can continue to move away from oil operations to mixed-use residential and commercial development.

Q: With oil, what is your perspective on how it's been working with the very divided, very impassioned interest in Signal Hill being an oil town and moving forward from that.

A: My job, as I see it on city council, is to continue to do what's in the best interest of Signal Hill. Today, our interests are way different than they were 100 years ago, and ultimately, in Signal Hill, we will have no oil production. It will happen. It might not be tomorrow, it might not be next week, it might not be next year, but at some point, that's the ultimate goal, is that it's all cleaned up and we have zero production. And that's my goal.

I think that's what most of the

residents and even SHP know that the goal is. So it's really about finding the best way to that goal and making sure that Signal Hill continues to be a safe place for people to live. And if we can progress towards that goal more quickly, that might be ideal. I'm not trying to slow that down in any fashion, but I also understand that our current oil producer, SHP, is in the best position to help us get to zero. I'm working with everyone involved to try to accomplish that goal.

We will hit that goal someday and the goal to get to zero can't be in spite of doing what's best for the city and the residents here. We want it to continue to be a safe place and my goal is to make that happen. We have been impacted by oil production from day one, and have taken every effort to make it as safe as possible for our residents and we'll continue to do that, with the ultimate goal of, you know, oil production will be gone someday.

Our biggest obstacle is the funding to make that happen and our best mechanism today to clean up a site is new development because the new developer comes in and they have to mitigate all those old wells and clean it up. The whole site has to be profitable enough for that to happen, and then it gets cleaned up and then we can move to the next site. So, if we can't develop, we really have our hands tied to make progress towards that goal.

Q: Who is your biggest leadership inspiration?

A: I'm gonna say my stepdad, his name's Chris Magnusson. My stepdad is the reason I moved here. He had his own business and he asked me to help with his business. He just had such a positive, can-do attitude about life overall, and every moment in his life was a reason to celebrate. He was a hard worker, but he was always there to help people achieve what they wanted to achieve. He would find out where you are trying to go, what you're trying to do, and he would work at helping you accomplish that goal. Q: Favorite book?

A: "The Four Agreements."

Q: *Favorite movies*?

A: "Groundhog Day," "Scrooged," "Devil Wears Prada" and "Out of Africa."

importance of investing in the city's talent, specifically youth talent. Richardson then announced renovations to the Long Beach Arena,

showed renderings of the soon-tobe-constructed Long Beach Bowl and a slew of 2028 Olympics plans. In a night full of tourism-centric aspirations, Richardson acknowledged the dozens of tourism-sector workers picketing for higher wages just outside the venue. He said he trusts that the "good faith negotiations" on both sides will lead to a fair solution.

Concession workers at the Convention Center have been in labor negotiations with ASM Global, which manages the Convention Center, since September 2023, and workers voted by a 85% majority Monday to authorize a strike. This came nearly a week after the Long Beach City Council passed a wage ordinance update for these workers that excludes temporary, or agency-hired, staff from the new wages.

The majority of the presentation was about the mayor's plan to make Long Beach a tourist destination for music, entertainment and cultural events. He shared that in 2023, tourism contributed \$2 billion to Long Beach's economy. When Richardson brought up how the city has tackled homelessness in the first two years of his term, shouts of protest erupted from members in the audience. The event was paused briefly while Richardson stepped off the stage, and a woman was escorted out by two police officers while she told onlookers that she was going to get kicked out of her home due to rent increases. Though most of the night was about what has already been accomplished during the first two years of Richardson's term as mayor, there were a few interesting nuggets of news saved until the end of the night.

2. A new Long Beach Police Academy Training Center will open soon, and the city will double the amount of firefighter academies it hosts in a year in an effort to recruit more firefighters and paramedics.



businesses 10 years or older; grants to help businesses acquire security cameras, cashless sale systems, and shatter-proof window coverings. There will be another program for legacy businesses with planning resources, employee stock ownership plans, worker co-ops and other strategies to help keep the business running when the original owner retires.

5. The Mayor asked Chief of Police Wally Hebeish and City Prosecutor Doug Haubert to create a Long Beach Organized Retail Theft initiative to identify additional strategies to protect businesses.

6. A new website, longbeach.gov /2028games, has been launched for residents to track 2028 Olympic planning and progress.

7. Multiple Olympics Community Advisory Committees will be formed, focusing on arts and culture, small businesses, workforce and economic inclusion, and youth sports. There will also be an Olympic Legacy Foundation Advisory Committee that will continue after the 2028 games. 8. The mayor shared rendered images of the planned Long Beach Bowl outdoor amphitheater, which will seat 10,000 to 12,000 people. The City will also work to form a private-public partnership to bring improvements and extensive renovations to the Long Beach Arena. 9. The city will develop an Entertainment Strategic Plan with an accompanying advisory committee to work to bring more entertainment to the city and assure that local businesses benefit from it. Long Beach will explore 10. developing a Sports and Entertainment Walk of Fame to highlight the athletes and entertainers who have come out of Long Beach.

The grand marshals announcement has since received backlash from several residents for a lack of Black representation, with Clinton being the only Black individual serving as grand marshal. Two local high school sports teams with Black athletes were appointed as a group to be grand marshals, but are serving in that role as a group rather than individuals.

A change.org petition calling for the City of Long Beach to transfer the management of the parade to a "viable Black nonprofit" was created on Monday, Jan. 13.

As of Jan. 16, the petition has received 275 signatures.

The petition lists the following demands:

• The City of Long Beach publicly acknowledges the harm caused by this decision on the same media platforms used to promote the parade and celebration and one printed publication.

•This should occur by the next City Council meeting scheduled for January 21, 2025.

• [Organizers] expect to meet with the 6th District Council member within 30 calendar days from the date of the MLK Parade and Celebration to discuss the results in further detail.

• The transfer of the 2026 responsibilities regarding the managing, planning, and execution of the parade and celebration. This will require shifting from the 6th District Council office to a viable Black nonprofit. The Black community in Long Beach will select the nonprofit via a community survey. The community includes businesses, nonprofits, and faith leaders of the City of Long Beach. This will ensure the parade truly honors Dr. King's legacy and reflects the richness of Black culture.

•The continued support and sponsorship from the Mayor and City Council.



Young residents invited to brainstorm ideas for Youth Power PB Long Beach

The third iteration of the Youth Power Participatory Budgeting (PB) Long Beach has begun, and youth ages 13 to 26 are invited to make their voices heard. Now through Feb. 1, local youth can share their ideas for how \$550,000 should be spent on youth summer projects.

This effort is led by Long Beach Health and Human Services' Office of Youth Development, along with The Nonprofit Partnership, Invest in Youth Coalition and Khmer Girls in Action.

"Long Beach is committed to fostering youth leadership and community engagement," said Mayor Rex Richardson in a public statement. "The youth participatory budgeting process is a powerful way to elevate youth voices, empowering them to shape programs and initiatives that directly impact their growth and success."

The Youth Power PB funding comes from Measure US and the City's Adopted Budget for Fiscal Year 2025, with this year's amount almost doubling the total funds allocated during the program's first cycle in 2023. These funds will be allocated to project budgets, with amounts ranging from \$10,000 to \$50,000. Youth who live, work or play in Long Beach will decide which proposals to fund. The 2025 cycle of Youth Power PB will begin with a series of in-person brainstorming sessions across the city, ensuring youth from various neighborhoods can make their voices heard. Youth need to only attend one session to submit their ideas for youth summer projects.
