



# 'The Middle Passage Experience' doesn't shy away from America's history

he African American Cultural Center of Long Beach's newest exhibit chronicles a difficult, but essential piece of American history. Though its contents consist of trauma, bondage and despicable cruelty, "The Middle Passage Experience" is both a testament to the undeniable strength it took to persevere, and the imporance of remembering the past.

The Middle Passage is the route that over 12.5 million Africans had to take aboard ships from Africa to America. These tight-packed floating prisons were run by a cruel regime and subjected Africans to inhumane conditions. As a result, over one million people died along the Middle Passage.

The exhibit was curated by Sharon Diggs-Jackson, a Long Beach-born-and-raised historian, genealogist and board member for the African American Cultural Center of Long Beach. The contents have been put on display two times before, once at the Cultural Center in 2003 and again in Downtown Long Beach in 2004.

Diggs-Jackson felt it was necessary to bring back "The Middle Passage Experience" exhibit this year so people get the chance "to really talk about our history as Americans," she said.

"To be able to understand the full breadth; the good and the bad, because all of that has gone into making us the nation that we are, and it's an important topic especially today ... This current climate we're living in, there are some that would like to erase our history completely, but I'm a historian and I believe in telling things the way that they were. It's not my job to rewrite or to remarket history, my job is to tell it as it happened," Diggs-Jackson said. Attendees will be taken through the perilous journey that over 12 million Africans took

# Community rallies against Trump administration's threats to education

The Teachers Association of Long Beach hosted a rally on Saturday with speakers condemning plans to dismantle the Department of Education and uplifting the importance of public education.

Between calls to action and a constant reaffirmation of support for marginalized student populations, a group of around 100 Long Beach community members gathered the morning of Feb. 8 in support of public education. The Teacher's Association of Long Beach hosted a rally with teachers, community organizers and elected officials who spoke against the current presidential administration's policy efforts that would negatively impact education.

"Education is the cornerstone of our society, who goes after the Department of Education?" California State Superintendent Tony Thurmond said.

President Donald Trump has been threatening to abolish the Department of Education since his campaign, but the decision would require congressional approval.

Thurmond reassured parents and the community that while the dissolution of the Department of Education is unlikely, the state is ready to fight back. He pointed to California congress members like Rep. Robert Garcia — who also spoke at the rally — who have pledged to vote against legislation trying to dismantle the department.

"This is not a partisan issue, this is an issue that affects people of all backgrounds and parties," Thurmond said. Long Beach Mayor Rex Richardson said these actions are an attack on democracy.

The Long Beach Department of Health and Human Services (Health Department) has introduced a new online Racial and Health Equity Data Hub, designed to provide an overview of the health status of Long Beach residents across different racial and ethnic groups. This interactive platform will utilize health data to address community challenges and promote health equity citywide.

The Data Hub offers tools for residents to explore how various social determinants of health-such as education, housing, public safety, and access to nutritious food-impact health outcomes in the community. These factors influence health, daily functioning, and quality of life for individuals. The goal is to use this data to improve these conditions across Long Beach's diverse neighborhoods.

The platform includes data on chronic diseases, communicable diseases, maternal and child health, and mental health, as well as factors such as economic equity, housing and homelessness. It allows users to view this information by race/ethnicity, gender, geography, and year.

The hub consolidates several other health-related City dashboards. including those for the Long Beach Recovery Act, Community Health Assessment, HIV Data, Homelessness, and Community Crisis Re-

The Data Hub will eventually integrate data from ongoing community needs assessments for the Cambodian, Native Hawaiian and Pacific Islander, Black, and LGBTQ+ populations, providing a more comprehensive look at the needs of Long Beach's diverse com-

"When we talk about improving the health of Long Beach residents, we need to look at the whole picture," Health and Human Services Director Alison King said in a public statement. "This new data hub allows us to analyze trends over time, which, in turn, helps inform policy so we can improve outcomes."

The data provided in the hub is drawn from sources such as the Big Cities Health Data Inventory, the American Community Survey, National Equity Atlas, and the CDC's PLACES datasets, with information available up to 2021.

# Level Up LB offers small business owners funds and assistance

Long Beach has opened applications for the second round of its Level Up LB: Extreme Small Business Makeover and Grant Program.

Level Up LB was created to financially assist aspiring entrepreneurs with their small businesses and help them craft sustainable business plans. Through this program, 20 small business owners will receive support services, participate in workshops and earn \$10,000 in grant funding to advance their business goals.

The chosen applicants for Level Up LB's second cohort will be connected with resources and informative workshops throughout a ten-week course that will center around creating new business and marketing plans. Following the course's completion, businesses will be awarded \$10,000 in grant funding to grow their business and implement their plans.

"Small businesses are the backbone of our economy and make up 52% of jobs in Long Beach," said Mayor Rex Richardson in a public

statement. "The continuation of the Level Up LB Program reflects our commitment to supporting small businesses, bolstering local job creation, innovation and connection, and the economic future of our city."

Applications are open now through Thursday, March 20 at 5 p.m.. Businesses that apply will be evaluated based on their need, readiness to participate and potential program impact on their business growth. For further eligibility details, visit longbeach.gov/

Level Up LB is led by staff from the Economic Development Department alongside support from local partners. Businesses chosen for the program will assess their business plan, financials, sales metrics and ways to reach the next level

"With Level Up LB, we are in-

vesting directly in the dreams and hard work of our entrepreneurs and small businesses," said Economic Development Department Director Bo Martinez in a public statement. "We are proud to provide the support and resources needed to help our local businesses grow and contribute to the fabric of our community. When small businesses succeed, our entire city succeeds."

In 2024, 29 small businesses received \$266,000 through the first round of Level Up LB. As part of the City's adopted Fiscal Year 2025 Budget, the Long Beach City Council approved a one-time funding of \$500,000 towards business improvement districts and small businesses, with half (\$250,000) allocated to Level Up LB.

# Long Beach to host meeting on District 6 public works projects ahead of upcoming Olympics

Long Beach will hold a community meeting Feb. 20 about projects planned for District 6 leading up to the 2028 Olympics, including the creation of the African American Cultural District.

The Elevate '28 initiative aims to improve the city before the influx of tourism that will occur during the 2028 Olympics, with nearly 200 projects aimed at enhancing parks, community facilities, accessibility and transportation throughout Long Beach.

Several major projects under Elevate '28 will take place in District 6, including the restoration of the VIP Records sign, the creation of the African American Cultural District and the Martin Luther King Jr. Park Vision Plan.

Public Works Department staff will give an overview of the projects, and afterwards community members can ask questions and offer feedback. Staff members from various City departments, along with the Office of Sixth District





Councilmember Dr. Suely Saro and local stakeholders will be present to discuss the planned improvements in the district.

in bondage that led them to North, South and Central America. Through physical artifacts, videos, images, informational boards and docents, the Cultural Center will aim to tell the entire story of Africans — not just slavery.

continent before the Atlantic slave trade.

Although the Middle Passage is the central component of the exhibit, the story doesn't begin or end there. Attendees will learn about daily life and civilization in Africa in the 1800s, a successful and thriving continent.

"The history that we've been led to believe is that Africa was this uncivilized nation and there was this need to go get these people and to bring them into civilization,' Diggs-Jackson said. "But the truth of the matter is the continent of Africa is the cradle of life, it's the cradle of technology. There were scientists, there were farmers, astronomers. It was an established society."

Historians have acknowledged that Africa is the birthplace of civilization as we know it, and many staples of life, such as the formation of states, engineering and architecture, originated there.

According to the Jim Crow Mu-

seum, West Africa had complex political structures that spanned large kingdoms such as Benin and Kongo, as well as villages that came to agreements which decided the governing powers. In the centuries before slavery became the dominant trade. Africans were known for their skill in medicine, mathematics and astronomy, as well as crafting gold, ivory and bronze goods.

The exhibit shows how certain peoples in Africa used to live and items they made such as weapons,

musical instruments and mudcloth (cloth made with fermented mud). There's also a large map of Africa and over 100 different villages and societies that used to exist.

Docents will also teach participants about how slavery impacted Africa; how Africa lost its youngest, strongest and brightest citizens for generations, and how its local economy was destroyed.

The Cultural Center will then take attendees through a corridor showing them what the Middle Passage journey was like, through images of how Africans had to travel on the ships to artifacts such as chains that were used. Images show how crammed the ships were, artifacts show how those aboard ships were intimidated and abused, and accompanying boards ask attendees to imagine being separated from their home, thrown amongst strangers, never to return.

"You can't just rewrite history because it serves your purpose. We all benefit from the truth and we need to learn from the good lessons as well as the bad, and slavery is truly a black spot in our history," Diggs-Jackson said. "We cannot rewrite history and we need to, as Americans, be able to own up to the good as well as the bad, because we learn from history ... History right now is such a controversial subject and we see what's happening in our country, of teachers and educators being prohibited from even talking about certain subjects, so it seemed like it's the right time to tell this story.'

The exhibit ends on what life was like for Africans once they became enslaved in North America. Displays show how American Christians used parts of the bible to justify slavery, and panels tell how auctions were conducted. This part of the story takes time to debunk common misconceptions about slavery, like that it only existed in Southern states or that all Africans were or became Christian.

Attendees will also learn about the ingenuitive ways that slaves found ways to live by creating secret meeting places to teach each other how to read and write, and by passing down their various traditions and culture even as America tried to erase it.

"While the story is traumatic, we try to leave people with the thought that — to have an understanding of the strength that had to have resided in those individuals who were put on that journey and then were able to survive, and once they got here into the United States, went on to make a life for themselves and to make a life for people like me who are fourth generation, just four generations removed from slavery," Diggs-Jackson said. "Ending on the hope that in spite of all of that, these people were survivors.

Diggs-Jackson said she felt it was important to end with the story of strength especially for the African American audience, "so when we start to feel like life is hard and there are struggles, that we call on that same DNA and energy and recognize that we are survivors, we are conquerors."

Local educators who are interested in taking their students to the exhibit can schedule a private educational tour, so students can learn about this part of American history "in a way that adds value."

If attendees feel inspired to learn more about their history, Diggs-Jackson has another exhibit across the street at the Historical Society of Long Beach. This smaller exhibit is about early Long Beach and the stories of the first African Americans who settled here. Residents can learn about the first Black church, the first Black families in the city and more.

Diggs-Jackson said her main focus for the next few years, as the City prepares to create a Historically Black Cultural District, is to compile the stories of all the people who made Black Long Beach.

"Long Beach has an amazing story," she said. "There've been amazing people, many of them are my elders I was blessed to grow up with so that's part of what we're committed to over the next couple

The Middle Passage Exhibit Experience exhibit will be on display at the African American Cultural Center of Long Beach (4321 Atlantic Ave.) on Tuesdays, Wednesdays, and Saturdays from 11 a.m. to 4 p.m. and on Thursdays and Fridays from 2 p.m. to 7 p.m. through March 1.

A special Sunday viewing will take place Feb. 16 from noon to 4 p.m., with light refreshments and discussions.

"What they want is an uninformed electorate," Richardson said. "We've seen it before, if you can't read you can't vote, you can't think critically, you can't speak up for the life that you want and for

Samantha Martinez, a senior at Long Beach Poly High School shared her experience as a daughter of an immigrant mother, who instilled in her the value and importance of education. She added that dismantling the Department

of Education would strip away the structure and resources students need to thrive.

"Education isn't just policy, it's power," Martinez said. "When we protect it, we give students not just the chance to survive, but the chance to succeed."

Nubia Flores, a Long Beach Unified School District (LBUSD) parent and organizer emphasized that if there was a time for parents and teachers to be united, it is now. She urged teachers to invite parents in because they also want safe and welcoming schools, adding that collaboration is needed at all levels.

"We need elected [officials] that are going to lay upon the line just like parents, teachers and staff do every single day that kids go to school," Flores said.

Several members of the Long Beach Unified school board were in attendance and gave speeches, including Superintendent Jill Baker, and board members Doug Otto and Juan Benitez.

During his speech, Benitez said

he commits to helping pass policies that help students. He also emphasized the importance of solidarity. He added that it is important to speak out and affirm equity for all marginalized groups whether that be immigrants, emerging bilinguals, LGBTQ+ students or students with disabilities.

"All of us, whether you went to [a public school] or not, are only here because of the powerful impact that a free equitable, well-funded, high-quality public education provides to everyone," Benitez said.

In the past weeks, LBUSD has posted messages to its website and social media recognizing the uncertainty of the current political climate, but reassuring parents that the district intends to ensure schools remain safe for all students. The district created a webpage with immigration resources that will be updated periodically.

Simi Sardana, the mother of two LBUSD students, told the Signal Tribune she left the rally feeling re-

"Any time that we can see the community come together and support each other, you just feel empowered and you feel energized," Sardana added. "We're in good hands here in Long Beach."

"This recognition is about honoring those who have paved the way for LGBTQ+ rights in Long Beach," said Cory Allen, chair of the selection committee, in a public statement. "Harvey Milk Park was the first in the nation named after an openly gay elected official, and it stands as a lasting tribute to those who fight for equality. We invite the community to submit nominations and help us celebrate the individuals who have shaped our city's LGBTQ+ history and ongoing fight for equality."
