A homecoming on wheels

Pigeon's Roller Rink returns to Long Beach

As summer rolls back into Long Beach, so too will one of the community's favorite old-fashioned pastimes. After an eight-month hiatus, Pigeon's Roller Rink will return to 2ND & PCH, transforming the vacant space into a cherished mecca for connection and joy.

The homecoming will be ushered in with a grand reopening on Saturday, May 3 at 10 a.m., with a ribbon cutting ceremony, free gifts for the first 100 guests and a full day of four-wheeled fun. Returning with new all-day passes, free lessons and membership parties, the rink is aiming to be more accessible than ever.

"It just feels like home," said Shayna Meikle, owner of Pigeon's Roller Skate Shop and Roller Rink. "Me and countless other people spend many hours there, celebrate achievements there, exercise there, get into the zone or whatever it is you need to do, it can all be done at the rink."

Pigeon's Roller Rink, an offshoot of the skate shop on Fourth Street, has operated since 2021, sandwiched between various retailers and restaurants at the 2ND & PCH shopping center. Pigeon's Roller Skate Shop was founded in 2011, but before turning to a life on wheels, Meikle was a middle school science teacher running a roller derby club in Long Beach in the evenings.

She would spend her days teaching children, and at night kept hearing testimonials from women, mostly mothers, who said joining roller derby and finding themselves through roller skating was saving their lives.

"As a teacher you're constantly trying to help the kids ... but I hadn't realized before those testimonials that I can't help these kids — their parents need help," Meikle said. "I really saw much greater reach for making positive change in people's lives through roller derby and roller skating."

Once the 100-member all ages roller derby group needed a new place to skate, Meikle began scouting locations. When she came across the 2ND & PCH lot, she realized it was big enough to share with more people.

What started off as a three-month lease has become a cherished community fixture and a space of inclusivity for

Signal Hill appoints nine commissioners across three commissions

Commissioners were appointed to the Civil Service, Parks and Recreation and Planning Commissions at the April 22 City Council meeting.

Fifteen residents applied for positions across three commissions, with most of the appointees being incumbents.

The Signal Hill City Council reviewed and appointed several residents to the Civil Service, Parks and Recreation and Planning Commissions on April 22.

Commissions are made up of residents who act as advisors to the City Council and City staff. They meet monthly and are paid only for the meetings they attend. Nine commissioners were selected across the three commissions. Residents will serve four-year terms on their appointed commissions from June 1 to May 31, 2029.

Parks and Recreation Commission

The Parks and Recreation Commission's duties are to program leisurely activities, facilities and services for Signal Hill residents. The commission also recommends policies concerning all parks and recreation properties, facilities, plans, programs and activities and can recommend programs for the improvement, acquisition and development of parks and recreation facilities.

The commission meets on the third Wednesday of each month at 6 p.m. at City Hall. Commissioners receive \$75 per meeting.

The Parks and Recreation Commission was the most applied to throughout the evening, with six residents applying. The three chosen commissioners were all incumbents, with some serving for several months and some for years.

The two additional existing commissioners are Kiran Gidwani and Caroline Kiss-Lee.

Civil Service Commission

The duties of the Civil Service Commission is to approve eligibility lists of those determined to be qualified for classified service in the City. They also hear appeals of classified employees involving suspensions, demotions or dismissals.

Ring in AAPI Heritage Month with dozens of free Long Beach Public Library events

The Long Beach Public Library (LBPL) is celebrating Asian American and Pacific Islander (AAPI) Heritage Month all May long with a variety of free cultural, educational and artistic programming.

The Library's slate of free community events will explore AAPI cultures while showcasing the traditions, histories and contributions of Asian and Pacific Islander communities in Long Beach.

The AAPI Heritage Month Kick-Off Celebration will take place Saturday, May 3 from noon to 4 p.m. at the Billie Jean King Main Library, located at 200 W. Broadway. This event will include a performance by local Cambodian dance company Modern Aspara and a screening of the documentary "New Wave," which centers on the experiences of Vietnamese families dealing with generational trauma. A post-screening Q&A with the film's director Elizabeth Ai will be moderated by Ky-Phong Paul Tran, an instructor at Renaissance High School for the Arts.

Throughout AAPI Heritage Month, all 12 LBPL locations will host a lineup of free programs aimed at children, teens and adults. Activities include a Chinese paper lantern craft workshop led by local artist Emmy Lam and the teen manga drawing series "The Manga Connection to Old Japan" with artist Sunny Seki.

Additional events include:
Botanical Water Coloring – Teens and adults can learn the basics of watercolor painting and cultivate a personal artistic style at this painting session with Gloria Teng, a botanical Chinese watercolor artist. Registration is encouraged. *Saturday, May 3 from 10 a.m. to noon at Bach Neighborhood Library (4055 N. Bellflower Blvd.)*

The City of Long Beach is inviting middle school youth to take part in a new survey aimed at improving park programming and amenities to better serve local youth.

The initiative, launched by the Departments of Parks, Recreation and Marine (PRM) and Health and Human Services, focuses on encouraging safe, healthy and active uses of City parks by kids ages 11 to 14.

The youth survey, available in English, Spanish, Khmer and Tagalog, will remain open through Thursday, May 22 and seeks feedback on how local parks can better support the physical, social and emotional wellbeing of middle schoolers. The input will help the

City tailor future park programs and amenities to match the specific interests and needs of young residents.



skaters of all levels. Which is why the abrupt hiatus took the community, and Meikle, by surprise when she was told a Pixar Putt mini golf experience would be taking their place in September 2024.

to expand their presence across Southern California, but didn’t want the Long Beach location to suffer.

Her hesitancy is warranted, as roller skating rinks have suffered from financial challenges in the last few decades. Many beloved rinks have been forced to close in recent years, including Los Angeles’ beloved World on Wheels and San Jose’s Aloha Roller Rink.

It’s a balancing act, Meikle explained, as the retail sales from Pigeon’s Roller Skate Shop helps keep the roller rink running and vice versa. They also operate at both locations on a month-to-month lease, which she said “isn’t great for business, or building community,” but allows them to afford the space.

“When someone shops at Pigeon’s on Fourth, it really does go straight to keeping the roller rink open,” Meikle said. “With roller

rinks you don’t really make money, you make enough to reinvest in your business, which you have to constantly do, which I love doing. I also just have a lot of motivation knowing that no one else is going to do it”

To cover the price of closing the Long Beach rink and opening the Mission Viejo ‘space,’ they put in a “crazy sale” at the shop during the holidays. Months later, the money made from the Mission Viejo rink allowed them to reopen the Long Beach location.

“We originally thought we’d be open here for six months, but they want us to stay,” Meikle said of the Mission Viejo location.

With Pigeon’s now running at two locations for the first time in its history, its Long Beach homecoming is aiming to be more accessible and community-focused than ever. Pigeon’s will be offering \$15 all-day passes, a rarity in the roller rink business, as rinks stand to make more money by selling timed sessions. Customers will be welcome to skate, leave for a bite to eat and return at their leisure.

Monthly passes will be \$45 and allow residents access to both rinks seven days a week, all day, as well as free skate rentals and members-only events such as potlucks, skate clinics, parties, discounted concessions and soon, discounts at the nearby eateries.

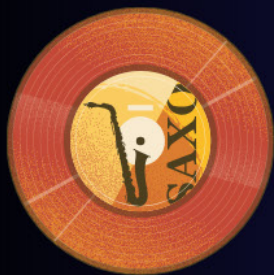
